The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and Twentieth Century Fox Organization (East Africa) shall hereinafter be referred to as the Respondents.

The Parties were heard in Nairobi on the 16th day of March 1967, and relied on their written and verbal submissions.

Award

The Court has to consider various factors before a wage increase is granted. An increase in the cost of living is only one of such factors. One of the other important factors which cannot be overlooked is that the worker should be able to get something more than the compensation for the loss of money value, in order to move towards the ultimate objective of enjoying a higher standard of living. But this can be granted only if under competitive conditions an industry can be shown to be capable of paying a full living wage. This has further got to be consistent with the growth of economy in the country and its Development Plan.

The Court has very carefully considered the various submissions made by both Parties and awards as follows:—

- (a) Wages.—The Court awards a wage increase of Sh. 32/50 per month to all employees.
- (b) Gratuity for the previous services up to the National Social Security Fund.—The Court finds that, the scheme proposed by the Respondents is reasonable and fair except that, the proposal that an employee should reach retirement age or complete ten years' further service with the Respondents from 1st September 1966, is unreasonable.

The Court has, therefore, decided that this proviso to the scheme should be deleted and an employee should be required to complete only three years of further service with the Respondents from the 1st of September 1966, in order to qualify for benefits under the proposed scheme.

(c) Effective Date and Duration.—The Court rules that, this award shall be with effect from 1st October 1966, and shall remain in force for a period of two years from that date.

Award

6. The Court has very carefully considered the submissions made by both parties in making its findings.

The Court awards a wage increase of Sh. 20 per month to all employees on their existing salaries and further that, the rates for the various grades shall also be increased by the same amount, provided that no employee shall get an increase of more than Sh. 20.

The Court finds that the fringe benefits covered in the other issues in dispute shall remain unaltered except on the issue of shift differential where the Court awards as follows:—

"In addition to basic wages/salaries employees working a 24-hour or less shift cycle as a team shall be paid a shift differential of 5 per cent of their basic wages/salaries per month to compensate them for the inconvenience involved in performing shift roster work. This shift differential shall not be included in the basic wage and accordingly shall not be taken into account when calculating Provident Fund contributions and overtime payment.

As it is intended to compensate the individual for the inconvenience abnormally incurred in shift roster work, the shift differential shall not be paid when the employee is absent from work through being sick, on leave or for any other reason for a particular day on which shift work was not actually performed. In order to ensure continuity of operation all shift employees shall remain on duty until relieved by the succeeding shift or until permitted to leave by the Manager or Supervisor in charge."

The Court rules that the effective date of this award shall be 1st June 1966 and that it shall remain in force for a period of two years from that date.

AWARD

The Court has carefully considered the submission made by the Respondents that this issue is not negotiable, but rules that it is a terminal benefit and the two headings of pension and principles of redundancy are wide enough to give Claimants a right to negotiate with the Respondents on the issue of gratuities. Furthermore, as far back as 1963 the Respondents had undertaken to consider a long service gratuity scheme and to make proposals to the Claimants in due course. The Court, therefore, finds that the Claimants are entitled to negotiate with the Respondents on this issue.

The Court has gone through the scheme proposed by the Respondents and awards it with the following amendments:-

- (a) The qualifying period of five years after January 1967, should be deleted.
- (b) Those employees who have been in the Respondents service before the commencement date of the National Social Security Fund, shall be paid on the basis of seven days' pay at the rate then current for each year of service prior to January 1967, up to a period of four years. Thereafter, they will be entitled to ten days' salary for each additional year of service.
