## THE TRADE DISPUTES ACT 1965

(15 of 1965)

## ORDER UNDER SECTION 36—COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 36 of the Trade Disputes Act, the Minister for Labour hereby orders every employer who employs not less than five members of the Printing and Kindred Trades Workers' Union to—

- (a) deduct every month Sh. 4 in respect of trade union dues from the wages of each of his employees who is a member of that trade union;

- (b) pay 85 per cent of the total sums so deducted in any month, not later than the 3rd day from the date on which such wages were paid, by crossed cheque made payable into the account of the Printing and Kindred Trades Workers' Union at the National and Grindlays Bank, Government Road, Nairobi;

- (c) pay 15 per cent of the total sums so deducted in any month, not later than the 3rd day from the date on which such wages were paid, by crossed cheque made payable into the account of the Central Organization of Trade Unions (Kenya) Account No. 140793-7 at the Barclays Bank, Queensway Branch, P.O. Box 30011, Nairobi;

- (d) notify in writing that trade union and that federation before the end of each month of the amounts of any payment made to the accounts of that trade union and of that federation in that month;

- (e) notify in writing the Registrar of Trade Unions before the end of month of the amounts of any payments made into the accounts of that trade union and of that federation in that month.

In exercise of the powers conferred by section 36 (2) of the Trade Disputes Act, Gazette Notice No. 4600 of 25th November 1966 is varied accordingly.

## THE WEIGHTS AND MEASURES ACT

(Cap. 513)

## NOTICE TO MOMBASA TRADERS

THE Weights and Measures Office in Tangana Road near Mombasa Railway Station, will be open during normal office hours for the period 3rd May to 22nd May 1967, for the acceptance of traders' weighing and measuring apparatus which requires verification and stamping.

2. All traders within a radius of 12 miles of the above-mentioned office whose apparatus was last stamped more than 12 months ago are required, under the provisions of the Weights and Measures Act (Cap. 513), to produce to the Inspector of Weights and Measures, all weights, measures of length and capacity, and weighing instruments which they have in use for trade, for verification and stamping.




