CAUSE No. 16 of 1967

Parties:—

Kenya Local Government Workers' Union
and

Municipal Council of Kisumu

Issue in dispute:—

To determine what amount should have been paid to Mr. Mande on his termination of employment.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Municipal Council of Kisumu shall hereinafter be referred to as the Respondents.

2. The Parties were heard in Nairobi on the 11th day of May 1967, and relied on their written and verbal submissions.

AWARD

6. During the hearing of this dispute the President of the Court pointed out to Mr. Karebe that, the Industrial Court could not under any circumstances encroach upon the jurisdiction of the High Court and the subordinate courts and neither could the Industrial Court inquire into the validity or otherwise of an order made by these courts. The Claimants' General Secretary accordingly withdrew that part of the claim which related to the amount which the Respondents had paid into the High Court as a result of a garnishee order served on the Respondents. The Court was then left with Mr. Mande's claim for two months' salary in lieu of notice as he has already received one month's pay.

It is true that on 2nd September 1965, Mr. Mande was informed that his services had been terminated with a loss of all privileges, but afterwards due to the intervention of the Claimants on his behalf and following the events like the investigation carried out by the Ministry of Labour, the Claimants succeeded in persuading the Respondents to reverse their decision of dismissing Mr. Mande from their service. The Court finds that this position having been achieved Mr. Mande's services could then only be terminated under rule 18 of the Respondents' Terms and Conditions of Service for Established Staff. It was not denied that Mr. Mande was not on the Established Staff. Under rule 18 of these Terms and Conditions of Service, three months' notice has to be given to an employee on Established Staff for the termination of his service. The Court finds that the word "retired" was wrongly used in the correspondence quoted hereinabove in the general background as under rule 17 of the said Terms and Conditions of Service an officer can be called upon to retire after he has attained the age of 50 years. This provision was, therefore, not clearly in the minds of the Parties and, therefore, if Mr. Mande was neither retired under rule 17 nor dismissed, then his services should have been terminated in the normal way and the Court finds that this is exactly what the Parties had intended and agreed upon on 3rd January 1967, and which had subsequently been confirmed by the Claimants on 4th January 1967.

For the foregoing reasons, the Court cannot accept the Respondents' submission that Mr. Mande is still to be considered as having been dismissed and that the Respondents had agreed to pay him their contribution to the provident fund as a favour and that one month's pay in lieu of notice was an *ex gratia* payment. To do so would be very contradictory and against the facts which came to light in this dispute.

The Court, therefore, having considered all the evidence very carefully finds that Mr. Mande should have been given three months' pay in lieu of three months' notice and as he has received only one month's pay, he is entitled to the remaining two months' pay.

2. The Parties were heard in Nairobi on the 9th day of May 1967, and relied on their written and verbal submissions.

AWARD

6. The Court had considerable difficulty in trying to follow the Claimants' submissions in this dispute and it was only after questions from the Court members that the Claimants put forward all the facts leading to the present dispute. The Court can find no reason whatsoever for allowing the Claimants to back out of the agreement which they had freely and voluntarily signed with the Respondents in September 1966. The Claimants should discharge the burden which they have undertaken under clause 22 (a) dealing with Part I of this agreement in that, they should approach the Minister for Labour and persuade him to extend the wage rates and terms and conditions of the agreement which they have negotiated with the Respondents to the non-members of the Respondents. The Claimants did not produce any evidence to the Court suggesting that they had approached the Minister for Labour in this connexion. In view of this, it is absurd for them to come to the Industrial Court and seek revocation of the agreement which they had freely and voluntarily negotiated. As far as the Claimants' submission that because terms and conditions are also included in the September 1966 Agreement, therefore, the whole of this agreement should be rejected, it appears that the Claimants have failed to appreciate that the clauses regulating terms and conditions of employment have not in any way been altered and continue to remain effective from the 1st day of September 1965, for a period of two years. In view of this the Court rejects the Claimants' contention and upholds the Respondents' submission that clause 22 (a) of the Agreement signed on 6th September 1966, applied and that after the signing of this agreement the 1965 Agreement lapsed.
