Applicants will be required to have a minimum of Cambridge School Certificate with high passes in English and Swahili, and a minimum experience in Information/Newspaper/Radio work or any other public media of information, of four years. Ability to handle publicity work meant for Radio consumption will be a distinct advantage. The post is pensionable and competitive, but prospects are excellent for the right man.

Assessor Trainees, East African Income Tax Department

Salary scale.—“A” 3: £804 by £43 to £976 p.a.

Candidates must be graduates of recognized Universities or must have passed the final examination of the Chartered Institute of Secretaries. In-serving officers who possess Higher School Certificate or an equivalent General Certificate of Education at advanced level may also apply.

Successful candidates will be given intensive specialized training in the East African income tax law and practice in the Department's School lasting about 2½ years. They will be expected to pass a preliminary and a final examination to qualify as Income Tax Assessor.

Assessors of Income Tax are required to deal with assessment and collection of Income Tax, to examine business accounts and to agree liability with taxpayers and taxpayers' accountants and lawyers.

After qualifying they will be promoted to the A.2 scale at £1,020 by £43 to £1,390 p.a. regardless of which they will have opportunity for promotion to senior assessor's grade if they complete three years' satisfactory service. Duties.—The programme of research to be undertaken will cover selected topics on the elucidation of the taxonomy, ecology, distribution, physiology, behaviour and commercial importance of the freshwater fishes of East Africa in both their indigenous environments and in their introduced habits, as well as similar considerations of particular exotic (foreign) species.

THE INDUSTRIAL COURT

CAUSE No. 15 OF 1967

Parties:—

Domestic and Hotel Workers' Union
and
Block Hotels Limited

Issue in dispute:—

Failure of the Management to pay arrears for 16 Stewards.

1. The Domestic and Hotel Workers' Union shall hereinafter be referred to as the Claimants and Block Hotels Limited shall hereinafter be referred to as the Respondents.

2. The Court commenced the hearing of this dispute on 17th May 1967, with the President sitting with Messrs. Ochwada, Ngoloma and Mrs. Lukalo. After the Parties had made their opening submissions the Court made the following Order:—

"The Court with the consent of the Parties directs the Senior Labour Officer, Nairobi, to compile a factual report on the actual work each one of the 16 employees involved in this dispute does. He should carry out his investigation accompanied by a representative of the Claimants and the Respondents. He should also ascertain and submit to the Court the details of the work done by a Head Waiter, a dining room steward, a room steward and a coffee shop steward.

This report should be compiled within four weeks of today."

Mr. Omondi, the Senior Labour Officer, Nairobi, submitted his report on 16th June 1967, and the hearing of the dispute was fixed for 18th July 1967. By this time Mr. Ochwada had ceased to be a member of the Court and Mrs. Lukalo had gone overseas, therefore, Mr. Mugalla was invited by the President of the Court to represent the workers in this dispute along with Mr. Ngoloma who represented the employers. In these circumstances the Court on 18th July 1967, recommenced the hearing of this dispute from the beginning. The Parties relied on their written and verbal submissions and the Claimants called two witnesses and the Respondents one. In addition the Parties agreed to the contents of Mr. Omondi's report and consented to it being accepted by the Court as part of the proceedings. Reference will be made to Mr. Omondi's report hereinafter as and when necessary.

AWARD

6. The Court has very carefully considered the submissions made by the Parties in this dispute and the evidence that was tendered in support thereof. It should be made clear at the

outset that Messrs. George Omollo, Sammy Kamau and E. Sebastian are not covered by the job descriptions and scales of pay which the Claimants have negotiated with the Respondents and which appeared as Appendix 1 to their submissions in the present dispute. It was agreed by the Respondents' witness Mr. Smith that Mr. George Omollo was in charge of all room service staff and that he was responsible to the Management for detailing staff to duties in accordance with the duty roster. He was responsible for discipline of staff and customers' complaints, furthermore when he was absent he was relieved by a member of the Management and not by any other room service staff. Messrs. Sammy Kamau and E. Sebastian were also responsible to the Manager of the Coffee Shop in shifts. They were also responsible for discipline of all coffee shop staff including stewards and when absent their duties were covered by Management and not by other staff from the coffee shop.

This being the position in respect of these three gentlemen and if the Respondents' submissions were to be accepted, then it appears that there is no employee who would benefit from the classification of room stewards with a scale of pay between Sh. 375 and Sh. 550 except a few dining room stewards. The Court finds that the Respondents were fully aware, as they are very experienced in hotel trade, of the job classifications appearing in the Wages Council Regulation Order of 1963 in respect of Hotel and Catering Trades. In this Order the word "steward" appears only once, as dining room steward capable of taking sole charge of dining room, therefore, the fact that the Parties agreed to a job classification on 1st December 1963, is indicative of the fact that there were some jobs in their hotel which were not provided for in the Wages Council Regulation Order. It is interesting to note that when the 1963 Order was revised in November 1965, there is mention of a head steward capable of taking sole charge of a dining room and a steward who is equated to a head waiter. The Respondents being aware all along of the classifications in the Wages Council Regulation Order made no attempt whatsoever to revise their own job classifications agreed with the Claimants. The Court must, therefore, come to the conclusion that the Parties have voluntarily departed from the classifications in the Wages Council Regulation Order and have agreed to their own job classifications. If Omollo and the other two gentlemen are part of Management, then the question is who are the employees who should fit in the two classifications of dining room stewards and room stewards. The Court finds that the 16 employees involved in this dispute are the ones who should have been classified in these jobs. It should also be noted that the uniforms of the room stewards and the dining room stewards, some of whom are on the scales between Sh. 375 and Sh. 550 are the same and that the coffee shop stewards have a different uniform to indicate that they are in the coffee shop, but who again could be interchanged with the room stewards. Moreover, the Respondents admit that on the terminology adopted in the job classification they would appear to be in the wrong.

The Court having found that these employees are entitled to be classified in the two jobs of dining room stewards and the room stewards, in the scales of pay between Sh. 375 and Sh. 550, is not at all satisfied as to why the Claimants did not take up this matter as far back as December 1963, when the job classifications were agreed to; why have they waited until 17th February 1966, to make a claim in respect of arrears of pay in respect of these employees from 1st May 1965. The Court finds that the Claimants failed to give any satisfactory explanation for this extraordinary state of affairs. To make matters worse the Parties had appeared before the Industrial Court in Cause No. 14 of 1966 and this matter had not been included as an issue in dispute although the Claimants tried to justify the omission that the Parties had not reached a deadlock on this matter at that time. Then there is a further delay because the Parties did not sign the notification of dispute form until 24th February 1967. All these facts lead the Court to only one conclusion and that is, that this matter had been allowed to drag on for such a long time because there was a genuine difference of opinion as to the job classifications of these 16 employees. The Court finds that there was no deliberate attempt by the Respondents to deprive these 16 employees of their agreed rates of pay.

In these circumstances the Court having found that these 16 employees should be classified amongst the dining room stewards and room stewards in the agreed list of job classifications between the Parties, the Court is not prepared to allow the Claimants' claim beyond 1st March 1967, in respect of arrears of pay. The Court, therefore, awards that these 16 employees should get the difference of pay between their rates and Sh. 375 with effect from 1st March 1967.

Kenya Chemical Workers' Union
and

E.A. Match Company Limited

Issues in dispute:—

- (1) Wages Increase.
- (2) Normal Working Hours.
- (3) Annual Paid Leave.
- (4) Uniforms and Overalls.
- (5) Maternity Benefits.
- (6) Leave Allowance.
- (7) Effective Date and Duration of Contract.

1. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and the E.A. Match Company Limited shall hereinafter be referred to as the Respondents.

2. The Parties were heard in Nairobi on the 17th day of July 1967, and relied on their written and verbal submissions.

AWARD

The Court has very carefully considered the arguments and the submissions put forward by the Parties in support of their contentions before making its award.

(1) *Wage Increase.*—As it was conceded by the Respondents that they would be subject to the new statutory minimum wage of Sh. 175 consolidated per month with effect from 1st July 1967, the Court awards an increase of Sh. 25 per month to all employees. This increase is to be inclusive of the increase due under the Regulation of Wages (General) Order 1967, vide Legal Notice No. 139.

(2) *Normal Working Hours.*—Nil award.

(3) *Annual Paid Leave.*—Nil award.

(4) *Uniforms and Overalls.*—The Court awards that in addition to the statutory requirements under the Factories Act, the Respondents should provide appropriate aprons to employees who by nature of their work come into close contact with gum, water, oil or grease or any substance deleterious to the garment or the person. Further the Respondents shall be responsible for laundering such aprons as and when necessary.

(5) *Maternity Leave.*—The Court finds that the arbitrator prior to the Industrial Court proceedings in Cause No. 49 of 1965 had established a reasonable provision in that, female employees benefit by two months' unpaid maternity leave. At the same time they are granted the sick leave entitlement amounting to three weeks on full pay and two weeks on half pay. In view of this the Court can see no reason to vary it.

(6) *Leave Allowance.*—The Court awards a leave allowance of Sh. 50 to be paid to employees when proceeding on annual paid leave.

(7) *Effective Date and Duration of Contract.*—The Court rules that the effective date of this award shall be 1st April 1967, and that it shall remain in force for a period of 18 months from that date.
