LAW EXAMINATION FOR ADMINISTRATIVE OFFICERS

1. It is notified for general information that the next Law Examination for Administrative Officers will be held on the 4th, 5th and 6th of December 1967.

2. The examination will consist of the following two sections, of three and two parts each, respectively:—

Section I

- (i) The Penal Code.
- (ii) The Criminal Procedure Code.
- (iii) Evidence.

Section II

- (i) The Civil Procedure Act and Rules.
- (ii) The Local Acts and Rules.

NOTE

3. The method of examination in the Local Acts and Rules has now been changed, and at the examination in December 1967, and in future examinations, the "Paper on Local Acts" will be designed to test the candidates' ability to search the Laws of Kenya for the answers required. This means that a set or sets of the Laws of Kenya will be supplied in each examination room, and candidates will have access thereto during the examination in the "Local Acts Paper". It should be noted that this is for the Local Acts Paper only. The method of examination in the other four papers of the examination is unchanged.

4. Candidates may appear for both sections or for either section at a time, but must pass each section as a whole to record a pass. Officers who possess a law degree of an accredited university are only required to pass part (ii) of section II.

5. Exemption in any part of the examination may be applied for by those officers who have passed the Kenya Police Law Examination "B" or a comparable examination for administrative officers in another territory.

6. Candidates will be required to pay a fee of KSh. 10 per paper. This fee shall be refundable to Government servants only who attain a 40 per cent mark, and shall not be refundable to those who do not attain this mark, and to non-Government employees.

7. Applications for this examination should be made to the Permanent Secretary, Office of the President, and should be submitted through District Commissioners or Heads of Departments so as to reach him at P.O. Box 30510, Nairobi, not later than Saturday, 1st November 1967. All applications must be accompanied by crossed postal orders or money orders payable to the Permanent Secretary, Office of the President, to cover entrance fees. Late applications and applications not accompanied by the requisite fees will not be acknowledged. Cheques will not be accepted.

The Branch has a staff of about 90 and is responsible for the production and publication of the trade and customs revenue statistics of East Africa. In addition, the officer in charge is also responsible for estimates of revenue for the purpose of tariff changes.

Issue in Dispute:

The status of Mr. Amon Kahiko and Mr. Tirus Mwangi—are they Union members or are they Management staff.

1. Messrs. Zimmermann Limited shall hereinafter be referred to as the Claimants and the Kenya Shoe and Leather Workers' Union shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 9th day of August 1967 and relied on their written and verbal submissions.

AWARD

The Court has very carefully considered the submissions made by the parties and finds that the issue in dispute as framed by them is ambiguous because from the facts which came to light during the hearing, the issue is capable of being answered in the affirmative in both parts that is, that these two employees are Union members and also it can be said that they are Management staff. With due respect to the parties, it is obvious that what they want the Court to decide is whether the two employees at the material time, that is, in June 1967 when there was a strike, were part of the Management, because it is accepted by the Claimants that, under the freedom of association guaranteed by the Constitution of the country any worker even if he is part of the Management can exercise his right and belong to a Union. It is a different matter that the carrying of a Union card might be incompatible with the managerial status and that such worker might find himself facing a conflict of loyalties, but the Court is not being asked to decide whether the Union membership of these two employees is advisable or not.

The Court is merely being asked to find out what position these two employees held in June 1967. The Respondents have submitted that, promotions of these two men to the supervisory level were never conveyed to them by the Claimants as required of them, but the Court has not been able to find either in the recognition agreement or in the terms and conditions of service agreement which was in force at the material time, any provision requiring the Claimants to do so.

The Court, therefore, finds that the Claimants were not obliged to inform the Respondents of the promotions of these two employees. Furthermore, in the agreement covering wages and terms and conditions of service agreement, the jobs being performed by these two employees are not mentioned in Appendix 1 which contains the various job categories in respect of which the agreement had been negotiated by the Respondents. This again leads the Court to the conclusion that it was understood by the parties that these two employees could not be represented by the Respondents. In addition to this, as far back as 1964, the employee, Mr. Amon Kahiko, had accepted his status as part of the Management and had requested his withdrawal from the Union membership. Obviously subsequent to this he joined the Respondents again but his membership of the Union is not material. The fact remains that even in

May 1967 he was warned, although wrongly, that he could not belong to the Union. The inference, of course, being that he was part of the Management.

The Court has failed to find any satisfactory reason as to why the Respondents did not repudiate or challenge the inclusion of these two employees in the list of supervisors published on 13th May 1967 and which they admit they had received. It was a simple matter for their General Secretary to write a letter to the Claimants on this point and the Court cannot accept the explanation given by the Respondents that, as they were involved in a strike, they had no time to do this. For the foregoing reasons the Court finds that it is clearly proved that these two employees although members of the Respondents could not be represented by them as they were part of the Management at the material time, that is, in June 1967.

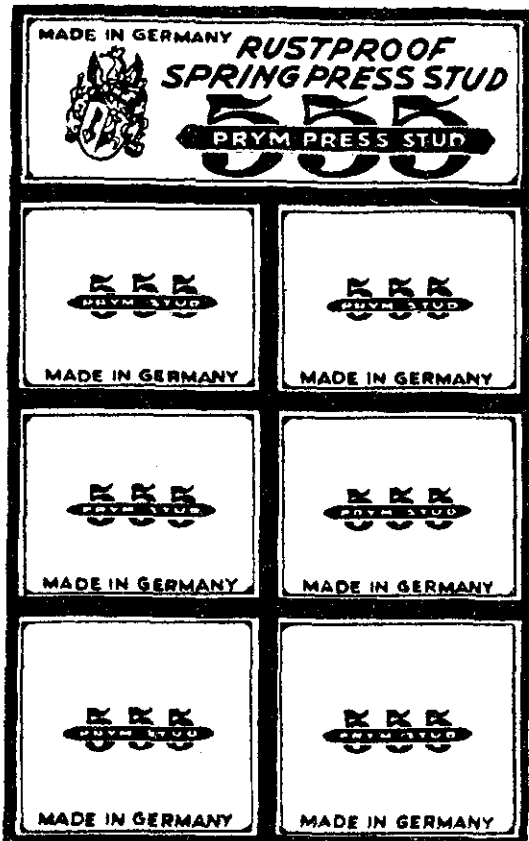
