Notice of Application for a Licence to Operate Air Services

PURSUANT to the provisions of regulations 6 and 7 of the East African Licensing of Air Services Regulations 1965, notice is hereby given that Kenya Air Charters Ltd., P.O. Box 30603, Nairobi, has applied to the East African Civil Aviation Board for a licence to operate the following air service:—

Air charter and aerial work, including cabotage within Tanzania, Uganda and Kenya, based in Nairobi and Arusha with two Cessna 401, one Cessna 205 and one Piper Twin Comanche (24 passenger seats) for a period of three years.

- 3. I have not seen certified statements from the Coast and Nyanza Provinces for the receipts of K£1,635-11-85 and K£81-3-60 included in the amount of K£7,208-17-90 shown against the item "Provinces-Collections (Notional)".
- 4. With reference to paragraph 3 of my Report for 1966, I have still not seen the relevent certificate for balance held in the Eastern-Province.
