#### THE TRADE DISPUTES ACT 1965

ORDER UNDER SECTION 36-COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 36 of the Trade Disputes Act 1965, the Minister for Labour hereby orders every employer who employs not less than five members of the Printing and Kindred Trades Workers' Union of Kenya to—

- (a) deduct every month Sh. 4 (four) in respect of trade union dues from the wages of each of his employees who is a member of that trade union;
- (b) pay 85 per cent of the total sums so deducted in any month, not later than the 3rd day from the date on which such wages were paid, by crossed cheque made payable into the account of the Printing and Kindred Trades Workers' Union of Kenya at the Barclays Bank Ltd., Queensway Branch, Nairobi;
- (c) pay 15 per cent of the total sums so deducted in any month, not later than the 3rd day from the date on which such wages were paid, by crossed cheque made payable into the account of the Central Organization of Trade Unions (Kenya) Account No. 140793-7 at the Barclays Bank, Queensway Branch, P.O. Box 30011, Nairobi;
- (d) notify in writing that trade union and that federation before the end of each month of the amounts of any payment made to the accounts of that trade union and of that federation in that month;
- (e) notify in writing the Registrar of Trade Unions before the end of each month of the amounts of any payments made into the accounts of that trade union and of that federation in that month.

In exercise of the powers conferred by section 36 (2) of the Trade Disputes Act, Gazette Notice No. 1477 of 12th April 1967, is varied accordingly.

#### THE INDUSTRIAL COURT

- 1. The Kenya Motor Engineering and Allied Workers' Union shall hereinafter be referred to as the Claimants and Regal Garage (1965) shall hereinafter be referred to as the Respondents.
- 2. The Parties were heard in Nairobi on the 23rd day of October 1967, and relied on their written and verbal submissions

#### AWARD

After a careful consideration of all the submissions made by the Parties the Court awards that all unionizable employees should get an increase of Sh. 20 per month with effect from 1st November 1967, except the two employees Mromegi Kimani who shall get an increase of Sh. 25 per month and Nguli Kioko who shall get an increase of Sh. 30 per month. This award shall remain in force up to 31st December 1968.

In making this award the Court was greatly influenced by the fact that the Respondents had with effect from 1st January 1967, granted increments to most of their employees varying between Sh. 10 and Sh. 20. For these reasons the Court was not inclined to award any backdating.

The Court would like to state that the Claimants are moving in the right direction in trying to secure better terms and conditions of service from this type and size of business in the motor industry as the major firms have with some justification pleaded that, they have to compete with these small firms as a result of which they lose a considerable amount of their business.

## THE INDUSTRIAL COURT

Cause No. 38 of 1967

Parties:-

Kenya Union of Sugar Plantation Workers

and

Madhvani Sugar Works Limited

Issue in dispute:-

The implementation of the agreement negotiated between the Kenya Union of Sugar Plantation Workers and the Kenya Sugar Employers Union (Nyanza) in the matter of wages and other terms and conditions of service.

- 1. The Kenya Union of Sugar Plantation Workers shall hereinafter be referred to as the Claimants and Madhvani Sugar Works Limited shall hereinafter be referred to as the Respondents.
- 2. The Parties were heard in Mombasa on the 16th day of October 1967, and relied on their written and verbal submissions. The Respondents called one witness Mr. E. M. Johnson a qualified agronomist with a long background and experience in sugar industry in West Indies and two years in Kenya. This witness is employed by Projects Developments Limited who are consultants in Sugar Industry.

The members of the Court visited the Respondents' sugar estate at Ramisi on the 17th of October 1967, and saw the various sugar-cane fields and the living conditions of the workers. The representatives of both Parties accompanied the Court members on this visit.

## AWARD

In Cause No. 60 of 1965 (between the same Parties) the Court had made the following award:—

"The Court awards that all the issues in dispute shall be incorporated in an agreement, to be drawn up and signed by the Parties hereto, within 14 days of the publishing of the Award provided that none of the benefits on these issues are less favourable than those found in the 'Nyanza Agreement'.

This new agreement shall be effective from 1st March 1966, and shall come to an end when the 'Nyanza Agreement' ends or is terminated by the Parties; the Court has taken this step in order to achieve uniformity on Terms and Conditions of Service within the Sugar Industry in Kenya."

The Court notes that the Respondents have not joined the Kenya Sugar Employers Union although it would have been to their interest to have joined the group. In ordering the Nyanza rates for the Respondents' employees the Court had stated that this step had been taken to achieve uniformity on Terms and Conditions of Service within the Sugar Industry in Kenya.

In previous proceedings the Respondents had not advanced the arguments which they produced this time and had merely asked for a breathing space on the ground that they had taken over a very poorly run and unproductive estate.

After a careful examination of all the arguments and the evidence produced the Court finds that it would not be appropriate at such an early stage of redevelopment at Ramisi to approve a "differential" with the Nyanza estates. The estate at Ramisi had suffered severely due to bad management and poor husbandry in the past. And while the Court acknowledges the good work that has been done and is being done by the Respondents, the Court feels that enough has not yet been done to establish that the low yield at the Coast will be permanent.

The Court must express appreciation at the way the Respondents have stepped up development at Ramisi by bringing a larger acreage under cultivation, by cleaning up the estate, by increasing employment and by improved production. This has no doubt involved heavy capital investment. The Court has taken into consideration all these points in arriving at its findings. The Court has decided to award the benefits of the Nyanza Agreement to the Respondents' employees. But as the Court finds that the current Nyanza Agreement is a very unsatisfactory document and leaves much room for improvement, it is not inclined to award the same in the current dispute. The Court directs the Parties to draw up a proper agreement incorporating all the wages, terms and conditions of service as applicable in Nyanza so that the defects and anomalies that exist in the Nyanza Agreement can be rectified.

The Court wishes to stress that it is provided in the Nyanza Agreement that the workers, particularly cane cutters, should complete the tasks laid down therein and the Ramisi workers should understand it clearly. The Claimants have promised full co-operation to the Respondents in trying to improve the productivity of the estate and it is to be hoped that they will ensure that their members should cut the same quantity of cane as the Nyanza workers since they are going to enjoy the Nyanza rates. The Parties should immediately work out the system of assessing the amount of cane cut on a weight basis.

The Court rules that its award bringing up the Respondents' rates to the level of the Nyanza Agreement should be with effect from 1st September 1967, and should terminate when the Nyanza Agreement comes to an end.
