#### THE MINING ACT

(Cap. 306)

EXCLUSION OF LAND FROM PROSPECTING AND MINING

NOTICE is hereby given that in exercise of the powers conferred by section 7 (1) (i) of the Mining Act, the Commissioner of Mines and Geology hereby declares the area described in the Schedule hereto to be excluded from prospecting and mining, provided that the exclusion hereby effected shall not extend to any part of the said area in respect of which any prospecting or mining rights shall have been granted before the 25th day of July 1968, so long as such rights shall continue to subsist, by renewal or otherwise.

thence following the international boundary between Kenya and Somalia first in a generally south-westerly direction and then in a generally southerly direction for a distance of approximately 83 miles to a point (Long. 41° 08' 07", Lat. 58' 02");

thence on a true bearing of 270° for a distance of approximately 20 miles to a point (Long. 40° 50′ 00″, Lat. 58' 02");

thence on a true bearing of 180° for a distance of approximately 17 miles to a point (Long. 40° 50′ 00″, Lat. 2° 57′ 58″);

thence on a true bearing of 90° for a distance of approximately 11 miles to a point on the international boundary between Kenya and Somalia;

thence following the international boundary between Kenya and Somalia in a generally southerly direction for a distance of approximately 27 miles to a point (Long. 40° 59′ 35″, Lat. 2° 20′ 25");

thence on a true bearing of 245½° for a distance of approximately 75 miles to El Nur water hole; thence on a true bearing of 324½° for a distance of approximately 85 miles to Lensayu water hole; thence on a true bearing of 202½° for a distance of

approximately 58 miles to Arba Jahan; thence on a true bearing of 328½° for a distance of approximately 130 miles to the point of commencement.

KAIGATI TOWNSHIP: SETTLEMENT SCHEME No. 43

THE Acting Commissioner of Lands on behalf of the Settlement Fund Trustees, gives notice that the plots in Kaigati Township as described in the Schedule appended hereto are available for alienation and applications are invited for the direct grants thereof.

- 2. A plan of the plots may be seen at the offices of the District Commissioner and the Local Settlement Officer.
- 3. Applications should be submitted to the Commissioner of Lands through the District Commissioner and not direct so as to reach the District Commissioner not later than 15th October
- 4. Applicants must enclose with their applications the sum of Sh. 200 as a deposit, which will be dealt with as follows:-
  - (a) If the applicant is offered and takes up and pays for a plot within a period of 30 days as required in para-graph 5 below the deposit will be credited to him.
  - (b) If the application is unsuccessful the applicant's deposit will be refunded to him.
  - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 30 days as required in paragraph 5, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

5. Each allottee of a plot shall pay to the Commissioner of Lands within 30 days of the notification that his application has been approved, the assessed stand premium and proportion of annual rent together with survey fees also the fees payable in respect of preparation and registration of the grant and stamp duty assessed at 2 per cent of the stand premium and annual rent, in default of payment of which within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot

#### General Conditions

The ordinary conditions applicable to township grants of this nature as varied hereby shall apply to the grants:—

- (a) The grants shall be made initially for a term of 33 years convertible to 99 years in due course in cases where development has taken place to the required standard as shown in (b) below.
- (b) The grantee will be required to erect within six months of the commencement of the lease buildings in traditional style in accordance with plans previously approved in writing by the Local District Council and the Commissioner of Lands. Should the buildings be of permanent materials and of an approved design and erected within two years of the commencement of the lease to the satisfaction of the authority concerned, the term of the lease, may, on application made prior to the expiry of the 33-year lease be extended to 99 years at such rental and condition as may then be prescribed.
- (c) The grantee shall maintain in good and substantial repair all buildings at any time erected on the land.
- (d) To provide on the land to the satisfaction of the local authority, a proper system for the disposal of sewage and sullage water.
- (e) The grantee shall erect a fence or plant a hedge on the boundaries of the land other than the frontage and shall keep such fence or hedge in good repair.
- (f) The grantee shall use the land for the purpose of business (excluding the sale of petrol except where specifically permitted) and residence and shall not indulge in any trade or business which the Commissioner of Lands considers dangerous or offensive.
- (g) The grantee shall not transfer, charge or part with the possession of the land without the previous written consent of the Commissioner of Lands.
- (h) The Commissioner of Lands or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether over-head or underground and the grantee shall not erect any buildings in such a way as to cover or interfere with any existing alignments of such installations.
- (i) The grantee will be required to pay such rates, taxes, charges, duties, assessments or outgoings of whatever descriptions as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon including any contributions or other sums paid in lieu thereof.

### THE REGISTERED LAND ACT

(Cap. 300)

MURANG'A COUNTY—ALIENATION OF PETROL SERVICE STATION SITES

- 1. The County Council of Murang'a gives notice that plots as described in the Schedule hereto are available for alienation and applications are invited for the direct grant of the individual plots.
- 2. Plans of the plots may be seen at County Offices at Murang'a.
- 3. Applications should be submitted to the Clerk to the Council, P.O. Box 52, Fort Hall, so as to reach him not later than noon on 2nd September 1968.
- 4. Each applicant must enclose with his application a cheque for Sh. 1,000 as a deposit, drawn on the applicant's own banking account (no other cheques will be accepted) made payable to the Clerk to the Council, Murang'a which will be dealt with as follows:—
  - (a) If the applicant is offered and takes up and pays for the plot within a period of 14 days as required in paragraph 5 below, the deposit will be credited to him.
  - (b) If the application is unsuccessful, the applicant's deposit will be refunded to him.
  - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in the following paragraph, the Clerk to the Council may declare the deposit forfeited and the applicant shall have no further claim thereto.
- 5. The allottee of the plot will pay to the Clerk to the Council within 14 days of notification that his application has been approved the assessed stand premium and proportion of annual rent together with the fees payable in respect of the preparation and registration of the lease (Sh. 35). In default of payment within the specified period, the Clerk to the Council may cancel the allocation and the applicant shall have no further claim to the grant of the plot.
- Applicants other than recognized Oil Companies should forward documentary evidence to indicate the source of petroleum products.

#### General Conditions

- 1. The ordinary conditions applicable to grants of this nature, except as varied, shall apply to this grant.
- 2. The term of the grant will be 33 years from the first day of the month following the notification of the approval of the grant.

#### Special Conditions

- 1. The lessee shall complete the erection of approved buildings on the land within 24 months of the commencement of the term.
- 2. The erection of buildings shall not be commenced until plans (including block plans showing the positions of the buildings and a system of drainage for disposing of sewage, surface and sullage water), drawings, elevations and specifications thereof have been approved in writing by the lessor and by any authority whose approval is required by law. Such plans, drawings, elevations and specifications shall be submitted for approval in duplicate.
- 3. The lessee shall maintain the buildings and the drainage system in good repair and condition to the satisfaction of the lessor.
- 4. No additions shall be made to the approved buildings without the prior consent in writing of the lessor.
- 5. The land shall only be used for a petrol service station and the lessee shall, throughout the term and to the satisfaction of the lessor, make substantial use of the land for such purposes.
- 6. The land shall not be used in any manner which the lessor considers to be dangerous or offensive to the public or the neighbourhood.
  - 7. The land shall not be subdivided.
- 8. The land shall not be charged, sublet or subleased or transferred without the prior consent of the lessor in writing. No application for such consent (except in respect of a loan required for building purposes) will be considered until Special Condition No. 1 has been performed.
- 9. The lessee shall pay all sums that may from time to time be demanded by the lessor in respect of the cost of construction, maintaining, repairing, improving and renewing all roads, drains and sewers serving or adjoining the land.

2. The parties were heard in Nairobi on the 2nd day of July 1968, and relied on their written and verbal submissions.

#### AWARD

In this dispute the first six issues arise out of the Claimants' demands and the remaining two result from the Respondents' demand for reducing the benefits being enjoyed by the workers at present under these items.

During the hearing it became apparent that no discussions had During the hearing it became apparent that no discussions had taken place on the fringe benefits as only the issue of wages was discussed at the two meetings held between the Parties after the Claimants had submitted their demands. The Court is satisfied that the present level of the various fringe benefits is reasonable and should not be disturbed. By far the most important issue in this dispute is the one relating to wages. Since 1965 when the Industrial Court made an award on wages and other items between the same Parties in Cause No. 34 of 1965, the wages have gone up as follows: have gone up as follows:-

- (a) From 1st September 1965, for a period of 12 months the workers received on an average an increase of Sh. 40 per month as a result of the aforesaid award in Cause No. 34
- (b) As from 1st September 1966, the Parties themselves freely negotiated a wage increase of Sh. 25 per month for all Unionizable employees for a period of 18 months, i.e. until 1st March 1968.

It is clear from this that the workers have received reasonable increases since September 1965. 




