*Accounts Controller, Ministry of Lands and Settlement*  
(No. 281/68)

*Salary.*—£2,175 fixed. AGREEMENT ONLY.

Applicants should have extensive practical experience at a senior level of financial operations preferably in Government with particular reference to accounting for grants and loans received for Development Schemes. They must have held a responsible position not below that of a Chief Accountant either in a Government institution, or of a comparable status in a large commercial concern. Knowledge of the principles of quasi-government and commercial accounting together with experience of land and/or agricultural finance would be advantageous. The successful candidate will be responsible to the Financial Controller for accounting control of the Agricultural Settlement Fund and will be required to act as Financial Controller when need arises.

*Assistant Controller of Apprenticeship and Trade Testing,*  
*Ministry of Labour* (No. 282/68)

*Salary scale.*—£810 to £1,710. PENSIONABLE or AGREEMENT.

Applicants should preferably possess a degree in Civil, Mechanical or Electrical Engineering, or an equivalent professional qualification, and should have had industrial experience of at least two years after graduation. Consideration may also be given to candidates without an Engineering degree provided they have graduated in a scientific discipline and have appropriate industrial experience. Duties of the post include assisting the Controller of Apprenticeship and Trade Testing in the administration of the Industrial Training Act, supervision of vocational training and trade testing at the National Industrial Vocational Training Centre, and supervision of and advice on training schemes operated by private employers. The successful candidate will be required to spend some months abroad on a training fellowship sponsored by the International Labour Organization.

*Commandant (Woman), The National Youth Service, Ministry of Labour* (No. 283/68)

*Salary scale.*—£1,104 to 1,356. AGREEMENT only.

Applicants should be women of mature age, of School Certificate standard of education and without family responsibilities. The successful candidate will be stationed at the Naivasha Women's Training Unit, over which she will exercise direct command. She will also have general responsibility for girls attached to other Units for the Service, and will be the Directors' advisor on matters affecting women enrollees. Designing and supervising the training programme constitutes an important part of her duties and previous experience of training of young women would be an advantage. She must be a capable administrator, able to supervise such matters as stores, transport and accounts, conduct correspondence, and to carry out disciplinary inquiries under the National Youth Service Act and Regulations. She must also possess the initiative to take on-the-spot decisions, and be able to exercise control over both staff and servicewomen.

*Tea Officer, Ministry of Agriculture* (No. 284/68)

*Salary scale.*—£1,104 to £1,356. AGREEMENT only.

Applicants should preferably have either a degree in Agriculture or a Diploma in Agriculture and practical experience of tea growing, or considerable period of service in a tea growing district. As the post requires considerable administrative ability, applicants should have sound experience of agricultural administration and should be able to speak Swahili fluently.

*Senior Inspector of Apprenticeship and Trade Testing, Ministry of Labour* (No. 285/68)

Applicants must be civil servants with at least five years' experience in practical trade testing in accordance with nationally accepted standards. Duties include supervising the work of

officers engaged in trade testing at the National Industrial Vocational Training Centre, in addition to trade testing in the field in which he is particularly competent.

*Inspector of Apprenticeship and Trade Testing, Ministry of Labour* (No. 286/68)

*Salary scale.*—£858 to £1,068. PENSIONABLE or AGREEMENT.

Applicants should have a good standard of education, be fluent in English and able to draft reports. They should have undergone apprenticeship or similar training of a recognized nature and hold a Kenya Government Grade I Trade Test Certificate as a Mason (Building and Stone Dressing) and have also acquired at least five years' experience in masonry, plastering and bricklaying subsequent to passing the Grade I Trade Test. They should have held a supervisory appointment in the construction or building industry. Possession of a relevant City and Guilds Certificate would be an advantage. Duties include instructing and trade testing employees in building trades at the National Industrial Vocational Training Centre in Nairobi and at out-stations as and when necessary, and also inspecting training schemes operated by private employers under the Industrial Training Act, and giving advice to such employers. The successful candidate will be required to spend some months abroad on a training fellowship sponsored by the International Labour Organization.

*Purchasing Officer, Ministry of Works* (No. 287/68)

*Salary scale.*—£858 to £1,068. PENSIONABLE or AGREEMENT.

Applicants should possess a B.Com. or similar degree of an approved University. Non-graduates who have gained relevant experience in an executive capacity in a large supplies organization, especially in Government, and who have a sound knowledge of general supplies and are conversant with the law governing contracts and purchasing will be considered.

*Executive Officer Grade II (Five Posts)—Available as shown Below* (No. 288/68)

*Salary scale.*—£858 to £1,068. PENSIONABLE or AGREEMENT.

*Ministry of Co-operatives and Social Services (One Post):*

Applicants must be civil servants of Cambridge School Certificate standard of education with considerable experience of Government office routine. They must have served for not less than one year at the level of Executive Officer Grade III. Successful completion of a course in Office Management or Accounts will be an advantage, and ability to conduct correspondence and control staff is essential. The successful candidate will be required to control the Department's Registry, Votes, Stores, Vehicles, and ensure the efficient routine administration of Head Office.

*Ministry of Commerce and Industry (One Post):*

Applicants should preferably possess a degree of an approved University, but candidates with a minimum qualification of Cambridge School Certificate Division II or the equivalent and who have had at least three years' experience in a responsible administrative or executive capacity may apply. Duties include dealing with advocates and advising the public on matters connected with the Rent Control Act. Duties entail the enforcement of labour laws and inspection of places of employment, industrial relations work, settlement of disputes and prosecutions.

**Salary scale.**—£678 to £828. PENSIONABLE or AGREEMENT.

Applicants should be of Cambridge School Certificate standard of education with at least three years' suitable experience since leaving school. Knowledge of Industrial Relations work or practical experience in general labour matters will be an advantage. Duties are to assist in Industrial Relations work, particularly with the Trade Union Movement.

**Executive Officer Grade III (Six Posts):** *One Post, Ministry of Economic Planning and Development; Two Posts, Ministry of Labour—One in the Kenyanization of Personnel Bureau; Two Posts, Ministry of Tourism and Wildlife—One in the Fisheries Department, One in the Game Department (No. 291/68)*

## Issue in Dispute:

Interpretation of gratuity clause.

1. The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the Kisumu Distributive Employers' Association shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 19th day of August 1968 and relied on their written and verbal submissions.

## AWARD

The parties in this dispute had appeared before the Industrial Court in Cause No. 9 of 1966 when the only issue in dispute was wages, the effective date having been agreed between the Parties to be 1st February 1966 with a duration period of 12 months.

Prior to the reference of the said dispute to the Court, the parties had reached agreement through conciliation on the other unresolved items at that time namely, annual leave, leave travel allowance, severance pay and maternity leave.

The only documentary evidence produced before the Court during the hearing of the present dispute was a copy of a document headed "Conciliation Between the Kenya Union of Commercial Food and Allied Workers and Distributive Employers' Association, Kisumu" and signed by the conciliator and the representatives of the Claimants and the Respondents.

In this document the following is recorded under the heading "Severance Pay":—

Agreed: 1-5 years, 7 days' pay for each completed year of service.

6-10 years, 10 days' pay for each completed year of service.

Over 10 years, 15 days' pay for each completed year of service."

Normally the parties draw up a formal agreement regulating terms and conditions of service after outstanding matters have been resolved either through conciliation or an award of the Industrial Court. In the present case this was not done and the Court had to rely on the document mentioned hereinbefore. The parties called no witnesses in support of their submissions.

Surprisingly although there is no reference anywhere during conciliation to "gratuity" the issue in dispute is "interpretation of the gratuity clause". During the hearing it became abundantly clear that what was causing the difficulty was the benefit under the heading "Severance Pay".

Apparently the termination of the services of one Mr. Thomas Ojinya by Mr. Patel, the Respondents' Secretary, led to the present dispute. The Claimants claimed severance pay on his behalf for the entire period of his service, while Mr. Patel paid him something calculated at the rate provided under the severance pay clause for service with effect from 1st February 1966. It was submitted by the Respondents during the hearing that what Mr. Patel paid was in fact, a terminal benefit and not severance pay.

The Court found itself in considerable difficulty in this dispute due to very inadequate evidence tendered by either party. However, after a careful consideration of all the submissions the Court has come to the conclusion that when the parties negotiated and reached agreement during conciliation on the issue of "severance pay" they were fully aware that it related to severance pay on redundancy. They did not approach this item as a terminal benefit. The Industrial Court has always considered severance pay in the context of redundancy. It is also a practice in this country to call a normal terminal benefit as "Gratuity". The Claimants are well aware of this as they have appeared before the Industrial Court on these matters in several disputes.

The Court would like to draw the parties' attention to the Industrial Court Cause No. 8 of 1967—Kenya Union of Commercial Food and Allied Workers and the Kenya Bankers' (Employers) Association in which the Court stated that redundancy is understood to mean, and means the involuntary loss of employment through no fault of the employee caused either by an excess of manpower or by the financial inability on the part of the employers to continue paying salaries.

As far as the question of the time from which the employee's service is to be taken into consideration for this benefit is concerned, the Court finds that in the absence of an express clause to the effect that an employee's service was to be taken with effect from 1st February 1966, the intention of the parties was that a redundant employee should be paid severance pay for all his service, i.e. from the date of engagement. If the intention had been otherwise it is such an important matter that it would have been recorded in writing, as no prudent employer could make such an omission if, in fact, it had been so agreed.
