Architectural Assistant (Buildings Branch) (Sixteen Posts) (No. 96/71)

Applicants should preferably be of Secondary School standard, and must have had a minimum of four years' experience as Draughtsmen in an Architect's office; or must have passed the Building Technicians examination of the East African Institute of Architects or its equivalent. THE INDUSTRIAL COURT

CAUSE NO. 2 OF 1971

Parties:—

Kenya Chemical Workers' Union
and
Carbacid (1961) Ltd.

Issues in dispute:—

1. Wages and salaries.
2. Extended annual paid leave.
3. Injury by accident.
4. Gratuity or service benefits.
5. Hours of work for watchmen/askaris.
6. Redundancy problems.
7. Effective date and duration of agreement.

1. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and Carbacid (1961) Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 19th day of February 1971 and relied on their written and verbal submissions.

AWARD

3. On 7th December 1962, the parties entered into an agreement setting out the terms and conditions of employment of the Respondents' employees. Amongst the various items, they agreed to the following grades and the consolidated minimum rates of pay in respect of the said grades:

| III | 155 | 200 |
| IV | 134 | 179 |

This agreement continued in force until it was amended in certain respects on 31st May 1967, with the assistance of a conciliator appointed by the Ministry of Labour. The Court cannot accept the Respondents' submission that the conciliated agreement of 31st May 1967, entirely replaced the 1962 Agreement. The Court finds that the 1962 Agreement continues in force as amended by the 31st May 1967 Agreement. The clause covering wages in this Agreement is as follows:—

"(a) Every employee shall receive a general wage increment of Sh. 30 p.m. on top of the existing wages for the period of 1st April 1967 and 31st March 1968.

(b) Every employee shall receive a further wage increment of Sh. 25 p.m. on top of the existing rates for the period of 1st April 1968 and 31st March 1969."

This agreement was to remain in force until 31st March 1969, and the Claimants forwarded to the Respondents their revised demands on 27th November 1968. The first meeting to discuss these demands, however, did not take place until 10th April 1969. After that, meetings took place on 21st April, 12th May, 16th May, 12th September and 7th October 1969. The Claimants reported a trade dispute to the Ministry of Labour on 10th October 1969, on certain items which had not been settled.

The Court is satisfied, after having gone through the documentary evidence, that the delay between 27th November till 10th April is attributable to the Respondents and between 16th May to 12th September the delay occurred because the Claimants had sought in negotiations a revision of job grading.

The Ministry of Labour appointed a conciliator on 30th October 1969, but the conciliator did not hold the first meeting until 21st April 1970, on which day the Claimants failed to make an appearance with the result that no meeting was held. After that there was another lapse on the part of the conciliator in that he did not call a meeting until 24th November 1970. At this meeting a deadlock was recorded on certain items and it was decided that the dispute should be forwarded to the Industrial Court. Although the Claimants signed the Notification of Dispute Form "A" on 21st December 1970, the Respondents did not sign it until 5th January 1971, because there was some disagreement on the issue of working hours.

The Court finds the delay at the hands of the conciliator as most unfortunate. The Court has on previous occasions expressed its concern over such delays and would once again draw the Ministry's attention to this sorry state of affairs.

Now coming to the issues in dispute, the Claimants stated that some employers, like the Respondents, were not concerned at all with the requirements of the workers' families and submitted that the workers were very poorly paid with the result that they could not meet the basic necessities of life. The Claimants added that the fact that the Government allowed other products in the country in competition with the Respondents' product was not their concern as the matter was beyond their control. They asked why should the salaries of unionizable employees be controlled and the non-unionizable employees should continue to get big salary increases. The Claimants requested the Court to eliminate the differentials between Nairobi and Esageri and

to award a 15 per cent wage increase on the current wages of the workers. They pointed out that originally they had demanded the following rates for the four grades:—

| Grade | Sh. p.m. |

| II | 550 |
| III | 480 |
| IV | 400 |

The Respondents on the other hand strongly argued against elimination of differentials which had been brought about with mutual consent based on geographical reasons. They stated that these differentials could not be eliminated overnight. They submitted that they employed 25 male persons including those engaged under Tripartite Agreement. Had it not been for the Tripartite Agreement, the new facilities in Nairobi would have allowed the Respondents to reduce the number of staff required for operations. This factor has not been used by the Respondents as a weapon in negotiation, nor have they made a major issue out of the fact that nearly 20 per cent of the company's sales were removed in mid-1970 when Uganda began producing its own CO₂. Representations were made to the Government as Kenya's product is essentially a local product and involves no outside raw materials other than perhaps electricity, which in itself is drawn from Uganda. The CO₂ currently used by Uganda is manufactured from imported chemicals involving the use of valuable foreign exchange. It is also relevant that the cost per kilo to the major bottlers and brewers in Uganda for their own product is materially more than that paid for Kenya's product, which is delivered in Kampala having travelled across the border.

The Court notes that the Claimants have argued that the four grades as laid down in the 1962 Agreement were increased in 1967 first by Sh. 30 and then by Sh. 25 and maintained that the current wage rates were as follows:—

| Grade | Esageri Sh. | Nairobi and Mombasa Sh. |

| III | 210 | 255 |
| IV | 189 | 234 |

The Respondents strongly challenged this and submitted that as far as they were concerned the wage rates had remained same as in the 1962 Agreement and that the 1967 Agreement had provided for a general wage increase to all workers. Relying on this, they had offered, prior to the proceedings, a Sh. 10 increase in respect of the grades and Sh. 5 wage increase for all workers and asked the Court to endorse it.

The Court finds this state of affairs most unsatisfactory and has decided to rule that, since all the employees in various grades after the 1967 wage increase are drawing the same wage, these should reflect the current rates for the four grades. After a careful consideration of all the submissions the Court awards the following new rates for the four grades:—

| Grade | Nairobi Sh. | Esageri Sh. |
|-------|----------------|----------------|
| I | 410 | 375 |
| II | 360 | 325 |
| III | 275 | 240 |
| IV | 254 | 219 |

The Court further rules that after one year the Nairobi rates should be increased by another Sh. 20 and the Esageri rates by Sh. 30.

Extended annual paid leave.—Nil award.

Injury by accident.—Since the Court has ruled that the 1962 Agreement as amended by the 1967 Agreement continues in force, the provisions of the 1962 Agreement covering this item are binding.

Gratuity or service benefits.—The 1967 Agreement provided as follows:—

"Gratuity payment shall be as follows:—

- (a) In the case of subscribers to the Post Office Provident Fund Scheme: half a month's pay for each completed year of service from 1961 until the commencement of the Post Office Provident Fund Scheme.
- (b) In the case of non-subscribers to the Post Office Provident Fund Scheme: half a month's pay for each completed year of service from 1961 until the commencement of the National Social Security Fund Scheme.
- (c) The money due to an employee under either para. (a) or para. (b) shall be held in a fund and paid to the employee when his services are terminated.
- (d) Gratuity will end with the introduction of the National Social Security Fund."

The Court can see no reason to vary this and therefore rejects the Claimants' demands on this item.

Hours of work for watchmen/askaris.—This is a demand which the Respondents have made requiring that the watchmen should work 72 hours per week and not be subject to the working hours of 42½ hours per week as the other workers. The

Court has very carefully considered this matter but has decided to leave the number of hours for watchmen as they are at present. The Court feels that if the Respondents had felt strongly on this matter then they should have raised it before signing the 1967 conciliated agreement.

Redundancy problems.—The Court awards that in the event of redundancy, the following principles shall apply:—

- (a) The Union shall be informed by the employer the reasons for and the extent of intended redundancy.
- (b) The principle shall be adopted of "last in first out" in the particular category of employees affected subject to all other factors such as skill, relative merit, ability and reliability being equal.
- (c) The redundant employee will be entitled to the appropriate period of notice or pay in lieu.
- (d) The redundant employee shall be entitled to severance pay on the basis of 14 days' pay for each completed year of service.

Effective date and duration of agreement.—The Court awards that the effective date should be 1st July 1970, and the agreement should remain in force for a period of two years.

THE INDUSTRIAL COURT CAUSE No. 39 OF 1970

Parties:—

Domestic and Hotel Workers' Union
and
Kenya Association of Hotelkeepers and Caterers

Issue in dispute:—

To seek Industrial Court wording of clause 17 of the Recognition Agreement.

1. The Domestic and Hotel Workers' Union shall hereinafter be referred to as the Claimants and the Kenya Association of Hotelkeepers and Caterers shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 14th day of January and 10th day of February 1971 and relied on their written and verbal submissions.

AWARD

3. This dispute has arisen from the parties' efforts to amend the Recognition Agreement which they had entered into in 1968 for the better conduct of their joint affairs. Clause 17 of the 1962 Agreement reads as follows:—

"The Union agrees that the hotel industry, as represented by the Association, will not be affected by internal disputes within other spheres of the Union's activities (bakeries, schools, private hospitals and domestic workers)."

Negotiations for the revision of the Recognition Agreement have proceeded satisfactorily and there now remains only one final area of disagreement before a document can be drawn.

On 15th August 1970, the Claimants' Secretary-General wrote a letter to the Secretary of the Respondents and in that letter, para. 1 reads as follows:—

"On our position, we are prepared the wording to remain as it is, but the matter to be taken to arbitration and if award is awarded, therefore be incorporated in the Agreement."

The Respondents maintained that this clearly proved that only the wording of clause 17 of the 1962 Agreement was to be changed and that the principle laid down in clause 17 of the 1962 Agreement was to stand unaltered. The Court has carefully considered this submission but has come to the conclusion that although this paragraph is very badly worded and makes no sense, however, after a careful consideration of all the surrounding circumstances leading up to this dispute, there is only one conclusion that can be drawn from it and that is that the Claimants want to preserve the right of calling their entire membership out on strike in the event of there being a dispute in any one section of their industry.

The Respondents submitted that in their view, it is fundamentally wrong for the hotel trade to be used as a weapon in any minor dispute that the Claimants may have in Kenya. They used the word "minor" advisedly as the Claimants' principal membership and principal influence is confined within the Respondent Association. Were the position to be reversed, there might be some logic in the Claimants' objection based on their reference to "collective strength". Whilst the Respondents are fundamentally concerned with the affairs of the Association members, Kenya's national interest cannot be disregarded. The

membership list shows that Kenya's tourist trade depends almost totally on accommodation and facilities offered by Association members and to use this situation as a lever against some small institution or establishment in trade in Kenya would be quite improper. Only small establishments and small institutions remain unorganized in Kenya today and are not amenable to advice and assistance from the Federation of Kenya Employers. All other institutions and establishments of any note are organized and are therefore committed to the settlement of disputes through the Trade Disputes Act and the Industrial Court.

In addition to the aforesaid, the Respondents asked the Court to find that the Claimants had suffered no hardship in running their affairs since the 1962 Agreement and the provisions of clause 17 quoted hereinabove. The Respondents stated that there was no justification for altering the existing arrangement on merely hypothetical grounds. They produced to the Court various agreements and books in support of their submissions.

The Claimants strongly submitted that it was vital for their existence to amend clause 17 of the 1962 Agreement because unless it was amended their Union would lose much of its bargaining strength. They pointed out that they represented workers in the following institutions:—

Hotels, bars and restaurants.
Clubs.
Flats, lodging houses and private homes.
Educational institutions.
Missionary undertakings.
Private hospitals.
Bakeries, sweets and biscuit making factories.

The Claimants put forward the following clause to replace clause 17:—

"If in any case, the Union Executive Board shall decide to call for the national strike for the whole Union, the Union shall notify the Association according to the Agreement. Also the Union shall arrange the intended strike to take place according to the phases. That is, there shall be phase one, phase two and so on according to the industries covered by the Union."

The Claimants stated that in 1962 they had agreed to clause 17 because at that time their interest was to gain recognition and they had therefore to make certain concessions but now, eight years after the first Agreement, they were entitled to rectify any shortcomings in their original Agreement. They added that their Union was not reckless and they would at all times adhere to the provisions of the Trade Disputes Act 1965.

The Court has carefully considered the submissions made by the parties and notes that both of them accept that the hotel industry plays a vital role in the tourist industry in Kenya. They also accept that tourism is one of the top revenue earners in the country now. In these circumstances it is the Court's duty to find a formula whereby a vital sector of the country's economy is adequately protected from any irresponsible, reckless or unconstitutional act committed by the workers or the Union leaders while at the same time maintaining the Union strength in being able to call out as a last resort its entire membership on strike on a dispute which they may have in a section of their industry. The Court appreciates that, generally, this right is considered fundamental to the existence and effectiveness of a trade union and that it would not be right to deny the Union this right if all their other efforts fail to elicit the necessary response.

After a careful consideration of all the submissions made by the parties, the Court awards that clause 17 of the 1962 Agreement should be replaced by the following clause:—

1. The Union will not cause, and will undertake to discourage, any stoppage or hindrance of work in sympathy with workers in other establishments where such other employees' action is illegal or in breach of agreement.

2. The Union will not cause, and will undertake to discourage any stoppage or hindrance of work in sympathy with workers in spheres of the Union's activities which are outside the hotel industry, as represented by the Association until such time as the following steps have been exhausted:—

- (a) The full agreed grievance machinery within the affected sphere.
- (b) The dispute has been reported to the Ministry of Labour and a conciliator has been appointed by the Minister and/or the appropriate steps have been taken by the Minister under the Trade Disputes Act 1965.
- (c) After steps (a) and (b) are exhausted, 21 days' notice shall be given to the Hotel Industry of the Union's intention to call their members out on strike.

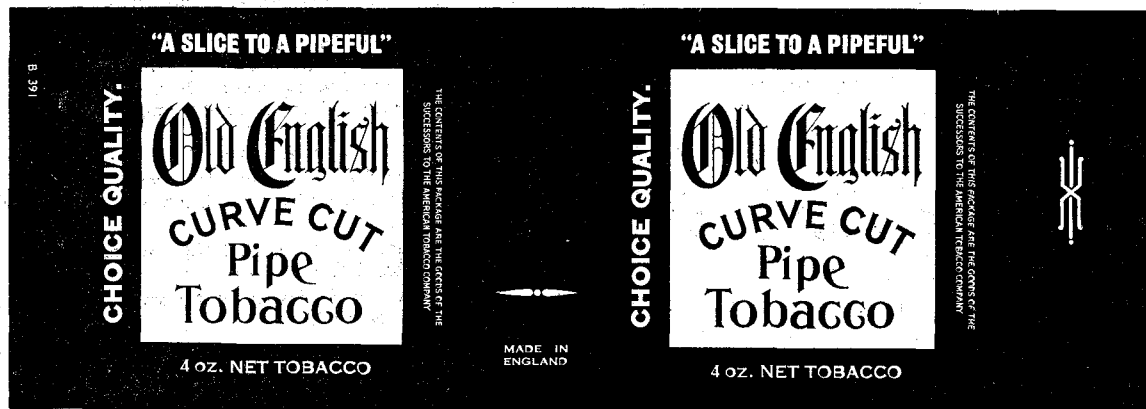
