- (c) Forfeited if a successful applicant fails to accept formally offer of a plot made to him within the stipulated time, and the applicant who fails to take such offer within the prescribed time, shall have no further claim thereto.

6. Applications must be accompanied by a statement indicating—

- (a) the detailed proposals of the applicant for the development of the site. Payment of terminal and other benefits to Mr. Sinange Otiti on his unlawful dismissal.

1. The Tailors & Textile Workers' Union shall hereinafter be referred to as the Claimants and Kisumu Cotton Mills Ltd. shall hereinafter be referred to as the Respondents.
2. The parties were heard in Nairobi on the 23rd day of March and 27th day of April, 1971 and relied on their written and verbal submissions. In addition the following witnesses were called by the parties to give evidence:—

## Claimants

S. Otiti.  
A. O. Onger  
G. Okungu.

## Respondents

R. Patel.  
Dorothy Okunga.  
P. Rajkotia.

## AWARD

3. Mr. Sinange Otiti was dismissed summarily in the afternoon of 16th September, 1970, after two incidents had taken place in the Respondents' factory at about 2.15 and about 4 p.m. the same afternoon. In both these incidents Mr. Otiti was involved.

In the first incident, Mr. Otiti is alleged to have incited the workers on shift "C" by shouting to them to demand immediate payment of their advances as there had been some delay in their payment because of a burglary which had taken place in the accounts office the previous night. Mr. Otiti is also alleged to have abused and insulted the Respondents' accountant, Mr. R. Patel, and had accused him of having participated in the theft.

In the second incident, Mr. Otiti is alleged to have gone into the waiting room, in which the Respondents' telephone operator also sits, and without any apparent cause or reason dragged her from her seat and holding both her hands and pulling her out of the room up to the flag post in the compound.

The Respondents' Industrial Relations Officer had suspended Mr. Otiti after the first incident for abusing his superior and behaving in an unruly manner. After the second incident, however, he was dismissed immediately for gross misconduct.

Mr. Otiti reported the matter to one of the shop-stewards who, in turn after failing to achieve any satisfactory explanation from the Respondents' I.R.O., reported the matter to the Claimants' Branch Secretary. As a result a meeting took place on 22nd September between the Branch Secretary and the Respondents' I.R.O. After the meeting Mr. Otiti submitted an apology in writing saying that he realized he had wronged Mr. Patel by joking and therefore asked the management to pardon him. The Respondents did not accept the apology and refused to withdraw his dismissal. The Claimants then reported a trade dispute to the Ministry of Labour on 7th October, 1970 and an investigator was appointed. After he had carried out his investigation the Ministry of Labour made known its findings and recommendation to both parties which were as follows:—

## Findings—

- (a) Mr. S. Otiti has been in the employ of the Kisumu Cotton Mills Ltd., since 1st February, 1966, as a driver.
- (b) Mr. Otiti was once warned in writing in 1968 for carrying unauthorized persons in the company's vehicle.
- (c) The incident which caused Mr. S. Otiti's dismissal happened on 16th September, 1970.
- (d) That the money for advances was stolen on 15th September, 1970 (this money was for the "C" Shift workers).
- (e) Although Mr. S. Otiti insulted Mr. R. U. Patel, Mr. Patel did not complain against Otiti. The management was only advised by the Company's Industrial Relations Officer, that Mr. Otiti be dismissed after the second offence involving him and the telephone operator.
- (f) The allegation against Mr. Otiti by Miss Dorothy Okunga (telephone operator) that Mr. Otiti pulled her out of the telephone room by force in disorderly manner up to the flag post outside the office is false because Mr. Benedicto

saw Miss Okunga's workmate who was present at the time when the argument started is blind person. Therefore he could not be regarded as an eye witness.

- (g) After a joint meeting between the Union and the management on 22nd September, 1970, the Union decided to advise their member to write a letter of apology to the management. (The letter was written to that effect.)
- (h) Mr. Otiti apologized to the management and asked for pardon. He further stated that he was joking with Mr. Patel on that particular day.
- (i) It is a known fact that Mr. Otiti likes jokes and he has been a driver of the vehicle carrying Mr. Patel from his home to the place of work and back home in the evenings. Therefore they might have been joking for quite a long time and that is why Mr. Patel did not report him to the management on the date of the incident.
- (j) The Company's Industrial Relations Officer stated in his report that he advised the management to dismiss Mr. Otiti after the second offence involving Miss Okunga and Mr. Otiti. The investigation revealed that the evidence of Miss Okunga was planned or a cooked subject to implicate Mr. Otiti into this matter.

## Recommendations—

Mr. Otiti should be reinstated but should not be paid for the days he has been out from work.

The Respondents reacted sharply to these "findings and recommendation" and alleged that the investigator had not examined any of their witnesses and in fact had heard the complete case on behalf of the management in less than ten minutes. The Respondents maintained that the investigator had therefore made his recommendation without proper knowledge of the case and maintained that some of the findings stated by him were completely false as follows:—

- (a) Mr. Otiti was never offered wages in lieu of notice as stated by the union to the investigator. As already explained to the Court the money due to Mr. Otiti was sent to the Labour Office as Mr. Otiti would not himself accept it.
- (b) To the knowledge of the Respondents the investigator never interviewed the telephone operator: therefore there is no possibility of him having exact knowledge of what happened. In addition, the Respondents never had to rely on the evidence of Mr. Suwe who is blind and this man was never requested to support the telephone operator.
- (c) The investigator states that the Company's Chief Accountant never gave evidence. This is true because he was never requested to give evidence by the investigator.
- (d) It is stated by the investigator that Mr. Patel did not complain against Mr. Otiti's action. This is quite false as according to the evidence submitted to the Court, Mr. Patel certainly did complain and the Industrial Relations Officer was also present and witnessed the incident.
- (e) It is not known on which basis the investigator suggests that the evidence of the lady telephone operator was planned or cooked as she had no reason to implicate Mr. Otiti and in fact she was attacked in a most unreasonable manner. The investigator states that Mr. Otiti looked rather old and not the type of person who would assault a lady. It is obvious the investigator did not see Mr. Otiti on the occasion when the incident, as reported above, actually took place.

During the hearing the Claimants stated that their demand was first for Mr. Otiti's reinstatement but failing that he should be paid the following terminal benefits:—

- (a) Pay for accrued leave not taken.
- (b) Pay for the days he worked.
- (c) Pay for one month in lieu of notice.
- (d) Pay for the days he has been out and including 6th February, 1971.
- (e) *Ex gratia* payment based on 10 days' pay per each completed year of service, calculated with the wage he is getting.

The Claimants submitted that as the first occasion on which the Respondents had mentioned the assault on the telephone operator by Mr. Otiti was before the investigator, it was a fabricated charge otherwise they should have brought up this matter when the shop-steward and their Branch Secretary had approached them immediately after Mr. Otiti's dismissal. They asked the Court to reject the allegation of the assault and to find that the accusation against Mr. Patel by Mr. Otiti of having participated in the theft, at the most warranted a warning letter and not a dismissal.

The Respondents on the other hand strongly maintained that they had taken the right action in first suspending Mr. Otiti after the incident with Mr. Patel, and secondly in dismissing him summarily after he had assaulted for no reason the telephone

operator, Miss Dorothy Okunga. They stated that Mr. Oti's dues had been deposited with the Kisumu Labour Office and were as follows:—

The Court has carefully considered the submissions made by the parties and the evidence given by the various witnesses and finds the evidence of Miss Okunga to be truthful and unbiased. The Court was very impressed with this witness's demeanour, and her frank and honest answers. In fact the Court can find no reason why this young lady should come to give evidence on oath if the story of the assault on her was a fabrication. The Claimants could not put forward any reason for her giving false evidence.

On the other hand Mr. Oti definitely has a reason to deny having assaulted her and the shop-steward and the Branch Secretary equally have a good reason for keeping silent on this incident.

Having accepted Miss Okunga's evidence, the Court also finds that the Claimants were fully informed by the Respondents' Industrial Relations Officer that the real reason for Mr. Oti's dismissal was his assault on Miss Okunga which, in their opinion, constituted a gross misconduct.

If Mr. Oti had not assaulted Miss Okunga, then the Court might have been inclined to give him the benefit of the doubt but in view of the fact that the unprovoked assault by him on Miss Okunga has been proved the Court has absolutely no sympathy whatsoever with Mr. Oti.

The Court would like to stress that such behaviour on the part of a worker will not be tolerated because if such incidents are condoned they can lead to a serious breakdown of discipline among the work force in an undertaking.

The Court finds that the investigator completely misdirected himself in his findings and his recommendation. In fact the way he carried out his investigation appears to have been very perfunctory and quite unsatisfactory.

For the foregoing reasons the Court finds that Mr. Oti is not entitled to any terminal or other benefits as claimed by the Claimants other than those which the Respondents have deposited with the Kisumu Labour Office.

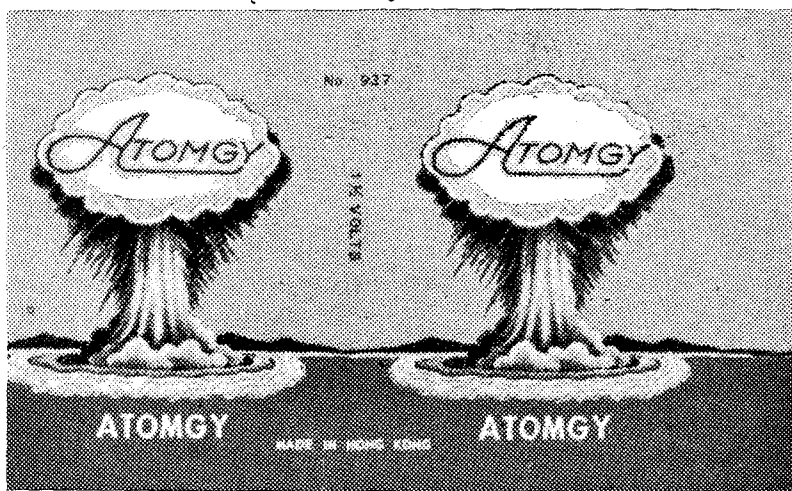
