CAPITAL ISSUES COMMITTEE

THE Minister for Finance and Economic Planning has formed a Capital Issues Committee consisting of representatives of the Treasury, the Ministry of Commerce and Industry and the Central Bank of Kenya. The Chairman is the Deputy Permanent Secretary to the Treasury.

The Terms of Reference of the Committee are as follows:—

To consider and advise the Minister for Finance and Economic Planning regarding the following matters:—

- (i) The terms, priority and timing of all new issues submitted to the Nairobi Stock Exchange, including issues by way of rights to existing shareholders, and including ordinary, preference, debenture and loan stock issues.
- (ii) The terms of any capital reconstruction, including capitalization of reserves, of all companies quoted on the Nairobi Stock Exchange and all unquoted companies which have total non-resident beneficial interests exceeding K£100,000.
- (iii) Issues of or amendment to Foreign Investment Protection Certificates provided under the Foreign Investment Protection Act.
- (iv) All applications for bank loans or other credit facilities in excess of K£250,000 when that figure exceeds 20 per cent of the foreign investment in non-resident controlled companies or 40 per cent of the total investment in resident controlled companies with non-resident participation.
- (v) To examine all management and royalty agreements to be lodged with the Committee which involve external payments exceeding K£25,000 per annum.

The Terms of Reference of the Committee will be varied from time to time in the light of working experience and changes in the country's financial situation.

THE INDUSTRIAL COURT

CAUSE No. 20 OF 1971

Parties:—

Kenya Local Government Workers' Union

and

Association of Local Government Employers
(Committee No. 1)

Issue in dispute:—

Payment of overtime to staff employees of Fire Brigade and Ambulance Services.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Association of Local Government Employers shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 29th day of June, 1971, and relied on their written and verbal submissions.

AWARD

3. This dispute has arisen as a result of the Claimants' demand on behalf of their members, the staff employees in the Fire Brigade and Ambulance Services both at Nairobi and Mombasa, for payments of overtime to them in accordance with terms and conditions of service for staff employees in the salaried grades. An agreement between the parties embodying 43 different items specifying terms and conditions of service for these employees came into effect from 1st January, 1970, after the Minister for Local Government had given his approval. In this agreement, under clause 8—hours of work—the following is provided:—

"The hours of work in respect of an officer shall be 34 per week in Mombasa and 39 hours per week in Nairobi."

Under clause 17 provision is made for payment of overtime and clause 17 (a) reads as follows:—

"Payment for overtime in accordance with arrangements approved by the Head of Department, after normal working hours for officers in salary scales 6-24 in Nairobi and 10-24 in Mombasa inclusive shall be paid as overtime, provided that such overtime has been specifically authorized in writing by the officer's section head."

As is obvious, no exclusions are made regarding entitlement to overtime payment in respect of salaried grades who are working in the Fire Brigade and Ambulance services operated by the Nairobi and Mombasa Councils. The Claimants have relied on this document in pressing their claim and have asked the Court to rule that although the salaried staff in these services worked 60 hours per week along with the employees in non-salaried grades (manual workers), they are entitled to be paid overtime for 26 hours per week in Mombasa and 21 hours per week in Nairobi. They pointed out that they had raised this matter with the Mombasa Municipal Council as far back as May, 1970.

The Respondents on the other hand submitted that the salaried staff in these services were not mentioned in the aforesaid agreement because there had been considerable overlapping in the negotiations and subsequent disputes registered with the Industrial Court in respect of both non-salaried and salaried staff employed by the Nairobi City Council and Mombasa Municipal Council. They reminded the Court that the parties had appeared before it in Cause No. 27/69 in which the issue was working hours in the Fire Brigade and Ambulance services.

The other dispute was registered by the Court as Cause No. 40/69 and in that dispute the Court had made an award on overtime which has been reproduced hereinabove as clause 17 (a) in the agreement covering salaried staff. They strongly maintained that at no time were they ever in doubt that the salaried staff at the Fire Brigade and Ambulance services were required to work 60 hours without payment of any overtime just as the non-salaried employees were required to do. Therefore there was no question of there being any entitlement for payment of overtime to staff employees in these services.

The historical background involving the negotiations leading to the two disputes mentioned hereinabove in the Industrial Court and the subsequent finalization of the two agreements between the parties regarding employees in non-salaried and salaried grades is extremely important and has a direct bearing on the issue in dispute. It is significant and very important that until the agreement covering staff employees was finalized and came into force from 1st January, 1970, there was in the past absolutely no question whatever that the staff employees at the Fire Brigade and Ambulance services who used to work 72 hours per week along with the manual workers were entitled to any overtime payment. This fact was accepted by the Claimants.

The Court can find no evidence that during the negotiations of the aforesaid two agreements for salaried and non-salaried grades any claim was made for the reduction of working hours for the staff employees at these services and for the payment of overtime to them in excess of the number of hours worked as

specified in the staff employees agreement. There is, however, ample evidence, both documentary and otherwise, showing how the number of working hours for employees at Fire Brigade and Ambulance services were reduced from 72 to 60 hours as a result of the Court award in Cause No. 27/69.

The facts briefly are that in the month of September, 1968, during negotiations between the parties, in respect of employees in non-salaried grades, agreement was reached on all items except hours of work and overtime for manual workers in the Fire Brigade and Ambulance services. After the parties had concluded their experiment of running these services on a three-shift system of 56 hours per week both at Nairobi and later at Mombasa, they could not come to an agreement and the matter was referred to the Court *vide* Cause No. 27/69. The Court issued its award reducing the number of hours from 72 to 60 per week.

During this time the parties had also embarked, on or about July, 1969, on negotiations relating to terms and conditions regarding staff employees and a large measure of agreement was reached. As has been stated above, certain issues arising out of these negotiations including overtime were referred to Court *vide* Cause No. 40/69 and the Court made an award on that issue along with others.

The crucial point in this dispute is to determine whether or not the parties had referred in Cause No. 27/69 the question of working hours for all employees at the Fire Brigade and Ambulance services, that is both staff and manual, to the Court or whether that dispute referred to working hours for manual employees only.

The Court has very carefully gone through all the submissions and the documentary evidence. It has further gone through the submissions in Cause Nos. 27/69 and 40/69 but cannot accept the Claimants' contention that the award in Cause No. 27/69 related to manual employees only. The Claimants have argued that because they had referred this issue to the Court prior to concluding their agreement on employees in non-salaried grades and because the experiment referred to hereinabove of working 56 hours per week was signed by the chairman of the manual employees along with the national officials, the issue and award in Cause No. 27/69 referred to manual employees only. The Court cannot accept this argument as there is no evidence whatsoever at any stage of the proceedings in Cause No. 27/69 to show that the employees involved in that dispute were manual workers only.

In fact all along it is clearly and unambiguously stated that employees at Fire Brigade and Ambulance services were affected by that dispute. There is no mention anywhere that it related to manual workers only.

The Court finds it inconceivable that the Nairobi City Council and Mombasa Municipal Council would agree to an arrangement quite contrary to the past working arrangements in Fire Brigade and Ambulance services thereby increasing their expenditure in these services due to payment of overtime to staff employees in Nairobi for 21 hours per week and in Mombasa for 26 hours per week without actually having negotiated this item. The Court has no doubt that due to the timing of the negotiations covering salaried and non-salaried (manual) employees of these Councils and the extent of overlapping in the two disputes before the Industrial Court, Nos. 27/69 and 40/69, the Respondents overlooked to have this exclusion recorded in respect of staff employees at Fire Brigade and Ambulance services, in the clause on hours of work and payment of overtime in the staff employees agreement. There is nothing more than that and the Claimants have been quick to spot this omission and have tried to push through their claim. The Court must add that the Claimants' agreement was indeed ingenious and quite attractive at first sight but on closer scrutiny of evidence and circumstances enumerated hereinabove, it is clear that there is no merit in it. For these reasons the Claimants' demand fails and the Court rules that all the employees, staff and manual, at Fire Brigade and Ambulance services should continue to work 60 hours per week without payment of any overtime as indeed they used to work 72 hours per week without payment of any overtime prior to the Court award in Cause No. 27/69.

Finally the Court would like to point out that if the Claimants wish to pursue this claim any further then they should put it forward at the appropriate time at some future date when the parties embark on negotiations for revising their existing agreements.

General Conditions

1. The ordinary conditions applicable to urban grants of this nature except as varied hereby shall apply to this grant.

2. The grant will be made under the provisions of the Government Lands Act (Cap. 280 of the Laws of Kenya) and title will be issued under the Registration of Titles Act (Cap. 281).

3. The grant will be issued in the name of the allottee as stated in the letter of application.

4. The term of the grant will be for 99 years from the first day of the month following notification of the approval of the grant.

5. Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the initial estimated amount for the construction of roads and drains to serve the plot, the assessed stand premium and proportion of annual rent, together with the legal fees payable in respect of the preparation and registration of the grant (Sh. 225) and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent). Special Conditions

1. The grantee shall erect complete for occupation within 24 months of the commencement of the term buildings of approved design on proper foundations constructed of stone, burnt-brick or concrete with roofing of tiles or other permanent materials approved by the Commissioner of Lands and shall maintain the same (including the external paintwork) in good and substantial tenable repair and condition:

Provided that should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

2. The buildings shall not be erected until plans (including block plans showing the positions of the buildings and a system of drainage for disposing of sewage, surface and sullage water on the land), drawings, elevations and specifications thereof shall have been approved in writing by the local authority and the Commissioner of Lands. 3. Not more than one private dwelling-house with the necessary offices and outbuildings appurtenant thereto (excluding a guest-house) shall be erected on the land.

4. The buildings shall not cover more than 50 per centum of the area of the land or such lesser area as may be laid down by the local authority in its By-laws.

5. The grantee shall not subdivide the land.

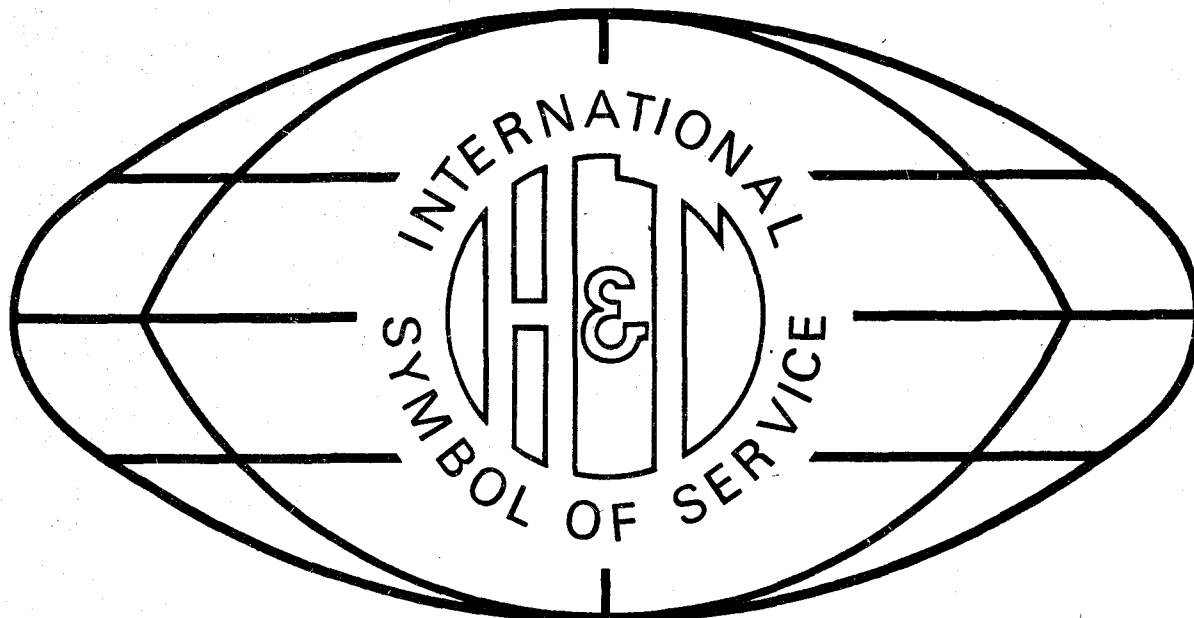

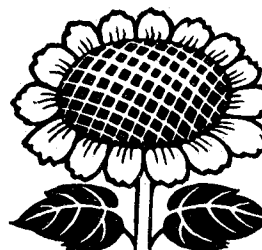

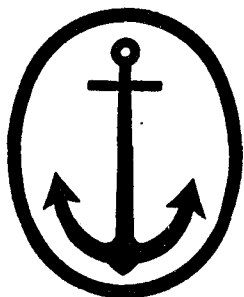
