Note—Incremental credits will be granted for approved previous experience to successful candidates who are not civil servants, provided the maximum of the salary scale is not exceeded, they will also be eligible for benefits and privileges enjoyed by civil servants in accordance with the existing Government Regulations.

Senior Superintendent (Mechanical) (One Post) Ministry of Works (No 214/72)

Salary scale—£1,494 to £1,866 PENSIONABLE

Applicants must be in possession of Cambridge School Certificate or its equivalent. They should have a recognized apprenticeship in Mechanical Engineering and thereafter should have had ten years' experience in heavy plant machinery, part of which should have been in a senior supervisory capacity. Applicants should have a knowledge of Workshop Costing and Stores Procedure. In addition they should have had experience of maintenance and operation of heavy earth moving equipment, such as Tractors, Graders, Power Shovels, Scrapers, Road Roller Air Compressors and a knowledge of the operation and running of vehicles.

Master (One Post) Vice-President's Office and Ministry of Home Affairs (No 215/72)

Salary scale—£690 to £972 PENSIONABLE or AGREEMENT

Applicants must possess the Cambridge School Certificate or East African Certificate of Education with either training in teaching or Social Work. Applicants with lower qualifications but with five years' experience in the field of Juvenile Delinquency will also be considered. Applicants must be mature persons of more than 25 years of age and must possess administrative ability and take keen interest in dealing with juvenile delinquents. A knowledge of accounts and store keeping will be an advantage. The successful candidate will be required to shoulder extra duties outside the normal office hours.

Legal Officer Grade III (Four Posts), Office of the Attorney-General (No 216/72)

Salary scale—£1,212 to £1,614 PENSIONABLE or AGREEMENT

Applicants must be advocates of the High Court of Kenya or hold a legal qualification specified in section 12 of the Advocates Act (Cap 16). They must be prepared to do civil or criminal work as State Counsel in the Attorney-General's Chambers or general legal work as a Legal Assistant in the Department of the Registrar-General. Applicants should specify the type of work preferred. 
