## VACANCIES FOR TRAINEES IN THE MINISTRY OF FINANCE AND PLANNING

## NOTE

Candidates must give precise details of the East African Certificate of Education/Advanced Certificate of Education results including the index number, Division obtained, year of passing the examination with details of distinctions, credits and passes.

*Statistical Assistant (Trainee) (Five Posts) (No. 76/74)*

Applicants must possess at least Division II in East African Certificate of Education with strong credits in Mathematics and English Language, but preference will be given to candidates who have passed in Division I with credits in the same subjects or those who possess the East African Advanced Certificate of Education or its equivalent with a principal pass in Mathematics. The training period is two years, during which time trainees will be required to attend a nine months' course at the East African Statistical Centre at Dar es Salaam. The remaining period will be spent working in the Central Bureau of Statistics of the Ministry.

Trainees holding East African Certificate of Education will be appointed on temporary terms at a salary of £312 per annum in the Job Group "D" (£312-£453), whereas those with the East African Advanced Certificate of Education or its equivalent will receive £399 per annum. After successful completion of one year's training and passing the necessary examination, they will be eligible for advancement to the Job Group "F" (£510-£714). There will be a deduction of 20 per cent of salary whilst attending the training course in Dar es Salaam. They will be required to pass the middle level examination at the Training Centre or the Registered Statistical Assistants' Examination of the London Institute of Statisticians. Successful completion of final training and passing the necessary examination will render a trainee eligible for appointment on probation as a Statistical Assistant in the Job Group "G" (£714 to £1,008) provided he has also completed two years from the original date of appointment to the training grade. There are prospects of further training and promotion to higher grade. Candidates will be required to sit an aptitude test prior to the final selection.
