## THE INDUSTRIAL COURT

CAUSE NO. 24 OF 1972

*Parties:—*Kenya Union of Sugar Plantation Workers  
and

Sugar Employers' Group of Federation of Kenya Employers

## RULING

The Respondents in the above dispute have applied for an interpretation of the Court award on the item of housing which was announced by the Court on 10th October, 1972.

The Court made the following award in para. 8 (iii) which is relevant to this application:—

"The Court awards that those workers who are not housed by the Respondents should be entitled to the following house allowance:—

*Sh. p.m.*

All workers up to Grade V	...	...	...	15
Others	...	...	...	40."

After the Court award had been announced the parties met and held a Joint Industrial Council meeting for the sugar industry composed of the parties to this dispute. The award on housing was discussed and subsequently the parties signed a collective agreement embodying all the items which had been agreed between them at their own level and also the Industrial Court award on the various items. In this agreement clause 18 on housing reads as follows:—

"Employees shall normally be provided with rent free housing in accordance with the Laws of Kenya. Where, however, sufficient housing is not available those employees who are not housed shall be entitled to the following housing allowance:—

*Sh. p.m.*

All workers up to Grade V	...	...	...	15
All other workers	...	...	...	40."

The Respondents want the Court to confirm that in view of the submissions before the Court, the Court award and the collective agreement, their interpretation is correct and proper. They interpreted the award to mean that the two categories of workers who are not housed and are not paid house allowance are as follows:—

- Those who resided in their own homes within reasonable distance of the estate.
- Those who were offered housing but preferred to live in their own homes.

The Respondents submitted that this was the only interpretation which the Court could give as the Court could not alter the Laws of Kenya and therefore the practice as agreed by the parties in their subsequent joint agreement must apply.

The Claimants opposed the Respondents' interpretation and maintained that the award could not be read in any other way than that of paying a house allowance to anyone not housed. They pointed out that the Respondents were in fact using this application by way of appeal to the Court to vary its own award and that the Court should not allow them to do so.

The Claimants further submitted that two major employers who were parties before the Court—E.A. Sugar Industries Ltd. and Chemelil Sugar Company—had implemented the Court award in line with their (the Claimants) interpretation. Those of their employees who were not housed by them but lived only a few yards away from the estates were paid housing allowance as awarded by the Court.

The Claimants emphasized that if the Court was to confirm their interpretation it would in no way be going against the Laws of Kenya. Finally they expressed their disappointment that the Respondents' representative had chosen to make this application despite the Court award being so clear and precise.

During the hearing of this dispute the Court had before it the parties' written and verbal submissions on this item along with the other issues in dispute. The Claimants' submission at that time was that the houses which are provided by the Respondents' members are not only poor but that thousands of workers are staying out in private houses paying rents and they had asked the Court to award rent as follows in respect of those workers who are not housed:—

*Sh.*

Porters, etc.	...	...	...	...	30
Clerks and Artisans	...	...	...	...	50
Supervisors, etc.	...	...	...	...	90

The Respondents on the other hand clearly drew the Court's attention to section 23 of the Employment Act which they quoted in full and also referred the Court to several other Court awards on the issue of housing and they asked the Court to confirm that the wording of the existing agreement was adequate.

The Court after carefully going through the parties' submissions made the award as it is quoted hereinabove and the Court would like to make it very clear that had it intended that section 23 of the Employment Act should continue to apply as interpreted by Respondents then it would certainly have stated so in its award.

The Court is satisfied that it has made an award to the effect that those workers who are not housed by the Respondents are entitled to the housing allowance as awarded by the Court irrespective of the distance involved at which their houses are located.

The Court would like to clarify that those workers who were offered housing by the Respondents but preferred to live in their own homes were not entitled to claim housing allowance as awarded by the Court.

The Court would like to clarify that its award is not in any way against the Laws of Kenya because it is the function of the Court as and when necessary to improve upon the minimum standards which are prescribed by the relevant statutes. The Court further notes that the award had continued for about one year and two major employers namely E.A. Sugar Industries Ltd. and Chemelil Sugar Company, have paid housing allowance to those of their employees who are not housed by them. The Court finds that they have acted properly.

For the foregoing reasons the Court cannot accept the Respondents' interpretation of the Court award on this point and confirms that the Claimants' interpretation is correct and proper.

thence for 60.96 metres on a bearing of 137° to point J, a wooden peg;

thence for 60.96 metres on a bearing of 113½° to point K, a wooden peg;

thence for 45.72 metres on a bearing of 137° to point L, a wooden peg;

thence for 64.3128 metres on a bearing of 228½° back to the starting point "A".

All bearings given above are magnetic.

(Cap. 280)MOIBEN TOWNSHIP—PLOTS FOR SHOPS/OFFICES AND FLATS  
(EXCLUDING THE SALE OF PETROL)

THE Commissioner of Lands gives notice that the plots in Moiben Township as described in the Schedule hereto are available for alienation and applications are invited for the direct grants of the individual plots.

2. A plan of the plots may be seen at the Public Map Office, situated in the Lands Department Building, City Square, Nairobi, or at the office of the Clerk, Wareng County Council, or may be obtained from the Public Map Office, P.O. Box 30089, Nairobi, on payment of Sh. 3 post free.

3. Applications should be submitted to the Commissioner of Lands, Nairobi, through the Clerk to the Wareng County Council, stating the plot required in order of preference. Applications must be on prescribed forms which are available from Lands Department or the Clerk to the Wareng County Council.

4. Applications must be sent so as to reach the Clerk to the Wareng County Council not later than noon on the 7th June, 1974.

5. Applications must not be sent direct to the Commissioner of Lands.

6. Applicants must enclose with their applications their cheque for Sh. 1,000 as a deposit, which will be dealt with as follows:—

- If the applicant is offered and takes up and pays for a plot within a period of seven days as required in paragraph 5 below, the deposit will be credited to him.
- If the application is unsuccessful the applicant's deposit will be returned to him.
- If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 of the General Conditions, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

*General Conditions*

1. The ordinary conditions applicable to township grants of this nature except as varied hereby shall apply to this grant.

2. The grant will be made under the provisions of the Government Lands Act (Cap. 280 of the Laws of Kenya), and title will be issued under the Registration of Titles Act (Cap. 281).

3. The grant will be issued in the name of the allottee as stated in the letter of application.

4. The term of the grant will be for 99 years from the first day of the month following the notification of the approval of the grant.

5. Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the initial estimated amount for the construction of roads and drains to serve the plot, the assessed stand premium, and proportion of annual rent, together with the survey fees payable in respect of the preparation and registration of the grant (Sh. 225), and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent). In default of payment within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot.

*Special Conditions*

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and local authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall within six months of the commencement of the term submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water) drawings, elevations and specifications of the buildings the grantee proposes

to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act (Cap. 280), if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid, shall be given (1) within 12 months of the commencement of the term, the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to the expiration of the said building period, the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. The land and buildings shall only be used for shops (excluding the sale of petrol), offices and flats.

6. 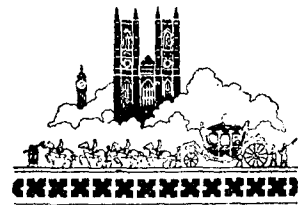

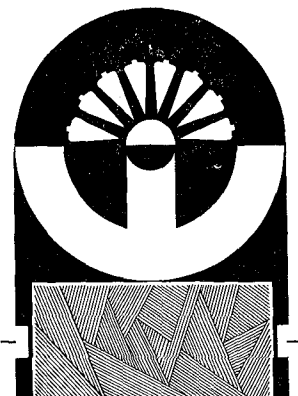
