Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with the existing Government Regulations.

Vacancies in the Ministry of Power and Communications:-

Counterpart Financial Manager (Supernumerary) (One Post) (No. 393/74)

Salary scale.—£1,866 to £2,334. PENSIONABLE or AGREE-MENT.

Applicants should be holders of a recognized Accountancy qualification, e.g. A.C.A., A.C.C.A., C.P.A., A.C.M.A., or a Bachelor of Commerce degree (accounts option) with at least four years' proved experience in financial management and accounting. Applicants must be well versed in accounting procedures and capable of administering a substantial turnover including preparation of final accounts, preparation of estimates, budgetary control, cash flow forecasts, and to be generally knowledgeable on personnel administration.

On successful completion of the necessary training, it is expected that the Counterpart will be promoted to fill the post of the Financial Manager which carries the salary of $K \pounds 2,334$ to $K \pounds 2,820$ in the Job Group "M".

Chief Fire Service Officer (One Post) (No. 394/74)

Salary scale.—£1,866 to £2,334. PENSIONABLE or AGREE-MENT.

Applicants are required to have a sound technical and administrative knowledge of fire service matters with at least eight years' fire fighting experience, of which a minimum of four years must have been spent as a senior officer of a major fire fighting organization. The successful candidate must be capable of maintaining efficient standards of performance of Fire Service Crew including their training, and ensuring that international standards of crash and rescue operations at all Government Aerodromes are maintained. He will also be required to have the capability to advise the Director of Aerodromes on safety standards on airport operational areas, and the Planning of Fire Service requirements including stores and equipment.

The successful candidate must be prepared to travel to and from the various airports when required to do so and if necessary attend courses abroad.

Superintendent (Buildings) (One Post) (No. 395/74)

Salary scale.—£1,212 to £1,614. PENSIONABLE or AGREE-MENT.

Applicants should be of mature age of East African Certificate of Education standard or its equivalent and should have undergone an apprenticeship in building constructions followed by considerable practical experience part of which should have been in a responsible supervisory position requiring control of staff and co-ordination of activities of building trades staff on maintenance of large buildings and services. They should have considerable experience in work planning and programming preparing estimates and controlling expenditure.

Pharmacist Grade I (One Post) (No. 396/74)

Applicants must be pharmacist registered or registrable in Kenya who have served for a minimum of three years since qualification and preferably in hospital pharmacy. The successful candidates will be posted to Provincial General Hospitals to be in charge of the hospital pharmacy as well as supervising staff working under them in the Provincial Hospital as well as in District Hospitals.

They will be expected to formulate ways and means of enhancing the efficiency of the pharmaceutical services within the provinces in which they will be posted.

Biochemist (One Post) (No. 397/74)

Salary scale.—£1,212 to £1,614. PENSIONABLE or AGREE-MENT.

Applicants must be holders of B.Sc. degree with approved experience of not less than two years in clinical chemistry. Alternatively they must have a Diploma in Clinical Chemistry with a minimum of three years' experience in Clinical Chemistry Laboratory work.

The successful candidate will be responsible to the head of Clinical Chemistry Department in the Kenyatta National Hospital Clinical Laboratories or head one of the Hospital Laboratories within the National Public Health Laboratory services.

Senior Library Assistant (One Post) (No. 398/74)

Salary scale.—£714 to £1,008. PENSIONABLE or AGREE-MENT.

Applicants should be in possession of the certificate of Librarianship of the East African School of Librarianship, Makerere University College or its equivalent. They must in addition have served in the grade of Library Assistant I for a minimum period of not less than three years and must have shown ability to organize and control work in a mediumsized library within the three years' period in this grade.

The successful candidate will be required to be capable of exercising judgement within existing rules, regulations and procedures in running a medium-sized library. The duties involve supervision of the junior staff engaged in duties such as classifications, cataloguing, shelving and circulation of books and periodicals, ordering and procurement of reading materials. In large and specialized departmental libraries, officers at this level may be required to perform these duties and train their junior staff.

Library Assistant Grade I (One Post) (No. 399/74)

Salary scale.—£510 to £714. PENSIONABLE or AGREE-MENT.

Applicants should be in possession of at least either the East African Certificate of Education with credits in the five subjects (one of which must be in English) or the East African Advanced Certificate of Education or its equivalent. Preference will be given to holders of the East African Advanced Certificate of Education or its equivalent. In addition, the officer should be in possession of the Certificate of Librarianship of the East African School of Librarianship, Makerere University College or its equivalent. Such an officer will be required to have completed at least two years' service as Library Assistant Grade II.

The successful candidate will be expected to be involved in the preparation of book binding, shelf arrangement, getting references for readers, cataloguing and recording of new publications, stocktaking and recording of revised holdings. He will in addition be expected to supervise and check the work of a smaller group of Library Assistants including messengers. Vacancies in the Ministry of Information and Broadcasting:-

News Editor (News Reader) (Two Posts) (No. 400/74)

Salary scale.— \pounds 1,212 to \pounds 1,614, PENSIONABLE or AGREE-MENT.

Applicants should preferably be graduates from recognized Universities with Journalism or History and Political Science as one of their major fields of study. They must have at least two years' experience in Journalism.

However, applicants who are not in possession of University degree but have passed the East African Certificate of Education Examination or East African Advanced Certificate of Education Examination or their equivalents, with a minimum of five years' experience in Journalism and News Reporting will be considered.

They must be fluent in both oral and written English and Swahili, have good news reading voice and be conversant with both local and international affairs. They must also be able to translate English into Swahili and vice versa.

Successful candidates will be required, among other things, to report, sub-edit and present Television and Radio News and programmes.

Maintenance Engineer (Six Posts) (No. 401/74)

Salary scale.— \pounds 1,212 to \pounds 1,614. PENSIONABLE or AGREEMENT.

Applicants must be graduates in Electronics with two years' experience in Telecommunications in Broadcasting field, or be holders of certificate equivalent to City and Guilds' Telecommunications Final, with seven years' experience, two years of which must have been in a supervisory capacity.

The successful candidates will be required to work independently and supervise engineering projects. They must be able to take overall charge of a single station, control staff and organize in-service training for staff in a station.

Designer Assistant Grade I (One Post) (No. 402/74)

Salary scale.--£510 to £714. PENSIONABLE or AGREE-MENT.

Applicant must be of East African Certificate of Education or its equivalent with at least two years' experience in television studio design work. Candidates should have some knowledge of printing techniques. Fluency in both written/spoken Swahili and English is essential. Creativity and proficiency in Graphic Design, Typography and Drawing will be an advantage.

Vacancies in the Ministry of Education:-

Senior Education Officer (One Post) (No. 403/74)

Salary scale.—£1,866 to £2,334. PENSIONABLE or AGREE-MENT.

Applicants must be professionally trained graduates with at least five years' experience in teaching or administration. Experience in broadcasting will be an advantage.

The successful candidate will be in overall charge of the Schools Broadcasting Service and be responsible to the Chief Inspector of Schools for the content of the programmes broadcast to schools, colleges and teachers and for educational broadcasting policy in consultation with the Chief Inspector of Schools. The successful candidate will also be responsible for the writing and production of radio, television and tape/ slide programmes for schools, colleges and teachers. He will also be responsible for the preparation of suitable support materials and for the testing and evaluation of programmes.

Executive Assistant (Secret Registry) (One Post) (No. 404/74)

Salary scale.—£714 to £1,008. PENSIONABLE or AGREE-MENT.

Applicants should be civil servants preferably of East African Certificate of Education or its equivalent, with at least three years' experience of work in a Secret Registry, a sound knowledge of Government Regulations and ability to control staff and organize work.

Preference will be given to those who have successfully completed a course in Government Protective Security.

Tax Officer Grade I (Fifteen Posts) (No. 405/74)

Salary scale.— \pounds 1,212 to \pounds 1,614. PENSIONABLE or AGREEMENT.

Applicants must be experienced civil servants with not less than two years' service in the grade of Tax Officer Grade II, and, who must have demonstrated outstanding technical competence and ability in addition to organizing and supervising skills. They should be officers of undoubted integrity.

The duties will consist of training and supervising groups of tax officers in the lower grades, approving and signing letters to tax-payers and their advisers, checking and auditing difficult tax returns, raising assessments especially difficult assessments, approving amended assessments, dealing with more difficult correspondence and interviews as referred to them by lower grade Tax Officers and leading P.A.Y.E. Audit teams and other forms of assistance to Senior Tax Officers including local committee work. They may be required to assume the role of a Senior Tax Officers.

Tax Officer Grade II (Sixteen Posts) (No. 406/74)

Salary scale.—£972 to £1,302. PENSIONABLE or AGREE-MENT.

Applicants must be experienced civil servants with not less than three years' service in the grade of Tax Assistant Grade I (former Tax Officer Grade III) and, who, must have demonstrated competence in handling more complicated tax files in addition to demonstrated capability of training officers of lower grades. They should be officers of undoubted integrity.

The successful candidates who would be working under the District Heads and Senior Tax Officers, would be responsible for all tax duties connected with the files including checking and auditing tax returns, drafting correspondence to tax-payers to agree liability, raising assessments on agreed incomes, raising estimated assessments as instructed where there is failure to submit returns; amending assessments; initially handling tax-payers objections and appeals; interviewing taxpayers on matters concerning incomes, assessments, objections, P.A.Y.E. audit and Tax Clearance work and raising assessments on business income as agreed by the Assessor.

The successful candidate will be stationed at Nairobi but will travel extensively throughout Kenya.
