VACANCIES

#### Note

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government Regulations.

Vacancies in the Ministry of Finance and Planning:

Assistant Computer Manager (One Post) (No. 28/77)

Salary scale.—K£2,514 to £3,036 per annum. PENSIONABLE or AGREEMENT.

Candidates must have at least two years' experience of supervising computer operations activities in an IBM System 370 Installation including full responsibility for the maintenance of the DOS operating system. Knowledge of teleprocessing applications and an appreciation of systems design plus Cobol Programming though not essential will be advantageous.

The computer unit provides a centralized data-processing service to all Government Ministries and is engaged in a wide variety of applications the scope of which has been increased through the introduction of tele-processing activities and the successful activities and the successful candidate will be responsible for—

- (a) overall supervision of computer;
- (b) maintenance of all software used within the department with emphasis on the operating-system; and
- (c) supervision of the day to day running and maintenance of operational systems.

Chief Supplies Officer (One Post) (No. 29/77)

Salary scale.—K£2,010 to £2,514 per annum. PENSIONABLE or AGREEMENT.

Applicants must be in possession of at least East African Certificate of Education or its equivalent. They should have considerable practical experience in supplies management including at least three years at Senior Executive or managerial level. Preference will be given to candidates who are in possession of high relevant professional qualifications issued by a reputable institution. Wide knowledge of Kenya Government Stores Regulations and Procedures will be an advantage.

The successful candidate will assist the Head of Supplies Services in all professional and administrative duties, be responsible for supplies management inspections, vetting overseas indents and contract documents, classification and coding, up-dating the stores catalogue, initiating directives and instructions on supplies systems and procedures, reviewing and up-dating the Supplies Mannual, supplies staff establishments, training and service records.

Senior Assessor (Four Posts) (No. 30/77)

Salary scale.—K£2,010 to £2,514 per annum. PENSIONABLE or AGREEMENT.

Candidates who should preferably be serving officers of the Government must have considerable experience of income tax matters and must have served as qualified assessors for at least three years. Those outside the service must be in possession of an approved degree either in Economics, Commerce or Law; or alternatively, a recognized Accountancy qualification equivalent to a degree. In addition they must be conversant with the Income Tax Act and should have considerable experience in management and administration of income tax work at senior level.

Duties will include examination of business accounts, training and supervising technical groups of Income Tax Assessors. They will also be called upon to assist the Principal Assessors with district administration or will be charged with the duties of administering large sub-district offices. In Investigation Branch, they will be required to conduct complicated investigation cases and will deal with tax fraud and evasion plus any prosecutions arising therefrom. In Training School, they will perform the duties of Trainers under the guidance of the Principal Assessor.

Senior Analyst/Programmer (Two Posts) (No. 31/77)

Salary scale.—K£1,614 to £2,082 per annum, PENSIONABLE or AGREEMENT.

Candidates should have a degree from a recognized university plus two years' experience in Systems Analysis and/or Programming or be in possession of at least East African Advanced Certificate of Education with four years' experience of Systems Analysis and/or Computer Programming. Serving officers with two years' service in the grade of Analyst/Programmer (Job Group "J") will also be considered.

All candidates must have full responsibility for one or more complete systems from the investigation stage through to implementation.

Analyst/Programmer (Three Posts) (No. 32/77)

Salary scale.—K£1,350 to £1,794 per annum. PENSIONABLE or AGREEMENT.

Candidates should have a legree from a recognized university with one year's Programming or Systems experience or be in possession of an East African Advanced Certificate of Education together with three years' experience of Computer Programming. Serving officers with at least one year's service in the grade of Programmer (Job Group "H") will also be considered.

All candidates should be familiar with the ANS Cobol programming language but knowledge of DOS Fortran or Assembler will be advantageous. Before qualifying for final selection, applicants will be required to provide evidence of having obtained the programmes grade in a aptitude test to be conducted by or on behalf of the Ministry.

Programmer (Seven Posts) (No. 33/77)

Salary scale.—K£1,086 to £1,446 per annum. PENSIONABLE or AGREEMENT.

Candidates should have a degree from a recognized university or be in possession of an East African Advanced Certificate of Education plus two years' experience of Programming in ANS Cobol, Fortran or Assembler. Serving officers in the Computer operations cadre at Job Group "G" or "H" will be considered for redesignation or promotion respectively provided that they have served for not less than two years in their current post.

Before qualifying for final selection, applicants will be required to provide evidence of having obtained the Programmer grade in a Computer Aptitude Test to be conducted by or on behalf of the Ministry.

Tax Officer II (Twelve Posts) (No. 34/77)

Salary scale.—K£1,086 to £1,446 per annum. PENSIONABLE or AGREEMENT.

Candidates who should preferably be serving officers in the Government, must have considerable experience of income tax matters and must have served as Tax Assistants for at least three

years. Those outside the service must be in possession of a degree in Commerce, Economics, Law or any other equivalent and approved qualification.

Duties will normally involve handling more difficult allocations, checking and approving original assessments raised by Tax Assistants, Supervision of groups of Tax Assistant and taking an active part in their training and development.

Vacancies in the Vice-President's Office and Ministry of Home Affairs

Executive Assistant (Casino Inspector) (Four Posts) (No. 35/77)

Salary scale.—K£804 to £1,086 per annum. PENSIONABLE or AGREEMENT.

Applicants must be of School Certificate standard of education or its equivalent and must have Accounting experience of at least four years. Preference will be given to applicants who have knowledge in Government Regulations and Accounting Procedures and have successfully completed Executive Course either at the Kenya Institute of Administration, Kabete or at the Government Training Institute, Maseno. Knowledge of Betting, Lotteries and Gaming Act is advantageous. Successful candidates will be required to work on night shifts and will occasionally rotate duties in the four casinos in Nairobi and Mombasa.

Salary scale.—K£1,350 to £1,794 per annum. PENSIONABLE or AGREEMENT.

Applicants should have been educated to the E.A.C.E. level, hold a City and Guilds full Technological Certificate or equivalent and have a minimum of five years' practical experience of which at least capacity. Experience in the preparation and application of modren teaching aids and methods will be an advantage. The holding of a Grade I Trade Test Certificate in a relevant trade is desirable but not essential.

The successful candidate will be required to organize and administer their section at an Industrial Training Centre including the discipline and guidance of both staff and trainees, prepare course paterns and materials, syllabi and proficiency tests, maintenance of all machines, tools and equipment in his section and carry out instruction in all the trades handled by his section.

Assistant Instructor (Two Posts) (No. 37/77)

- (i) Automotive Electrician—(one post)
- (ii) Masonry-(one post)

Salary scale.—K£804 to £1,086 per annum. PENSIONABLE or AGREEMENT.

Applicants should have been educated up to E.A.C.E. level; have served a recognized Craft Apprenticeship and obtained the Final Proficiency Certificate or Grade I Trade Test or, alternatively hold the City and Guilds Final Craft Certificate followed by at least two years' practical experience. Industrial or Technical teaching experience will be an advantage.

Duties will include instructing or trade testing in all relevant trades; preparation of training material and the preparation, marking and assessment of trade and proficiency tests. Successful candidates will be expected to study for the qualification requirements of an Instructor during the first two years of service.

Accountant Grade II (One Post) (No. 38/77)

Salary scale.—K£1,086 to £1,446 per annum. PENSIONABLE or AGREEMENT.

Applicants should be of School Certificate Standard of education or equivalent. They should have passed CPA Part I or equivalent examination of a recognized professional accountancy body with three years' practical experience in Accountancy. Applicants with at least five years' experience at Accounts Assistant level will also be considered.

Successful candidate will be charged with control of expenditure in the Department as required in the Financial Orders and Regulations, establishing, supervising and inspecting the accounts of group ranches. In addition, he will be required to train

treasurers of group ranches in the best way of maintaining their books of accounts. He will also conduct correspondence and supervise junior staff.

Salary scale.—K£804 to £1,086 per annum. PENSIONABLE or AGREEMENT.

Applicants must be civil servants who are qualified in accordance with the Scheme of Service for Clerical Officers (Personnel Circular No. 3 dated 1st April, 1973). The person to be appointed should have apptitude in accounts and should have passed Stage II of the Accounts Clerk Examination of the K.N.A.S.E.B. He should have served as a Senior Clerical Officer (Accounts) for at least three years. His duties will be to assist the Accountant Grade II in his duties viz setting up books of accounts for the ranches, examination of the ranches accounts as well as coaching the group ranches in book-keeping.

Applicants must have had several years' experience of outside criminal investigation work (not as a dark-room expert) or as a police Divisional Comander or in the rank not below that of Chief Inspector. They must be able to take lucid written statements in English or Swahili in an acceptable manner and must have a comprehensive knowledge of court procedures, preparation of case files and prosecution of cases in court.

Some knowledge of the tourist industry and at least one additional European language will be an advantage but not essential. The selected candidate must be prepared to travel extensively everywhere in Kenya.

Candidates from outside the Civil Service must be in possession of East African Advanced School Certificate or its equivalent with a minimum of two appropriate subjects at principal level and one subject at subsidiary level. Consideration will also be given to serving clerical in possession of a good East African School Certificate or its equivalent, with a minimum of three years' service in the Income Tax Department.

Selected candidates will undergo a two years' training programme which will be a combination of formal course interspersed with on the job training. Trainees will be trained on Income Tax Assessment, collection and accounting. Candidates who are selected to attend this course will be appointed as Tax Collection Assistant (Trainees) on Job Group "D", salary scale: K£369 by £15 to £399 by 18 to £489 by £21 to £531 per annum. Trainees in possession of the East African Advanced School Certificate will enter Job Group "D" at K£471 per annum. Any serving clerical officer selected for the course will continue to draw his/her present salary in Job Group "D/E" and will be eligible for the normal increment during the first year.

On successful completion of the first year of the course, trainees will be advanced to Job Group "F", salary scale: K£594 by £21 to £714 by £30 to £834 per annum and on passing the final "Tax Collection Assistant Qualifying Examination" at the end of course, trainees will be appointed as Tax Collection Assistant, Job Group "G", salary scale: K£804 by £30 to £864 by £36 to £1,044 by £42 to £1,086 per annum.

#### THE GOVERNMENT LANDS ACT

(Cap. 280)

NAIROBI-EMBAKASI VILLAGE CENTRE-COMMERCIAL PLOTS

THE Commissioner of Lands invites applications for alienation of commercial plots in the above area as described in the schedule hereto. A plan of the plots may be seen in the Lands Department or may be obtained from the Public Map Office, P.O. Box 30089, Nairobi on payment of Sh. 4.

- 2. Applications must be sent to the Commissioner of Lands, P.O. Box 30089, Nairobi, so as to reach him not later than noon on Friday, 11th March, 1977.
- 3. Applicants must enclose with their applications a sum of Sh. 1,000 in cash or send a postal order, money order or banker's order made payable to the Commissioner of Lands as deposit. No cheques will be accepted. The deposit will be dealt as follows:—
  - (a) If the applicant is offered and takes up and pays for the plot within the period of 14 days as required by paragraph No. 5 below, the deposit will be credited to him.
  - (b) If the application is unsuccessful, the applicant's deposit will be returned to him.
  - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required by paragraph No. 5 below, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.
- 4. Each application should be accompanied by a statement indicating:—
  - (a) the amount of capital it is proposed to spend on the project;
  - (b) the amount of actual capital available for development with a banker's letter or other evidence of financial status in support;
  - (c) the manner in which it is proposed to raise the balance of the capital required for development, if any;
  - (d) full details of both residential and/or commercial properties owned by the applicant in Nairobi City.
- 5. The successful allottee of the plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been successful, the stand premium and proportion of the annual rent together with conveyancing, stamp duty and registration fees, contributions in lieu of rates and provisional service charges. In default of payment within the specified time, the Commissioner of Lands may cancel the allotment and the applicant shall have no claim to the plot.

#### General Conditions

- 1. The grant will be made under the provisions of the Government Lands Act, (Cap. 280 of the Laws of Kenya), and title will be issued under the Registration of Titles Act, (Cap. 281).
- 2. The grant will be issued in the name of the allottee as given in the letter of application and will be subject to the Special Conditions set out below.
- 3. The term of the grant will be for 99 years from the 1st day of the month following the issue of the letter of allotment.

#### Special Conditions

- 1. No building shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2. The grantee shall within six months of the commencement of the term submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in comformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner.

Provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner in respect of any antecedent breach of any condition herein contained.

- 3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.
- 4. Should the grantee give notice in writing to the Commissioner of Lands that he/she/they is/are unable to complete the buildings within the period aforesaid, the Commissioner of Lands may (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term, the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to the expiration of the said building period, the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premim. In the event of notice being given after the expiration of the said building period, no refund shall be made.

- 5. The land and buildings shall only be used for shops offices and flats (excluding sale of petrol).
- 6. The buildings shall conform to a type plan laid down by the Nairobi City Council.
  - 7. The grantee shall not subdivide the land.
- 8. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof except with the prior consent in writing of the President: no application for such consent except in respect of a loan required for building purposes) will be considered until Special Condition No. 2 has been performed.
- 9. The grantee shall pay to the Commissioner of Lands on demand such sum as the Commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.
- 10. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner may assess.
- 11. Should the Commissioner of Lands at any time require the said roads to be constructed to a higher standard, the grantee shall pay to the Commissioner on demand such proportion of the cost of such construction as the Commissioner may assess.
- 12. The grantee shall pay such rates, charges, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President in lieu thereof.
- 13. #### THE INDUSTRIAL COURT

Cause No. 76 of 1976

Parties:--

Kenya Local Government Workers' Union

and

Masaku County Council

Issue in dispute.—Failure by the Council to pay Mr. Kanessi Mulandi his terminal benefits.

- 1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and Masaku County Council shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 10th day of January, 1977, and relied on their written and verbal submissions.

#### Award

3. The Notification of Dispute Form "A" dated 12th January, 1976, duly signed by the parties was received by the Court on 4th October, along with the statutory certificate signed by the Labour Commissioner.

The terminal benefits which the Claimants are seeking on behalf of their member, Kanessi Mulandi, are his Provident Fund dues amounting to Sh. 5,801/40 less Sh. 3,069/50 which the Claimants admit the Respondents are entitled to deduct from this amount as Mr. Mulandi admitted in writing on 21st January, 1970, when he officially handed over to another person that there was a shortage of Sh. 3,069/50 against him and which he promised to pay.

The Claimants have conceded that there is no doubt that Mr. Mulandi had misbehaved and had delayed the teachers' salaries and he was therefore properly dismissed on 20th January, 1970. The letter of dismissal appears in the Respondents' submission as appendix 2.

As stated above, on 21st January, 1970, he handed over to another officer and signed the aforesaid undertaking regarding the shortage of Sh. 3,069/50 but surprisingly in another document prepared on the same date by the Salaries Officer and Receipts Cashier they reported to the Treasurer of the Respondents that the total amount missing was Sh. 5,647/55. It is obvious that Mr. Mulandi did not accept any liability in excess of Sh. 3,069/50.

On 11th March, 1970, the Respondents through an advocate demanded a sum of Sh. 5,647/55 from Mr. Mulandi made up as follows:—

"Amount due as per agreed in writing on 21st January, 1970 ... ... ... ... ... 3,069 50

The amount you have to refund to my above clients of 1969 of which particulars fully known to you ... ... ... ... 2,578 05

Sh. 5,647 55."

The advocate, however, did not proceed to file action against Mr. Mulandi and the matter was just left there.

In the meantime, on 23rd January, 1970, Mr. Mulandi had been charged in the criminal court with stealing two amounts of Sh. 4,024 and Sh. 1,286 from the Respondents while he was employed by them as a clerk. On 10th February, 1970, he was acquitted and discharged.

The Respondents took a decision vide Minute No. TS28/70 regarding the terminal benefits due to Mr. Mulandi and the Minute reads as follows:—

"The Committee were informed that Kanesse Mulandi had been dismissed from the Council's service in consequence of gross misconduct and loss of Council's funds to the extent of Sh. 5,647/55 for which he had been charged and tried before the Machakos Resident Magistrate's Court. Although the defendant in this case was acquitted of the criminal charge, the Committee noted with great concern that the Council still sustained a financial loss of Sh. 5,647/55 and it was necessary for the Council to recover the loss from the officer concerned.

After a lengthy discussion, the Committee recommended that the loss be recovered from the officer's Provident Fund contributions and the balance of his refund of Provident Fund be paid over to him together with any other terminal benefits due to him.

Proposed by Councillor Nason Muthembwa.

Seconded by Councillor D. S. Mutune."

Consequent upon the aforesaid decision necessary forms were completed for refund of the dues of Mr. Mulandi from the Local Authorities Provident Fund Board (hereinafter referred to as L.A.P.F.B.). In Form PF5 the reason for closure is given as "dismissed for fraudulence" and it was stated that the relevant section of the Act applicable was 15 (1) (c) (i). The total amount in account is shown as Sh. 5.801/40 and it is stated that nil amount was due to the contributor or his legal representative and the form is dated 17th October, 1970.

On 18th January, 1971, the Secretary, L.A.P.F.B., wrote to the Respondents' Treasurer forwarding a cheque for Sh. 5,801/40 and stated as follows in the last paragraph:—

"If Mr. Kanasse was dismissed for misconduct or inefficiency his entitlement would have been Sh. 2,900/70 which is half of the total balance. But since he was dismissed in consequence of fraudulence he has to forfeit all the claim to the Council. His due excluding Council's contributions is by far less than the amount he is alleged to have misappropriated. The contributor does not qualify for any Council's due. Therefore under section 15 (1) (c) (i) of the Provident Fund Act, Mr. Kanasse has to forfeit all the entitlement to the Council."

As Mr. Mulandi was not paid his Provident Fund dues the Claimants reported the dispute to the Minister for Labour on the issue of wrongful dismissal, and the Chief Industrial Relations Officer recommended after an investigation was carried out that Mr. Mulandi's dismissal should be reduced to normal termination of employment and he should be paid all his terminal benefits including the payment of Provident Fund entitlements. This recommendation was issued to the parties on 21st May, 1974, the Claimants having reported the dispute to the Minister for Labour on 10th October, 1973.

The Claimants pressed for a payment to Mr. Mulandi in accordance with the Chief Industrial Relations Officer's recommendation but did not meet with any success.

In between, Mr. Mulandi started corresponding direct with the Respondents after having asked the Claimants' General Secretary to re-start his dispute with the Claimants after reading about an Industrial Court ruling in another case which he thought was similar to his. The Respondents informed him after giving him all the calculations that he had been paid all his dues and that he had no further claims against them and they asked the Claimants to treat the matter as closed. In these calculations they had deducted a sum of Sh. 5,647/55 which they stated was by way of recovery of shortages.

It is interesting to note that on 28th October, 1974, the Respondents at a meeting resolved to pay Mr. Mulandi his Provident Fund and this Minute reads as follows:—

"The Acting Clerk read a letter to the Committee from Ministry of Labour of 21st May, 1974, about payments of Mr. Kanesse Mulandi who was dismissed from Council's service few years back.

After a long discussion it was-

Proposed by Councillor D. Mutiso,

Seconded by Councillor Samuel Maingi

That as recommended by the Chief Industrial Relations Officer, Mulandi be paid all his terminal benefits including payment of Provident Fund entitlement.

Carried unanimously."

The Claimants have based their case mainly on this resolution which they said rescinded the Respondents' earlier resolution under Minute TS 28/70. They maintained that Mr. Mulandi is entitled to full dues from the Provident Fund less the amount which he admitted he owed to the Respondents.

The Claimants further argued that when monies were paid out from the Provident Fund under a normal termination then Form PF5 is used which had been used in the case of Mr. Mulandi and if it had been a case of termination due to gross misconduct then Form PF4 would have been used but this form had not been used in this case.

The Claimants also submitted that the L.A.P.F.B. under the chairmanship of their General Secretary, Mr. Karebe, had made recommendations to the Minister that full payment should be made to Mr. Mulandi and the Minister had powers to waive certain provisions of the Local Authorities Provident Fund Act which powers he exercised as a result of which a cheque was sent to the Respondents for Mr. Mulandi. The Respondents were, therefore, wrong in saying that Mr. Mulandi was not entitled to any dues under the Provident Fund Act.

The Respondents have relied on section 15 (1) (c) of the Act in resisting this claim. This section reads as follows:—

"15. (1) Subject to the provisions of this Ordinance, a contributor who voluntarily resigns from, is dismissed from or leaves the service of a local authority for any reason or in any circumstances other than those specified in section 14 of this Ordinance shall be paid such proportion of the balance standing to the credit of his account in the Fund as is specified hereunder, according to the circumstances—

(c) in the case of dismissal from the service of a local authority for misconduct or inefficiency, one half of the credit balance in the contributor's account:

Provided that-

- (i) where the dismissal is in consequence of an offence of a fraudulent character, or of grave misconduct, the person dismissed shall forfeit all claim to any payment under this Ordinance:
- (ii) notwithstanding paragraph (i) of this proviso, the Board may, on the recommendation of the local authority, return to him out of the Fund, or pay to his wife or family out of the Fund, a sum equal to the amount of all his contributions thereto under this Ordinance, or to such part thereof as the local authority shall think fit."

The Respondents argued that there is no doubt that Mr. Mulandi had been dismissed for having misappropriated their funds and therefore he had forfeited all claim to any payment from the Provident Fund. In any case at the most if he was to get anything under (c) (ii) he was entitled to his share of the contributions which in this case were Sh. 2,900/70. If the Court were to find that Mr. Mulandi was entitled to his share of the contributions even then the Respondents had nothing to pay him because he owed them a sum of Sh. 3,069/50 in respect of which he had given a written undertaking.

The Court is satisfied that Mr. Mulandi was dismissed for gross misconduct and in fact although a wrong form may have been filled by the relevant authority the reason on Form PF5 is given as "dismissed for fraudulence".

The Court has to decide if the Respondents, or the Claimants for that matter, can override the statutory provisions. The Respondents passed a resolution on 28th October, 1974, which is stated hereinabove and resolved that Mr. Mulandi should be paid all his terminal benefits including payment of Provident Fund entitlement and the Court finds that since Mr. Mulandi had been dismissed from the Respondents' service for misconduct he is entitled to only one half of the credit balance in his account which is Sh. 2,900/70 as the parties cannot under any circumstances override the statutory provisions which were properly explained to the Respondents' Treasurer by the Secretary of the L.A.P.F.B. on 18th January, 1971.

The circumstances and the facts in Cause No. 58/73 on which the Claimants have relied are not on all fours with the present dispute and the Court finds that that dispute is not relevant to this one.

The Court must record that the Claimants did not pursue this dispute on the basis of Mr. Mulandi's wrongful dismissal and they are asking for the payment to be made to him of Sh. 5,801/40 the total amount to his credit in the Provident Fund including the Respondents' contributions less Sh. 3,069/50 leaving a balance of Sh. 2,731/90.

The Court finds that at the most under the circumstances of this dispute Mr. Mulandi could be entitled to a sum of Sh. 2,900/70 from the Provident Fund but since he caused a shortage amounting to Sh. 3,069/50 as stated above and he undertook to make it good to the Respondents, the Court finds that he is not entitled to any further terminal benefits. The Claimants' demand is accordingly rejected.

The Court would like to add a rider to this award as both the parties did not make any submissions on a point which the Court feels is of considerable importance in disputes concerning claims connected with dues from the Local Authorities Provident Fund. Section 23 of the L.A.P.F. Act reads as follows:—

"Any question concerning the rights or liabilities of an employee of a local authority, or of a person claiming to be treated as such any employee, under any of the provisions of this Act or of any regulations made under this Act, shall be decided in the first instance by the authority concerned, and, if the employee or person aforesaid is dissatisfied with any such decision or with the authority's failure to come to a decision, shall be determined by the Minister, and the Minister's determination shall be final."

A close scrutiny of this section reveals that the Minister's determination is final on any question concerning the rights or liabilities of an employee of the Local Authority under any of the provisions of this Act. That being the position it is indeed questionable if the Industrial Court has any jurisdiction over claims of this nature. The Court would like the parties to examine this provision carefully for future reference.

The Claimants at one stage during the proceedings asserted that the Minister had waived certain provisions of the Act in order to enable Mr. Mulandi to get all his dues from the Provident Fund. No documentary evidence, however, was produced to show any such waiver. The Claimants wrote a letter to the Court on 1st February, 1977, and stated therein as follows:—

"Please refer to our telephone conversation, when you requested us to send the Minister's waiver. This is not possible to obtain as we do not have access to Ministry's documents or Minutes. When we promised to send such a document we expected co-operation from the Ministry.

"The argument was however based on procedure of payments as a result of Minutes of the Council, Minute 33/74 (see page 3 Union memo.). It appears that the Minister did consent to the Minutes because the action taken in January (see appendix 14 employers memo.) agrees with what the Minutes was seeking. The full amount could not have been paid to Mr. Mulandi without Minister's consent otherwise a surcharge would have been made on the Council officers for irregular expenditure. The only question is the deduction of an amount different to what Mr. Mulandi agreed during the handover-takeover after his dismissal."

The Court is not prepared to find that what the Claimants have stated in their letter can constitute a waiver by the Minister of any provisions of the Act in favour of Mr. Mulandi.
