THE INDUSTRIAL COURT

Cause No. 38 of 1976

Parties: --

Kenya Local Government Workers' Union

and

Nakuru Municipal Council

Issue in dispute:--

Arbitrary deduction of Sh. 6,532/30 from John Onyango.

- 1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Nakuru Municipal Council shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 19th day of January, 1977 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 26th March, 1976, duly signed by the parties was received by the Court on 3rd June, 1976, along with the statutory certificate signed by the Labour Commissioner.

The Claimants are seeking the refund of a sum of Sh. 6,532/30 to their member J. Onyango, an employee of the Respondents, which amount they claim was arbitrarily and wrongfully deducted from Onyango's salary in monthly instalments of Sh. 181/45. The last instalment to complete Sh. 6,532/30 will be deducted in February, 1977.

The history of this dispute goes back to February, 1970, when Onyango, who at that time was an assistant foreman in charge of maintenance in the housing department, was instructed to carry out some work which involved painting of some staff houses, and some general other maintenance work which involved the use of rolls of wire and cistern tanks.

The Respondents alleged that when the work was completed they suspected that more paint and materials were used than was necessary to complete the work then undertaken. The Respondents' Internal Auditor was instructed to carry out the necessary investigations and the investigations revealed that paint and materials as specified below valued at Sh. 6,532/30 were unaccounted for—

The Respondents explained how they had arrived at their aforesaid conclusions and stated that Onyango was called upon by the Municipal Treasurer to show cause why he should not be held responsible for the above paint and how the wire had disappeared. They alleged that Onyango failed to give a satisfactory explanation and the Finance Committee met on 21st April, 1971, and decided that the sum of Sh. 6,532/30 should be recovered from Onyango's salary to make good the loss of paint and wire. The deductions started in June, 1971.

Subsequently after Onyango had expressed his dissatisfaction with the Respondents' decision the matter was discussed by Joint Staff Council at a meeting held on 4th May, 1972, when under minute 37 the following was recorded—

"Salary deductions-John Onyango.

The Union having elaborated on the above item and the Council having heard the reports of the Municipal Treasurer and Housing and Estates Officer thereon it was agreed:—

1. That the above item be deferred to allow the Municipal Treasurer to study the Internal Auditor's report in connexion with the case to enable him to submit the necessary report to the Finance Committee for further consideration.

That if the Finance Committee is satisfied that there was no misappropriation of the Council's property the money deducted from Onyango's salary be refunded to him."

The matter was further discussed by the Establishment and appointment Committee on 19th September, 1972, when as a result of a report made by the Municipal Treasurer who stated that since the Deputy Town Engineer and the union representative had gone into details of the matter and had found that there was definitely misappropriation of Council's paint, it was decided that the necessary deductions should be continued from Onyango's salary to make up for the loss of paint.

The Claimants were certainly not happy at this and raised up the matter again and the Establishment and Appointment Committee met on 17th May, 1973, and noted the report of the Housing and Estates Officer that two coats of paint had been applied to the houses that were painted and that the Internal Auditor had assumed that only one coat of paint was used and agreed that the deduction from Onyango's salary should be stopped forthwith and the money so far recovered from him be refunded forthwith. The money that had been deducted as at that date was accordingly refunded to Onyango.

At a later date at the initiative of the Respondents' External Auditors who had raised queries about the lost paint and other materials the Controller and Auditor-General wrote to the Respondents on 14th May, 1974, and advised them that the said sum of Sh. 6,532/30 should be recovered. The deductions commenced on 31st August, 1974, and as stated above they are to be completed at the end of February, 1977.

The Claimants while agreeing with the historical background to the dispute have seriously questioned the Respondents' right to deduct an employee's salary in such an arbitrary manner on an allegation that he was responsible for the loss of paint and materials to the value as stated above. They maintained that it could be only one of two things, that is either Onyango had stolen the paint and the materials or he had been extravagant in their use. They argued that since the Respondents did not report the matter to the police at any stage it would be a fair assumption that the question of theft did not arise and that would leave only the assertion that Onyango had used the paint and the materials extravagantly. If that was the case then the Respondents had failed to prove how extravagant Onyango had been and raised the question if any employer was entitled to deduct an employee's salary by merely asserting that an employee had been extravagant in the use of the employer's materials.

The Claimants referred the Court to an agreement which they had made with the Respondents in the presence of a Ministry of Labour Conciliator on 12th August, 1975, where it was agreed as follows—

"(c) that item No. 2 of the reported trade dispute namely deduction of Sh. 6,532/30 from the salary of John Onyango be subject to an independent report by the investigator to the Minister for Labour as stipulated by section 7 (3) of the Trade Disputes Act, Cap. 234 of the Laws of Kenya."

The Ministry of Labour's findings and recommendation were as follows:—

"Findings

This is a difficult and tricky case in which the Council was not keen to make recoveries of Sh. 6,532/30 which the Council Internal Auditor had discovered to be the value of paint allegedly misused by Onyango on completion of his assignment. Ultimately the issue reached the Controller and the Auditor-General via information supplied by the External Auditors who checked on the Council's overall performance. The Controller and Auditor-General directed that the money be recovered.

With due respect to the Internal Auditor calculations of the amount of paint which was missing/misused, Onyango was not charged with the theft of the product. He may have been negligent in carrying out his duties but even this was not conclusively established. One is led to the conclusion that it was because of their doubts that the Council was prepared to waive the internal auditors recommendation that the cost of the missing/misused paint be recovered from Onyango's salary.

Recommendation

After careful consideration of all the submission it is recommended that, as intended before and agreed between the Union, Onyango be not required to pay for the missing/misused paint. The money deducted from his salary should be refunded to him."

The Claimants further submitted during the hearing a document in which they have given detailed explanation of how the paint and the materials for the various houses involved were used and said that they relied on this document to prove that there had been no extravagant use of the paint or loss of materials as alleged by the Respondents.

The Respondents, however, during the hearing produced a letter written by Onyango to the Municipal Treasurer on 19th July, 1971, where he had given a lengthy explanation for the unaccounted items involved. In this letter Onyango has tried to explain that he had used the paint on other houses in other estates as well apart from the ones that he had been instructed to renovate; he further said that there was a possibility that since the conversion from gallons into litres it was possible that the litres had been counted as gallons as one of the causes for excessive paint consumption. And in the end he wrote as follows:—

"The figures quoted above by me can be verified from the daily job allocation sheets and the monthly allocation of wages, I trust the above will now satisfy your enquiries and I wish to point out that I have not been given any written information that I shall be made responsible for this cause and to be covered from my salary I therefore beg to request you to reconsider your decision of deducting Sh. 150 from my salary every month."

The Respondents have explained in detail in their written submission how they had assessed the quantity of paint that would have been sufficient for the houses from surface areas. They stated they had established that 13 gallons would cover 10,400 sq. ft. which was approximately the size of a large house of 9,883 sq. ft. They had accordingly assessed that 13 gallons of paint were required for all houses except house No. 305/107 which required two coats of paint and for which they had made an allowance of 26 gallons.

The Court finds itself in considerable difficulty in this dispute because some six years after the event both sides have during the hearing put forward details of a technical nature regarding the amount of paint that could have been used in renovating certain staff houses belonging to the Respondents. There is no evidence whatever to show what was the state of these houses before the paint work commenced.

To make matters worse the Respondents have not acted consistently over this matter in that having once commenced deductions from Onyango's salary to recover the alleged cost of paint extravagantly used by Onyango they subsequently reversed their decision and refunded all the deductions made when the Housing and Estates Officer had reported that two coats of paint had been applied to the houses that were painted and that the Internal Auditor upon whose report the deductions had commenced had estimated that only one coat of paint was used.

The Court notes that the Claimants have stated during the proceedings that the Respondents' calculations did not include the servants' quarters and the face walls. Furthermore they alleged that the kitchens were in such a state that more than two coats were required therein. Then they quoted a few incidents when the tenants had insisted on changing the colour scheme which had necessitated repainting the houses.

Subsequently the Respondents at the behest of the External Auditor had recommenced to recover the aforesaid sum of Sh. 6,532/30.

Onyango has also given three different stories regarding the excess paint used. To begin with when the Respondents asked him to show cause why he should not be held responsible for refunding the above amount he failed to offer a satisfactory explanation as to how the paint had disappeared. Then he had written a letter on 19th July, 1971, in which he had given explanation in respect of these items. The Court notes that the Claimants were taken by surprise at this letter written by their member when it was produced by the Respondents as they were not aware that their member had written such a letter previously. The explanation given in this letter cuts directly

across the latest explanatory document which the Claimants submitted during the hearing and in which they tried to justify that Onyango had not either stolen any paint or had used it extravagantly.

In view of the aforesaid very unsatisfactory feature of this dispute and had the matter come to the Court much earlier the Court would have asked an outside expert to give a technical opinion and assessment over the amount of paint that could have been used in renovating the houses involved. But in the present circumstances of this dispute the Court feels that such an exercise would be futile. So the Court has to make a decision on the submission before it.

The employer has a right to deduct from the wages of his employee a reasonable amount for any damage done to or loss of any property lawfully in the possession or custody of an employer occasioned by the wilful default of the employee. The Court must, however, state that before an employer is allowed to exercise his right as stated he must be in a position to conclusively prove all aspects of the alleged loss for which he is holding the employee responsible. In the present dispute the Respondents have not proved conclusively any such loss. In fact the Court feels that they have handled this whole matter in a poor manner which is directly attributable to poor management and lack of adequate supervision.

The Court, however, is left with one very damaging piece of evidence against Onyango and that is his letter of explanation dated 19th July, 1971, which even took his own representatives by surprise and which highlights that Onyango had certainly contradicted himself in his defence.

After careful consideration of all the submissions the Court has come to the conclusion that the Respondents did lose a certain amount of paint which has not been accounted for and the materials as alleged. But on the other hand the Court also accepts that the paint that was used on the houses was more than what was assessed by the Respondents.

The Court having already pointed out the difficulties at arriving at an accurate assessment of the loss that the Respondents have suffered due to Onyango's actions the Court finds that a fair solution lies in apportioning the loss of Sh. 6,532/30 between both the parties in equal proportion. The Court accordingly awards that half of the amount deducted from Onyango's salary should be refunded to him. The Court would like to record that Onyango is still in the service of the Respondents although he is now on different duties.
