#### PUBLIC SERVICE COMMISSION OF KENYA

#### VACANCIES

APPLICATIONS are invited for the posts shown below. Completed application forms should reach the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, on or before 26th May, 1977.

Civil servant applicants should complete Forms PSC.2A in triplicate (submitting the original through their Heads of Departments) and Cards PSC.25 and 25A. Other applicants should complete Forms PSC.2 in triplicate and Cards PSC.24 and 24A.

These documents are obtainable either from the Secretary or from other Government offices.

Originals of certificates and similar documents should not be submitted unless specifically asked for.

#### Note

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with the existing Government Regulations.

#### VACANCIES-PUBLIC SERVICE COMMISSION-(Contd.)

Vacancies in the Ministry of Water Development (Mombasa and Coastal Water Supply):

Draughtsman Grade III (One Post) (No. 106/77)

Salary scale.—£804 to £1,086 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of an East African Certificate of Education or its equivalent. They should have had approved training in civil and mechanical engineering draughting and have had at least three years' progressive engineering practice in addition. They must have served for at lest a minimum of two years as assistnt draughtsman Grade I and must have obtained the grade one certificate at the Kenya Polytechnic or its equivalent. Non civil servants should be in possession of City and Guilds Diploma in Civil Engineering.

Preference will be given to those with experience in Water Supply, Draught and Cartography. Ability to work up sketches into finished drawings and a command of English are essential.

The successful candidate must be prepared to work in Coast Province under the Ministry of Water Development.

Senior Machine Operator (One Post) (No. 107/77) Salary scale.—£594 to £834 p.a. PENSIONABLE or AGREE-MENT.

Applicants must be civil servants in possession of East African Certificate of Education or its equivalent. They must have served for at least four years as Mechanized Ledger Clerk Grade I. Ability to supervise staff and conduct correspondence is essential.

The successful applicant must be prepared to work in the Coast Province under the Ministry of Water Development.

Vacancy in the Ministry of Finance and Planning

Input/Output Control Officer II (One Post) (No. 108/77)

Salary scale.—£594 to £834 p.a. PENSIONABLE or AGREE-MENT.

Applicants should preferable be of the East African Certificate of Education Division III or above with a minimum of one year's experience in the data-control and job-assembly section of a main-frame computer installation.

Before qualifying for final selection, candidates will be required to sit and acquire an appropriate passmark in a computer aptitude test to be conducted by or on behalf of the Ministry.

Vacancy in the Ministry of Works:

Chargehand (Building) (One Post) (No. 109/77)

Salary scale.—£594 to £834 p.a. PENSIONABLE or AGREE-MENT.

Candidates should possess the East African Certificate of Education or its equivalent. They should be in possession of a minimum of a Trade Test Grade II and must have a J.B.S. Certificate or its equivalent; or

Applicants must be of a good standard of Education and be able to write and read English. They must be in possession of a Trade Test Grade II, minimum in carpentry or masonary or plumbing and must be able to read architectural and engineer's drawings and to prepare a list of materials required for a simple job in their own particular trades; or

Candidates should be Artisans Grade I who have been in continuous employment in that grade for a minimum period of three (3) years.

They should in addition have knowledge of the following:-

- (a) Control of Public Funds.
- (b) Maintenance of Public Buildings Procedure.
- (c) Control of stores and staff.
- (d) Contract procedure.

Duties.—The successful candidate will be responsible for organization of the work of a gang of artisans of his particular trade under direct supervision of a more senior officer.

Vacancy in the Ministry of Labour (N.S.S.F.):

Caretaker/Senior Security Warden (One Post) (No. 110/77)

Slary scale.—£804 to £1,086 p.a. PENSIONABLE or AGREE-MENT.

Applicants should preferably be civil servants of mature age of East African School Certificate Standard of Education or

its equivalent with at least three years' experience in Security duties in establishments which require concerted security control. Preference will be given to applicants from Police and Prison Services who hold responsible positions. A sound knowledge of English and Swahili and ability to control and supervise a large cleansing staff and watchmen is essential.

Successful candidate will be responsible for the security of the Social Security House where he will live and must be prepared to work at odd hours.

Duties include supervision of subordinate staff, cleanliness and orderliness of premises and responsibility for equipment, fixtures and fittings.

Vacancy in the Ministry of Natural Resources:

Executive Assistant (One Post) (No. 111/77)

Slary scale.—£804 to £1,086 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants preferably of School Certificate Standard of Education with at least three years' satisfactory experience of Government office routine, a sound knowledge of accounting procedures, Government regulations and ability to conduct correspondence and control staff. Preference will be given to applicants who have successfully completed an Executive course either at the Government Training Institute, Maseno or the Kenya Institute of Administration, plus a pass in Proficiency Examination.

#### THE LAND ACQUISITION ACT, 1968

(No. 47 of 1968)




