KENYA GOVERNMENT OCCUPATIONAL TESTS FOR STOREMEN, 1977

YOUR attention is invited to the Personnel Circular No. 20 dated 17th August, 1968, in which the details for Occupational Tests Nos. I, II and III for Storemen were published.

In this connexion, it is notified for general information that this year's Occupational Tests Nos. I, II and III for Storemen will be held on Thursday, 25th and Friday, 26th August, 1977, at all the provincial centres, in accordance with the following terms and conditions:—

SCHEME OF THE EXAMINATIONS

2. Each examination will consist of the following Test Papers:—

(i) Storeman Examination III

- (a) English Language Paper (1 hour). (This paper will be set at the same level as that of Certificate of Primary Education—C.P.E.)
- (b) Practical Paper (2 hours).

(ii) Storeman Examination II

- (a) English Language Paper (2 hours). (This paper will be set at the same level as that of the former Clerical Examination.)
- (b) Arithmetic Paper (2 hours). (This paper will be set at the same level as that of the former Clerical Examination.)
- (c) Practical Paper (2 hours).

(iii) Storeman Examination I

Practical Paper only (2 hours).

ELIGIBILITY TO ENTER

3. The examinations are open to civil servants only, who must be Kenya citizens serving with the Government of Kenya, and in the case of:—

- (a) *Storeman Examination III* should be serving subordinate staff employed exclusively on stores duties, and with at least two years' service.
- (b) *Storeman Examination II* should be serving Storemen Grade III officers who have served for at least two years as Storemen Grade III.
- (c) *Storeman Examination I* should be serving Storemen Grade II officers with at least two years' satisfactory service as Storemen Grade II.

EXAMINATION FEES

4. A Registration Fee of K.Sh. 10 only will be paid by every candidate entering any of the three Storeman Examinations listed under paragraph (2) above, irrespective of the number of subjects the candidate is sitting. The fee, which will not be refundable under any circumstances, will be payable to the Secretary, Public Service Commission of Kenya, in either a crossed E.A. Money Order, E.A. Postal Order or cash. Personal cheques will not be accepted.

ENTRIES

5. Candidates must complete the examination entry forms in triplicate as set out in "Appendix" to this circular letter, copies of which can be reproduced and cyclostyled by each Ministry/Department as required, and the completed entry forms, duly certified correct by the candidates' Permanent Secretaries/Heads of Departments and accompanied by the registration fees of K.Sh. 10 per candidate, should be submitted to the Secretary, Public Service Commission of Kenya, N.H.C. House, Aga Khan Walk, Off Harambee Avenue, P.O. Box 30095, Nairobi, so as to reach him not later than Friday, 17th June, 1977. Late entries, incomplete or wrongly filled in entry forms and the entries not accompanied by the correct registration fees, will automatically be rejected.

EXAMINATION CENTRES

6. The examinations will be held in all Provinces at Mombasa, Nyeri, Embu, Nairobi, Nakuru, Kakamega, Kisumu and Garissa Centres. Candidates must specify at which centre they wish to sit the test, which should normally be that nearest to their station. The actual examination venue at each Provincial Centre will be notified to the candidates in due course.

EXAMINATION QUESTION PAPERS AND STATIONERY

7. (i) Examination stationery and test papers for these Occupational Tests will be supplied to the candidates by the P.E.O.s in charge of the Provincial Examination Centres. All candidates will, however, bring with them their own pens, pencils, rulers and ink. No other articles such as books, magazines, etc., will be permitted into the examination room.

(ii) *Answer Covers*.—It has been decided that from now on, candidates for all Government Examinations conducted by the Public Service Commission of Kenya, will not be allowed to write their names or their Ministries/Departments on the Answer Blue Covers, as has been the practice in the past. It will be necessary, however, for each candidate to write clearly on the Answer Blue Covers provided for each paper, the following:—

- (a) Name of the Examination.
- (b) Subject's Title.
- (c) His/Her Examination Index No. and
- (d) His/Her Examination Centre.

CONDITIONS FOR OBTAINING A PASS

8. In order to obtain a full pass in the appropriate examination, a candidate must pass every paper at one and the same sitting. There will be no partial passes and the names of successful candidates will be published in the Kenya Gazette. No certificates will be issued to the successful or any other candidates, and no syllabuses are available for these examinations.

EXEMPTION

9. Exemption from sitting the English and/or Arithmetic Papers will be in accordance with the provisions of paragraphs 3 (1) (i) (b) and 3 (2) (i) (c) of Personnel Circular No. 20 of 17th August, 1968, the Scheme of Service for Stores Cadre. It is emphasized that the Permanent Secretaries/Heads of Departments should ensure that only those candidates who obtained credits in the English and/or Arithmetic Papers in their E.A.C.E. Examination, or "O" Level Passes in their London General Certificate of Education Examination, are granted exemption in the same subjects for Occupational Test No. II. Mere E.A.C.E. Examination passes in the two subjects will not qualify the candidates for any exemption. Holders of C.P.E. Certificates (or its recognized equivalents) will be exempted from sitting the English Paper only, of the Storeman Examination III.

GENERAL CONDUCT OF THE EXAMINATIONS

10. Candidates will not be allowed to consult any books, files, notes, etc., during the examination, and any infringement of this rule will result in immediate disqualification from the whole examination and may also lead to disciplinary action being taken against the offenders. Examination papers and stationery will be supplied by this office, while the Provincial Education Officers in charge of the provincial centres, will be responsible for the distribution of the papers and stationery to their centres, appointment of invigilators, arrangement of the examination venues in their respective centres, and return to this office, of the candidates' answer scripts when the examinations are concluded, as directed by the Public Service Commission of Kenya.

CERTIFICATES

11. No certificates will be issued to successful candidates in the Occupational Tests, but names of the successful candidates will be published in the Kenya Gazette in the normal way.

FINAL DECISION

12. All in all, the decision of the Public Service Commission will be final in all matters related to these examinations. Correspondence from the candidates pertaining to the final results of the examinations will not be entertained by the Public Service Commission of Kenya.

CAUSE No. 69 OF 1976 (3)

Parties:—

Kenya Union of Commercial Food and Allied Workers
and

Kenya Commercial Bank Limited

Issue in dispute:—

Termination of services of Mr. S. K. Muthee without just and reasonable cause.

1. The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the Kenya Commercial Bank Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 24th and 27th April, 1977 and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:—

Claimants.—Mr. S. K. Muthee.

Respondents:—

Mr. E. Karanja.

Mr. J. Nyarwati.

AWARD

3. The Notification of Dispute Form "A" dated 5th August, 1976 duly signed by the parties was received by the Court on 17th September, 1976 along with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. S. K. Muthee worked for the Respondents from 12th March, 1968 up to 24th February, 1973 when his services were terminated. At the time he was working at the Respondents' Thika branch at a monthly salary of Sh. 975 p.m.

He was arrested by the police and charged in the criminal court. This case, however, was withdrawn by the prosecution and Mr. Muthee was discharged under section 87 (a) of the C.P.C. It appears that when the case was listed for hearing the prosecution witnesses failed to turn up for the simple reason that they had not been notified of the hearing date and the Magistrate having adjourned the hearing to the following day discharged Mr. Muthee when the witnesses still failed to turn up.

The criminal case was disposed of in June 1974 and then the matter ended up at the Ministry of Labour. An investigation was carried out and the following findings and recommendation were forwarded to the parties by the Permanent Secretary on 6th July, 1976:—

"Findings

On 7th November, 1972 Mr. Muthee, a cashier with the Bank passed a requisition cheque slip purportedly signed by a Bank's customer Mr. Macharia Kangara which was neither ordered nor received by him.

The cheque book was retained by Mr. Muthee and on 1st December, 1972 Mr. Muthee, while on leave, presented two cash cheques, one for Sh. 300 on his personal account and the other for Sh. 400 drawn on the account of Mr. Kangara. Both cheques were passed by the passing clerk, Mr. E. Karanja.

While still on leave, he called at the Bank on 2nd December, 1972 and was seen by the messenger, Mr. J. Nyarwati. He was seen going through the previous days cheques which had been returned from the Computer Centre. It was later discovered that the cheque for Sh. 400 was missing.

From the available evidence, and notwithstanding the Court's action in this regard, all the facts point to Mr. Muthee's involvement in this fraud.

Recommendation

In view of the above remarks I consider the action taken by the Bank in terminating the services of Mr. Muthee to have been justified in all material circumstances and within the provisions of the parties' collective agreement."

The facts leading to this dispute are that in early December, 1972 Mr. Muthee called at the bank and cashed a cheque for Sh. 300 drawn on his own account while the Respondents further allege that he also cashed another cheque No. 101907 for Sh. 400 on the account of one Mr. Macharia Kangara. The Respondents further allege that on the following day Mr. Muthee was seen in the bank going through the vouchers including cheques which had come back from the Computer Centre and subsequently they found that the said cheque for Sh. 400 was missing.

The Respondents are of the view that Mr. Muthee had forged the said cheque of Sh. 400 and that previously he had forged a requisition slip for a 12 leaf cheque book from which the said cheque for Sh. 400 had been issued and he had retained that cheque book. Mr. Kangara did not order that cheque book and he did not draw that cheque. The Respondents felt that they had no doubt that in these circumstances Mr. Muthee was not a proper person to remain in their employment and they terminated his services on 24th February, 1973 in accordance with the provisions of clause 4 (d) of the collective agreement.

Mr. Muthee was subsequently arrested and charged with forgery and uttering a false document and obtaining a document by false pretences to which he pleaded not guilty and as stated above he was discharged in the criminal court on 6th June, 1974

The Claimants have rejected the findings of the Ministry of Labour and submit that since no evidence was produced by the Respondents in the criminal case it must be assumed that

there was no concrete evidence against Mr. Muthee on which a conviction could be based. In these circumstances they stated that the evidence of Mr. E. Karanja and Mr. J. Nyarwati should not have been accepted by the Ministry of Labour.

The Claimants denied that they had at any time during the discussions at the parties' own level agreed that this dispute be withdrawn. They stated that discussion was merely deferred as the proceedings were *sub judice*.

The Claimants called Mr. Muthee to give evidence on oath and he denied having obtained a cheque book in the name of Mr. Kangara by false pretences or by forgery and he further denied that he had cashed a forged cheque for 400 from the account of Mr. Kangara. He admitted that while he was on leave he did present and cash a cheque for Sh. 300 from his own account but denied presenting a cheque for Sh. 400 as alleged by the Respondents. He further denied that he had gone to the bank to remove cheque No. 101907 for Sh. 400.

The Respondents called two witnesses Mr. E. Karanja and Mr. J. Nyarwati.

Mr. Karanja stated that on 1st December he had been approached by one of the bank's customers, Mr. Kangara, that he had issued a cheque for Sh. 1,000 to a firm and as he did not have sufficient funds in his account would Mr. Karanja be good enough to grant him the necessary overdraft facility for a few days in which time he would deposit more money. With this information in mind when Mr. Muthee presented two cheques one for Sh. 300 on his own account and the other one for Sh. 400 on Mr. Kangara's account he was unhappy and although he passed both the cheques for payment he subsequently sent a cashier to Mr. Kangara's place of work to find out if the cheque for Sh. 400 which Mr. Muthee had cashed had in fact been issued by Mr. Kangara. He got the information that Mr. Kangara had not issued that cheque and that Mr. Kangara would come and see him the next day.

This witness further stated that on 2nd December he saw Mr. Muthee who was on leave at that time come into the bank that morning in the working area. He, however, conceded that he took no action in making enquiries from Mr. Muthee about this cheque neither did he find out from him what he had come to do in the bank.

The other witness called by the Respondents, Mr. Nyarwati, who was a messenger in the bank at that time stated that on 2nd December as he went to collect the vouchers which included the cheques which had come back from the Computer Centre for the purpose of stamping them as usual he found Mr. Muthee going through them. He stood there and watched Mr. Muthee and asked him if he was looking for something. He said he waited for some time and then went away to do some other work.

During the hearing the Respondents produced a letter which had been written to the bank by Mr. Kangara on 11th January, 1973 in which he had written about 22 cheques totalling Sh. 5,960 issued between 14th March, 1972 and 1st December, 1972 in the following words:—

"The following cheques were debited in my account without my authority and I am sure that I have never bought any cheque book from your office nor given anybody the said cheques to withdraw money from my account."

The Respondents also produced some other cheques bearing the initials of Mr. Muthee with a view to proving that the initial on the requisition slip for a cheque-book bearing the Nos. 101905 to 101916 were Mr. Muthee's initials. They further produced Mr. Kangara's specimen signature card and asked the Court to find that the signature on the requisition form of Mr. Kangara was forged.

The Respondents told the Court that in a civil case which had been filed by Mr. Kangara both against themselves and Mr. Muthee they have had to pay about Sh. 6,667 to him to reimburse him for the debits in his account which Mr. Kangara had stated had not been authorized by him.

The civil action although filed by Mr. Kangara against Mr. Muthee and the Respondents took Mr. Muthee completely by surprise and he denied any knowledge of this action or that he had received any summons in respect of that case.

In this dispute the Court has to make a finding on whether or not Mr. Muthee had forged the signature of Mr. Kangara on the cheque book requisition form a photostat copy of which was produced during the hearing. The Respondents have further alleged that Mr. Muthee had forged a cheque for Sh. 400 which he had then cashed and which he had then subsequently removed from the bank premises on 2nd December, 1972. This cheque was not before the Court for obvious reasons.

The Court would like to emphasize that in the absence of evidence by an handwriting expert, the Court would be most

reluctant to make any finding on an allegation of forgery. The Judge and members of the Court are not handwriting experts and they do not intend to attempt to act as such experts. In these circumstances in view of Mr. Muthee's denial that he had forged Mr. Kangara's signature in obtaining a 12 leaf cheque book as stated above the Court has no evidence on which to find that Mr. Muthee had forged Mr. Kangara's signature.

Since the alleged forged cheque for Sh. 400 is also missing the Court would not like to make any comment on the forgery aspect of that cheque either.

The Court is now left with an allegation that Mr. Muthee came on 1st December, 1972 to the bank with two cheques of Sh. 300 drawn on his own account and Sh. 400 the alleged forged cheque on the account of Mr. Kangara and that he was paid cash for both the cheques.

It is pertinent that the Respondents' own witness Mr. E. Karanja had passed, according to his own evidence in Court, Mr. Kangara's cheque for Sh. 400 for payment allegedly to Mr. Muthee who had presented it for encashment.

The Court has very carefully considered the evidence of Mr. Karanja and the bank messenger Mr. Nyarwati but finds that it is not very satisfactory in certain vital aspects namely that if Mr. Muthee had come to the bank on 2nd December to remove the cheque for Sh. 400 and Mr. Karanja before that knew, according to his own evidence in Court that that cheque had been forged, why did he, Mr. Karanja, not take any action either himself or through the accountant or the branch manager in confronting Mr. Muthee for having committed such a serious offence? Mr. Nyarwati says that he saw Mr. Muthee in the bank going through the vouchers and although he knew that Mr. Muthee was on leave he, in his own words, allowed Mr. Muthee to continue to do what he was doing and went to perform some other tasks. This witness did not say that he saw Mr. Muthee remove anything from the bank.

The Court finds that the Respondents' case at best is mere speculation in the absence of expert evidence. This view is reinforced by the fact that Mr. Muthee was discharged in the criminal case. In these circumstances while the Respondents may have very strong grounds for suspecting Mr. Muthee of certain dishonest acts they have, however, failed on balance to prove to the satisfaction of the Court that Mr. Muthee was guilty of a dishonest act. The Court has a doubt in this dispute on the allegations made against Mr. Muthee and has decided to give him the benefit of same.

After a careful consideration the Court finds that Mr. Muthee has suffered a wrongful dismissal at the hands of the Respondents but because the Court has come to this conclusion by giving him the benefit of doubt the Court is not prepared to award his reinstatement. Furthermore Mr. Muthee's services were terminated on 24th February, 1973 and it would not be proper to award the reinstatement of a worker after such a long lapse of time.

The Court accordingly has decided that the Respondents should pay Mr. Muthee compensation for the wrongful dismissal that he has suffered and the Court awards that they should pay Mr. Muthee four months' salary by way of compensation.

Issue in dispute.—Termination of services of S. N. Njoroge without just and reasonable cause.

1. The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the Kenya Commercial Bank Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 28th and 29th April, 1977, and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:—

Claimants.—S. N. Njoroge.

Respondents.—A. K. Njoroge and S. S. Thathi.

AWARD

3. The Notification of Dispute Form "A" dated 5th August, 1976, duly signed by the parties was received by the Court on 17th September, 1976, along with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Njoroge was employed by the Respondents as a clerk on 16th August, 1971, and he was dismissed on 2nd May, 1974, at which time he was a cashier at their Government Road branch. His services were terminated in accordance with the provisions of clause 4 (a) (i) of the collective agreement for having misappropriated 40 notes of Sh. 100 each making Sh. 4,000 in all on 29th April, 1974.

On 9th August, 1974, Mr. Njoroge was charged in the criminal court for theft by servant and when the hearing was to take place on 12th August, 1974, the prosecutor stated that "we are having problems on this file and I have been asked to withdraw this case under section 87 (a) of the C.P.C." The Magistrate thereupon discharged the accused under section 87 (a) but Mr. Njoroge was told that he could be recharged.

The Claimants took up Mr. Njoroge's dispute on the ground that he was not responsible for the loss of Sh. 4,000 as alleged by the Respondents and the matter ended up with the Ministry of Labour and was duly investigated. The following findings and recommendation were conveyed to the parties by the Permanent Secretary, Ministry of Labour, on 6th July, 1976:—

"Findings"

On 29th April, 1974, Mr. Njoroge received from the Chief Cashier a sum of Sh. 155,000 for which he signed in cash summary sheet.

After the Bank was opened to customers on that day, Mr. Njoroge went to the Cash Officer, Surjit Singh, and claimed that cash amounting to Sh. 4,000 was missing from the total cash he had received that morning from the Chief Cashier. Surjit Singh quickly instituted a personal investigation and discovered the irregularities already narrated above.

From all the fact revealed, and notwithstanding that the Court case was withdrawn by the Prosecution under section 87 (a) of the Criminal Procedure Code, Mr. Njoroge personally must have tampered with the bundle in question and, therefore, is answerable for the disappearance of the Sh. 4,000. The normal procedure was followed between him and the Chief Cashier when the whole money was handed over to him. He raised no alarm and duly signed for the money.

Recommendation

In view of the above remarks, I consider the action taken by the Management in dispensing with Mr. Njoroge's services to have been in conformity with the provisions of the parties' collective agreement and, therefore, justified."

The Claimants rejected the above recommendation and findings and the matter is now before the Court.

The Claimants have argued that although the cashiers signed for the cash received by them from the chief cashier they only count the bundles as they take it for granted that the bundles would contain the exact amounts as enumerated therein and it was in this belief that Mr. Njoroge had accepted the cash in the morning of 29th April, 1974, totalling Sh. 155,000. Out of this amount he had been paid Sh. 120,000 in Sh. 100 notes. Out of this amount Sh. 100,000 was paid to him in one bundle which he thought at the time was sealed as received from the Central Bank. Later on in his cubicle just before the Bank opened at 9 a.m. he found that this bundle had been tampered with in that the outer case was broken and both the label on top of the bundle and the paper tape around the ten small bundles of Sh. 10,000 each were missing.

Mr. Njoroge had then promptly reported this matter to the cash officer, S. S. Thathi, and also told him that he was short of Sh. 4,000 in his Sh. 100,000 bundle.

The Claimants submitted that the time factor was very important in this dispute and that Mr. Njoroge could not have either lost this money or stolen it because from the time he received the money from the chief cashier that morning he had not left the Bank and the Bank had not opened and after he had reported the loss to Mr. Thathi he was interrogated by commercial investigators after which he was handed over to the

police. The police had searched him and after that the police had taken him and gone to his father's lawyers to see if they had received any money and in due course he had been charged in the criminal court where he had been discharged.

Mr. Njoroge gave evidence on oath and confirmed what is stated hereinabove and denied that he had misappropriated Sh. 4,000. He admitted, however, that he had signed the necessary document acknowledging receipt of Sh. 155,000 from the chief cashier on 29th April, 1974, and he admitted that there was a shortage of Sh. 4,000.

The Claimants raised a possibility that the money in question could have been stolen by Mr. Kamau, the chief cashier. Failing that this could be considered a case of a normal shortage in the course of a cashier's duties for which at the most a warning was warranted.

The Claimants stressed that the police had found no evidence against Mr. Njoroge and that he had a clean record during his 2½ years' service.

The Claimants asked for Mr. Njoroge's reinstatement and payment of all salary and privileges from the date of his termination.

The Respondents were emphatic that Mr. Njoroge reported the shortage of Sh. 4,000 to Mr. Thathi after the Bank had opened shortly after 9 a.m. in the morning. When the report was made Mr. Thathi had immediately gone to Mr. Njoroge's cubicle and checked all the cash and also made a search and did not find either the label which is usually on top of the sealed bundles or the paper wrapping around the ten bundles.

The Respondents added that after Mr. Thathi had made the necessary search he had then gone down accompanied by Mr. Njoroge to the chief cashier where he checked the chief cashier's cash trolley in case the money had fallen there but he did not find anything there either.

The Respondents stated that this was the first time to their knowledge where it was alleged that a sealed packet from the Central Bank of Kenya was found to contain Sh. 4,000 less in a bundle of Sh. 100,000.

The Respondents called two witnesses, the chief cashier and Mr. Thathi, the cash officer. The chief cashier stated that he gave Sh. 100,000 to Mr. Njoroge in a sealed bundle received from the Central Bank of Kenya and that to his knowledge the bundle was intact and had not been tampered with in any manner. He added that after Mr. Njoroge had examined the bundle he accepted it along with the rest of the cash before he signed the necessary receipt for the full amount.

Mr. Thathi confirmed what the Respondents had submitted and stated that he was sure that when Mr. Njoroge came and reported to him the shortage of Sh. 4,000 at that time the Bank had opened its doors to the public. He further added that the money received from the Central Bank was in sealed packets and they were put in the main reserve the keys for which were held by him and the accountant or the current account officer. From here as required sealed bundles are issued to the chief cashier. He also stated that if any of the bundles did not appear to be intact on receipt from the Central Bank then such a bundle is not issued to the chief cashier for handing over to the cashiers. The Bank officials made it a point to check the bundles to ascertain if they are in any way damaged and during his 16 years' on cash duties he had rarely seen a damaged bundle.

The Court cannot accept the Claimants' submission that this loss of Sh. 4,000 from a bundle of Sh. 100,000 should be treated as if it was a shortage incurred by a cashier during a normal day's work because such shortages can occur and are considered at the end of a day's work and not at the very beginning of a cashier's duties.

The Court had the benefit of a demonstration of two sealed bundles of Sh. 100,000 which were produced in the Court by the Respondents. One bundle was tampered with in Court in that the outer casing was cut and Sh. 4,000 from the top bundle were removed. It became obvious immediately that any person could see the difference between the sealed bundle and the one from which Sh. 4,000 had been removed. In these circumstances the Court finds it hard to believe that Mr. Njoroge had accepted a bundle of Sh. 100,000 less Sh. 4,000 without ascertaining whether or not it had been tampered with. It is highly unlikely that a cashier would accept a sealed bundle without making sure that it was not tampered with before signing a receipt for having received that bundle. If a bundle had been tampered with as claimed by him then the Court is of the view that he could easily have seen it when he was accepting it from the chief cashier.

The Court accepts the evidence of the Respondents' witnesses and finds that Mr. Njoroge must bear full responsibility for the loss of Sh. 4,000 from the money entrusted to his care.

After careful consideration of all the submissions the Court finds that Mr. Njoroge deserved a termination under the afore-said circumstances. The Claimants' demand is accordingly rejected.
