THE TEA BOARD OF KENYA Notes to Accounts at 31st December, 1976

1. Accounting Policies

BASIS OF ACCOUNTING

The Board prepares its accounts on the historical cost basis of accounting.

FIXED ASSETS

Fixed assets are stated at cost and include all assets which are expected to have a relatively long-term useful life.

DEPRECIATION

Depreciation is calculated on the following basis:-

Long leasehold property

-Nil

-15% on the reducing balance method.

Office equipment Short leasehold property is represented by the Jamhuri Show Stand which is included in the accounts at fully written down value.

TAXATION

The board is exempt from taxation.

EXCHANGE CONVERSIONS

All transactions during the year in foreign currencies are converted at the rates ruling when payment is made and exchange differences are dealt with in the revenue account.







Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary,
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

D.41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
