THE TRADE DISPUTES ACT

ORDER UNDER SECTION 36—COLLECTION OF TRADE UNION DUES

- notify in writing that Trade Union and that Organization before the end of each month the total amount of all payments made in to the accounts of that Trade Union and of that Organization in that month;
- notify in writing the Registrar of Trade Unions before the end of each month of the total amount of all payments made into the accounts of that Trade Union and of that Organization in that month.

And in exercise of the powers conferred by section 36 (2) the order notified by Gazette Notice No. 390 of 1974 is hereby cancelled.

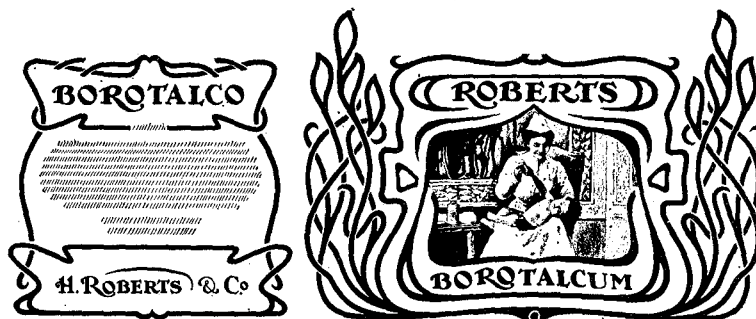

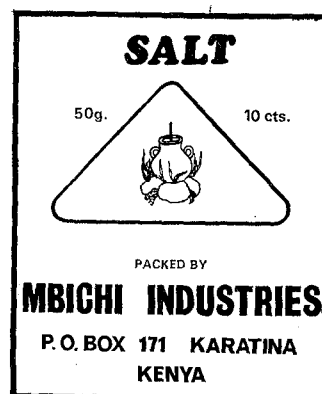
