(1) Every licence issued under this resolution shall be produced for inspection to any Police Officer, Administration Police Officer, Health Officer, Market Superintendent, Market Master or any employee of the Council authorized to do so by the Council.

(2) Any Medical Officer of Health, Health Officer, Veterinary Officer or other authorized officer may at any reasonable time visit any premises, whether licensed under this resolution or not, to make all inquiries for the purpose of ascertaining whether this resolution or any other condition to any licence issued under this resolution are being observed.

(4) Every person who is guilty of an offence under this resolution shall be liable to a fine not exceeding two thousand shillings or to imprisonment for a period not exceeding two months or to both such fine and imprisonment.

## THE TRADE DISPUTES ACT

(Cap. 234)

## ORDER UNDER SECTION 36—COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 36 of the Trade Disputes Act, 1965, the Minister for Labour hereby orders every employer who employs not less than five members of the Kenya Engineering Workers' Union to—

- (a) deduct every month the sum of six shillings in respect of trade union dues, from the wages of each of his employees who is a member of that Trade Union;
- (b) pay eight-five per cent of the total sums in any month, not later than the tenth day from the date on which such wages were paid, by a crossed cheque made payable into the account of the Kenya Engineering Workers' Union at the Standard Bank, Treasury Square Branch, P.O. Box 90170, Mombasa;
- (c) pay fifteen per cent of the total sums so deducted in any month, not later than the tenth day from the date on which such wages were paid, by a crossed cheque made payable into the account of the Central Organization of Trade Union (Kenya) Account No. 140793-7 at the Barclays Bank, Queensway Branch, P.O. Box 30011, Nairobi;
- (d) notify in writing that Trade Union and the Organization before the end of each month of the total amount of all payments made into the accounts of that Trade Union and of that Organization in that month;
- (e) notify in writing the Registrar of Trade Unions before the end of each month of the total amount of all payments made into the accounts of that Trade Union and of that Organization in that month.

And in exercise of the powers conferred by section 36 (2) the order notified by Gazette Notice No. 94 of 1969 is hereby revoked.

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. ## Senior Radiographer (Eight Posts) (No. 350/77)

Applicants must hold a qualification in therapeutic or diagnostic radiography acceptable to the Ministry of Health of the Government of Kenya. They must have had a minimum of nine years' approved practical experience and currently serving as Radiographer I or must have been in charge of an X-ray department at Provincial Hospital level or performing special duties.

The successful candidates will be responsible for running diagnostic services at Provincial level performing special duties as may be assigned to them.

**VACANCIES—PUBLIC SERVICE COMMISSION—(Contd.)****Radiographer Grade I (Fourteen Posts) (No. 351/77)**

**Salary scale.**—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must hold a qualification in diagnostic or therapeutic radiography acceptable to the Ministry of Health of the Government of Kenya. They must have a minimum of six years' practical experience in their respective branch of Radiography.

The successful candidates will be responsible for running radiographic services in a Provincial Hospital or a section within a large institution, or performing special duties as may be assigned to them.

**Senior Radiographic Film Processor (Nine Posts) (No. 352/77)**

**Salary scale.**—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants must hold qualifications following academic and practical training in darkroom practice in a Medical Diagnostic X-ray Department acceptable to the Ministry of Health of the Government of Kenya. They must have a minimum of five (5) years continuous service in the grade of Radiographic Film Processor I. In addition they must have wide experience in processing equipments to include manual and automatic as well as administration in darkroom practice in a large hospital.

The successful candidates should be able to work effectively and be responsible for running film processing at provincial level as well as perform special duties as may be assigned to them.

**Radiographic Film Processor Grade I (Eighteen Posts) (No. 353/77)**

**Salary scale.**—£642 to £900 p.a. PENSIONABLE or AGREEMENT.

Applicants must hold qualifications following academic and practical training in darkroom practice in a Medical Diagnostic X-ray Department acceptable to the Ministry of Health of the Government of Kenya. They must have a minimum of three (3) years' continuous service at the grade of Radiographic Film Processor II. In addition they must also have a sound knowledge of manual and automatic processing in radiological darkroom practice.

The successful candidates must be fully conversant with the X-ray darkroom techniques and be prepared to take charge of X-ray film processing within a province or other large institutions or perform special duties as may be assigned to them.

**Radiographic Film Processor Grade II (Thirty-two Posts) (No. 354/77)**

**Salary scale.**—£531 to £744 p.a. PENSIONABLE or AGREEMENT.

Applicants must be experienced in medical diagnostic radiographic film processing. They must have academic and practical training in darkroom practice in a Medical Diagnostic X-ray Department acceptable to the Ministry of Health of the Government of Kenya. They must in addition have a minimum of five (5) years' experience in the grade of Radiographic Film Processor III.

The successful candidates will be responsible for darkroom practice in a District Hospital or a smaller section within a large institution.

**Vacancies in the Ministry of Agriculture:****Senior Range Officer (One Post) (No. 355/77)**

**Salary scale.**—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a B.Sc. degree in Agriculture with specialization in Range Management from a recognized university. They should have at least five years' experience in range management and extension.

The successful candidate will be responsible to the Head, Range Management Division, for the development plans for all ranch units in liaison with other agencies involved in the livestock development project; implementation and supervision of such development plans; timely production of work schedules, development targets, quarterly/annual reports and financial estimates. He will be stationed in Isiolo.

**Mechanical Engineer Grade I (One Post) (No. 356/77)**

**Salary scale.**—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Mechanical Engineering from a recognized university with at least three years' working

experience in a large workshop. They should have thorough knowledge of Government regulations governing the use, maintenance and repair of motor vehicles. A relevant postgraduate qualification would be a definite advantage.

The successful candidate will be responsible to the Head, Livestock Marketing Division for the overall control, maintenance and repair of motor vehicles, development of the two existing workshops at Kitengela and Isiolo; supervision and training of the mechanics within the workshops. Although the work involves travelling to the outside stations, the successful candidate will be stationed at the Ministry Headquarters, Nairobi.

**Executive Officer II (One Post) (No. 357/77)**

**Salary scale.**—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants of at least East African Certificate of Education or its accepted equivalent. They must also have served as executive, personnel or accounts assistant for at least three years. A thorough knowledge of Government regulations, financial, personnel, office and stores procedures and ability to supervise staff and conduct correspondence are essential.

Preference will be given to applicants who have successfully completed Personnel, Executive, Office or Accounts Management course either at Kenya Institute of Administration, Kabete, or Government Training Institute, Maseno.

**Executive Officer II (Transport Officer) (One Post) (No. 358/77)**

**Salary scale.**—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be civil servants of at least East African Certificate Standard of Education and must also have served as an Executive Assistant (Transport) for a minimum period of three years. They should have experience in the administration of a large fleet of motor vehicles; a sound knowledge of Government regulations; accounting and stores procedures; procedures pertaining to the purchase and boarding of Government vehicles, investigation and reporting of vehicle accidents and ability to supervise staff and conduct correspondence independently.

The successful candidate will be stationed at the Ministry Headquarters, Nairobi.

**Inspector Mechanical (Two Posts) (No. 359/77)**

**Salary scale.**—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants should preferably be of East African Certificate of Education and be in possession of Government Trade Test Grade I in vehicle mechanics together with a valid driving licence covering cars and heavy commercial vehicles. They must have three years' field experience in the repair and overhaul of motor vehicles as well as workshop practice in gas and electric welding. Ability to supervise and control staff and assisting in training of mechanics is essential.

The successful candidates will be responsible to the Mechanical Engineer, Livestock Marketing Division, for the running of a Divisional Workshop, maintenance of vehicles, compiling inspection and damage reports as well as preparing transport returns.

**Vacancies in the Ministry of Works:****Senior Superintendent (Roads) (One Post) (No. 360/77)**

**Salary scale.**—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a minimum of three years of Post Secondary School Education in Civil Engineering at any Institution of Higher Learning, or should have a minimum experience of five years in Traffic Engineering Work and other related activities and be between the ages of 28 and 45 years.

The officer appointed to this post will be responsible to Senior Superintending Engineer (Planning).

This is a specialized and professional traffic engineering work which involves the planning, rural data collection, analysis and computerization of all traffic information for use not only in pavement design, but also in the economic evaluation of road projects, both for the short- and long-range planning of road construction and improvement.

**Typical Duties**

1. Planning and programming of rural traffic study for all road works activities of the Ministry of Works.

2. Supervision of traffic technicians engaged on manual traffic census, automatic counters and special surveys related to origin and destination studies, junction counts, delay studies, journey time measurements, etc.

3. Responsible for the analysis and computer punching of all Rural Traffic Data.

4. Interpretation of all traffic information into meaningful data for direct use in pavement design and benefit-cost analysis for road construction and/or improvement.

5. Liaison with and representing the Roads Department at all Town Planning and Physical Planning meetings.

6. Take charge of all day to day administrative and technical matters regarding the traffic engineering unit of the Planning Section, Roads Department.

*Superintendent (Electrical) (Four Posts) (No. 361/77)*

*Salary scale.*—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess the East African Certificate of Education or its equivalent.

They must possess the City and Guilds Electrical Engineering Technician Certificate, Final Grade (endorsements to this certificate will be deemed an advantage) or its equivalent, followed by at least six (6) years' practical experience, four (4) of which must have been in a supervisory position in one or more of the following:—

- (a) The preparation of design drawings, specifications and estimates for electrical installations in public buildings, hospitals, institutions, etc.
- (b) The installation, operation and maintenance of diesel generating plants and machinery including H.T. and L.T. distribution services.
- (c) The installation, operation and maintenance of refrigeration and air conditioning plants, cookers, water heaters, and general domestic appliances.
- (d) The installation, inspection and testing of electrical installations in public buildings, hospitals, institutions, etc.

They must possess a thorough working knowledge of the current "Regulations for the Electrical Equipment of Buildings" and hold an "A" licence.

*Architectural Assistant Grade II (Three Posts) (No. 362/77)*

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of the East African Certificate of Education or its equivalent and must have passed the Ordinary Diploma in Building and Civil Engineering from the Kenya Polytechnic or any recognized institution. They must have a minimum of four (4) years' practical experience in drawing office and must have thorough knowledge of the following:—

- (a) Taking rough sketches and working them up to finished drawings.
- (b) Knowledge of building construction.
- (c) Be acquainted with practices and procedures applicable in the building industry.
- (d) Preparation of site reports.
- (e) Model making and presentation drawings including perspectives.
- (f) Knowledge of the work of the quantity surveyor, electrical engineer and structural engineer.
- (g) Must be able to prepare production drawings for various public buildings such as offices, schools, hospitals, etc.

**IMPORTANT NOTICE TO SUBSCRIBERS

- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government, and must be submitted through the Office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction into the National Assembly only.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

**EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—****Kenya Gazette**

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
