THE REGISTERED LAND ACT

(Cap. 300)

MUYOGO TOWNSHIP, UASO NYIRO SETTLEMENT SCHEME, NYERI DISTRICT—PLOTS FOR BUSINESS-CUM-RESIDENTIAL PURPOSES

THE Commissioner of Lands on behalf of the President of the Republic of Kenya, gives notice that the plots at Muyogo Township, Uaso Nyiro Settlement Scheme as described in the Schedule hereto are available for alienation and applications are invited for the direct grants of the individual plots.

- 2. A plan for the plots may be seen at the Public Map Office situated in the Lands Department building, City Square, Nairobi, or at the office of the District Commissioner, Nyeri District, and at the office of the Clerk to Council, Nyeri County Council or may be obtained from Public Map Office, P.O. Box 30089, Nairobi, on payment of Sh. 4.
- 3. Application should be submitted to the Commissioner of Lands through the District Commissioner, Nyeri. Applications must be on prescribed forms which are available from Lands Department and the office of the District Commissioner, Nyeri or Clerk to Council's office.
- 4. Applications must be sent so as to reach the District Commissioner, Nyeri not later than 12 noon on 20th March, 1978.
- 5. Applications must not be sent direct to the Commissioner of Lands.
- 6. Applicants must enclose with their applications their cash for Sh. 400 as a deposit which will be dealt with as follows:—
 - (a) If the applicant is offered and takes up and pays for the plots within a period of seven days as required in paragraph 5 below, the deposit will be credited to him.
 - (b) If the application is unsuccessful, the applicant's deposit will be returned to him.
 - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 of the General Conditions, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

General Conditions

- 1. The ordinary conditions applicable to township lease of this nature except as varied hereby, shall apply to this lease.
- 2. The lease will be made under the provisions of the Registered Land Act (Cap. 300 of the Laws of Kenya) and title will be issued under the Registration of Titles Act (Cap 281.)
- 3. The lease will be issued in the name of the allottee as stated in the letter of application and the name must be in full.
- 4. The term of the lease will be for 33 years from the first day of the month following the notification of the approval of the allocation of the plot. And the term of the lease will be converted to 99 years in due course in cases where development is of high standard.

Special Conditions

- 1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specification previously approved in writing by the Commissioner of Lands and the Local Authority. The Commissioner of Lands shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2. The lessee shall within six calendar months of the actual registration of the lease submit in triplicate to the Local Authority and the Commissioner of Lands plans including block plans showing the positions of the buildings and a system of drainage for disposing of sewage, surface and sullage water, drawings and specification of the buildings the lessee proposes to erect on the land and shall within 24 months of the actual registration of the lease complete the erection of such buildings and the construction of the drainage system in conformity with plans, drawings, elevation and specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act if default shall be made on the performance or observance of any of the

requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof, in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner of Lands in respect of any antecedent breach of any condition herein contained.

- 3. The lessee shall maintain in good and substantial repair and conditions all buildings at any time erected on the land.
- 4. Should the lessee give notice in writing to the Commissioner of Lands that he/she/they is/are unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the lessee's expense), accept a surrender of Land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term, the Commissioner of Lands shall refund to the lessee 50 per centum of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period, the Commissioner of Lands shall refund to the lessee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

- 5. The land and the buildings shall only be used for Business-cum-Residential purposes (excluding sale of petrol or petrolium oils).
- 6. The building shall not cover more than 75 per centum of the area of the land or such lesser area as may be laid down by the Local Authority in its by-laws.
 - 7. The lessee shall not subdivide the land.
- 8. The lessee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof, except with the prior consent in writing of the Commissioner of Lands. No application for such consent (except in respect of a loan required for building purposes) will be considered until Special Condition No. 2 has been performed.
- 9. The lessee shall pay to the Commissioner of Lands on demand such sum as the Commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of the demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.
- 10. The lessee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or Local Authority upon the land or the buildings erected thereon including any contribution or other sum paid by the President in lieu thereof.
- 11. The lessee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner may assess.
- 12. The President or such person or authority as may be appointed for the purposes shall have the right to enter upon the land and lay down and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether overhead or underground and the lessee shall erect any buildings in such a way as to cover or interfere with any existing alignment of mains, service pipes, telephone or telegraph wires and electric mains.

Securicor Kenya Limited

Issue in dispute: -

Gratuity to retired employees.

- 1. The Kenya Union of Commercial Food & Allied Workers shall hereinafter be referred to as the Claimants and Securicor Kenya Ltd. shall hereinafter be referred to as the Respondents.
- 2. This dispute was fixed for hearing on 22nd November, 2. This dispute was fixed for hearing on 22nd November, 1977 but on that date the Claimants made an application for the hearing to be postponed as their Secretary-General who wanted to conduct the case personally had been hospitalized and further added that because it affected the issue of gratuity for some 3,000 workers the Assistant Secretary-General would not like to proceed with the hearing. Accordingly the hearing was adjourned to 23rd and 24th January, 1978 when it took

AWARD

3. The Notification of Dispute Form "A" dated 11th July, 1977 duly signed by the parties was received by the Court on 30th September along with the statutory certificate signed by the Labour Commissioner.

The issue in dispute reads "Gratuity to Retired Employees" and the Claimants have put forward arguments during the hearing of this dispute that their demands on this issue fall under two heads. The first one is in respect of payment of gratuity to 69 employees—28 at Mombasa and 41 in Nairobi—who have been retired by the Respondents. Secondly they want the Court to award that the Respondents should pay a gratuity to all their employees whom they retire in future as well.

In other words the Claimants are seeking an additional benelit for some 3,000 employees working for the Respondents in the shape of a gratuity payment on retirement.

The Claimants have based their demand on the Industrial Court award made in Cause No. 5 of 1965 which was consolidated with Cause No. 6 of 1965 between the Claimants who in those days used to be called Kenya Distributive & Commercial Workers' Union and Night Security Organization and International Security Services. In this dispute the Court made the following award on the item of gratuity:

"The Court awards that in the event of termination of service other than by resignation of the employee or arising out of gross misconduct by the employee the employee shall be entitled to:

One week's pay for each completed, year of service after five years and up to and including the tenth year of service.

Two weeks' pay for each completed year of service after the tenth year of service."

The Claimants have further submitted that because in 1972 the Respondents undertook to pay gratuity based on the above Court award to the six employees who were retired then they were now bound to follow this practice and maintained that

notwithstanding the 1969 collective agreement effective from 1st July, 1969 for three years between the parties the Industrial Court award of 1965 had continued in force and remains in force up till now.

The Claimants also pointed out that when the Respondents took over the business of Night Security Organization they had given to them a commitment in writing that they would continue to honour all the terms and conditions of employment which the Claimants had negotiated with that company on behalf of the employees and they added that one of the terms and conditions of employment was that workers would be entitled to the payment of gratuity as stated above. The Claimants, however, failed to produce this document in Court saying that probably it had been burnt along with other documents when the Claimants disposed of some old files.

The Respondents have resisted the Claimants' demands on the ground that the Industrial Court award in Cause No. 5 of 1965 had been superseded by a collective agreement between the Claimants and the Night Security Organization Mombasa Ltd. which at that time was associated company of the Respondents, which agreement was effective from 1st July, 1969 for a period of three years.

The Respondents added that the said agreement had in turn been superseded by another comprehensive collective agreement between the member companies of Security Services Group of F.K.E. and the Claimants and pointed out that both these agreements were silent on the issue of gratuity. This was because from June 1966 the National Social Security Fund having commenced the parties felt that there was no need for a gratuity clause to continue and had mutually agreed to drop it.

The Respondents produced an Agreement For Sale under which they had bought out the company called Night Security Organization Mombasa. In terms of this purchase agreement no employee gratuity liability was revealed or transferred or undertaken by the Respondents.

The Respondents explained that on 31st December, 1970 the Night Security Organization's liabilities to them under the warranties undertakings and covenants in the purchase agreement ceased and Night Security Organization became part and parcel of the Respondents.

The Respondents resisted very strongly the Claimants' demand as put forward by them during the hearing on the ground that the issue in dispute covered only 25 former employees of Night Security Organization Mombasa and 14 of their own employees all of whom were retired by them on 13th November, 1975. They stated that all these employees had collected their terminal benefits except eight who claimed that they should have been paid gratuity benefits.

The Respondents strongly rejected the Claimants' demand that the Court should make an award requiring them to pay gratuity to all their employees who would be retired in future as well as they maintained that this was not an issue in dispute which in any case they would very strongly resist.

Finally the Respondents offered without prejudice to there being no provision in the collective agreement on the payment of gratuity that they would be prepared to pay the employees concerned gratuity calculated only up to the commencement of the N.S.S.F. i.e. June 1966.

The Claimants' argument that Industrial Court award in Cause No. 5 of 1965 continues in force up to date notwithstanding the collective agreements that have been negotiated and bind the parties since then should be dealt with first. The Court would like to refer the parties to section 10 (6) of the Trade disputes Act which states:—

"Subject to the provisions of this section, an award shall as from the date that the award has effect, be an implied term of every contract of employment between the employers and employees to whom the award relates, so that the rate of wages to be paid and the terms of conditions of employment to be observed under the contract shall be in accordance with the award until it is varied by a subsequent award, or by agreement."

Based on the aforesaid legal provision a pattern over the years has developed in Kenya where the trade unions incorporate the Court awards in their collective agreements which on their expiry are revised and the trade unions make vigorous representations on the various items in order to improve them for the benefit of the workers.

In the present dispute the Court is satisfied that two collective agreements have been negotiated and entered into to which the

Claimants and the Respondents are parties after the Court award of 1965. Both the agreements are comprehensive and cover wages and salaries and other fringe benefits but are silent on the payment of gratuity. In these circumstances the Court has no option but to find that the parties by their own mutual agreement have dropped the Industrial Court award on gratuity made in 1965 primarily due to the reason that from June 1966 the workers had started contributing to the N.S.S.F. For the Court to rule otherwise on this particular item would be tantamount to seriously disrupting the whole system of collective bargaining in the country. The Court while rejecting this particular argument of the Claimants would advise them to seriously ponder over the consequences if the Court had accepted their submission.

The Court would now deal with another very important point in this dispute and that is the Claimants' attempt to get an award from the Court which would amount to the variation of the existing collective agreement between the parties requiring the Respondents to pay gratuity to their employees when they retire. This demand clearly is outside the issue in dispute before the Court. If the parties' intention had genuinely been to seek an award from the Court to vary an existing collective agreement then to begin with the Notification of Dispute Form "A" would contain the issue in dispute to be either payment of gratuity to employees on retirement or terminal benefits and not the issue as it appears which is gratuity to retired employees. The issue as it is worded clearly relates to those employees who have already been retired and the Court finds that only 39 employees are affected by this on whose behalf the Claimants have raised this dispute.

The Court would like to add that at a meeting of the Joint Industrial Council held on 31st August, 1976 under the item of gratuity the following is recorded:—

"Union: As proposed.

Group: Not acceptable. N.S.S.F. taking care.

Not agreed."

At a subsequent meeting on 14th September the following appears in the minutes of this item:—

"The Union informed the meeting that they had reported a trade dispute with one member of the Group over this issue. The dispute had not been resolved and it was not their wish to proceed with discussions with the Group over this point until the dispute had been resolved. They therefore proposed that discussions on this point be suspended for the time being.

While accepting the Union's proposal, Group representatives made it quite clear that their position remained as recorded in the minutes of the last meeting."

From the aforesaid extracts of the minutes it is clear that the item on gratuity as far as its incorporation in a collective agreement is concerned was dropped by the Claimants until such time as this particular dispute before the Court has been settled one way or the other. But in the meantime they have gone ahead and signed a comprehensive collective agreement dated 29th January, 1977 which remains in force for a period of two years from that date.

The Court would like to add that the Claimants will be entitled on the expiry of the collective agreement when it is being revised to put forward their demands on this issue when no doubt the matter will be considered on the arguments put forward by both the sides at that time.

After careful consideration of all the submissions the Court finds that the Claimants' arguments must fail and accordingly awards that all the 39 employees who have been retired by the Respondents should be paid a gratuity in accordance with the offer made by the Respondents which is for services rendered up to June 1966 when the workers started contributing to the National Social Security Fund. The employees services with the previous employer shall be taken into account when gratuity benefits are worked out.

THE INDUSTRIAL COURT

Cause No. 52 of 1977

Parties: -

Kenya Union of Commercial, Food and Allied Workers'

Maritime Forwarders (K) Ltd.

Issue in dispute: --

Refusal by the employers to enter discussions on "Job Description".

- 1. The Kenya Union of Commercial Food & Allied Workers' shall hereinafter be referred to as the Claimants and Maritime Forwarders (K) Ltd. shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 17th day of January, 1978 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 14th September, 1977 duly signed by the parties was received by the Court on 1st November along with the statutory certificate signed by the Labour Commissioner.

The background to this dispute is that the parties entered into a collective agreement in 1973 and agreed on a job grading in the following terms:—

- "1. Non-Clerical Staff:
 - (a) Cleaners, labourers and drivers.
 - (b) Messengers.
 - (c) Drivers.
- 2. Clerical Staff:

Grade A. Up to Form IV or four years experience.

- B. E.A. Certificate of Education or Higher School Certificate or five years experience.
- C. E.A. Advanced Certificate of Education or Higher School Certificate or six years experience."

The parties also agreed for the various rates for the above grades.

On a subsequent revision of the 1973 collective agreement the Claimants insisted on job classification and payment of salaries to clerical staff based on the number of years of service but the Respondents were not prepared to deviate from the grades laid down in the 1973 agreement and a deadlock was reached on this matter.

On 22nd November, 1976 the Claimants reported a trade dispute to the Minister for Labour on the three issues of Wages, Retirement Benefits and Job Description.

The Respondents, however, felt that the Claimants had reported the dispute rather prematurely and further correspondence was exchanged in respect thereto.

On 28th December, 1976 the trade dispute was accepted and a Conciliator was appointed but the Claimants informed the Conciliator that at the Respondents' request they were going to have a meeting with them in order to try to settle the matter. Nothing materialized and the first conciliation meeting was held on 10th March, 1977. Another meeting was held on 30th March, 1977 and by this time the parties had settled the issues of wages and retirement benefits and recorded a deadlock on the issue of job description.

On 1st April 1977 the parties signed another collective agreement effective from 1st June, 1976 for a period of three years based on the same job grading as it appears in the 1973 collective agreement. The parties have gone further and on 31st August, 1977 they have entered into a supplementary agreement giving further wage increases ranging between 4 to 6 per cent.

On 14th September, 1977 the parties signed the Notification of Dispute Form "A" with the issue as stated above.

With the aforesaid background the Claimants' demand is that the Court should direct the Respondents to forthwith enter into negotiations with them on the question of job description as they feel that the 1973 fob grading is totally out of place and is not appropriate for the type of work which the clerical staff are doing for the Respondents since they are now well established in business.

The Claimants in their written submission have set out the job descriptions for the various types of duties that are being performed and also submitted an administration chart for the Respondents undertaking.

The Claimants made it clear that they did not intend to use the Court as a negotiating forum.

The Respondents on the other hand submitted that they could not understand the Claimants' reasons for demanding discussions on job descriptions. They alleged that even the Conciliator could not understand what the Claimants were after.

The Respondents added that they got the impression that the Claimants' real problem was one of job grading or classification and maintained that if this was the case then the Claimants should realize that they had a binding collective agreement which was to run until June 1979 and they were therefore not prepared to tamper with it during its lifetime as this would lead to negotiations of the 1977 collective agreement being reopened.

The Court notes that the Respondents employ a total of 51 persons including the managerial staff and are engaged in shipping work as ship owners agents.

After going through the parties' written submissions and the arguments put forward by them during the hearing the Court has no doubt that what the Claimants are after is a new job structure in the Respondents' undertaking. It is indeed an error on their part to have termed their demand as job description because describing a job alone serves no purpose. A job description has got necessarily to be followed by a job classification which can lead to new job structure which in turn is followed by a further exercise of fixing rates for the various categories devised and agreed upon.

It is indeed most strange that the Claimants knowing fully well that such an important item as a new job classification—an item which is directly linked with the wage rates and increases thereon—was left outstanding to be settled by the Industrial Court and proceeded to sign a three years collective agreement with the Respondents based on the 1973 collective agreement. Further they have entered into another supplementary agreement giving further wage increases to the employees. The deadlock before the Conciliator was signed on 30th March, 1977 and the parties proceeded to sign the collective agreement which is in force for three years on 1st April, 1977.

The Court must say that the Claimants' officials dealing with this matter were obviously confused as to how to go about forwarding their demand on this rather complex issue of a job classification/evaluation exercise.

Without prejudice to the parties' rights on which the Court does not intend to give any ruling in this dispute arising out of the collective agreement signed between the parties on 1st April, 1977 and which is to run for three years the Court can find no reason why the parties cannot embark on negotiations for working out a new job structure. The present job grading is not related to the job being performed but is based on an employee's educational level and experience. This is not a very satisfactory arrangement but one which came about with the full active participation of the Claimants.

Notwithstanding that technically the issue in dispute is job description the Court having found that the real issue is job classification hereby directs the Respondents that they should immediately start negotiations with the Claimants on this issue. This would of course be without prejudice to the parties' rights arising out of the 1977 collective agreement.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE KENYA GAZETTE

- (2) Legislative Supplement contains Rules and Regulations which are issued by the Central Government, and must be submitted through the Office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction into the National Assembly only.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

D.41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
