THE INDUSTRIAL COURT CAUSE NO 53 OF 1977

Parties —

Kenya Union of Commercial Food and Allied Workers
and
Kenya Breweries Limited

Issue in dispute—

Refusal by the employers to pay overtime at the Barley Syrup Plant and Maltings

1 The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and Kenya Breweries Ltd shall hereinafter be referred to as the Respondents

2 The parties were heard in Nairobi on 18th January, 15th March and 20th and 26th April, 1978, and relied on their written and verbal submissions

AWARD

3 The Notification of Dispute Form "A" dated 1st December, 1976, duly signed by the parties was received by the Court on 2nd November, 1977, along with the statutory certificate signed by the Labour Commissioner

The Claimants' claim in this dispute falls under two distinct heads as the overtime in dispute relates to Respondents' two sections only—Maltings and Barley Syrup Plant (BSP)

In both these departments work is performed on a round the clock basis with the result that a shift system is in operation

The Claimants conceded that the Malting Section is as old as any other section in the brewery and that although they were not satisfied with the payment of overtime in this section the matter was, however, rectified to their satisfaction from 1976. They, however, maintained that the workers in this department are entitled to arrears of overtime payment in this section prior to the rectification

The Claimants based their claim for arrears on the ground that the Respondents were giving rest days to the workers during one of the weekdays instead of Sunday. The Claimants maintained that irrespective of the fact that the rest day was allowed to the workers during the weekdays if they were required to work on Saturday afternoon and Sunday then they should be

paid double time for such work in accordance with their collective agreement

The Claimants submitted that since the Respondents rectified the mistake in 1976 the workers were entitled to be paid overtime for all the period prior to 1976

Regarding the BSP the Claimants stated that the practice that was rectified in the Maltings Section in 1976 is continuing in this section and they claim that the workers when they are required to work on Saturday afternoons and Sundays in this section should be paid overtime as laid down in the collective agreement at basic rate plus 100 per cent

The Claimants have submitted that the Respondents' action in allowing the workers a rest day during the weekdays and swapping it with Sundays is contrary to the provisions of the collective agreement. In any case if they had wanted to do so then they should have had discussions with the Claimants and only after getting their agreement could they have started this system

The Claimants further make the point that the 45 hours that are required to be worked by an employee before he can be entitled to any overtime payment have to be worked between Monday and Friday and if a worker has not completed 45 hours prior to Saturday and Sunday's work he should still be entitled to basic rate plus 100 per cent for work done on Saturday afternoons and Sundays

The Claimants fear that if the Respondents were allowed to get away with the sort of arrangement that they had in force in maltings prior to 1976 and which was currently in force at BSP then in the very near future they would extend it to all their sections. This would certainly not be acceptable to the workers under any circumstances

The Respondents while admitting that under pressure from the Claimants they had changed the system in the Maltings Section pointed out that this had resulted in a situation where the workers in the boiler room and the engine room were since 1976 working without a rest day in order to earn overtime. They accepted that this was most undesirable and not beneficial for the health of the workers and was probably an illegal procedure which they claimed had been introduced as an interim measure due to the pressure from the Claimants

In the BSP which operates 24 hours a day for seven days a week a shift roster system is in operation under which the employees work only 168 hours per month instead of an average of 195 hours a month if they worked a normal 45 hours a week for 52 weeks in a year

The Respondents strongly maintained that the Claimants' demand that an employee working on a Sunday as his normal working day to be paid overtime was perhaps the most reckless demand to ever come from them

The Respondents stated that their production requirements were rising each day. To meet the rising demand they must be encouraged to consider introducing a four-week continuous shift roster in all their production units and thus provide additional employment to over 150 people whilst at the same time utilizing the same capital equipment to near full capacity

The Respondents also drew the Court's attention to the fact that an award in accordance with the Claimants' demand would have serious repercussions in the hospitals, hotels, railways, aviation and many other mining and manufacturing industries such as ground milling, cement manufacturing, shoe making, etc

The Respondents claimed that what they had done was in accordance with the provisions of the relevant clauses in the collective agreement which they had with the Claimants

They also informed the Court that although the change at the maltings affect only eight employees following structural renovations and expansions now 160 employees are required to work continuously for up to eight months during and after harvesting barley. During this period a four-shift roster would be an ideal arrangement if the employees involved were to get the necessary rest day in a week and it would also create an additional 54 jobs

The Respondents added that other departments where employees worked continuously 56 hours a week to cover peak periods include transport, BSP and security. Again a proper shift arrangement in these departments would create 120 new jobs

The Respondents also referred to the various relevant ILO Conventions and recommendations in support of their stand and asked the Court to award accordingly

In order to determine this rather complex issue the Court must examine thoroughly the relevant provisions in the collective agreement between the parties. The Court was told that these provisions as they appear in the current agreement have been in force for several years

Clause 5 dealing with hours of work reads as follows —

- “(a) The basic working hours shall be forty-five per week. The company will where possible and practicable considering the work requirements make arrangements for the forty-five hours to be covered between Monday and Friday
- (b) Normally eight consecutive hours of work, exclusive of meal times, constitute a working day Mondays to Fridays and five consecutive hours of work for Saturdays. The times of beginning and stopping work shall be those stated on the official notice board at the place of work
- (c) The hours of work may be varied according to the department's requirements, such as “shift” work, always provided that the basic hours shown at (b) above are not exceeded”

Clause 9 on overtime reads as follows —

- “(a) The company has the right to require any employee to work more than the forty-five basic working hours provided that employees wishing to be excused additional working hours shall receive full consideration on production of reasons acceptable to the company. Except in any emergency, at least six hours notice shall be given to the employees concerned
- (b) For authorized overtime worked the employees shall be paid at the following rates —
- (i) Monday-Friday in excess of 8 hours—basic rate plus 50 per cent
 - (ii) Saturday—1 p.m. onwards, rest days, Sundays and Gazetted Public Holidays—basic rate plus 100 per cent
 - (iii) Overtime rates are only payable after the forty-five basic hours have been worked

(iv) Method of calculation $\frac{\text{Monthly rate}}{195 \text{ hours}} = \text{hourly rate}$ ”

A close study of clause 5 shows that the basic working hours shall be 45 per week and that where possible and practicable considering the work requirements they are to be covered between Monday and Friday

It is also clearly established that the hours of work may be varied according to a department's requirements such as shift work, provided that the basic hours shown in 5 (b) are not exceeded

This clearly shows that the parties expect that the workers would be required to do “shift” work. The purpose of 5 (b) would therefore be merely to lay down that an employee on shift work would not be required to work more than eight consecutive hours exclusive of meal times for Mondays to Fridays and five consecutive hours for work on Saturdays

There can be no dispute on the point that where in certain sections of an undertaking work carried out is of a continuous nature then it is not possible and practicable for the required hours of work per week to be covered between Monday and Friday

The Claimants' main contention in this dispute is that they do not object to shift work as such in the two sections concerned but insist that the Respondents do not have the right of substituting a weekday for Sunday as a rest day. The Claimants further contend that this can only be done with the consent of the employee

The Court cannot accept the Claimants' submission on this point as the Regulation of Wages (General) Order 1977 is quite clear on this point. Section 7 of these Regulations reads as follows —

“Every employee shall be entitled to one whole rest day in each week —

Provided that—

- (i) an employer and his employee may, by mutual consent agree to the deferment of the employee's rest day and the rest day so deferred may be taken by the employee on a subsequent day or may subject to a maximum accumulation of fourteen such rest days at any one time, be accumulated and taken as leave with full pay in addition to the employee's entitlement to annual leave with full pay under paragraph 9 of this Order,
- (ii) the weekly rest day of a person under the age of sixteen years shall not be so deferred”

The Claimants quoted only a part of the above Regulations but reading the whole Regulation it becomes immediately obvious that the Claimants' submission cannot be sustained in law on this particular point

The Court has now to determine if there is anything in the parties' collective agreement which prevents the Respondents from doing so or which commits them to the weekly rest day to a Sunday only and no other day

The Claimants referred to clause 2 (a) of their collective agreement particularly to the proviso which reads

“The Memorandum of Agreement shall supersede all existing Terms and Conditions of Employment or Service and shall apply to all regular employees covered by this Agreement throughout Kenya for those employees in those Occupational Gradings as set out in Schedule “B” of this Agreement. Provided that where work of a special or unusual character is required from an employee, other than those defined, any other terms and conditions may be fixed by special agreement between the Management and the Union”

The Claimants' argument is that the introduction of shift work and the granting of the weekly rest day to workers on a weekday instead of Sunday can only be brought about after agreement with them

The Court is not impressed by this argument because the proviso in 2 (a) is clearly not intended to require the Claimants' agreement to the introduction of shift work in the section where the work is of continuous nature. On the Claimants' own admission Maltings Section is as old as the Brewery itself and the shift system has been in operation in that section

There is a reference to “rest days” in clause 9 (b) (ii) regarding overtime where it is clearly stated that on Saturdays after 1 p.m., on rest days, Sundays and Gazetted Public Holidays, the workers will be entitled to the basic rate plus 100 per cent. If the Respondents have expressly agreed with the Chairman that Sundays only are to be rest days in their undertaking then why do the words “rest days” appear in this subsection along with Sundays and Gazetted Public Holidays?

The Court, however, is very much concerned and takes seriously the submission put forward by the Claimants that the Respondents may gradually decide to introduce continuous work in all their sections and this would seriously affect the present pattern in the country where Saturday afternoons and Sundays are workers' leisure time. The Court will make appropriate comment on this in due course

The Court has no doubt that overtime rates are only payable after 45 basic hours per week have been worked. The Claimants have put forward the submission that these 45 hours have to be covered between Monday to Friday but the Court has already made it clear that this is only where it is possible and practicable which obviously it is not during shift work

On the other hand the Court does not accept that the manner under which the Respondents are operating their shift system for continuous work in the BSP is in accordance with the provisions of the collective agreement. From appendix B to their written submission it appears that some shift workers in one week do 48 hours and get a rest on a weekday. In another week a worker does only 32 hours and gets three rest days being a weekday, Saturday and Sunday and then another shift worker does 40 hours' work with two rest days on Tuesday and Friday. The Court gathered that under this system they are not paying overtime to the workers during the week they work 48 hours i.e. three hours more than the 45 hours specified in the collective agreement per week

The Court cannot endorse the Respondents' practice of working out the total number of hours per month and then getting an average of hours worked per week. The payment of overtime is not related to the number of hours worked per month by an employee but is to be paid after an employee has been required to work more than 45 basic working hours in a week. In these circumstances the Court finds that where a worker has worked more than 45 hours per week notwithstanding that during another week he may work far less than 45 hours the worker is entitled to be paid overtime for the extra hours worked and the Court awards that the workers are entitled to be paid overtime for such extra hours at basic rate plus 100 per cent. It is entirely the Respondents' outlook if they require the workers to work less than the required 45 hours per week and give them more than one rest day. The workers are not to be deprived of their benefits by an arrangement which is instituted by the Respondents. The Court would like to recall that under the recognition agreement one of the management responsibilities is to establish working schedules and to make work adjustments—clause 2 (d)—but this does not mean that the workers can be deprived of their basic entitlements under the collective agreement

The Court further awards that its award as far as it is applicable to BSP should be with effect from 1st December, 1976 i.e. the Respondents are required to pay the employees for all the overtime that they have worked in accordance with the Court's rulings since 1st December 1976

Having disposed of the BSP Section the Court would now like to turn to Maltings Section. Here the parties have worked out an amicable arrangement since 1976 as a result of which the workers have no overtime claim since then. They are, however, claiming overtime payment prior to the time when this arrangement was made in 1976

The Court cannot entertain this claim as it is too vague and no particulars were submitted in support thereof. The Claimants

have admitted that this section is as old as the Brewery itself and the Court wonders why they had not raised their claim for payment of overtime if there is any merit in it prior to this dispute, or when the various collective agreements between the parties were negotiated and agreed. The Court therefore rejects the Claimants' demand made on behalf of the various employees working in this section for payment of any overtime arrears.

During the hearing one very important point emerged and that is the Respondents' statement, which the Court has no reason to doubt, that the workers in the Maltings Section particularly in the Boiler and Engine Rooms are working week in week out without any rest days. The Court finds this to be rather a serious matter as the Respondents in their written submission have clearly stated in the following terms —

"From the information now before the Court and in the light of the above statement by the union, it is now clear that the Claimants are asking the Court to endorse an unfortunate and an illegal procedure which has been introduced as an interim measure due to the pressure of the union. A system which by its nature gives an employee no rest day in a week as required by law—refer section 8 of the Employment Act 2 of 1976 which clearly states 'Every employee shall be entitled to at least one rest day in every period of seven days'."

The Court would like to direct the parties to forthwith embark on negotiations in order to rectify this serious matter. The Court is asking the parties to do it themselves because they have brought about this arrangement by their own agreement and it is therefore their duty to amend this arrangement in such a manner that they would not appear to be adopting an illegal procedure contrary to the provisions of the written law.

Apart from making this observation the Court is not inclined to make any further order as far as Maltings Section is concerned as its operation in this department is not an issue in dispute before the Court. If the Respondents had wanted to see any change in this section then they should have reported a trade dispute to the Minister for Labour on this particular item and in the event of non-settlement the issue would then have come to the Industrial Court for a ruling. The issue before the Court is quite clear and that is the Claimants' demand for payment of overtime to their members in the aforesaid two sections. There is no mention anywhere of the Respondents' complaint that they are not happy with the present system and they would like to see a change in it.

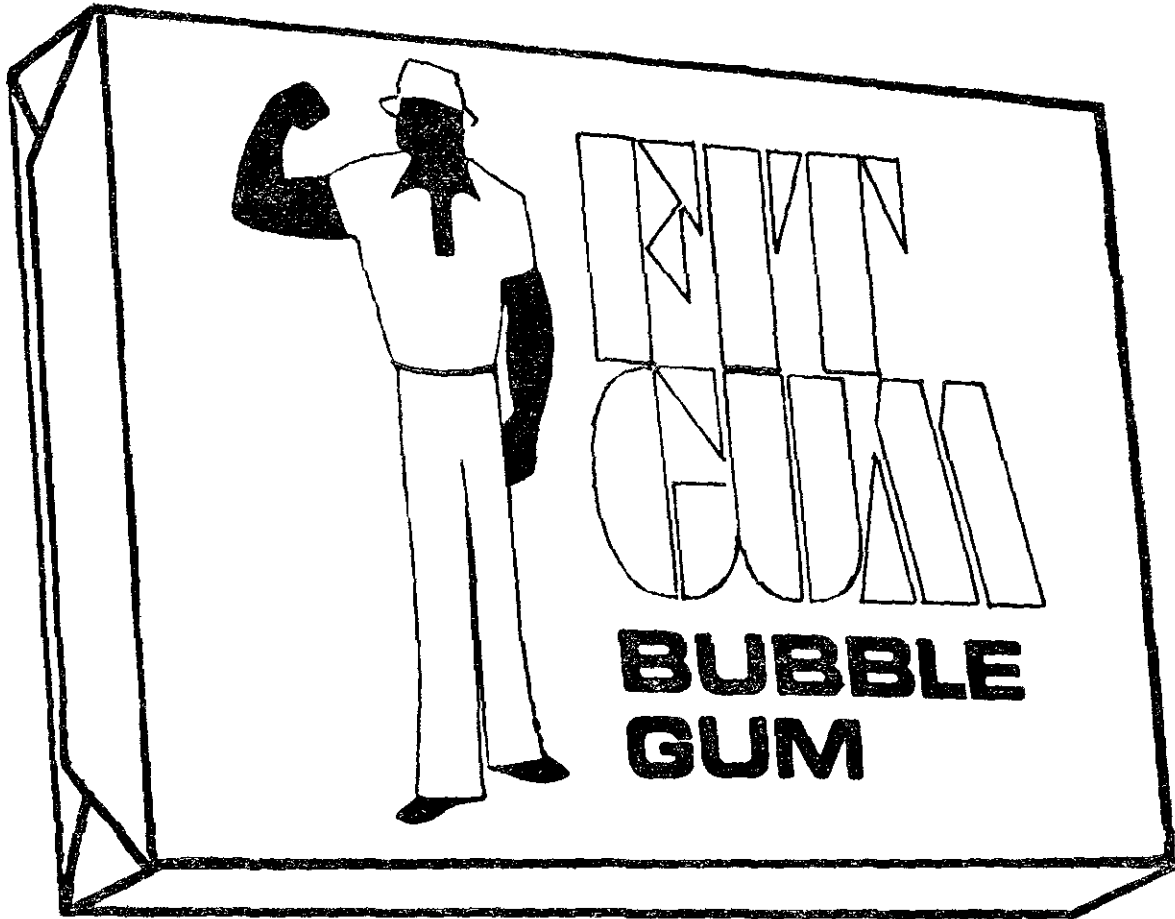

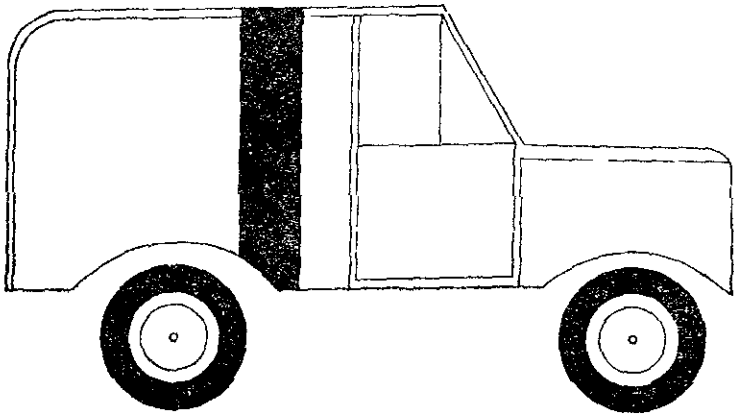
