The Minister rejected the dispute under section 5 (1) (b) which reads:—

"Inform the parties that he accepts or rejects the report of the trade dispute, having regard to the sufficiency or otherwise of the particulars set out in the report, to the nature of the report, or to the endeavours made by any of the parties to achieve a settlement of the dispute, or having regard to any other matter which he considers to be relevant in the circumstances."

The Court cannot accept the Appellants' submission that the Minister should be deemed to have rejected the dispute under section 5 (1) (aa) because this sub-section deals with a refusal to accept the report of a trade dispute when the Minister is of the opinion that any matter in dispute is barred from negotiation under the terms of a recognition agreement or a collective agreement in force between any of the parties to the dispute. The Appellants have neither a recognition agreement nor a collective agreement with the Kenya Government or its Ministry of Community Affairs. The Kenya Government deals with only one union and that is the Union of Kenya Civil Servants with whom the Government has entered into a recognition agreement. The Court finds that there is no merit in the Appellants' submission that the Kenya Government is employing all the former Community employees on an agency basis.

The Court must point out that even if by the barest of technicalities the Community is not dead the fact remains that the Kenya Government is not responsible for discharging the debts and obligations of the Community. If the Community is alive then the Appellants' grievances should be directed to that body and it is not proper for them to drag in the Kenya Government into their dispute with the Community.

The Court is satisfied that the Minister did not misdirect himself in law or otherwise and he must have taken into consideration all the other matters relevant in the circumstances before he decided to reject the report of the trade dispute under section 5 (1) (b). The Court having found that the Minister acted properly in rejecting the dispute under this sub-section further finds that as such the Appellants have no right of appeal to the Industrial Court.

The Court must point out that an appeal can lie against the Minister's order only if the Minister rejects to accept a trade dispute under section 5 (1) (aa) and the Court has no doubt that it is for this reason only that the Appellants argued that the Minister should be deemed to have rejected the report of their trade dispute under this sub-section because otherwise they have no right of appeal.

After careful consideration of all the submissions the Court finds that since the Minister acted properly and in accordance with the legal provisions of the Trade Disputes Act the application for leave to appeal against the Minister's order should be rejected and the Court so rejects it.

Failure to give such notice will be taken into account in considering any application by an opponent for an order for costs if the opposition is uncontested by the applicant.

Where it is stated in the advertisement of the applicant that the mark, upon its registration, is to be limited to certain colours, the colours are, as far as possible, indicated in the accompanying representations of the mark in the usual heraldic manner.

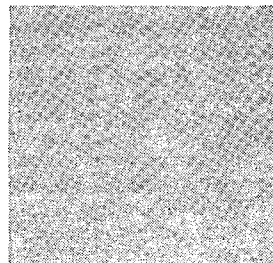

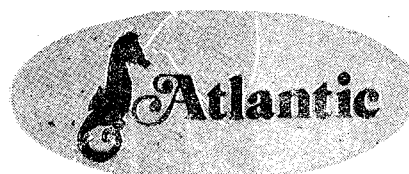

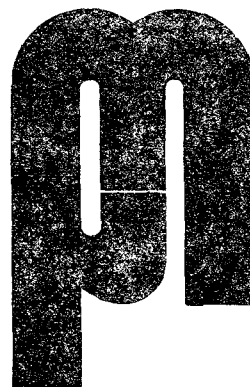
