Physical Planning Officer (Trainee) (Five Posts) (No 368/78)

Applicants must possess one of the following qualifications —

- Five year Bachelor of Architecture degree of the University of Nairobi or its approved equivalent
- Bachelor of Arts degree of the University of Nairobi in Land Economics or Building Economics or the Bachelor of Science degree of the University of Nairobi in Civil Engineering or Surveying and Photogrammetry or Agriculture or equivalent

(c) Bachelor of Arts degree of the University of Nairobi or any other recognized university with at least two of their subjects of study from among Economics, Geography and Sociology in a 3-2-2 degree or with one of the subjects from among the above in 3-1-1 degree

(d) Approved equivalent qualifications recognized by the University of Nairobi in the above fields or other fields associated with planning

Trainees will initially be appointed on temporary terms of service in Job Group "H" (K£1,170 to K£1,554 p a). The training period is normally three years and include attendance at the University of Nairobi in the post-graduate course leading to the degree of Master of Arts (Planning) followed by one year of practical examination set by the Architectural Association of Kenya. On successful completion of the academic training, trainees will be eligible for advancement to salary scale Job Group "J" (K£1,446 to K£1,938 p a) entering the scale on K£1,614 p a. Appointment as Physical Planning Officers in Job Group "J" will be on probationary terms of service.

Assistant Draughtsman (Trainee) (Four Posts) (No 369/78)

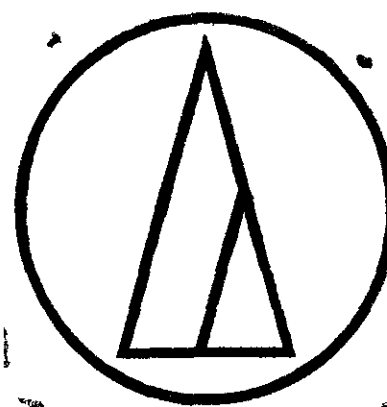
