- (d) notify in writing that Trade Union and that Organization before the end of each month the total amount of any payments made into the accounts of that Trade Union and of that Organization in that month;
- (e) notify in writing the Registrar of Trade Unions before the end of each month of the total amount of any payments made into the accounts of that Trade Union and of that Organization in that month.

And in exercise of the powers conferred by section 36 (2) the order notified by Gazette Notice No. 1932 of 1972 is hereby cancelled.

- 4. Applications must be sent so as to reach the Town Clerk, Kisumu Municipality, not later than 18th December, 1978.
- 5. Applications must not be sent direct to the Commissioner of Lands.

- 15. The Commissioner of Lands reserves the right to revise the annual ground rental payable hereunder after the expiration of the 33rd and 66th year of the term hereby granted. Such rental will be at the rate of 4 per centum as assessed by the Commissioner of Lands.

THE INDUSTRIAL COURT

Cause No. 35 of 1978

Parties:-

Domestic and Hotel Workers' Union and

East African Examination Council

Issue in dispute:-

Refusal by the Council to sign recognition agreement with the Union.

- 1. The Domestic and Hotel Workers' Union shall hereinafter be referred to as the Claimants and East African Examination Council shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 19th day of September, 1978 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 14th April, 1978 duly signed by the parties was received by the Court on 14th July together with the statutory certificate signed by the Labour Commissioner.

The Respondents are a body Corporate established by the East African Examinations Council Act 1967 (Cap. 39 of the Laws of the E.A. Community).

The Council was established to conduct within East Africa such academic, technical and other examinations as it may consider necessary or desirable in the public interest.

From 1967 until about 1971 Tanzania was also an active member of the Respondents when it decided to pull out. The present members are Kenya and Uganda who have mutually agreed to continue to run the Council even after the breakup of the Community.

To all intents and purposes the Respondents are still operaing as before under the same law. They have a head office in Kampala and a regional office in Nairobi and the Court was told that the majority of their employees are stationed in Kampala. In Nairobi they have 72 members of staff.

At the end of August 1977 the Claimants enrolled, according to them 32 of the Respondents' employees into their membership and approached the Respondents for recognition pointing out that as the Respondents' employees had not been represented by any other trade union and the Claimants' union was the proper trade union to represent them they expected the Respondents to sign the recognition agreement which was forwarded to the Respondents.

After a further exchange of letters between the Respondents and the Claimants the Counsel to the Community came into the picture on behalf of the Respondents and the matter dragged on until the demise of the Community when the Attorney-General's Chambers took over the representation of the Respondents in this matter.

On 30th November, 1977 the Attorney-General informed the Claimants that he could not advise the Respondents to enter into negotiations for a recognition agreement with the Claimants because the particular category of employees of the Respondents could not be properly represented by the Claimants and that they were not eligible for membership of the Claimants.

The dispute is now before the Court and the Claimants have argued that their union represents the interests of the employees in all the secondary schools and colleges under the Board of Governors of the Ministry of Education and all other institutions which are grant-aided by the Ministry of Education and that they had secured not only recognition from these institutions but had entered into collective agreements as well.

The Claimants also referred to the recognition agreement which they had secured from the Nairobi University and produced it in support of their demand in the present dispute.

The Respondents have resisted very strongly the Claimants' demand on the ground that the work which their employees did was of great public importance requiring utmost confidentiality and that it would therefore not be in the public interest for them to recognize the Claimants.

The Respondents also asked the Court to consider very critically but objectively the Claimants' constitution and the Respondents' unique position and their operations. They referred to clause 3 (a) of the Claimants' constitution and argued that the Claimants could not recruit the Respondents' employees into their membership because the nature of their job is different from the trades enumerated in the membership clause.

The Respondents further submitted that the terms and conditions of service of their employees both in Kenya and Uganda are uniform and it would not be in the public interest to accord recognition to the Claimants in a regional office in Nairobi as this would cause division in their operations and would be detrimental to the Respondents' work.

Finally the Respondents put forward the plea that their employees should be encouraged to form their own union or an employees' association for the purpose of conducting their own affairs with the Respondents,

This dispute has raised some interesting points. The Claimants' constitution on the question of membership states that the membership of the Claimants union shall be open to all employees engaged in hotels, bars and restaurants' private homes and clubs, private hospitals, educational institutions, religious undertakings, university and university colleges, bakeries, sweets and biscuit making factories including those employed as domestic servants provided such employee is above the apparent age of 16 years.

The Respondents have submitted that the employees working in the educational institutions, religious undertakings and university and university colleges as mentioned above to whom the Claimants membership is open must be employees engaged in duties allied to those of a domestic and hotel worker, such as caterers, cooks and kitchen staff, dormitory workers and the like but not those in specialized supervisory and secretarial categories like the employees of the Respondents that the Claimants are now seeking to recruit and enlist. The Court finds this to be an interesting argument but then the Claimants have produced as an exhibit a recognition agreement which they have secured with the Nairobi University under which the Claimants have been accorded full recognition as a properly registered, constituted and representative body and as the sole labour organization representing the interests of college employees (with the exception of academic, supervisory, administrative, senior technical and senior clerical staff whose names will be advised by the Registrar to the Claimants).

Unfortunately for the Claimants the Respondents have raised further two important points, one is that the Claimants have only 29 of their employees out of a total of 72 in their membership, and further that their head office where the bulk of their staff is stationed is in Kampala showing their international character. They pointed out that if the Claimants are granted recognition that would raise a serious problem in that in due course the Respondents employees in Kenya and Uganda would be segmented. The Court agrees with the Respondents that this is not desirable as all their employees should continue to function as one body. The Court feels that the smooth functioning of the Respondents would indeed be undermined if they are required to sign a recognition agreement with the Claimants.

The Court was told by the Respondents that as of 1st July, 1977 the terms and conditions of employment of their employees were the same as those of the Kenya civil service.

The Court has very carefully considered the submissions made by the parties in this dispute and has come to the conclusion that as the matters are at present the Claimants' attempts to be recognized by the Respondents should fail. The Court accordingly rejects the Claimants' demand.


