7. Each application should be accompanied by a statement indicating: -

- (a) The amount of capital it is proposed to spend on the project.
- (b) The amount of actual capital available for development with a banker's letter or other evidence of financial status in support.
- (c) The manner in which it is proposed to raise the balance of the capital required for the development, if any.
- (d) Full details of both residential and/or commercial properties owned by the applicant.

#### General Conditions

1. The ordinary conditions applicable to township grants of this nature except as varied hereby shall apply to this grant.

2. The grant will be made under the provisions of the Government Lands Act (Cap. 280 of the Laws of Kenya), and title will be issued under the Registration of Titles Act (Cap. 281).

3. The grant will be issued in the name of the allottee as stated in the letter of application.

4. The term of the grant will be for 99 years from the first day of the month following the notification of the approval of the grant.

5. 14. The grantee shall pay such rates, taxes, charges, duties, assessments of outgoings of whatever description as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon, including any contribution or other sum, paid by President of the Republic of Kenya in lieu thereof.

15. The President of the Republic of Kenya or such person or authority as may be appointed for the purposes shall have

the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any buildings in such a way as to cover or interfere with any existing alignments of mains or service pipes or telephone or telegraph wires and electric mains.

16. The Commissioner of Lands reserves the right to revise the annual rental payable hereunder at the expiry of the 33rd and 66th year of the term hereby granted: such rental will be at the rate of 4 per cent of the unimproved freehold value of the land as assessed by the Commissioner of Lands.

Parties:-

Tailors and Textiles Workers' Union and

#### Blanket Manufacturers Group of F.K.E.

Issue in dispute.---Underpayments of the employees covered by the agreement signed on 1st September, 1977.

1. The Tailors and Textiles Workers' Union shall hereinafter be referred to as the Claimants and the Blanket Manufacturers Group of Federation of Kenya Employers shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 10th day of January, 1979, and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated 24th July, 1978, duly signed by the parties was received by the Court on 6th November together with the statutory certificate signed by the Labour Commissioner.

The parties had signed a collective agreement, hereinafter referred to as the Principal Agreement, on 7th August, 1975, for a duration of 36 months with effect from 1st August, 1975.

As a result of the Cabinet Directive in May, 1977, the Regulation of Wages (General) Order, 1977 (L.N. 185) dated 1st July, 1977, came into operation on that date. As a result of this the statutory minimum wages per month for various categories of employees specified therein were increased by the amounts specified therein.

On 1st September, 1977, the parties agreed to enter into a supplementary agreement to the Principal Agreement. In this supplementary agreement they agreed as follows:-

"In accordance with the Cabinet Directive of 18th May, 1977, on renegotiations of collective agreements and new minimum wages, agreement as follows has been reached on wages increases:

Persons in employment of the Group who have not benefited from recent increases in the basic minimum wages will receive wage increases of 6 per cent on the prevailing rates of wages on 1st May, 1977.

The above increases to take effect from 1st May, 1977.

Other provisions of collective agreement signed between the parties and effective from 1st August, 1975, remain unchanged."

The Claimants have raised this dispute on the ground that two of the Respondents' members are underpaying their employees in contravention of the agreements made between

them. They stated that the most affected workers are machine attendants whose wages prior to the announcement were Sh. 360 p.m. and Sh. 368 p.m. respectively and who received increases of Sh. 15 and Sh. 7 only instead of the official and negotiated increase to which they were entitled of Sh. 21/60 and Sh. 22/08 (6 per cent).

The Claimants have asked the Court to order the Respondents to pay their employees arrears of Sh. 6/60 and Sh. 15/08 p.m. from the date of the agreement.

The Claimants further argued that their supplementary agreement had been based on the May-Day announcement and that they had signed it in good faith as they did not expect the Respondents to misinterpret the agreement which they had made with them. They also accused the Executive Officer of the Federation of Kenya Employers, Coast Branch, for not taking down the minutes of the meeting between the employers and the trade unions which he normally chairs.

Finally the Claimants argued that one of the Respondents, i.e. Blanket Industries, had implemented the agreement according to the Claimants' interpretation and they asked the Court to order other members also to do the same.

The Respondents have vigorously opposed this demand on the ground that there was no confusion or ambiguity in the supplementary agreement. They pointed out that only those employees who did not benefit from the General Order of July, 1977, were to be given a wage increase of 6 per cent on the prevailing wage rates with effect from 1st May, 1977. This meant that even those who got increases as a result of the General Order had to be given those increases as from 1st May, 1977.

The Respondents submitted that in accordance with their agreement they had adjusted the minimum wages and gave the necessary details in their written submission.

The Respondents rejected the Claimants' argument that the machine attendants who were earning Sh. 360 and Sh. 368 p.m. as at 30th April, 1977, should have received increases of Sh. 21/60 and Sh. 22/08 respectively instead of the resultant increase of Sh. 15 and Sh. 7. They asked the Court not to accept this argument as to do so would defeat the principle of free negotiations and kill the spirit of give-and-take in such negotiations. They requested the Court to reject the Claimants' demand.

The Court would like to recall that the Government Directive of May, 1977, as far as the private sector was concerned clearly stressed that the increases of up to 6 per cent were not automatic and were to be negotiated between the parties. It is because of this that the parties entered into the supplementary agreement on 1st September, 1977. The Court has carefully studied this agreement and finds that it is very clear and there is no ambiguity in it which should have caused any confusion in the minds of the parties. The agreement clearly states that persons in employment of the Group who have not benefited from recent increases in the basic minimum wages will receive wage increases of 6 per cent on the prevailing rates of wages on 1st May, 1977. This means that those employees whose basic minimum wages were increased are not entitled to 6 per cent wage increase as they have already received an increase on their wages as a result of the General Order which was published at the time.

It was the Claimants' duty to make sure that the supplementary agreement was worded in the manner in which they want to interpret it now. It is of no use for them to enter into a clearly worded agreement and then later on to come and say that the agreement does not represent what they had agreed and that they had signed it in good faith. The Court has already warned the trade unions about this matter and hopes that in future they will take utmost care to make sure that the agreements they sign contain exactly what they allege to have been agreed at the joint negotiating meetings.

After careful consideration of all the submission the Court is satisfied that there have been no underpayments to the employees covered by the agreement signed on 1st September, 1977, and the Claimants' demand is accordingly rejected. The Court would, however, like to add that one employer who had implemented the agreement differently from the rest has indicated and agreed to carry on paying those rates and the Court accordingly makes it clear that he should not deduct any amount from his employees.

- Particular attention should be paid to the following points:----(i) Signatures must be clarified by means of rubber-stamping
- or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenva Gazette

D.41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
