## VACANCIES

APPLICATIONS are invited for the posts shown below. Completed application forms should reach the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, on or before 10th May, 1979.

Civil servant applicants should complete Forms PSC.2A in triplicate (submitting the original through their Heads of Departments) and Cards PSC.25 and 25A. Other applicants should complete Forms PSC.2 in triplicate and Cards PSC.24 and 24A.

These documents are obtainable either from the Secretary or from other Government offices.

Originals of certificates and similar documents should not be submitted unless specifically asked for.

## NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government Regulations.

*Vacancies in the Ministry of Lands and Settlement:**Project Manager (One Post) (No. 141/79)*

*Salary scale.*—£2,712 to £3,540 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Agriculture from a recognized university. They must have at least five years' experience in project preparation, analysis, implementations, control and evaluation. Post-graduate training in either Agriculture, Economics, Farm Management or related fields will be an added advantage. Serving officers must have served at the level of Senior Agricultural Officer, Job Group "L", for at least three years and knowledge of Government personnel, financial and accounting procedures is essential.

Duties of the Project Manager will include the direction and control of project operation in conjunction with senior local and expatriate staff. He will pay particular attention to staff matters, project reporting, budgeting, liaison with other Government departments and agencies and will maintain close relations with the local inhabitants and the settler population.

The successful candidate will be responsible to the Director of Settlement for the overall implementation and management of the Magarini Land Settlement Project and will be based at Magarini in Malindi Division of Kilifi District.

*Senior Agriculture Officer (Extension and Credit) (One Post) (No. 142/79)*

*Salary scale.*—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should be holders of a Bachelor of Science degree in Agriculture from a recognized university and must have at least five years' experience in agricultural extension. Post-graduate training in agricultural extension would be an advantage. Preference shall be given to civil servants who are already serving as Agricultural Officer I (Job Group "K").

The successful candidate will be responsible for initiation and implementation of an agricultural extension service in the Magarini Land Settlement Project, Kilifi District. The work involves farm planning and budgeting, administration of a credit scheme, supervision and training of technical personnel. The successful candidate will be based within the project area.

*Senior Agricultural Officer (Planning) (One Post) (No. 143/79)*

*Salary scale.*—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates in Agriculture and should have at least five years' experience in project preparation, implementation and evaluation. The applicants should have served at the level of Agricultural Officer I (Job Group "K") for at least three (3) years.

Post-graduate training in Agricultural Economics or Farm Management will be an advantage.

The Senior Agricultural Officer (Planning) will assist the Project Manager in project implementation, evaluation and expansion. He will be responsible for data collection, analysis and interpretation including preparation of progress reports

and formulation of policy recommendations for settlers and the Project Management Guidelines. He will advise on record-keeping at the settlers level.

The successful candidate will be stationed at Magarini in Malindi Division of Kilifi District.

*Agricultural Officer Grade I (Two Posts) (No. 144/79)*

*Salary scale.*—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Agriculture from a recognized university with at least three years' experience.

One of the posts will deal with operation and administration of the General Investigation Station at Magarini. Experience in running a Government Research Station will be an added advantage but not essential.

The second post will deal with administrative and technical matters at the Project Manager's office. Applicants for this post should have field experience in agricultural extension and preference will be given to those who have served as Divisional Agricultural Officers or District Agricultural Officers.

Duty station will be Magarini in Malindi Division of Kilifi District.

*Superintending Engineer (Mechanical) (One Post) (No. 145/79)*

*Salary scale.*—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Mechanical Engineering from a recognized university or an equivalent qualification and must have been registered by the Kenya Engineers Registration Board. They must have had five years' satisfactory post-graduate experience in mechanical engineering three of which must have been in a responsible supervisory position related to operations and maintenance of vehicles and heavy tractors. Proven ability in administration and organization is necessary as the successful candidate will be in-charge of all project vehicles, plants, heavy tractors and will supervise and direct all the project staff involved in the operation and maintenance of the machinery and equipment.

Duty station will be in the project area at Magarini in Malindi Division of Kilifi District.

*Senior Technical Officer (Soil Conservation) (One Post) (No. 146/79)*

*Salary scale.*—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

The applicants should have served as technical officers Grade II for a minimum of five years. They must have had 10 years' experience in water and soil conservation activities and must have served for at least five years at National Level. The applicants must have had practical experience at supervisory level and a wide experience in survey work, planning, dam designing and dam construction and laying out water and soil conservation measures suitable for both small scale farming operation as well as large scale farming operation.

The successful candidate will be directly responsible for the day to day planning and supervision of the land development programme, land clearing, ploughing, banking and plot demarcation. Responsibilities for the post shall include an element of training of operators in the mechanized operation and the marking of plot boundaries. Successful candidate shall in addition be required to design and lay out soil and water conservation works. Training of subordinate staff in this aspect would be an important function. The officer will have the ability and responsibility to interchange men and machines between operations if necessary, to avoid parts of the programme falling behind schedule. Co-ordination with workshop staff to ensure that maintenance programmes are carried out will also be an important function.

Duty station will be Magarini in Malindi Division of Kilifi District.

*Agronomist Grade I (One Post) (No. 147/79)*

*Salary scale.*—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Agriculture from a recognized university. They must have served as Agronomists in a Research Station for a minimum of three years. Post-graduate training in Agronomy will be an added advantage.

The successful candidate will be responsible for conducting agronomy trials at the General Investigation Station, Magarini

and will be required to formulate crop production recommendations for use by the extension services in the area in conjunction with agricultural planner. He will also be responsible for bulking of seeds and other planting materials suitable for the area. At a later date he will be required to recommend suitable grasses and fodder crops suitable for animal production in the area.

Initially, the successful candidate will work with the Australian Senior Agronomist and will be based at Magarini in Malindi Division of Kilifi District.

*Vacancies in the Office of the President:**Senior Assistant Telecommunications Engineer (Six Posts)*  
(No. 148/79)

*Salary scale.*—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess the East African Examinations Council, Telecommunications Technicians Certificate, Course No. 271 or equivalent plus considerable practical experience with a reputable telecommunications organization, preferably the Kenya Police Force. Applicants should be familiar with all methods of telegraphic handling and will be required to exercise administrative control over uniformed Police Radio Operators as well as civilian technicians. A thorough working knowledge of M.F., H.F. (S.S.B./I.S.B.) V.H.F. and U.H.F. Fixed, mobile and portable equipment as well as Radio Bearer/Multiplex Equipment together with associated aerial systems is essential. Knowledge of teleprinters and radar traffic analysis equipment is desirable. Applicants must also have a good working knowledge of Kenya Government Code of Regulations and stores accounting procedures. Successful candidates will be required to serve at any Provincial Headquarters.

*Lecturer (Farm Management) (One Post)* (No. 149/79)

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must have previous experience in farm management and labour administration. A diploma or higher qualification or relevant discipline will be an advantage.

Work involves teaching, preparation and design of courses, seminars, workshops and teaching aids for the public as well as long professional courses for extension staff. In addition to these duties the successful applicant will be responsible for the development and management of a demonstration farm which will serve as educational link between the centres and the farmers in the locality. It also involves the organization of field days and shows. Ability to give courses of instruction and communicate technical farming information to residential students and study tour groups is essential.

*Senior Fingerprint Assistant (One Post)* (No. 150/79)

*Salary scale.*—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants who have served in Job Group "F" for a period of not less than two years. They must have shown merit and ability in work performance within the two years' service.

The duties entail testing classifications and extensions and giving alternatives to fingerprint formulae put up by Fingerprint Assistants, supervision of their work and training or searching and comparing finger marks found at scenes of crime and/or identification of dead bodies using fingerprints.

The officer appointed may be required to give expert evidence of fingerprint identification in a Court of Law.

The post is in the Fingerprint Bureau of the Criminal Investigation Department.

*Vacancies in the Ministry of Power and Communications:**Superintendent (Electrical) (Two Posts)* (No. 151/79)

*Salary scale.*—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must have full Technological Certificate in Electrical Engineering Technician or Electrical Installation Technician course or its equivalent, followed by at least three years' practical experience, one of which must have been in a supervisory position in one or more of the following:—

- (a) The preparation of design drawing, specifications and estimates for electrical installations in public buildings, hospitals, institutions, factories, etc.

- (b) The installations, operation and maintenance of electrical generating plants and machinery including H.T. and L.T. distribution services.

- (c) The installation, inspection and testing of electrical installations in public buildings, hospitals, institutions, factories, etc.

They must have a thorough working knowledge of the current "Regulations for the Electrical Equipment of Building" and hold an Electrician's "A" Licence.

*Electronic Technician Grade I (Two Posts)* (No. 152/79)

*Salary scale.*—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess East African Examination Council Telecommunication Technicians Certificate Part II or its equivalent and must have worked satisfactorily for not less than three years as Electronic Technician II.

Applicants must have a thorough working knowledge of H.F., V.H.F. and U.H.F., Meteorological Radars, Radio Sonde, Facsimile Receiver and Transmitters and Meteorological Satellite equipment.

Successful candidates must work on the above-mentioned equipments independently.

*Electronic Technician Grade II (Six Posts)* (No. 153/79)

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must have the East African Examinations Council Telecommunications Technicians Certificate Part II or its equivalent in Mathematics, Telecommunications Principles and Radio. Also must have three years' proven experience in the maintenance of Meteorological Radars, Meteorological Radio-Sonde and Meteorological Satellite Ground Automatic Picture Transmission equipment, H.F., V.H.F. and U.H.F. Transmitters and Receivers.

*Vacancies in the Ministry of Information and Broadcasting:**Stage Designer (Four Posts)* (No. 154/79)

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduate from accredited universities with specialization in Fine Art or Design. Consideration will, however, be given to those who do not possess a university degree but who are in possession of the East African Certificate of Education and a diploma in Fine Art from a recognized institution, coupled with at least three years' practical experience in television design work. They must be fluent in both written and spoken Kiswahili and English. A knowledge of printing will be an added advantage but is not essential.

*Security Officer (One Post)* (No. 155/79)

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be of East African Certificate of Education standard or its equivalent and should have had working experience in the armed forces or other security organizations and holding a commissioned rank or a senior position for at least five years. Proven organizational ability and capacity for supervision and leadership are essential. Officers who have served in the post of Senior Security Warden for at least four years may be considered.

The successful candidate will be responsible for security of Government property within Broadcasting House and other relevant stations. Duties will include supervision and maintenance of discipline among security staff. He will also be required to carry out security checks within Broadcasting House and to investigate cases of lost Government property.

*Vacancy in the Ministry of Economic Planning and Community Affairs (Central Bureau of Statistics):**Library Assistant Grade I (One Post)* (No. 156/79)

*Salary scale.*—£642 to £900 p.a. PENSIONABLE or AGREEMENT.

*Library Assistant Grade II (One Post) (No. 157/79)*

*Salary scale.—£531 to £744 p.a. PENSIONABLE or AGREEMENT.*

Applicants should be in possession of East African School Certificate and must have worked as Clerical Officers in a Library for at least two years and must have subsequently attended a Library Course and been awarded the Certificate of Librarianship of the East African School of Librarianship, Makerere University or its equivalent and must have been confirmed in their appointment.

*Vacancy in the Ministry of Natural Resources:*

*Senior Library Assistant (One Post) (No. 158/79)*

*Salary scale.—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.*

Applicants should be civil servants who are in possession of East African Certificate of Education or its equivalent and must have served in Job Group "F" for a period of not less than three years and are in possession of the Certificate of East African School of Librarianship, Makerere University or its equivalent and have shown ability to organize and control work in a medium-sized library within the three years of service in Job Group "F".

The successful candidate will be responsible for carrying out specialized library duties of more complex nature than those of judgement within existing rules, regulations and procedures in running a medium-sized library. The work mainly involves—classification, cataloguing, shelving, and circulation of books and periodicals, ordering and procurement of reading material and supervision of junior staff. In large and specialized departmental libraries, Senior Library Assistant may be required to assist the Librarian in the management and supervision of the library services including training of staff.

Ability to work from rough sketches and survey field bookings to finish drawing is essential and experience in map preparation would be advantageous. A good command of English is very essential and desirable. Successful candidate will be required to supervise the work of a number of draughtsmen and train junior personnel and must therefore be mature person.

*Draughtsman Grade III (Electrical) (One Post) (No. 160/79)*

Applicants must be in possession of East African Certificate of Education or its equivalent. They must be holders of the City and Guilds Electrical Engineering Technical Certificate, Final Grade, or its equivalent. They should have at least five years' practical experience as draughtsman in an electrical engineering office (building services) and must have passed the relevant occupational Test Grade I.

2. *Education Grant*.—Under certain conditions an education grant is paid up to a maximum of \$2,250 per child annually, as well as expenditure on children's education travel to and from the home country or other permissible place of education.
3. *Pension Fund*.—The staff member will become a full participant in the United Nations Joint Staff Pension Fund which involves a contribution by the staff member of 7 per cent of his pensionable remuneration (presently established at 125 per cent of the gross salary) with the Organization contributing 14 per cent. The staff member's contribution plus accrued interest will be refunded to him on termination of his contract.
4. *Compensation for Service Incurred, Death, Injury or Illness*.—The Organization pays compensation for death, injury or illness attributable to the performance of official duties, in accordance with established rules.

5. *Medical Insurance*.—A staff member assigned to Headquarters will be required to participate in the Quebec Medical Insurance Plan (Medicare) and the appropriate deduction will be made from salary. In addition there is a supplemental optional group medical insurance plan.

Group medical insurance plans are available to staff members assigned to Regional Offices.

6. *Life Insurance*.—A group life insurance plan can be joined by the staff member.
7. *Sick Leave*.—Adequate sick leave is granted.
8. *Annual Leave*.—Six weeks annual leave accrue each year.
9. *Travel and Related Expenses on Appointment*.—The Organization meets the cost of travel expenses of the staff

member and recognized dependents from the place of home to the duty station, and in addition pays reasonable costs of removal of furniture and personal effects. In the case of posts in Regional Offices other than Paris, the Organization may offer to pay an assignment allowance in lieu of removal of furniture and personal effects. Also payable is an installation grant, varying in amount according to the location of the duty station and the number of dependents of the staff member, to compensate for expenses normally incurred in initially settling in at the duty station.

10. *Travel and Related Expenses on Termination*.—The Organization pays the cost of travel of the staff member and recognized dependents from the duty station to the place of home. The Organization also pays reasonable costs of removal of furniture and personal effects to the staff member's home unless the staff member was being paid an assignment allowance during the appointment.

11. *Terminal Payments*.—A repatriation grant designed to assist in the re-establishment of the staff member in the home country and varying in amount with the length of service rendered and family status is paid on separation from service. In addition, if the services of a staff member holding a fixed-term appointment of more than six months are terminated for reasons other than serious misconduct, prior to the expiry date of the appointment a termination indemnity will be paid by the Organization; in certain cases the payment of this indemnity is discretionary and it is not paid in case of resignation, abandonment of post or expiry of fixed-term appointment.

4. Applications must be sent so as to reach the Clerk to County Council of Olkejuado, not later than noon, on 14th May, 1979.

5. Application must not be sent direct to the Commissioner of Lands.

6. Applicants must enclose with their applications their money orders or postal orders or cash of Sh. 1,000 as a deposit which will be dealt with as follows:—

- (a) If the applicant is offered and takes up and pays for a plot within a period of seven days as required in paragraph 5 below, the deposit will be credited to him.
- (b) If the application is unsuccessful the applicant's deposit will be returned to him.
- (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 below of the General Conditions, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

7. Each application should be accompanied by a statement indicating—

- (a) the amount of capital it is proposed to spend on the project;
- (b) the amount of actual capital available for development with a banker's letter or other evidence of financial status in support;
- (c) the manner in which it is proposed to raise the balance of the capital required for the development, if any;
- (d) each applicant should fill in his/her new number as it is appearing in the identity card under the Registration of Persons Act;
- (e) In case of companies, names of directors to be included;
- (f) full details of both residential and/or commercial properties owned by the applicant in the Republic.

*General Conditions*

1. The ordinary conditions applicable to township grants of this nature except as varied hereby shall apply to this grant.

2. The title will be made under the provisions of the Trust Lands Act (Cap. 288 of the Laws of Kenya).

3. The grant will be issued in the name of the allottee as stated in the letter of application.

4. The term of the grant will be for 33 years from the first day of the month following the notification of the approval of the grant.

5. Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the initial estimated amount for the construction of roads and drains to serve the plot, the assessed stand premium and proportion of annual rent, together with the survey

fees payable in respect of the preparation and registration of the title (Sh. 400) and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent) in default of payment within the specified time. Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot.

*Special Conditions*

1. No building shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The lessee shall within six months of the actual registration of the lease submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings, the grantee proposes to erect on the land and shall within 24 months of the actual registration of the title complete the erection of such buildings and the construction of the drainage system in conformity with such plans, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Trust Lands Act (Cap. 288), if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful by him on behalf of the County Council to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the County Council in respect of any antecedent breach of any condition herein contained.

3. The lessee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the County Council that he is unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that in such notice as aforesaid shall be given—

- (1) within 12 months of the actual registration of the title, the County Council shall refund to the grantee 50 per centum of the stand premium paid in respect of the land; or
- (2) at any subsequent time prior to expiration of the said building period, the County Council shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period, no refund shall be made.

5. (a) The land and buildings shall only be used for one private dwelling house, excluding a guest house.

(b) The land and buildings shall only be used for shops (excluding a petrol station), office and flats.

(c) The land shall only be used for inoffensive industrial purpose with ancillary offices and stores.

6. The buildings shall not cover more than 75 per centum of the area of the land if used for shop and/or office purposes only or such lesser area as may be laid down by the local authority in its by-laws and not more than 50 per centum of the area of the land if used for the combined purposes of shops, offices and flats or such lesser area as may be laid down by the local authority in its by-laws. And not more than 50 per cent if used for residential purpose; and not more than 90 per cent if used for industrial purpose.

7. Accommodation not exceeding one hundred square feet may be provided for a care-taker or watchman in case of industrial purposes plots

8. The land shall not be used for the purpose of any trade or business which the Commissioner of Lands or local authority considers to be dangerous or offensive.

9. The lessee shall not subdivide the land.

10. The lessee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof, except with the prior consent in writing of the Commissioner of Land, no application for such consent (except in respect of a loan required for building purposes) will be considered until Special Condition No. 2 has been performed:

Provided that such consent shall not be required for the letting of individual shops, offices and flats.

11. The lessee shall pay to the local authority on demand such sum as the local authority estimate to be the proportionate cost of construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

12. The lessee shall from time to time pay to the local authority of lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the lands as the local authority may assess.

13. Should the local authority at any time require the said roads to be constructed to a higher standard, the grantee shall pay to the Commissioner on demand such proportion of the cost of the construction as the local authority may assess.

14. The lessee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President in lieu thereof.

15. The County Council or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.

## THE INDUSTRIAL COURT

CAUSE No. 3 OF 1979

Parties:—

Amalgamated Union of Kenya Metal Workers  
and  
Nu-Tread Tyres Limited

Issue in dispute—

Termination of services of Douglas Muthui.

1. The Amalgamated Union of Kenya Metal Workers shall hereinafter be referred to as the Claimants and Nu-Tread Tyres Limited shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 26th day of March, 1979, and relied on their written and verbal submissions. The Respondents also called Parminder Singh Bedi, the Managing Director, to give evidence on oath.

## AWARD

3. The Notification of Dispute Form "A" dated 21st March, 1978, duly signed by the parties was received by the Court on 5th February, 1979, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Douglas Muthui was employed on 9th November, 1972, as a tyre examiner by the Respondents at the wage that was specified for that category of workers in the parties' collective agreement. His services were terminated on 19th June, 1976; at that time he was earning Sh. 495 p.m. He was offered a sum of Sh. 654 made up as follows:—

The Claimants having taken up the matter on his behalf an Investigator looked into the matter. On 6th March, 1978, the Permanent Secretary released the findings and recommendation to the parties. These were as follows:—

"Mr. Muthui was employed and trained by the company as a tyre expert he had the knowledge of certifying that the tyres were fit for retread. He was under a supervisor who he could consult in difficult cases but he became irresponsible and untrustworthy.

He began to pass on worn out tyres for retread in favour of customers who would later give him tips through corrupt practices. So the company decided to terminate his services. Note has been taken that at the termination of his services Mr. Muthui received his terminal benefits.

Having made the above observations it is clear that Mr. Muthui abused the trust entrusted in him and therefore has to blame himself. In the circumstances it is considered that the action taken by the management against Mr. Muthui who had become untrustworthy was justified. His terminal benefits alleged to have been paid should be paid if not already done."

The Claimants did not accept the above findings and recommendation and alleged that the Investigator was biased and they could not understand how the Investigator had come to

the above conclusion. They alleged that the Investigator had not done her homework properly.

The Respondents naturally accepted the Ministry's recommendation.

During the hearing the Claimants did not call any witness, not even Mr. Muthui who was present in Court. The Respondents called Parminder Singh Bedi, their Managing Director, to give evidence on oath.

Mr. Bedi explained that Mr. Muthui's work had been very unsatisfactory and produced two letters of warning dated 13th and 21st August, 1973, served on Mr. Muthui. On the first occasion the offence was that he had accepted a truck tyre which was below the standard as it had flint cuts all over and had three sections. The second warning letter was because he had signed a receipt No. 13800 without checking properly and not bringing the matter to the notice of the management.

He also referred to a third letter of warning dated 14th August, 1975, and again the offence was that Mr. Muthui had accepted three tyres below retread standard.

The Court, however, agrees with the Claimants' submission that in accordance with clause 13 (e) of the parties' collective agreement the third letter of warning was issued when the earlier two warnings had been expunged from his employment record as this particular clause reads as follows:—

"If an employee completes twelve months from the date of either the final warning, second warning, or the first warning without any further offence, any warning recorded on his employment record card shall be cancelled."

The fact, however, remains that Mr. Muthui was not dismissed under the warning clause and was dismissed, according to the management, for having committed a gross misconduct on 18th June, 1976, in that he accepted two tyres from a particular customer which were not suitable for retreading. These two tyres were produced as exhibits in the Court by Mr. Bedi while giving evidence and both of them had the signature of Mr. Muthui on them with words "O.K." on one tyre having been crossed out.

Mr. Bedi confirmed that the chalk handwriting was Mr. Muthui's but conceded that the inspector's code numbers which should be within the tyres were not there in these two tyres. He added that this further showed that Mr. Muthui had not done his duty properly.

As far as the condition of these two tyres was concerned he showed to the Court that in one of the tyres there was a big patch inside and the tyre should therefore have been rejected. He added that four or five plies in the other tyre were also damaged and that tyre should also have been rejected. He denied any personal conflict with Mr. Muthui and said that Mr. Muthui had not improved despite several warnings with the result that they had no alternative but to dismiss him on 19th June.

The Court has carefully considered the Claimants' various points and arguments made on behalf of Mr. Muthui but unfortunately for them in the absence of Mr. Muthui's evidence on oath they remain as mere assertions without having been proved in any manner. The Court cannot understand why the Claimants did not call Mr. Muthui to give evidence on oath and to be cross examined by the Respondents so that the Court could have judged whether or not he was telling the truth. The Court would like to remind the parties that appear before it that it is up to them to prove their points by calling the necessary witnesses or by tabling authentic documentary evidence.

The Court has before it the evidence of the Respondents' Managing Director which he gave on oath and in the absence of any contradictory evidence the Court has no alternative but to accept his evidence because his evidence in the main remained unshaken in cross examination. Mr. Bedi gave the following answers when he was cross examined:—

"I have been in tyre trade since 1956 only through experience. Own business in 1967. We have supervisor. Mr. Muthui was under the supervisor who is the Plant Manager. Our employees have been given a chart listing defects which should not be accepted; the instructions re defects are besides the machine.

"Muthui cancelled O.K. after he knew that he had been caught, he cancelled one only. This is Muthui's handwriting. Inspector's Code No. is inside the tyre, it should be there if he did his duty properly. I could have set a trap but I did not do so."

If as the Claimants put forward to the Court, Mr. Muthui had not signed the documents in respect of these two tyres then he should have been called to give evidence and say so on oath because Mr. Bedi stated clearly in his evidence in chief that

these two tyres were accepted by Mr. Muthui and not the other tyre examiner.

In view of the documentary evidence regarding the two tyres in question and the fact that these two tyres were produced in Court as exhibits the Court is satisfied that these two tyres are the same tyres which Mr. Muthui is alleged to have accepted because of the serial numbers as recorded in the documents coupled with the evidence of Mr. Bedi on oath. The Court cannot uphold the Claimants' submission that the incident that led to Mr. Muthui's termination was merely based on suspicion and guess-work that he intended to get a reward from a customer in passing a worn out tyre for retreading.

The Court is satisfied that Mr. Muthui was an unsatisfactory employee and after careful consideration of all the submissions the Court rejects the Claimants' demand to find that Mr. Muthui's services were terminated wrongfully and that he should be reinstated without loss of benefits.

Since the Respondents had offered to pay Mr. Muthui one month's salary on an *ex gratia* basis the Court feels that they should stick to their offer and the Court accordingly awards that Mr. Muthui in addition to the amount offered by the Respondents to him amounting to Sh. 654 as stated hereinabove should be paid one month's salary.

The Court would like to add in the end that the allegation of bias made against the Investigator appointed by the Ministry of Labour was not proved at all and would like to add that it was rather an unfair criticism of the Government official involved.
