They must have taught Mathematics up to "A" level or at a Secondary, Teachers College for at least five years and must be fully conversant with current developments and issues in the teaching of Mathematics at every level of the school system in Kenya. They must show evidence of having been involved in curriculum development activities in the subject of Mathematics as well as having been actively engaged in examinations work or research work in the field of Mathematics.

Education Officer (Inspector for Physics/Chemistry) (One Post) (No. 300/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must be professionally qualified graduates with honours degree in the field of Physics/Chemistry from recognized universities and must have taught Physics/Chemistry up to "A" level or at Secondary Teachers College for at least five years. They must be fully conversant with current development and issues in the teaching of Physics/Chemistry at every level of the school system in Kenya and must show evidence of having been involved in curriculum development activities in the subject of Physics/Chemistry as well as having been actively engaged in examinations work or research work in the field of Physics/Chemistry.

Education Officer (Inspector for Technical Subjects) (One Post) (No. 301/79)

Applicants must be trained graduates of a recognized university in Engineering or its equivalent. Applicants holding Technical Teachers Certificates must be of Approved Teacher Status. Industrial experience and a minimum of three years teaching in a technical institution will be essential. Knowledge of schools administration, examinations and curriculum development will be an added advantage.

Executive Assistant (Eight Posts) (Re-Advertisement) (No. 303/79)

Salary scale.—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants of East African Certificate of Education or its equivalent with at least seven years satisfactory experience in the Clerical cadre, one year of which must be in the grade of Senior Clerical Officer. A thorough knowledge of Government Regulations, Government office routine and procedure, and ability to control staff and conduct correpondeince independently, are essential.

Preference will be given to applicants who have successfully completed a three-month course in office Management at the Kenya Institute of Administration, Kabete or at the Government Training Institute, Maseno. A pass in Proficiency Examination for Clerical Officers is mandatory.

Successful candidates will be liable for posting anywhere in Kenya.

Non-graduates must have attended a recognized Probation Officers' Course of Training with experience of at least two (2) years satisfactory service in Probation Field work at the grade of Probation Officer III.

Successful candidate will be expected to take charge of a less busy district or very busy and complicated division. This would involve organizing and planning all Probation Court investigations and rehabilitation of offenders as well as organizing and controlling staff. He/she will also be the Secretary of Probation Case Committee in his/her area.

Trainee Vacancies in the Office of the President:

Laboratory Technologist (Trainee) (Seven Posts) (No. 306/79)

PENSIONABLE or AGREEMENT.

Applicants should hold the East African Certificate of Education with two credits in Science subjects, one of which should be Physical Science or Chemistry: or be holders of East African Advanced Certificate of Education with at least a pass in Chemistry. The successful candidates will be trained in the Chemical Analysis of Foods, Drugs, Water Industrial Materials and in forensic science and will be sponsored for the relevant training at the Kenya Polytechnic.

Training Conditions

- (i) The training, period will normally be for three years.
- (ii) Trainees will initially be appointed on temporary terms of service and will be paid a fixed allowance of K.Sh. 820 per month if in possession of East African Certificate of Education or K.Sh. 960 per months for holders of East African Advanced Certificate of Education. This allowance will be inclusive of house allowance. The first six months of training will be a period of trial during which the training may be terminated by either party.
- (iii) On successful completion of the training, trainees will be eligible for appointment on probationary terms of service to the grade of laboratory Technician III (Job Group G) on salary scale £864 to £1,212 p.a.

Fringe Benefits

Trainees will be entitled to the following fringe benefits.

- (i) Accommodation allowance at the rate of K.Sh. 15 p.m. when travelling on duty away from permanent station and make their own arrangement for boarding and lodging provided they do not stay with Government Officers.
- (ii) Free medical treatment at Government hospitals for themselves only but not to members of their family.
- (iii) Free transport whilst travelling to join the course and also when travelling on vocation leave.
- (vi) Free stationery/book and protective clothing or uniform where the nature of training makes it necessary, provided the recommendation of heads of training Institutions/Training Officer has been obtained.
- (v) 14 days annual vocation leave.

Fingerprint Assistant (Trainee) (Eleven Posts) (No. 307/79)

PENSIONABLE or AGREEMENT.

Applicants must possess either East African Certificate of Education at least Division III or the East African Advanced Certificate of Education or their equivalent and they will draw a fixed training allowance of K.Sh. 520 per month and K.Sh. 665 per months, respectively; or K.Sh. 820 per month and K.Sh. 965 per month if living in privately rented accommodation.

They should have normal eyesight and have an aptitude for attention to detail.

Successful candidates will be trained in the theory and practice of fingerprint work as a means of establishing the identity of persons for the purpose of Police investigations. Thus, the work involved requires great patience and painstaking attention to detail.

The initial training period in the classroom will be for a period of three months at the end of which an examination will be held to determine the capabilities and the aptitude of the trainees and the unsuccessful candidates will have their training discontinued. - 1. The Kenya Management Staff Association shall hereinafter be referred to as the Claimants and Olympic Airways (E.A.) shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on 4th and 5th April, 1979, and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:—

Claimants.-Mrs. D. S. Diniz.

Respondents.-P. Simopoulos.

AWARD

3. The Notification of Dispute Form "A" dated 14th August, 1978, duly signed by the parties was received by the Court on 12th February, 1979, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mrs. D. S. Diniz was employed by the Respondents on 1st August, 1974, as a Ground Hostess/Secretary. She was suspended from duty on 15th February, 1978, on the ground that during the course of her duties on OA 102 of 26th November, 1977, she demanded excess baggage payment of US dollars 150 from passenger L. Schiller and received from him K.Sh. 1,203/60, the equivalent of this amount for which she neither issued an official receipt nor submitted the amount to the company. She was told that the matter would be further investigated and a final decision would be conveyed to her in due course.

Mrs. Diniz denied the allegations made against her and inquired which Government department was investigating the alleged complaints against her. She further stated that the accusation was initiated through malice and with deliberate aim of humiliating her and dispensing her services without proper cause.

On 21st April, 1978, her services were terminated in the following terms:—

"Further to our discussion in my office, I regret to inform you that your services with Olympic Airways are terminated with effect from 20th April, 1978.

Although your offence makes you liable to summary dismissal we have decided to give you a normal termination with your benefits. Please arrange to call at our Accounts Office to collect your dues. At the same time, you are required to hand in the company's properties (uniforms, etc.)."

The Claimants acting on her behalf reported a trade dispute to the Minister for Labour and it was investigated by the Ministry. The Permanent Secretary released the findings and recommendation on this dispute to the parties on 1st August, 1978, which were as follows:—

"Findings-

From the evidence given by the passenger and from the records of Barclays Bank International Ltd., Airport Agency, of 25th November, 1977, between 10 p.m. and 12 midnight there is no doubt that Mrs. Diniz received this money. She failed to issue the receipt or to notify the company. She being an employee of the company for several years ought to have known that such an act was against the laid down regulations. I do not therefore find her suspension and subsequent termination wrongful.

Recommendation-

I recommend that she be paid all her terminal benefits she is entitled to as offered by the employer."

The Claimants rejected the Ministry's findings and recommendation and the dispute is now before the Court.

The Claimants during the hearing expressed great surprise as to how the Ministry of Labour had arrived at its findings and recommendation because in their opinion no valid evidence was obtained on which to base such findings and recommendation. They submitted that the Respondents' Regional Manager for East Africa had a grudge against Mrs. Diniz for the reason best known to him.

The Claimants stated that in matters where money was involved it was necessary that the facts should be checked properly before a decision is taken and they added that the Respondents had admitted to them that they had taken the action of terminating Mrs. Diniz's services before seeking any legal advice.

The Claimants explained to the Court that they had insisted all along for the Respondents to produce valid evidence to include—

- (a) bank slip;
- (b) complainant's letter; and
- (c) any voucher containing evidence.

The Respondents further failed to produce any evidence to them and they wondered from where the Ministry of Labour got the evidence of cheques which was not produced at the time of the investigation.

The Claimants recalled that the real problem between Mrs. Diniz and the Respondents began in May, 1977, when she had come back from sick leave and she was asked to resign and was sent on two weeks' leave. She was, however, reinstated on 20th June, 1977, after the Claimants and the Ministry of Labour had intervened. They emphasized that this showed that the Respondents were looking for a reason to get rid of her. The Claimants asked the Court to award Mrs. Diniz 12 months' salary for wrongful termination that she had suffered in addition to her other terminal benefits. Her salary at the time of her termination being Sh. 2,141 with a house allowance of Sh. 190.

The Respondents vigorously submitted that when their New York office had transmitted to them via Athens the complaint received from Mr. Schiller they had carried out investigations and as a result they were satisfied that Mrs. Diniz was guilty of gross misconduct but had decided to give her a normal termination and had accordingly paid her a sum of Sh. 6,761/95 details of which were given in their written submission.

In addition to the parties' written submissions in which all the details relating to this dispute appear the Court heard the evidence on oath both of Mrs. Diniz and P. Simopoulos.

The Court can find no reason to doubt that an incident took place involving Mrs. Diniz and an American passenger Mr. Schiller as a result of which the Respondents lost Sh. 1,203/60 which was due to them by way of excess baggage which Mr. Schiller carried. The Court is not prepared to believe that Mr. Schiller was an innocent victim of extortion of this amount by Mrs. Diniz. There is more to this incident as far as Mr. Schiller's conduct is concerned. The fact, however, remains that Mrs. Diniz was involved in this incident.

The Court cannot accept the Claimants' submission that the Respondents have cooked up a story of this nature in order to get rid of Mrs. Diniz. To find so would be very far fetched.

From the documentary evidence that was produced the Court is satisfied that Mr. Schiller, between 4 p.m. and midnight of 25th November, 1977, in order to obtain K.Sh. 1,203/60 had cashed \$150 in cheques at the airport bank. The Court has noticed that Mr. Schiller has referred to the person involved in the incident as a Greek lady but later on referred to her as a female of Asian extraction. Having looked at Mrs. Diniz the Court can understand that this was a genuine mix up and that she is the person who is being referred to by Mr. Schiller as the only other lady on duty at that time was an African lady.

Despite the doubts which the Court has about Mr. Schiller's conduct in this affair the fact remains that Mrs. Diniz, an employee of the Respondents, was involved in this very unfortunate affair. The Court can find no reason whereby to find that Mrs. Diniz was an innocent party to this affair or that she was not at all involved in this matter. The Court would like to add that an employee should not enter into shady deals of this nature with his or her employer's customers.

The Court notes that the Respondents have paid Mrs. Diniz fully up to the end of May, 1978, although she was on suspension from 15th February, 1978, and since this amount includes all her terminal benefits which were due to her the Court can help her no more. The Court would like to add that Mrs. Diniz secured another employment with effect from 14th June, 1978.

After careful consideration of all the submissions the Court finds that the Claimants' demand in this dispute should fail and the Court accordingly rejects it.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenva Gazette

D.41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
