Council's refusal to pay house allowance in lieu of duty houses to Messrs. John Luseso, Rattan Singh Birdi and Mohamed Yakub at Juja Road (Water and Sewerage Department).

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Nairobi City Council shall hereinafter be referred to as the Respondents.

2. The mentions and hearings took place in Nairobi on 21st March, 24th April, 4th July, 5th July, 13th July, 20th September, 1978 and 18th and 30th April, 10th May, 6th June and 10th July, 1979.

#### AWARD

3. The Notification of Dispute Form "A" dated 10th January, 1978, duly signed by the parties was received by the Court on 6th March, 1978, together with the statutory certificate signed by the Labour Commissioner.

The Court commenced the hearing of this dispute on 4th July, 1978, and the hearing continued the following day when after the parties had made their opening submissions at length it was adjourned to 13th July for further submissions.

On 13th July, 1978, the Claimants and the Respondents argued on the relevant Nairobi City Council Building By-laws with the Claimants maintaining that the Respondents had violated their own Building By-laws. They also referred to the relevant minutes where it was stated that the Building plans had been noted but not approved. The Respondents denied all these allegations. At the end of the submissions on that day it was agreed by the parties that an independent architect's report on the houses that were offered to the persons involved in the dispute would be made available to the Court.

The matter thereafter dragged on awaiting the independent architect's report and on 30th April, 1979, the Court was told that the independent architect's report was being discussed by the parties and there was a possibility that the dispute might be settled.

After a couple of further mentions the parties having failed to settle the dispute, it was once again heard by the Court on 10th July, 1979, when the Claimants made their further submissions.

After a short adjournment the parties informed the Court that they had decided to settle the matter and requested the Court to make an award by consent.

The Court accordingly makes the following award by the consent of the parties:—

1. "That with effect from the date when the Council first offered duty houses in writing to the following employees: Mohamed Yakub, Rattan Singh Birdi and John Luseso the said employees are entitled to duty house allowance as per clause 43 (b) of the Terms and Conditions of Service for the Salaried Grades.

2. That the affected employees be paid their duty house allowances with effect from 1st March, 1971, for the period of their employment with the Council or until the duty houses shall be provided by the Council whichever date is earlier, as provided for, in the Town Clerk's letter Ref. No. EMK/3248/3/12/1, dated 11th June, 1979.

3. That in addition the Council agrees to reimburse the Union Sh. 8,315 being half the fee of the total fee paid by the parties to Messrs. Govani Associates, Chartered Architects for their professional services.

4. That this agreement is in full and final settlement of the dispute.

That this will be without prejudice to the parties' positions on any dispute that may be in the pipeline on the subject of housing."

#### Parties:—

Kenya Local Government Workers' Union

#### Issue in dispute:—

Dismissal of John Rabougi Ogot.

#### RULING

#### Interpretation Application

The Court announced its award in the above dispute on 25th January, 1979, and towards the end of the award stated as follows:—

"The Court has very carefully considered all the aspects of this dispute as highlighted by the parties during their submissions and which came out through the evidence of their respective witnesses and has come to the conclusion that Mr. Ogot did not deserve termination and accordingly the Court finds that he has suffered a wrongful dismissal.

The Court is always very cautious in ordering the reinstatement of an employee who has been wrongfully dismissed by an employer but in this case the Court finds that in the interest of justice Mr. Ogot should get his former job back which he occupied when he was summarily dismissed.

The Court is empowered to award compensation in case where reinstatement is ordered to the extent of the actual pecuniary loss suffered by the employee as a result of the wrongful dismissal but the Court has decided that in addition to reinstatement Mr. Ogot should get 12 months' salary by way of compensation for the wrongful dismissal that he has suffered and so awards. The Court further awards that he should be reinstated with effect from 1st February, 1979."

The Claimants have applied for an interpretation of the above award because they maintain that the Respondents have not implemented it properly. The Claimants have argued that reinstatement means re-establishment and that he should have been restored to his former position without loss of any benefits whatsoever. They felt that Mr. Ogot had suffered a wrong at the hands of the Respondents and the Court award being in their favour was intended to rectify this wrong in all respects.

Accordingly the Claimants submitted that according to them Mr. Ogot was entitled to the salary increments for the four years from December, 1975 to December, 1978. He should also be allowed his accrued leave for three months or any payment in lieu thereof. Furthermore Mr. Ogot should be paid all the medical expenses incurred by him or his family to which he was entitled at the rate of Sh. 240 per year.

Finally the Claimants asked the Court to order the Respondents to maintain Mr. Ogot's continuity of service and to rule that he should be eligible to the superannuation and service benefits.

The Respondents called this application an absurd demand and stated that it was nothing but an appeal to the Court to award further and more benefits than the Court had originally awarded.

The Respondents referred to the fact that Mr. Ogot had been dismissed which the Court had found to be wrongful and for which it awarded him compensation amounting to 12 months' salary which worked out at Sh. 35,520. The Respondents added that if the Court had awarded full compensation then it would have amounted to Sh. 110,000.

The Respondents submitted that in accordance with the Court award they had reinstated Mr. Ogot with effect from 1st February, 1979, at the same salary scale at which he was when he was dismissed but because the scales had gone up he was now earning £1,884 p.a.

Finally the Respondents stated that Mr. Ogot was paid his contributions to the superannuation fund at the time of his dismissal and was also paid in respect of leave which had accrued.

The Court would like to refer the parties to the last paragraph of its award in which the Court clearly pointed out that it is empowered to award compensation in case where reinstatement is ordered to the extent of the actual pecuniary loss suffered by the employee as a result of the wrongful dismissal. The Court having made this observation proceeded to make an award of 12 months' salary only by way of compensation for the wrongful dismissal that Mr. Ogot had suffered. The Court also added that he should be reinstated with effect from 1st February, 1979.

The Court would like to point out that if what the Claimants state are further benefits due to Mr. Ogot under the Court award as listed in their arguments hereinabove then the Court would have stated so in its award.

The Court award is very clear and it was intended to give Mr. Ogot his job back with effect from 1st February, 1979, and the Court assessed the compensation due to him for the wrongful dismissal that he had suffered at Sh. 35,520, i.e. 12 months' salary. The Court did not award him anything more than that.

After careful consideration of all the submissions the Court finds that the Claimants' interpretation of the Court award must fail and the Court accordingly rejects their application.

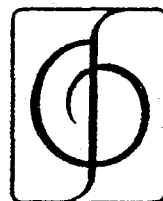

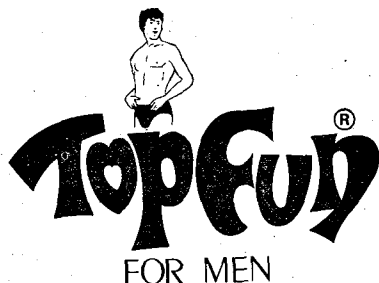
