- 3. Wages.
- 1. The Tailors & Textiles Workers' Union shall hereinafter be referred to as the Claimants and African Cotton Industries Ltd. shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 25th day of July, 1979, and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated 6th February, 1979, duly signed by the parties was received by the Court on 10th May together with the statutory certificate signed by the Labour Commissioner.

This dispute has arisen from the parties' efforts to revise their previous collective agreement which was effective from 1st September, 1976, and expired on 31st August, 1978.

All the three items in dispute entail considerable labour costs which the Respondents have to bear and are therefore strictly subject to and within the Guidelines which have been issued to the Court by the Vice-President and the Minister for

The Claimants are demanding that the Respondents should provide free night transport to all their employees who start and finish their shift work at 11 p.m. They also want all the employees to be paid a monthly house allowance of Sh. 150 each to enable them to meet the increased house rents which they had to pay.

On the issue of wages the Claimants' demand is for a 41.09 per cent increase with effect from 1st September, 1978, and a 25 per cent increase for the second year effective from 1st September, 1979. They maintain that these demands are in accordance with the permitted increases in the Guidelines.

The Respondents have vigorously resisted both the demands for night transport for night workers and the payment of house allowance of Sh. 150 to each employee per month on the ground that the additional cost involved in meeting these demands was prohibitive and they could not afford it.

On the issue of wages they have offered a 5 per cent wage increase with effect from 1st September, 1978, and another 5 per cent from 1st September, 1979.

The Court notes that the Respondents' workforce as at December, 1978, was 94 and as at June, 1979, it has gone up to 124. This increase includes nine new employees and 21 casuals who have been taken into regular employment. The Respondents have therefore complied with the Presidential directive on increasing employment.

On the issue of night transport the Claimants' demand would cost the Respondents a sum of Sh. 175,504 per year and the demand of house allowance would cost the Respondents a sumof Sh. 223,200 per year.

The Court would like to point out that under the Guidelines the workers' entitlements on the revision of the collective agreement was restricted in 1978 to an average of about two thirds of the increase in the cost of living and from January 1979, the wage increases are to average no more than one half of the rise in the cost of living.

Considering the nature of the industry and the fact that the Respondents have created new jobs the Court has come to the conclusion that it cannot accept the Claimants' demand for a 41.09 per cent increase for the first year and 25 per cent increase for the second year. These demands and those on the house allowance and night transport are well beyond the permissible limits under the Guidelines.

The Court has, however, decided that although an award is being made in 1979 the workers should benefit for the first year with effect from 1st September, 1978, under the Guidelines allowing them compensation up to two thirds of the coast of living increase. The second year increase will be subject to the latest Guidelines effective from 1st January, 1979, permitting a wage increase of one half of the rise in the cost of living. The E.P.D. analysis states that the cost of living indices include increases in rents, transport costs and other items normally use in the compilation of the cost of living

The Court notes that the Nairobi wage earners cost of living index from 1st September, 1976, up to the end of August, 1978, had risen by 34.7 per cent. This would give the workers a total wage increase of about 26.9 per cent two thirds of which would be 24.7 per cent plus 3.8 per cent G.D.P. growth rate. This would give the workers a first year general wage increase of about 13.5 per cent for the first year and a similar increase for the second year.

The Court cannot overlook the wage increase of 4 per cent which was granted to the workers in the supplementary agreement in 1977 and credit must be given for this increase.

After careful consideration of all the submissions the Court finds that the Respondents' offer of a wage increase of 5 per cent each year is too little and the Court can see no reason why the Respondents should not grant full increases due to the workers under the Guidelines. The Court has accordingly decided to award the Respondents' employees covered by this dispute a wage increase of 12 per cent with effect from 1st September, 1978, and another wage increase of 10 per cent with effect from 1st September, 1979.

The Court having granted the workers their full entitlement under the Guidelines in the above wage increases cannot make any award on the other two issues. The Court, however, has decided to rule that the housing element in the consolidated wage which is being paid to the workers shauld be deemed to be 15 per cent. This would enable the Claimants, as and when the Guidelines are eased, to negotiate property on this item with the wage increases.

With the aforesaid comments on the issue of night transport and house allowance these two demands are rejected.


