In accordance with the directives of the Assistant Director-General for Education, the incumbent is responsible for coordinating and supervising the activities of the Sector as regards publications and, under the authority of the Assistant Director-General, for ensuring the smooth functioning of the Publications Unit of the Sector.

The incumbent will be responsible for-

- (a) establishing, during the preparation of the Draft Programme and Budget, the draft Publications Plan for the Sector for the coming biennium, co-ordinating and harmonizing the proposals sent in the Divisions;
- (b) establishing each year during the preparation of the Programme Activity Details (PADs) and in co-operation with the Divisions of the Sector, the draft production plan, taking into account the programme activities contemplated, staff resources and the available budgetary allocations of the Sector, as well as the quotas assigned for translation;

- (e) supervising the implementation of the Sector's Publications Plan, following each manuscript through the successive stages of the preparation process and ensuring that the date-limits indicated in the Plan are respected;
- (f) maintaining for that purpose permanent liaison with the Officer of the Unesco Press as well as with the Consultative Committee on Publications; compiling for the Committee, material for reports on the implementation of the Plan; and representing the Sector at the Committee's meetings, according to the decisions of the Assistant Director-General;

(g) carrying out all other functions assigned to the Publications Unit, as defined in Item 1300 J and Appendix 13D of the Manual.

Qualifications and experience required
