AWARD

3. The Notification of Dispute Form "A" dated the 14th March, 1979, duly signed by the parties was received by the Court on the 2nd August, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

J. Kabaya worked for the Respondents for a period of approximately 12 years—from 1965 to 1977. His services were terminated on the 2nd June, 1977, when he was informed by the Town Clerk that the Respondents had lost confidence in him as their employee and it had been decided to terminate his services in accordance with clause 25 (a) of the terms and conditions of service for employees in the salaried grades Committee No. 2. He was paid the following amount:

"7th June, 1977:

To amount paid to the above-named being terminal benefits to J. Kabaya—

	Sh. cts.
Provident Fund	2,896.10
Net salary as per attached pay roll	1,254.50
Total	4,150.60
Less Min. ESGP/673/77 (b)	1,482.00
Net	2,668.60"

The Claimants took up the matter on his behalf and reported the dispute to the Minister for Labour and the Ministry's findings and recommendations were conveyed to the parties on the 1st December, 1978, in the following terms:

"During the 13 years Mr. Kabaya worked with the Council of Meru he had a very clean record which had earned him a promotion.

From both submissions the suspension was a result of a fight between Mr. Kabaya and another employee. It is not clear what the cause of the fight was, nor is it clear how it was investigated.

Mr. Kabaya with other askaris took possession of spare parts of the sewing machine in fair discharge of their duties yet Mr. Kabaya was the only victim of repaying the money (Sh. 1,482) claimed by the complainant. It seems that investigation regarding this matter was not properly done.

Mr. Kabaya, while he had had a clean record, seemed to have engaged himself in the latter period with activities that tended to be on the bad side.

With the above in mind it is my considered opinion that termination of service rather than dismissal would have been appropriate.

I therefore recommend that his dismissal be reduced to normal termination with full terminal benefits paid to him and further that the money deducted be refunded to him."

The background to this dispute is that Mr. Kabaya used to work as a clerical licensing officer and his duties were to check the business premises in town in order to ensure that the businesses had the necessary municipal licences. He was accompanied by municipal askaris on his rounds.

On the 12th May, 1976, the Respondents' Town Clerk suspended him and in the Town Clerk's letter it was stated that there were allegations that certain wananchi had been issued with unusual bonds to attend cases in the Court because they had not paid for the council licences. The officer of the Council and the officer-in-charge of Meru police station had been informed that although the bonds had been issued the cases were not in Court. The Town Clerk further wrote in the letter that Mr. Kabaya had fought with askari M'Itwamwari. He was accordingly suspended under clause 27 (a) of the terms and conditions of service on half pay until the matter was dealt with.

Thereafter the matter was discussed at subsequent meetings of the Finance, Staff and General Purposes Committee and to begin with the Town Clerk's action in suspending Mr. Kabaya was confirmed and the police were asked to provide the Council with a report on the investigation of the fake bonds. Eventually at a meeting of this committee held on the 13th October, 1976, the following decisions were taken—

- "(a) that in view of the old clean record and of the repentant attitude, Mr. Kabaya be allowed to resume duty on the 14th October, 1976;
- (b) that Mr. Kabaya is guilty of an offence and he should be disciplined by reprimanding him for contravention of the terms and conditions of service by assaulting another employee while on duty;
- (c) that no further payment be made to Justus Kabaya in respect of salary for the five months that he was serving the suspension as he was not working for the Council;

(d) that this Committee authorizes transfer of Mr. Kabaya from the Licensing Section in the best interests of the public for restitution of the good image of this Council which has been somewhat impaired by action of the employee; and

(e) that the Town Treasurer be authorized to pay the claim submitted by Stephen Muriara of P.O. Box 545, Meru, and later recover the payment from Mr. Kabaya's salary if Mr. Kabaya does not produce the property taken."

It is apparent that along with the complaints against Mr. Kabaya are the issuing of fake bonds by him and the fight with an askari, there was also the question of recovering a certain amount from his salary for damages to be paid to one Stephen Muriara which he had claimed from the Respondents regarding the removal and subsequent loss from his shop of certain articles by Mr. Kabaya.

The acting treasurer reported that he was finding it difficult to make deductions from Mr. Kabaya's salary in favour of Mr. Muriara as there was no legal backing to take such action. The matter was deferred for further consideration and eventually because Mr. Kabaya had objected to this deduction from his salary as he denied having confiscated any property belonging to Mr. Muriara a sub-committee was appointed to investigate the matter. After the sub-committee had completed its work the Respondents took the following decisions—

- "(a) that the Council pays this claim of Sh. 1,482 by Mr. Muriara;
- (b) that because Mr. Kabaya acted unlawfully; and
- (c) defectively over this matter the regulation does not cover him and therefore the paid claim should be recovered from his money;
- (d) that as the Council has lost confidence in this officer the committee recommends that Mr. Kabaya be terminated from the services of the Council in accordance with clause 25 of the Terms and Conditions of Service Committee No. 2."

The Court has gone through the evidence given by the various witnesses both on behalf of the Claimants and the Respondents and the parties' written and verbal submissions before coming to its decision. The Court is satisfied that fake bonds were being issued in Meru town during the material time by Mr. Kabaya who used to be accompanied by certain persons who may or may not have been genuine policemen. He had embarked on this course of action without the knowledge of the Town Clerk whose duty it was to arrange for police assistance as and when necessary for the enforcement of the municipal by-laws. The Town Clerk told the Court that he had never sought any police assistance in this regard. The Court is also satisfied that when a couple of persons who had been issued with fake bonds reported at the Court for their cases they were told that they had no cases against them. In fact there were no files of any such Court cases.

The fight which Kabaya had with one of the Municipal askaris was related to the issue of the alleged fake bonds and the Court accepts the evidence of the askari regarding the circumstances of the fight as against the evidence given by Kabaya.

The Court, while rejecting Mr. Muriara's evidence substantially re his alleged claim of Sh. 1,482 against the Respondents and his allegations of bribe being sought from him by Kabaya, is satisfied that he was issued with a bond to appear in court and when he went to the court he was told that there was no case against him in the court records. So he was obviously given a fake bond.

The Court cannot accept the Claimants' argument that the only reason why Mr. Kabaya's services were terminated was because he had objected to the deduction of Sh. 1,482 from his salary. This was one of the reasons, the other very strong reason was the issue of fake bonds by Mr. Kabaya. It would be not only improper but would be a disservice to the public if such a conduct on the part of a local authority official who had gone around harassing innocent wananchi is condoned.

After careful consideration of all the submissions the Court is satisfied that the Respondents had more than necessary evidence to lose confidence in Mr. Kabaya and were therefore entitled to terminate his services. The Court must therefore uphold the Respondents' action in this regard. The Court has, however, found that the Respondents did not act properly in not paying Mr. Kabaya the balance of his salary for the five months that he was on suspension in 1976 and the Court accordingly awards that Mr. Kabaya should be paid the balance of his salary for the period between the 13th May to the 14th October, 1976.

The Court has also come to the conclusion that the Respondents had erred in deducting Sh. 1,482 from Mr. Kabaya's terminal benefits and the Court awards that they should pay him back this amount.

The Court accordingly rejects the Claimants' demand for Mr. Kabaya's reinstatement and for payment of compensation for the wrongful dismissal but awards that Mr. Kabaya should be paid the aforesaid amounts.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-

Kenya Gazette

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
