- (j) Knowledge of water supplies and Civil Engineering Works (Roads) would be an added advantage.

(l) Ability to carry out surveying and levelling as well as the ability to set out a building or group of buildings.

(m) Ability to produce drawings of constructional detail and must have ability to measure work in progress for the purpose of preparing variation orders and interim payment.

(n) Experience in reinforced concrete work and in making various tests required in connexion with concrete work.

B. Kinyanjui started working for the Respondents on the 8th August, 1973 as a reservations officer. The Respondents have a chain of hotels and lodges with over 2,000 beds and Mr. Kinyanjui's duties were in connexion with their reservations.

He started at a salary of K.Sh. 1,200 p.m. which was increased to K.Sh. 2,100 after completion of the probationary period.

On the 19th August, 1977 he was a victim of a vicious assault by thugs and received serious head injuries which necessitated his being hospitalized for nearly six weeks. He was also unconscious for some time. On the 4th January, 1978 he reported for duty but it was quite obvious that he was not feeling well and was told to go home. He had suffered a partial paralysis of one side of the body and his speech was incoherent. He, however, came back on duty on the 30th January, 1978 and the Court was shown a hospital card from the Kenyatta National Hospital on which it had been stated that he had been recommended for light duty. On the 30th January, 1978 he felt unwell and was admitted to Nairobi Hospital under treatment of Dr. W. W. Kiragu. He was again in hospital for 16 days and he reported on duty on the 16th February, 1978.

On the 15th March, 1978 he was informed in writing by the personnel officer that the management had come to the conclusion that he was unable to perform his duties as required and it was felt that he needed rest to gain his normal health. The management had, therefore, decided to send him on three months' paid leave during which time it was hoped he would recover and would be able to resume his normal duties. He was told to report back on the 14th June, 1978 with a medical certificate from the doctor who would be attending him. On the 14th June, 1978 he reported on duty and brought with him a certificate from Dr. Kiragu which stated that he had now sufficiently recovered to resume light duties for three months. He continued reporting for work until the 20th June when he was retired from the Respondents' employment with effect from the 30th June, 1978 on the ground of his continuing ill health.

A trade dispute was reported to the Minister for Labour and the Ministry's findings were released to the parties on the 10th August, 1979 in the following terms:

"The crux of this dispute is whether the retirement of Mr. Kinyanjui on medical grounds was justified or not. The doctors who had and are still treating Mr. Kinyanjui have not indicated in their report that the injury suffered by Mr. Kinyanjui had incapacitated him to a point of not being able to do his work. All what the doctor especially Dr. Kiragu has said is that he should be on light duty. If the company were not satisfied with that recommendation they should have made arrangements for him to be examined by a doctor of the company's choice but this was not done. Alternatively the company should have made arrangements for Mr. Kinyanjui to appear before a medical board. This was also not done. So the company unilaterally decided to retire Mr. Kinyanjui on medical grounds without any advice from a medical

expert. In a case like this one, one can only find that the company decided on insufficient medical evidence and therefore their action was wrong.

In view of the above findings I recommend that the company should make arrangements for Mr. Kinyanjui to appear before a medical board whose recommendations should be a basis of either retiring or reinstating Mr. Kinyanjui. In the meantime since Kinyanjui has been out of employment for one full year I recommend that he should be paid half salary for that period i.e. six months' salary as compensation for being wrongfully retired."

The Court notes that the Respondents complied with only a part of the recommendations in that a medical board was arranged to examine Mr. Kinyanjui. The Court was given the board's report which was as follows:

"History: Was assaulted about two years ago and sustained a severe head injury for which he needed surgical treatment. He has since had an episode simulating a convulsion and he is on adequate treatment for this possibility.

The injury has left him with a left sided facial weakness, a mild degree of right sided hemiparesis and slight impairment of speech.

He has made good recovery. The deficit which he is left with is likely to be permanent. But it is mild; we find him fit to continue with his work as a reservation officer in the hotel industry."

The Respondents having failed to either reinstate him or pay him compensation, the dispute is now before the Court.

The Claimants are pressing for his reinstatement and also for payment of six months' salary as recommended by the Ministry mainly on the ground that the Respondents did not have any medical evidence on which to retire Mr. Kinyanjui on grounds of ill health. They also stressed the report of the medical board which had said that they found Mr. Kinyanjui to be fit to continue with his work as a reservations officer in the hotel industry.

The Respondents on the other hand have very strongly resisted the Claimants' demand on the ground that there was absolutely no doubt that as a result of the injuries received by Mr. Kinyanjui he was not in a fit state to continue working for them in a section like reservations dealing with over 2,000 beds and which necessitated dealing with clients, carrying out the work with great accuracy and speed. The Respondents have also argued at length on the nature of the injuries received by him in order to prove that his injuries were serious and it would be impossible for him to carry out his work properly. The Respondents pointed out that they had been very generous to Mr. Kinyanjui and had given him every opportunity to recover for 9½ months from the date of his injuries. They referred the Court to his contract of employment and other terms and conditions of service and asked the Court to find that Mr. Kinyanjui had no case either in law or equity.

The Court notes that in Mr. Kinyanjui's letter of appointment dated the 16th October, 1973 it is clearly stated that in the event of sickness after sick leave has been exhausted the Respondents may at their own discretion terminate or continue his employment without pay. At the time of the incident Mr. Kinyanjui was entitled to a maximum of two months' sick leave with full pay and thereafter to a maximum of two months' sick leave with half pay. The Respondents have, however, paid him full pay from the date Mr. Kinyanjui received injuries up to the date his services were terminated i.e. for 9½ months. He was also given an exgratia payment of K.Sh. 1,000. The Respondents who were entitled to terminate his services with one month's notice or pay in lieu thereof did not do so after the four months period of sick leave had been exhausted.

The Court must express its appreciation at the generous treatment that the Respondents have given Mr. Kinyanjui in that out of a total of 287 days from the date of his injuries up to the date his services were terminated he worked for 50 days only but was paid his full salary for all this time.

The claimants have made a big play about the medical board's recommendation but one significant point to note in this respect is that the medical board examined Mr. Kinyanjui almost two years after he received injuries. To penalize an employer to keep on his payroll an employee in these circumstances would be improper and harsh. It would not be fair to expect an employer to keep on waiting year after year for an employee to fully recover to resume duty especially when he had only five years' service with them.

The Court must, however, find that at the time when the Respondents decided to retire Mr. Kinyanjui on grounds of continuing ill health on the 30th June, 1978 while they had formed their own conclusion by observing him at work that he was not capable of performing his duties normally they

should have taken the additional step of obtaining appropriate medical evidence before retiring him on medical grounds. In all probability medical evidence would have supported the management observations Mr. Kinyanjui's ability to perform his duty or otherwise. The Court has no quarrel with the Respondents' contention that in the final analysis it is the management ordinarily who are in a better position to judge the performance of a worker but once the management decides to get rid of a worker on medical grounds then it is necessary that they should equip themselves with the medical evidence as well. To this extent the Court finds that the management erred and as a result the Court has come to the conclusion that Mr. Kinyanjui has suffered a wrongful dismissal.

The Court having found that Mr. Kinyanjui has suffered a wrongful dismissal cannot overlook the very generous treatment that the Respondents had given him since he received injuries which were quite unrelated to his job. The Court has carefully considered the question of Mr. Kinyanjui's reinstatement but has come to the conclusion that under the circumstances of this dispute reinstatement is not warranted and the Court has decided to give him compensation instead. In assessing the compensation the Court has taken into account that although Mr. Kinyanjui was entitled to two months' sick leave on full pay and two months on half the Respondents paid him full salary for 9½ months before terminating his services. In these circumstances the Court awards that Mr. Kinyanjui should be given an additional four months' salary only by way of compensation for the wrongful dismissal.

#### Issues in dispute:

1. Housing allowance.
2. Night shift allowance.
3. Gratuity/retirement benefits.
4. Effective date.

1. The Kenya Bakers & Confectioners Workers' Union shall hereinafter be referred to as the Claimants and Elliot's Bakeries Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 16th January, 1980 and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated the 29th August, 1979 duly signed by the parties was received by the Court on the 18th October together with the statutory certificate signed by the Labour Commissioner.

The Respondents since 1980 had been negotiating with the Domestic and Hotel Workers' Union the terms and conditions of employment of their employees. The latest collective agreement between the Respondents and the Domestic Union was effective from the 1st July, 1976 for a period of two years.

The Claimants were established on the 6th December, 1977 and the recognition agreement between them and the Respondents was signed on the 20th December, 1977. The parties then embarked on negotiating a collective agreement for the Respondents' unionizable employees and several meetings were held between them. The Court was told that it was agreed by the parties to adopt the salary structure of the previous collective agreement between the Respondents and the Domestic Union and negotiations proceeded on that basis. It is not disputed that the parties agreed to a first year wage increase of K.Sh. 65 p.m. with a similar increase for the second year but there is a serious disagreement on whether or not this wage increase was on the basis of a consolidated wage as claimed by the Respondents or on the basis of a deconsolidated wage as claimed by the Claimants. The Claimants stated in Court that if they failed on the housing issue then they had the right to go

back and negotiate the wage increase once again in order to further improve it. The Respondents denied this. The Court can find no conclusive evidence tendered by either party one way or the other on this crucial aspect of the dispute but the fact remains that the Respondents had agreed to negotiate house allowance with the Claimants as a separate item.

During the hearing the Respondents raised certain very alarming points in that due to the shortage of wheat flour they had sent 97 workers on unpaid leave in their Nakuru bakery and they intended to lay off another 255 employees. The parties also explained the circumstances of the strike in Nakuru in 1979 but as that matter is the issue in another dispute the Court would not like to deal with it at this stage. The Respondents' application to the Minister for Labour to declare another 255 employees redundant will no doubt receive consideration and will also probably end up before the Court in due course. One fact, however, remains and that is that the wheat shortage cannot remain permanent. It is a temporary matter and it is only a matter of time before wheat supplies are back to normal.

It is very regrettable that due to the rivalry between the Domestic Union and the Claimants the workers did not get any wage increase which was to be negotiated as a result of the Presidential directive in May 1977. In the private sector the wage increases were to be negotiated up to a maximum of 6 per cent.

#### *Effective date*

The Court would first of all like to deal with the issue of effective date. On this issue the Claimants demand that the effective date of their first collective agreement with the Respondents should be the 1st January, 1978 and the Respondents wanted it to be the 1st January, 1979. They are agreed on a duration period of two years. The Court finds that the stand taken by both the Claimants and the Respondents on this issue is wrong. The previous collective agreement between the Respondents and the Domestic Union expired on the 30th June, 1978 and the Court can see no valid reason whatsoever to deprive the workers of wage increases with effect from the 1st July, 1978. The Court accordingly awards that the effective date should be the 1st July, 1978.

#### *Housing allowance*

Coming to the housing allowance the Court finds that the present wages are consolidated and contain a housing element. The collective agreement between the Respondents and the Domestic Union has created a contract of employment between the Respondents and their employees under which they are being paid consolidated wages. So the Court cannot accept the Claimants' demand that they are entitled to disregard all that the other union did on behalf of the workers and they were entitled to start afresh. The Court, however, is very sympathetic to the workers in that they did not get any wage increase as a result of the Presidential directive of May 1977. This fact coupled with inconclusive evidence on the circumstances and the basis on which parties agreed to a wage increase of K.Sh. 65 for the first year and a similar wage increase for the second year has made the Court to look into the aspect of the housing element with a view to improving it.

After careful consideration of the submissions the Court awards that the workers are not entitled to a separate house allowance and that the consolidated wages should continue in force. The Court, however, awards that whatever housing element may be in the consolidated wage it should be increased by K.Sh. 10 p.m. with the result that the workers shall be entitled to a consolidated wage increase of K.Sh. 75 for the first year effective from the 1st July 1978 and another similar increase of K.Sh. 75 for the second year effective from the 1st July 1979.

#### *Night shift allowance Gratuity/retirement benefits*

The Court has carefully considered the Claimants' demands on the night shift allowance and gratuity/retirement benefits but is not inclined to make any changes in the existing provisions. The current night shift allowance is paid at the rate of 10 per cent of the basic pay and with an increase in the basic pay the workers will benefit accordingly. The Court rejects both these demands.

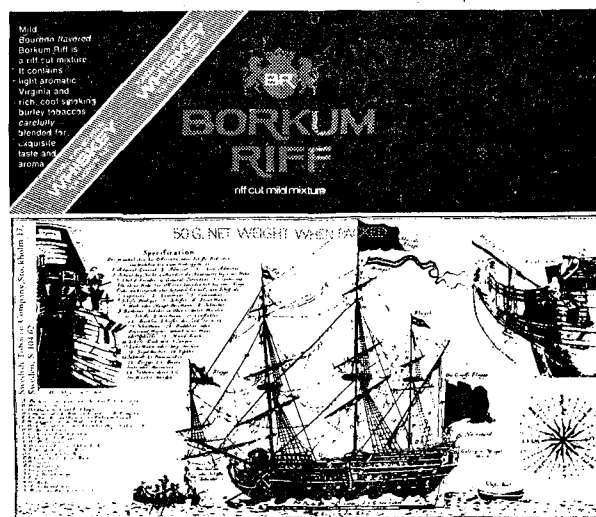
