THE GOVERNMENT LANDS ACT

(Cap. 280)

MOMBASA, MOI INTERNATIONAL AIRPORT—HANGAR SITES

The Commissioner of Lands gives notice that the plots at Mombasa Moi International Airport as described in the schedule hereto are available for alienation and applications are invited for the direct grants of the individual plots.

- 2. A plan of the plots may be seen at the Public Map Office situated in the Lands Department building. City Square, Nairobi or at the offices of the Mombasa Municipal Council or may be obtained from the Public Map Office, P.O. Box 30089 Nairobi on payment of Sh. 10.
- 3. Applications must be sent so as to reach the Town Clerk, Mombasa not later than 12 noon on Tuesday 8th April, 1980.
- 4. Applications should be submitted to the Commissioner of Lands through the Town Clerk, Mombasa.
- 5. Applicants must enclose with their applications a sum of Sh. 1,000 in cash or send a postal order, money order or bankers cheque made payable to the Commissioner of Lands as deposit. No cheques will be accepted. The deposit will be dealt with as following:
 - (a) If the applicant is offered and takes up and pays for the plot within the period of 14 days as required by condition No. 7 below, the deposit will be credited to him.
 - (b) If the applicant is unsuccessful, the applicant's deposit will be returned to him.
 - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required by condition No. 7 below, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim, thereto.

 - (b) The amount of actual capital available for development with a bankers letter or other evidence of financial status in support.

- 7. The successful allotee of the plots shall pay to the Commissioner of Lands within 14 days of notification that his application has been successful, the proportion of the annual rent together with conveyancing, stamp duty and registration fees and contribution in lieu of rates. General Conditions

- 1. The Grant will be made under the provision of the Government Lands Act (Cap. 280), and title will be issued under the Registration of Titles Act (Cap. 281).

- 3. The term of the grant will be for 25 years from the 1st day of the month following the issue of the letter of allotment.

Special Conditions

- 1. No building shall be erected on the land nor shall additions or external alterations be made to any building otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner of Lands shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2. The grantee shall within 6 calendar months of the actual registration of the grant submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and system

of drainage for disposing of sewage, surface and sullage water) drawings and specifications of the buildings the grants proposes to erect on the land and shall within 24 months of the actual registration of the grant complete the erection of such buildings and the construction of the drainage system in conformity with plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything-to-the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part theerof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner of Lands in respect of any antecedent breach of any condition herein contained.

- 3. The grantee shall maintain in good and substantial repair and conditions all buildings at any time erected on the land.
- 4. The land and buildings shall only be used for aircraft hangarrage, workshop and offices.

The revised charges have been prepared on a single application form, called "Application for Agricultural Mechanization Services" and referred to as Form LDD/April/1980. This form now combines the former Tractor Hire Service charges and the soil conservation service charges.

All the agricultural mechanization service jobs started before 1st of April, 1980, will be charged on the old rates, while all the jobs started on and after this date will have to be applied afresh on the revised application form, and will be charged on the new rates.

In order that an applicant of the agricultural mechanization services may be programmed, he or she may apply for the services at the nearest agricultural mechanization station, or at his District Agricultural Office. The Permanent Secretary of Agriculture requires that the applicant completes and signs the application form detailing the types of services required and the mode of payment.

It is important to note that all the revised mechanization charges will be on per hour basis while the transport and personnel charges will be on per kilometre or daily rates respectively. The personnel rates are fixed whether the services are hired for a full day, or part of the day.

Acreage rates have also been provided to be used only in case of problems in applying hourly rates.




