## ADMINISTRATIVE OFFICERS' EXAMINATION, 1980

IT IS notified for general information that this year's Administrative Officers' Examination will be held on Wednesday 27th, Thursday 28th and Friday 29th August, 1980, in accordance with the provisions of Personnel Circular No. 6 of 4th April, 1970.

## SCHEME OF THE EXAMINATION

2. As in the past, the examination will consist of the following six test papers to be held over the three days as follows:

First Day—Wednesday, 27th August, 1980

- (i) Law (Parts I and II) (3 hours), 9 a.m. to 12 noon.
- (ii) Government Organization and Practice (3 hours), 1.45 p.m. to 4.45 p.m.

Second Day—Thursday, 28th August, 1980

- (iii) Civil Service Regulations (3 hours), 9 a.m. to 12 noon.
- (iv) Public Financial Management and Control (3 hours), 1.45 p.m. to 4.45 p.m.

Third Day—Friday, 29th August, 1980

- (v) General Knowledge of East African and World Affairs (3 hours), 9 a.m. to 12 noon.
- (vi) Applied Logic and Report Writing (3 hours), 1.45 p.m. to 4.45 p.m.

## SYLLABUSES

3. There is no change to the syllabuses given in Appendix "B" to the Personnel Circular No. 6 of 1970, apart from increasing the time allowed for each test paper—as indicated in paragraph (2) above.

## ELIGIBILITY TO ENTER

4. The examination is open to Administrative Officers serving with the Kenya Government, either as Administrative Officers in the Provincial Administration (as defined in Appendix to Personnel Circular No. 6 of 7th June, 1974), Assistant Secretaries in Ministries, Second/Third Secretaries in the Foreign Service or the District Development Officers.

## EXEMPTIONS

5. (a) Candidates who attempted this examination previously and passed in one or more subjects have been credited with those subjects. They will (this year and perhaps in future) have

to re-sit only those subjects in which they failed in order to achieve a full pass in this examination, i.e. when they have passed in all the six subjects, including any exemptions.

(b) Serving officers with legal qualifications, from accredited universities may, on application to the Registrar, High Court of Kenya, be exempted from sitting for Part I of the Law Paper. Similarly, Law Graduates from the East African Universities, including serving officers who have obtained a pass in the Police Law Examination "B", can, on application, be exempted from the entire Law Paper of this Examination. All applications for exemption under this provision should be made through the candidates' Permanent Secretaries/Heads of Departments to the Registrar, High Court of Kenya, giving details of the legal qualifications held, and enclosing therewith photostat copies of the relevant documents to support their claims. Exempted candidates must quote reference numbers of their letters of exemption when they submit their entry forms for registration.

#### REGISTRATION FEES

6. Each candidate will be required to pay a Registration Fee of K.Sh. 20 only, regardless of the number of subjects to be attempted. The fees should be paid in either crossed Kenya Money Orders, Kenya Postal Orders or in cash. Personal cheques will not be accepted. The Money Orders, etc., should be made payable to the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, and should be attached to the appropriate Entry Form. Under no circumstances will the fees be refundable.

#### EXAMINATION ENTRY FORMS

7. Candidates are required to complete the Entry Form in TRIPPLICATE, as set out at the "Appendix" to this Circular Letter. The forms should be reproduced and cyclostyled by each Ministry/Department as necessary, as no supplies will be obtainable from this office. The completed entry forms, accompanied by the correct Registration Fees, should be submitted through the Permanent Secretary, Office of the President, Nairobi, to the Secretary, Public Service Commission of Kenya, so as to reach him not later than 20th June, 1980. Under no circumstances will late entries be accepted.

The Permanent Secretary, Office of the President, is requested to ensure that all entry forms are properly filled in, are from eligible candidates only, in accordance with paragraph (4) above, are certified correct by him at Part "C" as required and are transmitted to this office by the closing date. Entry Forms endorsed by him will automatically be rejected.

#### EXAMINATION CENTRES

8. As in the past, all Provincial Headquarters in Mombasa, Nyeri, Embu, Nairobi, Nakuru, Kakamega, Kisumu and Garissa will be the Centres for this Examination. Centres outside Kenya may be established for those intending and eligible candidates in the Foreign Service.

#### EXAMINATION TEST PAPERS AND STATIONERY

9. (i) Arrangements for the issue of examination test papers and stationery, appointment of invigilators, examination venues and submission to this office of candidates' answer scripts in respect of each Provincial Centre, will be made by the Provincial Education Officers in charge of each centre, acting on behalf and on the directions of the Public Service Commission of Kenya. The Permanent Secretary, Ministry of Foreign Affairs, will take care of those for Foreign Service Centres. No special stationery other than the ordinary writing foolscap papers to be supplied by this office, will be required for this examination. All candidates will, however, bring with them to the examination room their own rulers, pens and ink.

(ii) *Law Books.*—Candidates may also bring their own Law Text-books to be referred to during Part II of the Law Paper, if they are sitting for the Law Paper. The Provincial Education Officers are, however, requested to ensure that the relevant Law Books (Volumes of the Laws of Kenya, the Constitution of Kenya, etc.) are available at their Centres for the use of the candidates during Part II of the Law Paper. The books should not be used at all in answering Part I of the Law Paper.

(iii) *Answer Blue Covers.*—Candidates will not be allowed to write their names or Ministry/Department on the Answer Blue Covers. It will be necessary however, for each candidate to write clearly the following:

- (a) Name of the Examination;
- (b) Subject's Title;
- (c) His/Her Examination Index No., and
- (d) His/Her Examination Centre,

as asked for on the Answer Blue Cover provided for each paper.

- (l) *Terminal payments.*—A repatriation grant designed to assist in the re-establishment of the staff member in the home country and varying in amount with the length of service rendered and family status is also paid on separation from service. In addition, if the staff member's services are terminated after at least one year of service for reasons other than serious misconduct, a termination indemnity varying in amount with the length of service rendered will be paid by the Organization; in certain cases the payment of this indemnity is discretionary and it is not paid in case of retirement, resignation or abandonment of post.

11. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion for the maintaining all roads and drains serving or adjoining the land as the Commissioner may assess.

Karsandas Chaturbhuj & Company Ltd.

Issue in dispute:  
Recognition.

1. The Amalgamated Union of Kenya Metal Workers shall hereinafter be referred to as the Claimants and Karsandas Chaturbhuj & Co. Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard on the 22nd April, 1980 and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 4th April, 1979 duly signed by the parties was received by the Court on 14th December together with the statutory certificate signed by the Labour Commissioner.

The Dispute before the Court revolves around recognition of the Claimants by the Respondents and at the conciliation before the reference of the dispute to the Court the parties' position was as follows—

- (a) The Respondents feel that the Claimants are not the right union to represent their employees because they are mainly dealing with the distribution of motor vehicle spares and are not manufacturing, repairing or assembling.
- (b) The Claimants feel strongly that they are the proper body to represent the workers in this company because the company sells motor parts which are allied to the motor industry

After listening to the parties' submission during the hearing the Court finds that the following points are established.

The Respondents are involved in retail trade of spare parts and accessories which they backed up by producing the necessary wholesale and retail trade licences and also import and export licences. The Claimants also don't deny this.

A certain number of the Respondents' employees joined the Claimants in February, 1978 and according to the check off list submitted by the Claimants in their memo 15 workers joined them.

The other trade union which could lay a claim to recognition by the Respondents i.e. the Kenya Union of Commercial Food & Allied Workers has shown no interest whatsoever to either recruit the Respondents' employees into their membership or to approach the Respondents for recognition.

From the evidence produced by the parties the Court is satisfied that there is a certain amount of overlapping between the Claimants and the Commercial Union in that some firms which although strictly speaking fall within the industry covered by the Commercial Union have recognized the Claimants. These firms are—

E.A. Auto Spare, Aquva Agencies, Century Tractor (E.A.) Ltd., United Auto Tools.

At the same time there are other firms like Gailey & Roberts Ltd. which the Claimants feel belong to their industry but which have recognized since last so many years the Commercial Union.

The Respondents have given the names and salaries of their unionisable employees who number 28 in all with the Respondents claiming that the Claimants have recruited only 36 per cent of the unionisable employees i.e. only 12. They produced two letters with a request to them from two employees asking them to cancel their names from the list showing them as union members.

Under the aforesaid circumstances the Court has to make a finding which is further complicated by the new Industrial Relations Charter which was signed by the Kenya Government, the Central Organization of Trade Unions (K) and Federation of Kenya Employers whereby it is the intention to reorganize the trade unions along industrial lines (revised) and in the proposal the metal industry which will fall within the Amalgamated Union of Kenya Metal Workers is defined as:

"2. Garages and motor repair shops, tyre retreaders, electrical and electronic equipment assemblers including radio and television repair shops and motor assemblers."

After careful consideration of all the submissions the Court has come to the conclusion that the Claimants' demand for recognition by the Respondents should be rejected for the time being but the Claimants will be at liberty to raise a fresh dispute on this matter if they are so inclined after they have enrolled in their membership at least 50 per cent of the unionisable employees. At that time the parties will no doubt be able to review their respective stands in the light of the new Industrial Relations Charter. In case the dispute is not settled the parties will be at liberty to move the Court again by reporting a fresh dispute to the Ministry of Labour on this issue.

Union's version:

Wrongful dismissal of Kivuti Ngwili.

Employers' version:

Alleged wrongful dismissal of Kivuti Ngwili.

1. The Kenya Engineering Workers' Union shall hereinafter be referred to as the Claimants and Metro Engineering & Welding Works shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 23rd April, 1980 and relied on their written and verbal submissions. The parties also called the following witnesses to give evidence on oath:

Claimants.—W. Mungai.

Respondents.—Y. Bagha.

## AWARD

3. The Notification of Dispute Form "A" dated 19th October, 1979 duly signed by the parties was received by the Court on 18th February, 1980 together with the statutory certificates signed by the Minister for Labour and Labour Commissioner.

This dispute concerns K. Ngwili who worked as a welder for the Respondents from 6th December, 1965 to 17th July, 1978 when his services were terminated on grounds that he had failed to report on duty.

The background to the dispute is that Mr. Ngwili had gone on leave from February 1978 to 3rd March. He returned to work but on 27th April, 1978 he was admitted to Port Reitz Chest Hospital with pulmonary tuberculosis. He remained there until 13th June, 1978 and on his discharge was given two weeks' off duty ending on 26th June 1978. There is no difference between the parties up to this point. Thereafter, however the Claimants allege that he told the Respondents that the doctor had instructed him to do light duty only but the Respondents insisted that he should carry on with his normal work which he did up to 30th June, 1978. The Respondents, however, stated that he did not tell them about the light duty work until 1st July which was a Saturday and as he had not produced any medical certificate they could not accept his statement. The Respondents further allege that Mr. Ngwili left for home saying that he would come to collect his dues on Monday 3rd July, 1978 but instead came back with a letter from a doctor reading as follows:

"Ministry of Health: to whom it may concern:

The undermentioned, believed to be in your employ, has this day been admitted to Port Reitz Chest Hospital at Mombasa, Kivuti Ngwili, TB No. Msa/211/78. He was recommended two weeks off duty on discharge on 13th June, 1978. He is now recommended three months light duties. Sgnd. Medical Officer."

The Court feels that these differences are very minor points in this dispute as the overriding fact is that Mr. Ngwili was sick and the doctor recommended him three months' light duties with effect from 3rd July, 1978. The main bone of contention between the parties is that the Respondents maintain that there is no lighter work in their undertaking than that of welding which they were prepared to let Mr. Ngwili do but with considerably reduced output with the Claimants maintaining that Mr. Ngwili was under no circumstances fit for carrying out the work of a welder which was his normal work.

The matter ended up with the Federation of Kenya Employers' coast branch where the matter was discussed on 2nd September and the Federation advised the Respondents to reinstate Mr. Ngwili but the Respondents did not accept this advice.

The matter was investigated by the Ministry of Labour who found that the Respondents had not only acted arbitrarily but also very unreasonably and the last paragraph of the finding and recommendation read as follows:

"It was not really an employee's duty to ask for clarification of what composed of light or heavy duties. The employer should have done it if not satisfied with medical certificate of incapacity and the contents therein. By ordering Mr. Ngwili to report on duty to perform heavy welding work on

17th July, 1978 was extremely unfair and also ill intended because on 12th July, 1978 the date of the said letter, the union had commenced negotiations and had agreed to contact the doctor at Port Reitz Hospital to specify whether or not Mr. Ngwili was to perform welding jobs. It was, therefore, unfair to dismiss the complainant before such a report was received. The management all the way had acted unfairly and this could not have been expected to be the case of a person who had worked diligently for over 13 years without any warning whatsoever.

Mr. Ngwili's dismissal was wrongful and therefore entitled to reinstatement. Unfortunately there appears to be acrimonious action on the part of the management and the reinstatement would not serve any useful purpose. I therefore recommend that he should be paid 12 months' salary as compensation for wrongful dismissal. In addition he should be paid outstanding wages, if any, leave due."

During the hearing the Respondents called Mr. Bagha who is their accountant and deals with personnel matters to come and give evidence on oath. In cross-examination Mr. Bagha stated that if he had a mandate he would have accepted the advice of the F.K.E. coast branch and further he admitted that the Respondents had omitted to seek another doctor's advice. He, however, maintained that the whole problem stemmed from the fact that Ngwili did not get a letter from the doctor that he could not do any welding and stated that the only other job in the undertaking was that of office messenger which Ngwili could not do because he could not read or write.

The Court finds this to be a rather sad case where an employee with 13 years' service developed TB and had to lose his job under the aforesaid circumstances as the employer has attempted to completely wash his hands off this employee by maintaining that because he did not report for work on a certain day therefore he had frustrated his contract. The matter is not so simple, however, and the Court expects the employers to give humane treatment to the workers. The best way of dealing with this matter was for both the Respondents and the Claimants to have got together and seek a medical opinion before deciding on the next step re-Mr. Ngwili's future. If there was no lighter work than welding in the Respondents' undertaking then probably the parties could have considered the question of retiring Mr. Ngwili on medical grounds. The Court has gone through the parties' collective agreement but unfortunately there is no provision therein for retirement on medical ground. There is a provision on sick leave which the Respondents stated they have fully complied with and the Court does not doubt that.

The Claimants in this dispute are not asking for reinstatement but are asking for months pay for wrongful dismissal, annual leave and leave travelling allowances, all his outstanding wages including the arrears of the current Industrial Court award in Cause No. 47/79 and one month's pay in lieu of notice.

After careful consideration of all the submissions the Court finds that the Respondents acted rather precipitately and were not justified in giving an ultimatum to an employee with 13 years' service, and, who had suffered from a serious illness like TB and was just recovering, that he should either start working as a welder from a certain date or would be deemed to have left the employment. The Court has come to the conclusion that Mr. Ngwili has suffered a wrongful dismissal but in view of the fact that the Claimants also made no attempt to get a certificate from the doctor that Mr. Ngwili could no do welding work at all, 12 months' salary by way of compensation is not justified. The Court has decided to reduce the Ministry of Labour's recommendation by four months and the Court accordingly awards that Mr. Ngwili should be paid eight months' salary for the wrongful dismissal that he has suffered. The Court directs that his compensation should be worked out on the basis of his revised salary as at 1st July, 1978 according to the Industrial Court award in Cause No. 47/79. In view of the fact that Mr. Ngwili had come back from leave in March 1978 and was sick soon thereafter and was paid sick leave in full the Court does not award him any annual leave or leave travelling allowance. The one month's pay in lieu of notice claimed by the Claimants in part of the eight months' compensation awarded by the Court.

This confusion had arisen because of the rationalization during the negotiations of the wage structure. They maintained that the agreed minimum wage increases were to be added to the rationalized wage scales.

The Respondents vigorously opposed this allegation and maintained that the Claimants had failed to understand and appreciate that the workers were now being paid more favourable bonus than during the previous three years' service scheme.

As the Claimants had produced the names of the employees affected on the day of the hearing the Court allowed the Respondents' general manager to check that list and to report back the result of the investigation on 14th May, 1980.

On 14th May the parties informed the Court that as a result of the check that had been carried out by the Respondents they had now settled the matter in dispute and asked the Court to make an award in respect of five employees only.

## AWARD

3. By consent of the parties the Court awards that the Respondents should pay the following amounts to the employees shown against their names:

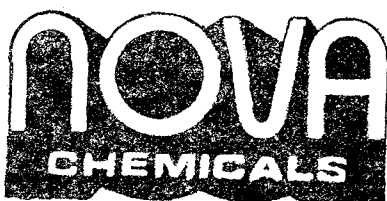

**IMPORTANT NOTICE TO SUBSCRIBERS  
TO THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplements, etc.*:-

- (1) *Kenya Gazette* contains notices of a general nature and which do not affect legislation, and may be submitted direct to the Government Printer.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government, and must be submitted through the Office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction into the National Assembly only.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

**Kenya Gazette**

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
