Applicants should be holders of Bachelor of Science degree in agriculture from a recognized university and must have at least three years' experience in agricultural extension. Post-graduate training in agricultural extension would be an advantage. Preference shall be given to civil servants who are already serving as agricultural officer (Job Group "K").

The successful candidate will be responsible for initiation and implementation of an agricultural extension service in the Magarini Lands Settlement Project, Kilifi District. The work involves farm planning and budgeting, administration of a credit scheme, supervision and training of technical personnel. The successful candidate will be based within the project area.

**Senior Agricultural Officer (Planning) (One Post) (Re-advertisement) (No. 185/80)**

**Salary Scale.**—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates in agriculture and should have at least five (5) years' experience in project preparation, implementation and evaluation. Post-graduate training in agricultural economics or farm management will be an advantage.

Applicants should be graduates in mechanical engineering from a recognized university or an equivalent qualification and must have been registered by the Kenya Engineers Registration Board. They must have had three years' satisfactory post-graduate experience in mechanical engineering, one of which must have been in a responsible supervisory position related to operations and maintenance of vehicles and heavy tractors. Proven ability in administration and organization is necessary as the successful candidate will assist the superintending engineer (mechanical) in supervising and directing all the project staff involved in the operation and maintenance of the machinery and equipment for the project.

Duty station will be the project area at Magarini in Malindi Division of Kilifi District.

**Senior Technical Officer (Soil Conservation) (One Post)**  
(Re-advertisement) (No. 188/80).

**Salary Scale.**—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

The applicants should have served as technical officers Grade II for a minimum of five years. They must have had ten years' experience in water and soil conservation activities and must have served for at least five years at national level. The applicants must have had practical experience at supervisory level and a wide experience in survey work, planning, dam designing and dam construction and laying out water and soil conservation measures suitable for both small scale farming operation as well as large scale farming operation.

The successful candidate will be directly responsible for the day to day planning and supervision of the land development programme, land clearing, ploughing, banking and plot demarcation. Responsibilities for the post shall include an element of training of operators in the mechanized operation and the marking out of plot boundaries. Successful candidate shall in addition be required to design and lay out soil and water conservation works. Training of subordinate staff in this aspect would be an important function. The officer will have the ability and responsibility to interchange men and machines between operations if necessary, to avoid parts of the programme falling behind schedule. Co-ordination with workshop staff to ensure that maintenance programmes are carried out will also be an important function.

Duty station will be Magarini in Malindi Division of Kilifi District.

**Superintendent (Lithographer) (Mapping) (One Post)**  
(No. 189/80)

**Salary scale.**—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants who have had extensive lithographic experience in the mapping field and in addition must have passed Survey of Kenya Occupation Test Grade I in photolithography or City and Guilds Advanced Craft Diploma or have approved comparable qualifications from recognized printing institution. Three years' post qualification practical experience in offset lithographic machine printing or graphic and photomechanical reproduction on projects related to map reproduction is essential.

Successful candidate will be required to conduct work on graphic and photomechanical reproduction, aerial photography techniques, plate making, machine printing and proofreading of various maps and other printed materials.

The candidate should be capable of instructing in-service trainees within the reproduction section and have ability to control staff working under him.

Those who have attended management course at Kenya Institute of Administration will have an advantage.

**Land Registrar I/Registrar of Titles (Lands) (Eight Posts)**

**Salary scale.**—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should possess legal qualification from an approved institution and preferably be persons who have already been admitted as advocates of the High Court of Kenya. Civil servant applicants who are not legally qualified, but are of East African Certificate of Education level with at least four years' practical

experience in a district land registry in the grade of Land Registrar II will also be considered. Applicants should have a thorough knowledge of laws relating to land registration and stamp duty procedure. Ability in handling correspondence, dealing with members of the public and supervising staff is essential. Successful candidates will be required to take charge and work in a district land registry anywhere in the country.

Applicants must be civil servants with at least ten years in map production techniques and must have passed Survey of Kenya Occupational Test Grade I in photolithography. Applicants who have passed the Survey of Kenya Occupational Test Grade II and have put up 15 years of exemplary practical proven work will also be considered. In addition they must also have a wide practical understanding of large litho presses i.e. Sovereign 550, etc.; photographic camera equipment such as Klimsch Super Autoolorika 2000, and also well versed with mapping photomechanical equipment used for reproduction of maps. Preference will be given to candidates who have specialized in either litho offset printing, graphic reproduction, photomechanical electronics and on such allied equipment or who have modern knowledge on photo electronic type setting machines. Applicants must possess a minimum educational standard of Cambridge School Certificate Division II with credits in English language and literature. They should in addition have served a recognized apprenticeship as Compositor/Proofreader for five years, or received equivalent experience on the job training for five years.

They must have thorough knowledge of spelling, punctuation and typography. They should also have an inquisitive mind and be able to concentrate for long hours.

They must have served as Cartographer Grade II for at least three years and must have a sound knowledge of cartographic drawing office work which includes procedures, material map data collection, map compilation, map reproduction methods and map checking. 1. The Kenya Timber & Furniture Workers' Union shall hereinafter be referred to as the Claimants and Silentnight (K) Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 3rd and 30th April 1980 and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:

## Claimants:

Charles J. Murunga.

## Respondents:

Clive E. Thornhill.

## AWARD

3. The Notification of Dispute Form 'A' dated 24th November, 1979 duly completed and signed by the parties was received by the Court on 15th February, 1980 together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. C. J. Murunga started working for the Respondents as a labourer with effect from 3rd June, 1969 the company having started its operations in Kenya in 1968. So he was among the senior employees of the Respondents until the time of his termination on 15th September 1978. During this period he proved to be not only a good worker who improved his working ability and skills resulting in rapid promotions for him but a very competent and sensible shopsteward. He was so successful as a shopsteward that the Claimants submitted during the hearing

that he was promoted to the position of foreman in the dispatch department in order to make him a non-unionizable employee. Prior to this promotion Mr. Murunga had in June, 1977 refused to accept the position of key worker—spring interior and cutting unless he received a salary increase as well.

Mr. Murunga, however, accepted the new appointment and tendered his resignation from the Claimants. It appears that despite this official resignation he continued to be a member of the Claimants without the Respondents' knowledge.

In or about September, 1978 it came to the knowledge of the Respondent that their products were on sale in the city at prices which were below the normal prices for such products and the Respondents became suspicious in view of the quantity that a particular dealer had in his possession who according to their official account was a small dealer. The Respondents embarked on investigations and this resulted in their coming to know that their goods were sold by their employees to dealers. This was done through overloading in excess of the orders. The Respondents had a confrontation with the dealer in question and got a written acknowledgement from him that he would pay them K.Sh. 45,000. The Respondents thereafter reported the matter to CID.

As a result of the report made to the CID by the Respondents about six employees, two drivers, two turnboys and Messrs. Murunga and Kimoli, were taken by the police to CID offices on 14th September, 1978. They were, however, released on 15th September without any charges having been preferred against them. The Respondents then proceeded to terminate their services and the letter written by the managing director, Mr. C. E. Thornhill, to Mr. Murunga stated—

"On your own admission you have been involved in the theft of mattresses from the company warehouse and that subsequent sale to Lucky Furniture Mart. This is confirmed by your statement to the police of 15th September, 1978.

This offence is punishable by summary dismissal. I am therefore writing to notify you formally that your employment with this company is terminated with immediate effect."

The Claimants reported a trade dispute to the Minister for Labour and the Ministry's findings and recommendation as conveyed to the parties on 10th August, 1979 were as follows—

"After the alleged theft, Mr. Murunga was later released from police custody because there was no charge against him.

The management had on concrete proof to show that the police reported that the six employees had confessed about the alleged theft. The dismissal arising out of the alleged theft is therefore wrongful.

After careful consideration of the facts contained herein it is recommended that Mr. Murunga should be paid all his terminal benefits as demanded by the union and be paid six months' salary as compensation for wrongful dismissal. He should also be given a letter of reference stating his actual position at the time of dismissal."

As a result of the above recommendation which was rejected by the Respondents the Claimants have made the following demand against the Respondents—

Plus overtime worked from 20th August, 1978 to 13th September, 1978, (the respondent has the actual number of hours worked) roughly 96 hours.

Reference letter in accordance with agreement between the parties."

The Respondents have strongly resisted this demand on the ground that Mr. Murunga had admitted to the police his involvement in this fraud which led to a theft of the Respondents' property to the tune of K.Sh. 40,000 in which other five employees were also involved. Mr. Thornhill told the Court that he had asked the police to charge the employees for the criminal offence that they had committed but the police had refused to do so, as all the evidence available was that of accomplices and that they would not be successful. Mr. Thornhill added that he then decided to dismiss them all despite the fact that Kimoli and Murunga had denied any knowledge of this fraud.

It is most unfortunate for the Respondents that they had not been able to produce either to the Investigator appointed by the Ministry of Labour or to the Court any evidence, documentary or otherwise, showing the admission by Mr. Murunga of his involvement in the theft of mattresses from the Respondents' warehouse. The Court is not prepared to accept any hearsay statements from the Respondents witness to the effect that the police had told him that Murunga and others had admitted being involved in this theft. The Respondents should have either summoned the investigating police officer or produced the statements made by any of these people confessing to their guilt.

In addition to this vital missing link in the Respondents' evidence there is the evidence on oath of Mr. Murunga that he had been in that department for only three months and had suggested to Mr. Mbeva who was his superior certain ways to control the department but his suggestion had been turned down on the ground that he had no right to change anything. Mr. Murunga told the Court that he had noticed excess storage of products and on one occasion he had noticed an extra mattress and had informed Mr. Mbeva about it. Mr. Murunga impressed the Court as a truthful witness and the Court notes the fact that he was new in that department. In the absence of any convincing evidence implicating him in the theft the Court finds that the Respondents had no reasons to terminate his services.

The Court having found that Mr. Murunga has suffered a wrongful dismissal has decided to award him six months' salary by way of compensation for the wrongful dismissal that he has suffered as the Claimants have not asked for his reinstatement. In addition to this Mr. Murunga is entitled to be paid for the days he worked and for his accrued leave which the Court believes the Respondents have already paid him vide their letter of 20th February, 1980. In case Mr. Murunga has not received the cheque which the Respondents forwarded him then arrangements should be made to pay him this amount along with six months' salary being the compensation which the Court has awarded him. The Court would like to say that one month's notice for termination is included in the compensation awarded.

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

*Kenya Gazette*

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.
