APPEAL No 1 OF 1980

Parties:

Ranjodh Singh & Co.

and

Minister for Labour

with

Kenya Timber & Furniture Workers' Union

1. Ranjodh Singh & Co. shall hereinafter be referred to as the Appellants, the Minister for Labour shall hereinafter be referred to as the Minister and the Kenya Timber & Furniture Workers' Union shall hereinafter be referred to as the Union.

2. The parties were heard in Nairobi on the 22nd July, 1980 and relied on their written and verbal submissions.

JUDGEMENT

3. This is an appeal lodged by the Appellants against an order made by the Minister for Labour requiring them to recognize the Union as representing their employees. This order was signed on 9th April, 1980, by the then Minister, Hon. E. W. Mwangale. As arguments were made by the parties on this order it is reproduced hereinbelow in full:

"The Trade Disputes Act (Cap. 234), order under section 5 (1A):

Whereas there is a trade dispute involving the recognition of Kenya Timber & Furniture Workers' Union (hereinafter referred to as 'the trade union') as a trade union representing the employees of Ranjodh Singh & Co. (hereinafter referred to as 'the employer')—

And whereas the Minister is satisfied—

(a) that the trade union has in its membership a simple majority of the employees of the employer who are eligible by virtue of the Union's constitution to join the trade union; and

(b) that there is no rival trade union claiming to represent such employees:

Now therefore, in exercise of the powers conferred by section 5 (1A) of the Trade Disputes Act, it is ordered that the employer shall, from the date of this order, accord recognition to the trade union for negotiation and collective bargaining purposes."

The main grounds of appeal are that as at 9th April, 1980, the date of the Minister's order, the Union did not have a simple majority of the Appellants' employees in its membership. The Appellants stressed that the material date for the purposes of this order is the date the order is signed by the Minister and for this reason any background prior to this date is completely irrelevant and should not have been taken into consideration by the Minister and the Court should also not take it into consideration. The Appellants maintained that the background would be prejudicial to them. The Appellants submitted that on 9th April, 1980, they had 11 employees, five of them casual, in employment who were eligible for trade union membership and that on the material date only two of the said 11 had joined the Union membership. This clearly showed that the Union did not have a simple majority of their employees in their membership. They asked the Court to find that the Minister's order was improper and bad in law *ab initio*.

The Minister's representative referred the Court to the back ground of the dispute in that on 4th July, 1979, the Union had reported a trade dispute to the Minister under section 4 (1) of the Trade Disputes Act. Conciliation efforts by the Ministry failed to resolve the dispute and the conciliator had reported to the Minister that although the Union had recruited 16 of the Appellants' employees as its members the Appellants had refused to recognize the Union on the ground that their nature of work was rather seasonal and depended very much on demand. The Minister, through the Permanent Secretary, asked the Union on 26th November, 1979, to furnish proof of the alleged membership of the Union supporting its demand for recognition. The Union had forwarded a list of 16 names and a photocopy of the check-off list form. On receipt of this information and after a close scrutiny of the names submitted by the Union the Minister was satisfied that the Union had a simple majority and there was no rival trade union claiming such employees. He accordingly made the aforesaid order in accordance with the provisions of section 5 (1A) of the Trade Disputes Act. For these reasons the Minister asked the Court to dismiss the appeal.

The Court would like to refer to the fact that the Minister's order is made only after a trade dispute on the issue of recognition has been reported to him and the trade dispute is accepted by him. Section 5 (1A) starts off as:

"Where a trade dispute involves an issue concerning a recognition agreement or the recognition of a trade union..."

It is obvious that the date when a trade dispute is reported to the Minister is rather important for the purpose of the Minister's order in dispute of this nature. The Court cannot accept the Appellants' submission that the material is 9th April, 1980, in this appeal. If the Court was to accept the Appellants' submission then it is highly likely that in every such dispute the trade union may start off by having a simple majority but an unscrupulous employer can whittle it down by dismissing trade union members and then claim that at the date when the Minister made the order the trade union did not have the simple majority. This is exactly what has happened in this dispute also as five of the Appellants' employees were after the trade dispute had been reported by the Union to the Minister and all these disputes are now with the Ministry and are being investigated. The Union pointed out this fact and maintained that even on the Appellants' grounds of appeal that they had only eleven employees it is obvious that five who had been dismissed plus the two were still in employment constituted a majority.

Subsequent to the hearing of the appeal the parties exchanged further documentary information with copies to the Court in order to further elaborate the number of employees in the Appellants' employment on the various dates and the Union members. The Court notes that the Appellants maintained that on 21st May, 1979, the date of the check-off list, they had 24 employees in their employment while in their letter dated 29th July, 1980, they stated that they had 38 employees working for them. The date the trade dispute was reported is 4th July, 1979, and the Appellants have further relied on the date when the Minister made the Order, i.e. 9th April, 1980.

The Court must overrule the Appellants' submission that the material date to determine if the trade union had a simple majority is the date on which the Minister makes the order. It is obvious that from the date a trade dispute is reported to the Minister investigations are carried out on his behalf such as requiring the trade union to submit and prove the number of employees in its membership, etc. The Minister after exhausting all his inquiries then makes the necessary order. In this appeal the Court is satisfied that the Minister thoroughly investigated the Union claims. The Court must emphasize that the Minister uses the powers vested in him under section 5 (1A) most sparingly and after making complete inquiries into the whole dispute. The Minister acted and made the order on the check-off list as submitted to him. The Court is satisfied that on that date the Union had a simple majority in its membership.

The Court has carefully considered the various submissions and arguments and lists of employees as submitted by the parties but cannot find any reason to set aside the Minister's order. The appeal is accordingly dismissed.

1. Kwale Saw Mill shall hereinafter be referred to as the Appellants, the Minister for Labour shall hereinafter be referred to as the Minister and the Kenya Timber & Furniture Workers' Union shall hereinafter be referred to as the Union.

2. The parties were heard in Nairobi on the 23rd July, 1980 and relied on their written and verbal submissions.

JUDGEMENT

3. This is an appeal lodged by the Appellants against an order made by the Minister for Labour requiring them to recognize the union as representing their employees. This order was signed on 9th April 1980 by the then Minister Hon. E. W. Mwangale. As arguments were made by the parties on this order it is reproduced hereinbelow in full:

"The Trade Disputes Act (Cap. 234 of Laws of Kenya) Order under section 5 (1A):

Whereas there is a trade dispute involving the recognition of Kenya Timber & Furniture Workers' Union (hereinafter referred to as the trade union) as a trade union representing the employees of Kwale Saw Mill (hereinafter referred to as the employer)—

And whereas the Minister is satisfied:

(a) that the trade union has in its membership a simple majority of the employees of the employer who are eligible by virtue of the Union's constitution to join the trade union; and

(b) that there is no rival trade union claiming to represent such employees:

Now therefore, in exercise of the powers conferred by section 5 (1A) of the Trade Dispute Act, it is ordered that the employer shall, from the date of this order, accord recognition to the trade union for negotiation and collective bargaining purposes."

The Appellants in this appeal adopted the submissions which had been made on behalf of the Appellants in appeal No. 1 of 1980 acting on the premise that the material date in the appeal was 9th April, 1980, the day the Minister signed the order. The Appellants produced lists of their employees as at 9th April, 1980, 12th July 1980 and 27th October, 1979 and argued that the Union did not have in its membership a majority of their employees. The Appellants also amended the following paragraph of their memo of appeal:

"2. We have a total staff of 20 employees out of which three are in the administration and seventeen are labourers; out of them three are members of the union but rest of the fourteen are non-members."

The amendment that the Court allowed at the Appellants' request was that instead of 20 employees they had 70 weekly and casual employees.

The Appellants pointed out that since the Minister had not referred to any previous background in his order therefore the background as submitted on his behalf in reply to their appeal was not relevant. They added that the Minister should have referred to the various dates in his order if they were to be taken into account.

Surprisingly the Appellants did not come prepared with a list of their employees showing their membership of the Union as at 22nd September, 1979 which is the date when the check-off list was signed along with that of 27th October, 1979.

As in appeal No. 1/80 in this appeal also the Court directed the parties to exchange further documentary evidence with each other with copies to the Court in order to determine the number of people in the Appellants' employment at the various dates and their position re-union membership. The Court received all copies of the correspondence exchanged between them with the Appellants claiming that the majority of their workers were not and even now were non-union members and asked for the appeal to be allowed.

On behalf of the Minister it was pointed out that the Union's dispute with the Appellants dated back to 31st October, 1972 and the Court is satisfied from the factual background in respect

thereto that the Appellants have all along firmly rejected all attempts by the Ministry of Labour to require them either to recognize the Union or to submit the dispute on union recognition to the Industrial Court. This confrontation between the Union and the Appellants continued until 1979 when the Trade Disputes Act was amended and the Union requested the Minister to use his powers to order the Appellants to recognize them.

The Minister had before him two lists dated 22nd September and 27th October, 1979 showing the names of the people who had signed the check-off in respect of union membership. The number of employees in the Appellants' employment at the time was alleged to be 65 and the Minister having rejected three names from those who were members of the Union he came to the conclusion that out of 65, 52 were Union members and he accordingly having satisfied himself that the Union had a simple majority and there was no rival trade union claiming to represent such employees signed the aforesaid order on 9th April, 1980.

The Union after confirming what had been stated on behalf of the Minister pointed out that when they had submitted their recognition proposals to the Appellants, the Appellants had immediately declared 14 employees redundant on ground of lack of business. They, however, later on agreed in January this year after the Ministry of Labour had intervened to take them back in employment. The Union, however, stated that these 14th employees had never been reinstated. The Union further pointed out that between 25th January and April, 1980 the Union members were victimized by the Appellants as they were being forced to revoke union membership to block the recognition. This resulted in a strike. A return to work formula was worked out on 25th April, 1980 and in this clause 3 reads as follows:

"The parties agreed that the 17 employees who had claimed to have been forced by the employer to revoke their union membership were still members of the union as the employer had refuted their claim."

The Union contended that despite all the attempts by the Appellants to force their employees to revoke their union membership they had 41 members as at 25th April, 1980 as follows:

- "1. Four reinstated members out of 15 dismissed employees.
2. 17 members whose claim of forced revocation was refuted by management.
3. 20 members who had disagreed to revoke membership despite frustrations."

The Union maintained that the above figures had been confirmed in the return to work formula signed by the Appellants in the presence of the Provincial Labour Officer.

This recognition dispute resulting in the Minister's order which is the subject matter of this appeal has indeed a very unfortunate background and it is quite obvious that the Appellants have all along resisted any dealing with the Union by not recognizing them and had indeed frustrated the machinery for resolving this dispute.

The Court must overrule the Appellants on their submission that the material date is 9th April, 1980. The Court has already pointed out in Appeal No. 1/80 that the Minister makes the order under section 5 (1A) only after a trade dispute has been reported to him. In this case there is a long history dating back to 1972 continuing up to 1976 when the dispute on recognition was shelved. Contrary to what the Appellants have submitted all this background is extremely relevant because the Minister has to thoroughly investigate the claims by the Union before he can use his powers to order its recognition by an employer. In 1979 September/October the total number of employees working for the Respondents were 65 excluding those working in the forest. Out of these 55 had acknowledged to be union members although the Minister rejected three names leaving 52. The Minister further having accepted that there was one duplication 51 employees were left as Union members.

The Court has carefully considered the aspect of the forest workers who the Appellants claim are their employees for the purposes of this appeal but the Court agrees with the Minister and the Union that these persons working in the forests are employed on contract basis and are not really employees of the Appellants. They are given a specific job to do which they do and are paid for it on contract basis.

The Court has carefully examined all the lists that have been submitted by the parties and finds that only those which are dated 22nd September and 27th October, 1979 are relevant for the purposes of this appeal. The Court has scrutinized these lists and has come to the conclusion that the Minister's order is proper and that at the material time the Union had a simple majority of the Respondents' employees in their membership.

For the foregoing reasons the Court can see no reason to interfere in the order made by the Minister dated 9th April, 1980 and rejects the appeal. The appeal is accordingly dismissed.

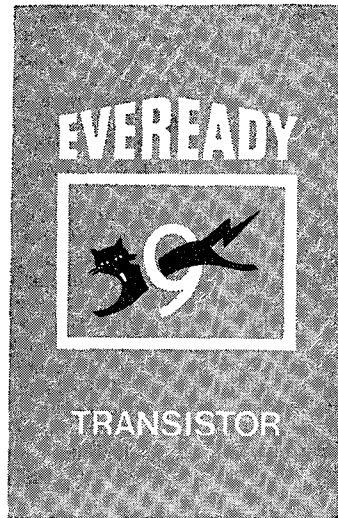

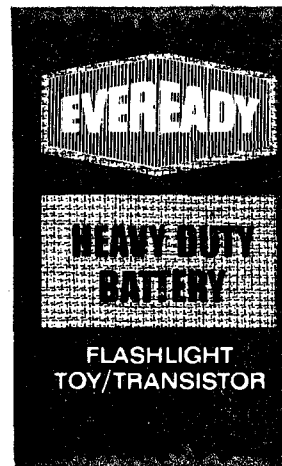

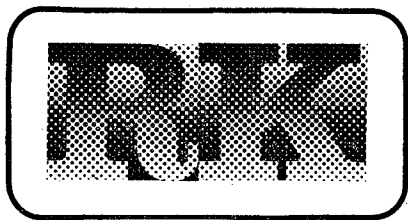
