VACANCIES

APPLICATIONS are invited for the posts shown below. Completed application forms should reach the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, on or before 17th October, 1980.

Civil servant applicants should complete Forms PSC. 2A in triplicate (submitting the original through their heads of department) and Cards PSC 25 and 25A. Other applicants should complete Forms PSC. 2 in triplicate and Cards PSC. 24 and 24A.

These documents are obtainable either from the Secretary or from other Government offices and are issued free of charge.

Originals of certificates and similar documents should not be submitted unless specifically asked for.

NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government Regulations.

Vacancies in the Ministry of Health:

Senior Analyst (One Post) (Re-advertised) (No. 295/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess a minimum of MSc. degree in Chemistry or Biochemistry and a post graduate qualification in the chemistry of food or drugs from a recognized university. They should have at least three (3) years' practical experience in the Chemical analysis of food or drugs at the Biochemistry I (Job Group K) level. Administrative experience will have an added advantage.

The successful candidate will be posted to the food chemical laboratory at National Public Laboratory Services, Nairobi and will be responsible to the Director—N.P.H.L.S. for day-to-day administration. He/she is expected to work in consultation with the Chief Public Health Officer, Ministry of Health.

Animal House Superintendent (One Post) (Re-Advertised)
(No. 296/80)

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess Certificate from Associate of the Institute of Animal Technician or in Animal Husbandry or its equivalent with at least three (3) years' practical experience in management or small animal houses.

Alternatively, applicants with at least five (5) years' practical experience and are due to take recognized Animal House Management examination will be considered.

The duties include breeding of the small laboratory animals, training laboratory personnel and assisting the Animal House Superintendent in taking care of animals under experiments.

The successful candidate should be prepared to work on Saturdays, Sundays and Public Holidays. He/she will be responsible to the Animal House Superintendent (Job Group "J") in-charge at the National Public Health Laboratory, Nairobi.

Vacancies in the Ministry of Agriculture:

Senior Agricultural Officer (Forty Posts) (No. 297/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a Bachelor of Science degree in agriculture from a recognized university. They should have served as Agricultural Officers for at least 5 years, 2 (two) of which should be at Job Group "K". In addition applicants must have proven ability to organize and supervise staff. They should be familiar with Government's development policies, Code of Regulations and Financial Orders. They must be able to co-operate with Ministerial agencies, committees and members of the public.

The successful candidates will be posted as district agricultural officers to any of the districts in the Republic.

The duties attached to the post include planning, implementation and co-ordination of agricultural development programmes and projects in the district; supervision and guidance of all the Ministry of Agricultural staff in the district; preparation of work programmes, various reports and financial estimates. He will also be the holder of Authority to Incur Expenditure (A.I.E.); attend various committees and boards as appropriate and, any other duties as may be assigned from time to time.

*Vacancies in the Ministry of Livestock:**Senior Range Officer (One Post) (No. 298/80)*

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates in agriculture specialising in Range Science, from a recognized university with at least five years' experience in Range Management or related work, two years of which must be at Range Officer Grade I. A relevant post-graduate qualification would be a definite advantage. They should indicate their interest either in group ranch development or grazing block development.

The successful candidate will be responsible to the Head, Range Management Division for the co-ordination and evaluation of all activities related to either group ranches or grazing blocks, ensuring production or acceptable development plans and implementation of such plans in the respective development areas in co-operation with other agencies involved in the livestock development project.

Senior Livestock Officer (Four Posts) (No. 299/80)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving officers with not less than two years' experience at Job Group "J" as Livestock Officers I.

They must be in possession of diploma in Animal Husbandry from Egerton College or its equivalent. They must be conversant with Government Procedures and Implementation of Animal Diseases Act, Cattle Cleansing Act, and other related legislation.

Successful candidates will be required to organize compulsory dipping schemes at provincial level.

*Vacancies in the Ministry of Energy:**Conservator of Forest (One Post) (No. 300/80)*

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a B.Sc. degree in Forestry with a minimum of 3 years' field and/or administrative experience at Job Group "K". Applicants must have experience in planning and/or execution of forest projects at the national level and acquired a national view of the forest resources development. They must have therefore displayed a capacity in dealing with a national forest project and handling teams of professionals at Job Groups "H" and "J".

The duties will include planning the national programme on fuel, wood and charcoal starting from nurseries through woodlots and plantation to charcoal. The successful candidate will be administratively in charge of a team of professionals and a field labour force. He/she will report on the activities of the section to the director of the technical division.

This is a challenging job requiring experience, imagination and determination as the successful candidate will be expected to start the section from scratch and ultimately develop it to cover large nurseries, plantations and charcoal production.

Vacancies in the Attorney-General's Office (Judicial Department)
Executive Assistant (Two Posts) (No. 301/80)

Salary scale.—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers preferably of East African Certificate of Education standard or its equivalent, with a minimum of six years' satisfactory clerical experience in various aspects of general clerical functions and have served in a Civil or Criminal Court Registry, and be serving in the grade of Senior Clerical Officer. They must have passed the Proficiency Examination for Clerical Officer.

Successful candidates must be prepared to serve in any court in the Republic of Kenya.

*Vacancies in the Office of the President:**(Lands Department)**Deputy Chief Valuer (Rating) (One Post) (No 302/80)*

Salary scale.—£2,712 to £3,540 p.a. PENSIONABLE or AGREEMENT.

Applicants should be civil servants in possession of Bachelor of Arts degree in Land Economics—Preferably upper second class honours degree or Associates of Royal Institution of Chartered Surveyors and must be Members of the Institution of Surveyors of Kenya.

They should have at least five (5) years' working experience in the Valuation Office of which two (2) years should be at the grade of Senior Valuer (Job Group "L"). Applications with a relevant Masters degree will also be considered.

The successful candidate will head the Rating Section of the Valuation Division of Lands Department and will be responsible for the rating programme and preparation of valuation rolls for local authorities in Kenya and control payment of contributions in lieu of rates to local authorities for Government owned land. This is a senior post and will require controlling and supervision of valuers and other technical staff attached to the Rating Section at the Headquarters and staff posted with the Local Authorities.

Senior Valuer (Five Posts) (No. 303/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should be civil servants in possession of Bachelor of Arts degree in Land Economics—preferably upper second class honours degree or Associates of Royal Institution of Chartered Surveyors and must be Members of the Institution of Surveyors of Kenya. They should have at least four years' working experience in the valuation office of which two years should be at the grade of Valuer Grade I (Job Group "K"). Those with a relevant Masters degree will also be considered.

Successful candidates will head various valuation schedules in the Valuation Division, Lands Department and will involve controlling and supervision of both professional and technical staff attached to them.

Recorder of Titles (One Posts) (No. 304/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess legal qualifications of approved institutions and have preferably been admitted as advocates of the High Court of Kenya. They should have considerable approved experience since qualifying during which most of the time should have been devoted to conveyancing and land registration. A thorough understanding of the Land Titles Act is essential. Applicants must also be familiar with the provisions of the Government Land Act, the Registration of Titles Act, the Applied Indian Transfer of Property 1882 Act, the Registered Land Act and the Land Control Act. They will also be expected to have a knowledge of the provisions of various laws relating to Trusts and Trustees, Administration of Estates, Bankruptcy, Limitation of Actions, Survey, Land Adjudication, Trust Land and other matters. A knowledge of the English Common Law and the Principles of Equity will be an advantage. The successful candidate will be required to perform the duties of the Recorder of Titles and will be stationed at Mombasa. The duties will include the completion of an adjudicated claim under the Land Titles Act.

*(Government Press)**Senior Superintendent (Litho) (One Post) (No. 305/80)*

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must have passed at least the Final or Advanced Craft Certificate Examination of City and Guilds in Graphic Reproduction and Platemaking or Lithographic Machine Printing, with a minimum of five years' post-qualification experience.

They should have thorough knowledge of colour separation and operation of multi-colour offset printing machine. In addition they should have a working knowledge of Costing and Estimating.

As the work involves supervision, the applicants are expected to have successfully completed the Senior Management Course at Kenya Institute of Administration or its equivalent.

The successful candidate will be expected to take charge of a busy Lithography Department at the Government Press and also perform any other duties that may be assigned to him by the Government Printer from time to time.

*Vacancies in the Ministry of Local Government:**Draughtsman Grade 1 (Two Posts) (No. 305/80)*

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants in possession of East African Certificate of Education and must have obtained from a recognized training institution the City and Guilds Ordinary Diploma in either Building or Civil Engineering or its equivalent as certified by the Principal, Kenya Polytechnic and must have served for at least three years as Draughtsman II (Job Group H) in a physical planning drawing office. Applicants without the above qualifications but have served for at least three years in physical planning drawing office as Draughtsman II, and have shown outstanding merit as certified by their heads of department will also be considered.

Duties will involve production of model physical development plans for major urban centres, purchase and control of drawing office stationery and equipment, supervision, training and development of junior draughtsmen.

*Vacancies in the Ministry of Tourism:**Executive Officer II (One Post) (No. 307/80)*

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with minimum East African Certificate of Education or its acceptable equivalent who must have served in the grade of Executive Assistant for at least three years. They should be conversant with Government Office Procedures, Personnel Management, Accounting and Store Regulations. They should also be able to conduct correspondence and control staff.

The successful candidate will be deployed in the Ministry's Department at Kenyatta Conference Centre.

Investigation Officer II (Two Posts) (No. 308/80)

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be Kenya citizens and should be graduates preferably in Commerce, Economics, Law or a good B.A. general degree with Economics as a major subject from approved universities.

Some knowledge of at least one European Language will be an advantage.

Non-graduate applicants may be considered provided they have had several years' experience of outside criminals investigation work (not as dark-room experts) or Police Divisional Commanders or in the rank not below that of Chief Inspectors. They should be able to take lucid written statements in English or Swahili in an acceptable manner, they must have a Comprehensive knowledge of court procedures, department of cases files and prosecution of cases in Court of Law.

Some knowledge of tourist industry will be advantageous but not essential. The selected candidates must be prepared to travel extensively on duty.

*Vacancies in the Ministry of Commerce:**External Trade Officer I (Technical) (One Post) (No. 309/80)*

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a degree in Agriculture from a recognized university and preferably with post graduate training in marketing of agricultural products. They must also have a sound knowledge of modern food production methods and quality control, as well as extensive experience, of a minimum of four years, in providing technical assistance to industrial undertakings in the food sector. They must also have ability to provide guidance and leadership to colleagues, and to plan and initiate action for implementation.

The successful candidate will be posted to Kenya External Trade Authority (KETA) to provide technical assistance in export marketing of agricultural products, in food items processing and in product development and adaptation to the food industries with a view to enhancing the international marketability of their products, and thereby contribute towards export promotion effort to KETA. He/she will also deal with

identification of export oriented products in the foods sector and will provide guidance to other colleagues in the Technical Section of KETA in carrying out their duties.

External Trade Officer I (Three Posts) (No. 310/80)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a degree in either Business Administration, Commerce or Economics and must be working as an External Trade Officer II or in an equivalent post. They must also have ability to plan and initiate action for implementation in the areas of their operation. They should have extensive experience, of at least three years, in carrying out the activities related to those attached to these posts as specified here below.

The successful candidates will be posted to the Kenya External Trade Authority and will actively participate in planning and initiating action on marketing research, sales and marketing export training, external trade information, documentation and facilitation and market intelligence and reporting. They will also provide assistance to exporters in export promotion and development, and will take a leading role in organizing sales and marketing missions, participation in trade fairs, dissemination of trade and marketing information and export training programmes.

External Trade Officer II (Technical) (Two Posts) (No. 311/80)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a degree in Mechanical, Chemical or Electrical Engineering or in Design from a recognized university and have an aptitude for acquiring interest in the theory and practices of marketing of technical products, some practical knowledge in marketing would be an advantage.

The successful candidates will be posted to Kenya External Trade Authority and will be required to provide technical assistance, under the guidance of senior colleagues to industrial undertakings engaged in production of technical products, with a view to improving export potential through adaptation, development designing diversification and quality and cost control, and through adaptation and selection of appropriate technology. The job also entails carrying out pre-feasibility studies on export oriented technical products as well as some aspects of export marketing of technical products.

*Vacancies in the Office of the Vice-President and Ministry of Finance:**Inspector/Collection Officer II (Ten Posts) (No. 312/80)*

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a recognised degree in Commerce or in Arts with Economics, Accounting or Auditing as a major field of study. Applications will also be considered from those holding at least the East African Certificate of Education with a credit in Mathematics and have obtained a pass in C.P.A. Part I or its equivalent and have acquired not less than three years' experience in accounting or audit work.

Duties include verification of registered manufacturers, sales tax return and payments of tax arrears, penalties, sales tax credits, reconciliation of tax records, refund claims and other matters pertaining to sales tax.

Vacancies in the Ministry of Transport and Communications: Senior Executive Officer (One Post) (Headquarters) (No. 313/80)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with a minimum education qualification of East African Certificate of Education or its equivalent. They must have served at the level of Executive Officer Grade I for at least three years. They must have a thorough knowledge of Accounting Procedures and Regulations, as well as Government Stores/Purchasing Procedures and Regulations. They should be able to control staff effectively and conduct correspondence independently. The duties of the post include Security of Government Buildings, control of a large pool of Government vehicles, write-offs and losses of Government stores. Furthermore, the successful applicant will be expected to co-ordinate and supervise the work of several registries in the Ministry including supervision of general cleanliness of the Headquarters Building Complex. A strong sense of responsibility, meticulous accuracy, adaptability, tact and alertness are essential attributes expected of the successful

applicant, as the officer will frequently be involved in quite a variety of Public Relations matters. The successful candidate will also be required to maintain close supervision on the Ministry's Library. Hence, it is necessary that the applicant should have knowledge and experience in the procedures relating to purchase of a wide variety of technical books and other publications obtained either locally or through the Crown agents in London.

Preference will be given to applicants who have successfully completed a management course either at Kenya Institute of Administration or the Government Training Institute, Maseno.

Superintendent (Civil) (One Post) (No. 314/80)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should be of mature age and good education with several years experience in pavement maintenance and construction, part of which should have been in a supervisory capacity preferably at a major aerodrome. They should have considerable experience in work planning and programming, preparing estimates and controlling expenditure and also have considerable experience in the use of mobile maintenance equipment, maintenance of bitumen, and concrete pavements.

Assistant Surveyor Grade I (One Post) (No. 315/80)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must have passed East African Certificate of Education or its equivalent. They should have passed Technician Diploma in Land Survey from the Kenya Polytechnic or hold Survey of Kenya Occupational Test Grade I in Land Survey.

In addition applicants must have at least five years of post qualification of which three years must have been at Survey Assistant Grade II (Job Group "H") level. They should also possess wide field experience in Topographical, Engineering or Cadastral Survey including Triangulation, Traversing, Techeometry, Photo Interpretation levelling and setting out of Engineering construction works. Successful candidate must be prepared to travel all over the Republic to perform general aerodrome survey duties. He would be in charge of an independent survey team and therefore ability to handle staff is essential.

Operations Officer I (One Post) (No. 316/80)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving Operations Officers Grade II and have successfully completed the International Civil Aviation Organization (I.C.A.O.) type Flight Operations/Government Operations and personnel licensing examination or undergone a course upto the Airline Transport Pilot's Licence having covered ground subjects at any I.C.A.O. approved Institution, or applicants must be in possession of a current or lapsed Commercial Pilot's Licence or a current or lapsed professional Flight Navigator's Licence. Air Traffic Control Officers with an aerodrome. Approach and Area/Radar Ratings will also be considered.

Duties of the post include the following :

- (a) Actioning of monthly reports in respect of Government aerodromes as well as licensed and private airstrip facilities and serviceability.
- (b) Preparation of aircrew licence examination papers and marking and grading of the same.
- (c) The evaluation and notification to Air Traffic Services Units of approved operating aircraft companies weather minima.
- (d) Carrying out written and oral examinations in respect of Radiotelephony procedures with a view to subsequent licensing.
- (e) Carrying out limited civil aircraft accident investigation duties as may be required.
- (f) Co-ordination with the relevant authorities in the production of aeronautical charts, viz. 1:1,000,000 1:250,000 and 1:50,000.

Operations Officer Grade II (One Post) (No. 317/80)

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should have at least an East African Certificate of Education or its equivalent. They must be of good character and health and with at least five years' previous experience in the ground control of aircraft movement. They should also be well conversant with the preparation of aircraft parking plans.

The successful candidate will be issued with uniforms and will be required to obtain the Adult First Aid Certificate of the St. John's Ambulance Association.

Duties include, deputizing for the Operation Officer I, preparation of aircraft parking plans, allocation of stands control of ground movement of aircraft, operation of airbridges, maintenance of aircraft movement records and enforcement of regulations pertaining to the terminal aprons.

The airport operates for 24 hours a day on shift basis and successful candidates should be prepared to work in shifts.

Draughtsman Grade II (Two Posts) (No. 318/80)

Salary scale.—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be holders of East African Certificate of Education or equivalent, preferably from a technical school. They should have had at least five years' experience in a recognized drawing office. They should possess a diploma in draughtsmanship or other equivalent certificate in drawing and they should be able to demonstrate their ability in performing duties of draughtsman in an electrical/electronic drawing office. Previous specialized training in the use and maintenance of audio visual training will be an advantage.

Duties involve preparation of circuit diagrams, scale elevation electronic unit plans, building sections, drawing of figures, charts, maps and other graphics, reproduction of graphics in a suitable form by means of a photographic or other printing processes, visual aids design and maintenance.

Dismissal of Elly Matoke.

1. The Kenya Management Staff Association shall hereinafter be referred to as the Claimants and Johnson & Johnson (K) Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 5th and 14th August, 1980 and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oaths:

Claimants.—E. Matoke.

Respondents:

E. Kangiri.

W. Mulandi.

H. Mugazia.

A. H. Davidson.

AWARD

3. The Notification of Dispute Form "A" dated 15th November, 1979 duly signed by the parties was received by the Court on 15th May, 1980 together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

E. Matoke was employed by the Respondents as a production supervisor with effect from 10th January, 1977 at K.Sh. 4,250 p.m. Prior to that he had worked with E.A. Industries Ltd. for some 5½ years. He told the Court that he left the employment of E.A. Industries Ltd. for better prospects. The Court is satisfied that he had a clean record with that company.

On 30th January, 1978 his salary was increased to K.Sh. 4,583 p.m.

In the letter of 1st July, 1977 addressed to him, while his efforts were recognized, it was pointed out to him two areas in his work which he was required to work on.

"1. The procedure for filling batch sheets have not been adhered to i.e. batch sheets should be filled out as you are mixing the ingredients and not after.

2. Your mixing operations should be planned so as to take the shortest possible batch time."

On 12th October, 1978 he was dismissed from the Respondents' employment with immediate effect for gross misconduct. In his letter of dismissal the following two paragraphs appear:

"During the months of June and July you together with others stole finished goods having the value of K.Sh. 170,000 from our warehouse.

Alternatively you are guilty of gross negligence; whilst employed as production supervisor you permitted products to be manufactured which were not documented thus enabling such products to be subsequently stolen."

The fact that he was served with this letter of dismissal while in police custody is not disputed. He was detained at CID headquarters for five days during which he was interrogated and then released without any charge having been preferred against him. On his release he attempted to discuss the matter with the Respondents but was not allowed in. He then approached the Claimants who took up the matter on his behalf and the dispute was investigated by the Ministry of Labour. The Ministry's findings and recommendation were conveyed to the parties in the following terms:

"It was found that though a witness claimed to have seen Mr. Matoke loading his car with the stolen goods in June, 1978 he did not report the incident to the authority until October, 1978. The management could not prove beyond any doubt that Mr. Matoke stole or was even connected with the said incident. The management's submission which gives an alternative implies that they were unsure and so the benefit of doubt rests with Mr. Matoke. The dismissal was found to be wrongful.

After a careful consideration of the facts contained in this report it is recommended that Mr. Matoke should be reinstated back to his duty and be paid for the time he has been out of employment. Alternatively he should be paid six months' salary as compensation for wrongful dismissal."

The Respondents having refused to accept the Ministry's findings and recommendation the dispute is now before the Court.

The Court would like to immediately dispose of one point and that is that allegations of theft by them have not been proved against Mr. Matoke. The Court agrees with the Claimants' submission on this point.

There are certain other important points somewhat relevant to this dispute that came up during the hearing. The Respondent's factory manager during the material time was suffering from a nervous breakdown and was often absent. The production foreman, D. Mutua, working under Mr. Matoke in or about July/August, 1978 was imprisoned for theft as he was caught whilst attempting to remove baby products from the Respondents' factory on 24th July, 1978.

One George Isaac Ronga was charged for stealing and in the alternative for unlawful handling of stolen property on 17th October, 1978. He was, however, found not guilty and acquitted. The Respondents' financial director, A. H. Davidson, was most unhappy at this and lodged a complaint with the Attorney-General. As the letter to the Attorney-General and his reply are confidential the Court does not intend to divulge the contents therein. The Court must, however, reject the Respondents copy of the judgment that was produced which was obviously as poorly typed that it prompted the Respondents to make some unsavoury comments. The Claimants gave a proper copy of the judgment and it is obvious that the Respondents' certified copy was typed shoddily by someone in the Law Courts. This matter, however, is neither here nor there but the Court has referred to it because a lot of heated arguments took place on it. The fact remains that Mr. Ronga was acquitted of having stolen Respondents' products valued at K.Sh. 170,000/05 or for handling Respondents' products valued at the same amount knowing or having reason to believe them to have been stolen.

The facts leading up to Mr. Matoke's dismissal really started on 27th September, 1978 when one of the Respondents' customers at Westlands telephoned them to report that their products were offered to him at prices substantially below the normal ex-factory prices. The matter developed from there and the Respondents eventually traced 87 cartons at a freight forwarding company's warehouse in Nairobi. The Respondents identified them to have been manufactured in their factory. The Respondents' financial director, Mr. Davidson, admitted that they had recovered all their stolen products.

The Court having found that there is no proof of theft against Mr. Matoke or his involvement in any criminal activity has to decide if in fact notwithstanding this aspect of the dispute the Respondents had legitimate grounds for terminating his services for gross negligence as stated in paragraph 2 of the letter of dismissal dated 12th October, 1978. The Court was given very detailed documentary evidence in connexion with the manufactured products that had mysteriously disappeared from the Respondents' factory. The Court has no reason to doubt the analysis which was produced by the Respondents during the hearing and which was not challenged by the Claimants for the simple reason that these documents were not put to Mr. Matoke at the time of dismissal to get his answer in respect of the missing items. It is quite obvious from the various documents produced that certain products were produced without authority or knowledge of the Respondents' top management in their factory and which were found at the freight company's warehouse and in respect of which there was no record in the Respondents' factory. Other products were manufactured but were not transferred to the stores yet other products from the same batches showed the same number of production in dozens and transferred to store yet dozens of such products from the same batch were recovered from the freight company's warehouse.

The Respondents through their witness, E. Kangiri, established that Mr. Matoke at least knew Mr. Ronga as he saw them talking in their own language when Mr. Ronga had come to the Respondents' premises to buy certain products. At that time Mr. Kangiri was an invoicing clerk and much to his surprise Mr. Ronga insisted on four different invoices although the products were ordered and bought in the name of the same firm. When Mr. Kangiri wanted to write one invoice the customer, Mr. Ronga, told him that he was buying the products for four different people. By that time Mr. Matoke had come and had told Kangiri to do as the customer wished. The Court does not place much weight on this evidence as the insinuation which the Respondents tried to draw from this incident is rather far removed. Mr. Matoke's arrival when Mr. Ronga was buying these products could have been accidental.

Another of the Respondents' witnesses, W. Mulandi, who in 1978 was working as a painter for the Respondents stated that one day when he was working on a Saturday around 3.30 p.m. on 24th June, 1978 he saw Matoke come with another person, Joshua Okiri, and entered the factory. He described how Matoke brought his car in and reversed it to the factory door and then both of them went in the factory. He saw them removing eight cartons of baby lotion and put them in the boot. This witness admitted that he did not report this incident because Mr. Matoke was working in the factory and had the keys to the factory. Later on sometime in October 1978 this witness reported this incident to the management when workers were being asked if they had seen things being taken out of the factory. The Claimants have asked the Court to disregard the evidence of this

witness and whereas in a criminal case such evidence may cast a doubt, in civil proceeding it raises a probability which the Court cannot disregard or overlook. But at the same time it is in evidence that the Respondents paid Mr. Okiri a sum of K.Sh. 17,500 by way of general damages and agreed costs in a civil suit in the High Court where Mr. Okiri had sued them for defamation. The Court has taken this point also very much into consideration before making its findings in this dispute.

After analysing the witnesses' evidence and the documents that were produced the Court is in agreement with the Claimants that as far as any criminal offence is concerned there is no enough evidence against Mr. Matoke. The Court, however, notes that the Claimants have not put forward any reasonable explanation as to how in a factory where literally under the nose of the production supervisor machines worked and produced products in respect of which there is no record and in other cases products produced from the same batch number were found in freight company's warehouse for which there was no record either in the Respondents' books. The Court wonders how if such a senior person as production supervisor had been doing his job properly without any negligence the Respondents would have lost goods worth over K.Sh. 170,000 although they have recovered all of them subsequently. This fact, however, does not absolve Mr. Matoke from his responsibility as a production supervisor to explain how such enormous quantities of products were manufactured in the factory, some completely without his knowledge, as there are no records and others far in excess of the numbers produced and were subsequently found in a freight company's warehouse. It should be pointed out that senior personnel are employed to carry out important duties in an organization for which they are duly paid. They are expected to discharge their functions to the best of their ability.

The Court must add that the Claimants' attack on the financial director, Mr. Davidson, his presence in the country as an expatriate does not help them much in the present dispute. The Court, however, has taken note of the Claimants' submission that some employers are very arrogant out of Court.

The Claimants made a good point when they said that Mr. Matoke should have been asked to explain the alleged areas of negligence of which the Respondents accused him in the letter of termination. Mr. Davidson stated in his evidence that before he could ask Mr. Matoke to give an explanation on how the products had disappeared from the factory the CID took him away and as it was his intention to dismiss him he gave Mr. Matoke the letter of dismissal personally. He added that although all the goods have been recovered it was only after a lot of legal expenses.

After careful consideration of all the submission the Court finds that there were ample reasons under the circumstances of this dispute which are mentioned hereinabove for the Respondents to lose confidence in Mr. Matoke, their production supervisor, and they were therefore justified in terminating his services. The Court, however, feels that his services should have been terminated in accordance with the terms of his contract of employment as summary dismissal was not justified. The Court accordingly awards that the Respondents should pay Mr. Matoke one month's salary in lieu of notice which they were required to give him before terminating his services. Apart from this and Mr. Matoke's other dues which the Respondents have offered to pay the Court rejects the Claimants' other demands regarding his reinstatement without loss in salary and/or any compensation.
