Duties include the running of the Voice of Kenya Television Division, control and direction of television producers and announcers in Broadcasting House or Mombasa Television Station, planning and organization of television programmes, implementation of programmes policy and vote control, negotiating contracts for the purchase of syndicated films, selection and recommendation of programmes from other countries' programme exchange, chairing the Voice of Kenya or Mombasa Television Censorship Committee meeting and maintaining a high standard of staff discipline.

Chief Information Officer (One Post) (No. 327/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a degree in either Journalism or Social Science from a recognized university and proven ability in writing for the Press. They should be fully conversant with news administration and treatment in addition to other public relations requirements. However, serving officers with a minimum of East African Certificate of Education and at least five years' relevant experience in Job Group "K" may be considered. They must be mature and responsible persons who are able to supervise and motivate Government journalists.

The duties include organization of Government information work and mass media techniques, the production of a range of publications and news releases and the writing of feature articles. A knowledge of Government regulations and the Law of Libel and Copyright will be an added advantage. The successful candidate must be prepared to work during odd hours, including Sundays and public holidays.

Chief News Editor (One Post) (No. 328/80)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should possess a degree in either Arts, Social Science or Journalism from a recognized university plus at least two years' editorial or journalistic experience, part of which must have been in a responsible position. However, serving officers with a minimum of East African Certificate of Education and at least five years' editorial or journalistic experience in Job Group "K" will also be considered. Applicants must have a high standard of written and spoken English, a wide knowledge of East African and world affairs and must be conversant with the policies and aspirations of the Kenya Government. They must be mature, responsible and lively persons who have a highly developed sense of news value and who are competent to assess the implications of local and overseas bulletins.

The duties include supervision of the staff and work produced in the News Division of the Voice of Kenya. The successful candidate will also be responsible for arrangements covering a variety of Press Conferences and would be required

to ensure that news bulletins, commentaries and Government publicity arrangements in general are drawn up and disseminated on radio and television in accordance with the policies of the Government. He must be prepared to work during abnormal hours, including Sundays and public holidays. Ability to get good work from junior staff is essential.

Vacancies in the Ministry of Livestock Development:

Senior Livestock Development Officer (Thirty-nine Posts) (No. 329/80)

Applicants must be in possession of a degree in Veterinary Medicine/Agriculture/or Range Management. In addition the candidates must have served at Job Group "K" for not less than two years.

- (2) A dog is deemed to have been in contact with an animal if it has been in the same building, kennel, field or other place as the animal.
- 4. For the purposes of paragraph 3, the dog shall be secured in a suitable place of detention in the immediate neighbourhood of the place where the dog is normally kept or in such other place as may be approved by the Director of Veterinary Services.

5. The place of detention shall comprise a kennel or other enclosure with sufficient adjoining space to provide for the full liberty of the dog in the open air, the whole being so enclosed as to prevent the escape of the dog therefrom or its contact with any other dog:

Provided that in the absence of such facilities the dog may, as a temporary expedient, be detained in such manner as may be approved by a veterinary officer or inspector.

- 6. A veterinary officer, or any person authorized by him in writing, may destroy any dog not controlled in accordance with the provisions of paragraphs 3, 4 and 5.
- 7. The carcass of an animal that has died from rabies or that has been destroyed on account of rabies shall be burned or buried by the owner or the person in charge of such animal
- 8. No person shall move any dog or cause any dog to be moved out of or into the area specified in the Schedule without the prior written permission of a veterinary officer.

- 9. Wages general increment.
- 10. Duration of agreement.
- 1. The Transport & Allied Workers' Union shall hereinafter be referred to as the Claimants and Kenya Airways Ltd. shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 29th July, and relied on their written and verbal submissions.

Award

3. The Notification of Dispute Form "A" dated 4th December, 1979, duly signed by the parties was received by the Court on 20th May, 1980 together with the statutory certificate signed by the Labour Commissioner.

The Respondents came into being on 4th February, 1977 after the collapse of the East African Airways. This is the date when they leased a Boeing 707 aircraft and started their operations. At this time they had engaged 1976 employees on a temporary basis. These employees were formerly working for the E.A. Airways.

The Respondents offered permanent employment to all their employees with effect from 1st September, 1977 and the Court was told that as at 1st July, 1980 the number of employees had risen to 2856.

The Claimants were recognized by the Respondents on 3rd May, 1978 for the purposes of collective bargaining in respect of the unionizable employees. This recognition was granted after long and, according to the Claimants, difficult negotiations.

The dispute before the Court has resulted from the parties' attempts to negotiate a first collective agreement between them. Out of the 34 items tabled by the Claimants for incorporation in the collective agreement 24 of them which had no monetary implications were agreed but the remaining ten involving financial implications were left in abeyance and are now before the Court.

The most important items before the Court are housing allowance, rate of pay and wages scales, wages general increment, effective date and duration of agreement. The Respondents have adopted the stance that the current wage scales effective from 1st September, 1977 and which were revised in September, 1978 are progressive with annual increments granted every year and therefore should not be revised. They pointed out that the effect of the annual increments together with the general wages review of September 1978 reflected an overall wages increase of 17.5 per cent within a space of two years. They emphasized that the current rates are fair and reasonable bearing in mind the current economic recession the world is going through coupled with the effect of recent oil price increases to the aviation industry.

The Claimants have demanded the following starting minimums for the various grades:

The Claimants were very bitter that the Respondents had not made any counter proposals to their demands. They maintained that their members were entitled to at least 30 per cent increase for the two years between May 1978 to May 1980 and asked the Court to award an increase to reflect the cost of living increase in addition to maintaining the annual inrements. The Claimants stated that it was not fair that because of the frustrations they had experienced at the hands of the Respondents their members should be denied the benefits of the wage increases from 1st May, 1978, the date they had obtained recognition from the Respondents. They pointed out that they were now ready for a second collective agreement.

The most important point in this dispute is the one of financial viability of the Respondents as a national carrier. During the hearing and as a result of the very detailed investigations carried out by the Employment Promotion Division at the request of the Court it has become apparent that the losses made by the Respondents are as follows:

For the period ending 31st March, 1981 a loss of 80 million is forecast."

It is also not disputed that the Respondents are a wholly owned Kenya Government Enterprise and the Government has advanced loans or authorized increased overdrafts to meet their cash requirements over the years beginning 1977. The Respondents stated that the funds generated by them had always been insufficient to meet both the capital and revenue expenditure required by the airline.

The Claimants, however, very severely criticized the Respondents by stating that the non-unionizable employees of the Respondents had a wage bill of £6,600,000 p.a. as against wage bill of £2,478,642 p.a. for 2230 unionizable employees. The Claimants gave further details of the fringe benefits enjoyed by the top management which they termed as extravagant. The Respondents, however, discarded the Claimants' allegations in this regard as fictitious.

The Claimants were also most critical of the managerial set up created by the Respondents and accused them of having increased the number of managers unnecessarily by saying that whereas the E.A. Airways had only nine managers for operating 27 aircraft the Respondents had created 29 managers for a much smaller fleet. They also accused them of extravagant expenditure for higher grades and made an allegation that three million shillings were being used for five top executives.

The Respondents countered these allegations by saying that they were fictitious but they did not produce anything concrete in reply.

Before making its award the Court would like to make its position clear. The dispute before the Court is on clearly defined issues which are set out hereinabove and the Court is required to make an award in respect of them. It is not the Court's function in this dispute to look into the organizational structure which has been set up by the Respondents as the Court is not acting as a commission of inquiry into the operations of the Respondents. The Court has no doubt that the Claimants will be at liberty to put forward their views on these matters including the alleged extravagant expenditure on the top executive to the Parastatal Review Committee and the Government commissioned team from the International Air Transport Association in Geneva. These two bodies will no doubt come up with some positive recommendations for streamlining the structure and other areas of the airline's operations.

After carefully examining all the documentry evidence and the E.P.D. reports which the Court appreciates very much the Court is satisfied that the Respondents are facing problems arising out of relatively recent establishment in an already strongly competitive industry. Moreover, the Respondents had to absorb most of the former employees of the defunct E.A. Airways. In these conditions the Court is not inclined to make an award which would not assist the Respondents to sort themselves out of their current financial problems and to subsequently take off.

The Court notes that with effect from 1st September, 1978 the salaries of the various grades were increased as follows:

After careful consideration of all the submissions the Court awards that the effective date of this first ever agreement between the parties should be 1st May, 1980 and that it should remain in force for a period of two years from that date.

On the other issues the Court makes the following award:

- 8. Rate of pay and wage scales
- 9. Wages general increment

The Court awards that with effect from 1st May, 1980 the workers should get a wage increase as follows:

The Court further awards another similar wage increase with effect from 1st May, 1981. These increases are in addition to the annual increments to which all the Respondents' employ-yees are entitled under the present salary structure. If any employees are earning above their rates for their grades they should also get similar wage increases.

The Court awards the following house allowances with effect from 1st May, 1980:

6. Meal allowance

At present subsidized meals are given and the employees pay a small amount in meeting the meal cost although until 1978 free meals were provided for shift workers. The Claimants are demanding free meals for the shift workers and for those employees outside the airport who are engaged in shift work they demand as follows:

The Respondents have asked the Court not to interfere with the present arrangements.

After careful consideration of all the submissions and because of the cost factor involved the Court rules that the present arrangement should continue.

5. Severance pay

6. Redundancy

The Court awards that for the time being the statutory provisions as contained in the current Regulation of Wages General Order should prevail except that an employee declared redundant should be paid severance pay at the rate of 15 days' pay for each completed year of service.

4. Staff travelling expenses

The current arrangements are that:

- (a) All employees owning cars and using them are paid K.Sh. 600 p.m. as travelling allowance.
- (b) There is provision of free transport for employees not owning cars.

The Claimants demand: K.Sh. 2,000 p.m. for those employees using their cars to and from work instead of the current K.Sh. 600 p.m. In addition they demand a revision of the mileage allowances and demand them to be K.Sh. 3; K.Sh. 4.50 and K.Sh. 6 per Km. for cars with 1200 c.c., 1200—1700 c.c., and 1800 c.c. plus, respectively. The Claimants appear to have no quarrel with those employees who have no cars but are provided with company transport to and from place of work.

In view of the financial difficulties which have been mentioned hereinabove in the award the Court has decided that the current arrangement should continue for the time being.

3. Acting allowance

Both parties have agreed that in the event of an employee acting on a higher grade than his he should be paid acting allowance at the rate not less than the difference between such higher grade and his normal salary. The Claimants, however, want the acting allowance to be paid after an employee has worked in the higher grade for a period of 14 days and over.

The Court awards that the acting allowance should be paid to an employee where he has acted in the higher post for a period of 21 consecutive days. The Claimants' other demands on this item are rejected.

1. Leave allowance

The current allowance is K.Sh. 300 per employee proceeding on leave or subsidized air tickets. The Court agrees with the Claimants that the latter is not often used due to abvious practical reasons. The Claimants, however, are demanding that the allowance be increased to K.Sh. 750 with the Respondents making no offer.

The Court notes that the Claimants' demand will require K.Sh. 1,002,600 over and above the current annual labour cost bill

The Court is not prepared to burden the Respondents with such sharp increase on their total labour costs and has come to the conclusion that at least for this collective agreement the current arrangement should continue in force.

- 1. Minimum wages and general wage increase.

- 3. Annual paid leave.
- 1. The Kenya Engineering Workers' Union shall hereinafter be referred to as the Claimants and E.A. Hydraulic & Metal Industries Ltd. shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Nairobi on the 26th August, 1980 and relied on their written and verbal submissions.

AWARD

The Notification of Dispute Form "A" dated 4th June, 1980 dulysigned by the parties was received by the Court on 23rd June together with the statutory certificate signed by the Labourt Commissioner

At the commencement of the hearing the Claimants informed the Court that they had decided to drop issue No. 3 on annual paid leave and further confirmed that the effective date and duration had been agreed by the parties. The Court will comment on this aspect hereinafter in the award.

The Respondents used to be members of the Minor Engineering Group until 31st July, 1976 and their relationship with the Claimants had commenced since 3rd June, 1969.

A collective agreement was signed on 21st June, 1977 between the parties after the Respondents had left the Minor Engineering Group. It was effective from 1st August 1976 and was to remain in force for a period of two years from that date.

The Claimants forwarded their proposals to the Respondents for revising the agreement on 9th May, 1978 and the Court is satisfied from the documentary evidence produced by the Claimants that the Respondents kept silent on this matter with the result that no progress could be made in discussing the Claimants' proposals who were then forced to report the dispute to the Minister for Labour on 15th September, 1978. While the dispute was with the Ministry the Claimants took the initiative and wrote to the Respondents' managing director as a

result of which two meetings took place between the parties on 9th and 26th March, 1979. It is obvious that by this time almost one year had already elapsed.

A conciliation meeting took place on 29th October, 1979 but the parties failed to resolve the three issues as stated hereinabove and expressed their willingness to submit the dispute to the Industrial Court. Thereafter there was a further delay before any steps could be taken in this dispute as the Respondents did not return the Notification of Dispute Form "A" duly signed by them for forwarding the dispute to the Industrial Court. The matter dragged on despite the Minister's reminders to the Respondents until 4th June, 1980 when the Respondents eventually signed the Notification of Dispute Form "A". They stated that the Form "A" had been lost therefore they could not sign it.

The two-year period of a collective agreement which the parties had envisaged to be effective from 1st August, 1978 has already expired. For this most extraordinary situation the Court finds that the Respondents are directly responsible and it is obvious that they have taken an undue advantage of the ban on strikes currently in force in the country. The Court must express its great dissatisfaction at the conduct of the Respondents in this dispute and as a result the Court has decided that its award should be backdated for two years effective from 1st August, 1978 even though it will have expired by the time the award is announced. The Court cannot allow such employers to get away with delaying manoeuvres in the hope that they can escape paying the workers their wage increases when due.

There is one further complication in this dispute that the statutory minimum rates for some of the categories have been increased with effect from 1st June, 1980. So that means that from the two-year duration of this award the new statutory rates would be applicable for June and July, 1980.

In accordance with the August, 1977 Wages Guidelines which are applicable to this dispute the following picture emerges the workers' entitlement under them:

The Claimants have stated that 68 employees fall under the lower income group and 27 employees under the middle income group. The Respondents agree that the majority of employees belong to the lower income group.

The Employment Promotion Division have stated that the lower income group may be compensated up to 40 per cent i.e. 34.5 per cent plus 1977-78 productivity measure amounting to 5.8 per cent.

The Court is satisfied that the workers' entitlement under the Guidelines between 1976 and July 1978 is 24.9 per cent. The Respondents have, however, offered general wage increases of K.Sh. 50 p.m. with effect from 1st August, 1978, to 1st August, 1979 and 1st August, 1980. This offer on an average is 8.7 per cent. The Court has already stated that it does not intend to make an award beyond the two year period with effect from 1st August, 1978. The Court accordingly denies the Respondents' request that the Court award should continue up to 31st July, 1981.

After careful consideration of all the submissions the Court awards that all the employees affected by this dispute should get a wage increase of 12.5 per cent with effect from 1st August, 1978 and that after 12 months from that date they should get a further wage increase of another 12.5 per cent for the second year.

Housing allowance

The Court notes that there is no firm commitment on the part of the Respondents in respect of housing although they have housed some of their employees in what their spokesman called old colonial type labour lines. This facility is free of

charge through the Respondents' associated company known as Continental Developers Ltd.

The Respondents stated that even in 1976 the Claimants had asked for housing allowance of K.Sh. 150 p.m. in addition to the basic wages but had later dropped this demand and agreed to a consolidated wage. The Respondents saw no reason why there should be any change now.

The Court notes that the Claimants have now demanded a sum of K.Sh. 180 p.m. in respect of unhoused employees over and above their current wages.

The Court feels that in view of the unsatisfactory background of this dispute which has forced the Court to make an award which has already expired by time it is announced the Court is not inclined at this stage to make a radical departure from the existing arrangement. The Court accordingly makes no award on this issue but directs the parties to apply their minds to this problem seriously in the next revision of the collective agreement which the Court directs that they should embark upon immediately so that they can have the next collective agreement effective from 1st August, 1980 concluded within a reasonable time



Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-

Kenya Gazette

- D.41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.
- It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
