Functions.—Under the supervision of the Chief, Teacher and Higher Education Division, and in close co-operation with other members of the Unesco-seconded team of specialists and with the administrative and teaching staff working in the UNRWA/ Unesco system, the incumbent will—

- (a) supervise and guide the In-Service Teacher Education programme within the UNRWA/Unesco system;
- (b) help integrate the theoretical and the practical aspects of the in-service teacher-training programmes;
- (c) help co-ordinate the work of the staff attached to this programme;
- (d) help gear the training programme, as a whole, to the needs of the UNRWA/Unesco schools;
- (e) prepare annual schedules for in-service courses and coordinate the organization and supervision of in-service training;
- (f) assist the division in the development of its programme, specially in the field of in-service teacher education;
- (g) assist in the co-ordination of in-service and pre-service training programmes;
- (h) assist in the organization of summer courses, seminars and workshops for teachers; and
- (i) undertake such other duties as may be assigned to him by the Chief of Division, the Supervisor and the Director of the Department.

Oualifications and experience required-

- (a) university degree, preferably in education and psychology;
- (b) experience in planning and implementing teacher-training programmes;
- (c) considerable teaching experience in schools and in teachertraining institutions;
- (d) language requirements—excellent knowledge of English and Arabic desirable.

Organizational location.—Production Services Division Office of the Unesco Press.

Duties and responsibilities.—Under the supervision of the Chief of the Division, the incumbent will perform the following duties, in addition to those normally assigned to a copy preparer—

(a) organize and supervise the work of his unit with due regard for the production plan; distribute tasks among the members of his unit with due regard for the particular abilities of each one.

- (b) ensure in permanent liaison with the other copy preparation units the strict co-ordination of the various language versions of each work.
- (c) find suitable solutions to the various problems encountered by copy preparers in the course of their work; where necessary, consult directly or indirectly the competent sections of PUB, the publications unit of the sector or the person responsible for the publication; submit to the Chief of the Division the general policy problem requiring action on his part.
- (d) approve the texts of works for composition and printing.
- (e) whenever necessary: participate in preliminary studies in the course of which the layout of works is decide upon; provide the sectors concerned with all the necessary guidelines regarding the presentation of manuscripts; study with the art section the presentation of texts.
- (f) draw up, in close association with the other chief copy preparers and without losing sight of the development of modern techniques of composition, the typographical rules specially applicable to the organization's publications.
- (g) perfom any other tasks entrusted to him within his field of competence particularly those relating to the search for and application of new production methods.

Qualifications and experience required:

- (a) University studies or equivalent.
- (b) Perfect command of the French language. Thorough knowledge of French syntax and spelling. Good knowledge of English and/or Spanish; knowledge of other languages (Arabic, Rusian) an advantage.

COMMONWEALTH YOUTH PROGRAMME: CARIBBEAN CENTRE

VACANCY FOR TUTOR IN PROJECT AND PROGRAMME PLANNING

APPLICATIONS are invited for the above position on the staff of the Regional Centre which is based in Guyana and which is an element of the Commonwealth Youth Programme administered by the Commonwealth Secretariat, London.

The Tutor will be responsible to the Regional Director and his/her responsibilities might cover the whole of the Commonwealth and periods in each year are likely to be spent outside of the Caribbean Region.

DUTIES

In training youth workers the Tutor in Youth Project and Programme Planning will be responsible for the following areas of training:

- (a) Project design and implementation.
- (b) The relationships between community-level project design and implementation and national planning.
- (c) Basic techniques of manpower planning.
- (d) Basic techniques of socio-economic analysis and evaluation.
- (e) The history of developmental planning, with emphasis on the attention given to youth.
- (f) Participatory research within communities.

- (a) advice on the development of programmes to facilitate the involvement of young people in the economic, social or cultural development of their communities preferably resulting in the creation of jobs for young unemployed;
- (b) advice on the design, implementation and evaluation of youth projects;
- (c) advice on the funding of such projects through international agencies and other sources.

The Tutor in Youth Project and Programme Planning will also be expected to—

- (a) facilitate the gathering, processing and dissemination of information and data or project planning and development through the Commonwealth Youth Programme information service;
- (b) assist the Commonwealth Youth Programme in the preparation of syllabi on Youth Project Planning and Development.

QUALIFICATIONS

Candidates should normally be educated to tertiary level, with qualifications either directly related to development planning or in a related field of social science. Particular attention, however, will be given to field experience related to the above activities—preferably at community level in a developing Commonwealth country.

Some administrative experience is desirable, as is the capacity to work well under difficult circumstances and in cross-cultural settings; a knowledge of modern training techniques and methods is highly desirable.

Salary and Allowances

- (a) Salary is negotiable but will not be less than \$24,000 (G) per annum.

- 2. The parties were heard in Nairobi on the 8th October, 1980 and relied on their written and verbal submissions.

AWARD

- 3. The Notification of Dispute Form "A" dated 20th May, 1980 duly signed by the parties was received by the Court on 16th July together with the statutory certificate signed by the Labour Commissioner.
- 1. X-ray operator (Rhodes Avenue Dispensary)

Mr. C. Masinde was appointed to the post of trainee radiographer by the Respondents in May, 1958. The Respondents sponsored him to study radiography in the then King George VI Hospital for one year. He successfully completed the course and was appointed to the post of radiographer with effect from 1st April 1959. The Respondents did not challenge this letter of appointment. The Court notes that prior to his joining the Nairobi City Council he had worked in the armed forces and was in possession of a certificate showing that he radiographer group A class 3.

From the evidence that was tendered by the Claimants during the hearing by way of appendices to their written submission and which was not challenged by the Respondents the Court is satisfied that to all intents and purposes Mr. Masinde worked as radiographer at the Rhodes Avenue Dispensary also known as the Chest Clinic. The Court is also satisfied that during all these years Mr. Masinde's superior officers strongly recommended him for promotion.

In January, 1971 the parties agreed to appoint Inbucon International Ltd to carry out a job evaluation exercise of the complete staff of both Nairobi and Mombasa local authorities. The jobs of X-ray operator, radiographer and darkroom technician were considered and as a result of the job evaluation exercise the three jobs were categorized in the following salary scales:

X-ray operator: Salary scale M .. K£456 to K£633 Radiographer: Salary Scale J .. K£1,146 to K£1,692

Darkroom technician: Salary scale

М .. K£456 to K£633

The Court notes that notwithstanding Mr. Masinde's original letter of appointment under which he was appointed as a radiographer the Respondents appointed him in salary scale 22 to the post of X-ray operator with effect from 1st January, 1970 carrying a salary scale of £360 by £25 to £560.

This new designation having taken place Mr. Masinde and the Claimants are naturally now fighting for upgrading the post of X-ray operator, Rhodes Avenue Dispensary. The matter has been discussed repeatedly at the various meetings and at one stage it is recorded in the minutes of the Joint Negotiating Committee No. 1 meeting held on 28th November, 1977 as follows:

Darkroom technician and X-ray operator:

The Executive Secretary reported that these two posts had, at the request of the union in April, 1976, been dropped from the agenda of a Staff Joint Committee; the union reserved their position."

The Court agrees with the Claimants' submission that this did not mean that they had given up their demand on this item.

The position now is that after the Inbucon report both X-ray operator and darkroom technician are at the same salary scale M with the radiographer in scale J. As is obvious from their salaries the difference is quite substantial.

Unfortunately for Mr. Masinde since the publication of Legal Notice No. 182 of 31st August, 1979 it is now a legal requirement that a private clinic may not include a clinical radiological laboratory unless the practitioner who operates the clinic is himself qualified in the use of ionising radiation or employs a radio-grapher. The same legal notice defines a radiographer to mean a holder of a diploma in radiography obtained from the Medical Training Centre or such similar institution which is recognized by the Ministry of Health.

The Respondents informed the Court that they had recently created a post of radiographer at the chest clinic in compliance with the above notice and although Mr. Masinde applied he was not even shortlisted because he did not have the necessary qualifications as required by the law. They argued that because of this Mr. Masinde could not be graded in scale J.

The Claimants pointed out that at the time when Inbucon were carrying out their job evaluation exercise Mr. Masinde was on leave and therefore he was not able to inform the team carrying out the job evaluation exercise what exactly he did.

As stated earlier the Court is satisfied that he was in charge of this clinic for all these years and it is only now since the legal requirement that hte Respondents have taken the trouble of advertising the post of radiographer whereas in the past they were quite content to let Mr. Masinde do the work which the radiographer will now do.

The Claimants submitted that Mr. Masinde had all along been at the maximum for all these years and the only times he benefited by way of wage increase was when they negotiated and obtained higher salaries for their members.

The Court agrees with the Claimants when they say that when the latest collective agreement between the parties was signed they were aware that the dispute on these two issues was pending therefore the Court finds that any award made in respect thereto would not amount to interfering with a registered collective

Notwithstanding the Respondents' plea that the Nairobi Review Committee should look into this matter if the Claimants were not happy with the grading the Court finds that Mr. Masinde has indeed suffered a grave injustice and it would be most unfair to delay a final solution to this dispute any longer.

After careful consideration of the submissions the Court has come to the conclusion that X-ray operator and darkroom technician should not be in the same salary scale as they are at present. The Court has decided to award that the X-ray operator should be graded in salary scale L and that his starting salary should be £1,026 by £36 to £1,134. The Court further awards that the regrading should be carried out from the effective date of the collective agreement i.e. 1st August, 1979.

2. Darkroom technician (Pumwani Maternity Hospital)

After careful consideration of the submission the Court finds that the Claimants have not made out any case for upgrading of this post and therefore it should remain at its present salary scale M.






