METHODS OF CHARGE BY-LAWS THROUGHOUT ALL AREAS IN
KENYA SUPPLIED BY THE LICENSEE

NOTICE is given to all whom it may concern that the East African Power and Lighting Company Limited, a limited liability company incorporated in the Republic of Kenya having its registered office at Electricity House, Harambee Avenue, Nairobi, intends to make application on 11th April, 1983, to the Minister for Energy under sections 72 and 149 of the Electric Power Act for the approval by him of proposed by-laws to be known as the "Methods of Charge (E.A.P.L.) By-laws, 1983", which if and when approved will revoke the existing Methods of Charge (E.A.P.L.) By-laws, 1978.

The object of and reasons for the application are to achieve an overall increase in revenue which has become necessary to enable the power industry to meet part of the development costs for new electricity generation and transmission projects, namely Geothermal, Kiambere, Turkwel, Kilifi/Bura transmission line and second interconnector to the Coast.

The fuel oil surcharge currently in force will be absorbed in the new tariff. There will also be uniform energy charges throughout the day and night as the cost of supplying energy over a 24-hour period is now the same. Furthermore, the rates for interruptible supplies have been adjusted to reflect more closely the marginal cost of providing those supplies.

All present and future consumers will be affected by the approval of the application in that the application of the proposed new by-law will result in increase in the cost of electricity to different categories of consumers by amounts varying between 5 per cent and 27 per cent; the overall tariff increase being 12.9 per cent.

Copies of the proposed "Methods of Charge (E.A.P.L.) Bylaws, 1983", have been deposited at the offices of the licensee and are open to public inspection during normal office hours without payment. Copies of the proposed by-laws may be purchased at the office of the licensee at a price of K.Sh. 5 per copy.

Any public or local authority, company, person or body of persons desirous of making any representation on or objection to this application must do so by letter addressed to the Minister for Energy and marked on the envelope "Electric Power Act", on or before the expiration of fourteen (14) days from the date of the application as stated in this notice and must forward a copy of such representation or objection to the applicant.

2. The parties were heard in Nairobi on 26th October, 1982, and 25th and 26th January and 18th February, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

AWARD

3. The Notification of Dispute Form "A" dated 26th October, 1981, duly signed by the parties was received by the court on 12th July, 1982, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The dispute concerns seven salesmen with long service with the respondents and whose services were terminated on 17th November, 1980. They were all earning K.Sh. 1,256 per month at the time. Their length of service was—

- O. Othero started working on 25th September, 1959;
- T. Nyangau started working on 1st July, 1970;
- K. Wanyaa started working on 13th July, 1972;
- E. Oyugi started working on 2nd August, 1970;
- N. Gichuru started working on 13th July, 1972;
- N. Abdulrahaman started working on 1st February, 1971;
- C. Ogaga started working on 30th July, 1970.

They were dismissed in accordance with section 21 (c) (d) of the collective agreement. The respondents, however, decided to reduce the dismissal to termination.

The dispute was investigated by the Ministry of Labour and its findings were that they had suffered a wrongful dismissal and it was recommended that they should be reinstated unconditionally without loss of seniority. Further the period betwen the termination and reinstatement be treated as leave with quarter pay. The claimants accepted the recommendation subject to all the employees being paid full salary for the period they were out of employment. The respondents rejected the ministry's finding and recommendation.

This dispute is closely connected with the respondents' efforts down at Mombasa (where all these persons were working at the material time) to reduce payment of overtime to their various employees as it was felt that it was unduly high. In early 1980 the respondents carried out a route survey which revealed that the highest demand for milk was between 5 and 8 a.m. For this reason they decided that the distribution of milk should take no more than four hours on any one route and that the route sales should be completed by 10 a.m.

The new procedure was that the salesmen were to start operation of their respective routes from 3 a.m. and were normally expected to complete the distribution by 8 a.m. Any salesman who was unable to complete his distribution by 8 a.m. was allowed to stay on the route until he completed his distribution provided he entered the reasons for the delay in the route

occurrence book which was to be introduced. The respondents maintained that it was a mere formality for the day milk supervisor to complete the overtime sheet for recommendation by the senior supervisor and approval by the branch manager.

Various meetings took place between the workers and the management where the question of staff overtime was discussed with the shopstewards complaining that it was being reduced by the management. The parties were then deadlocked on how to check this. The workers also complained about the way overtime was recorded and paid and it was agreed that a committee be formed between union representatives and the management to be chaired by the accountant.

The court has carefully gone through the various meetings and correspondence on this point and finds that the issue of overtime was indeed causing quite a few problems down at the coast. While these exchanges were taking place some discussions between the production manager and the branch manager took place at Mombasa on 11th November, 1980. Notes were prepared of these discussions and paragraphs 4, 5 and 6 of these notes which are important for this dispute read:

- "4. Mombasa loading group will be booked in at 12 midnight and the first job will be to sort out transit damages and then load sales vehicles. This means that Mombasa sales vehicles will be loaded with milk already sorted and that there should be no leakers received from salesmen. The loading group will be booked off by 6 a.m.
- 5. The sales group will be booked in at 2.30 a.m. to commence sales by 3 a.m.
- 6. Route sales at Mombasa should then be completed by 8 a.m. This will also give time for vehicles to transport crates back to Nairobi."

The respondents maintained that these notes were not operational and that the claimants' shopstewards obtained them through unauthorized means and have misused them for their own mischievous goal. The court is not so sure, however, on this point because one of the respondents' own witnesses, Mr. Muoki, clearly admitted in evidence that he could not have started the new working schedule which was the same as it appeared in the above notes of discussion on 11th November, 1980, without instructions from his superiors. Moreover, in the time sheets for 13th and 14th November the branch manager had clearly stated that there was no overtime on these time sheets although some workers appear to be entitled to overtime. One very interesting thing about an additional document marked supplementary overtime request time sheet; is that at the bottom it is clearly stated that no staff should be engaged on overtime duties before this is approved. This clearly is not practical and is contradictory in certain respects to the actual practice.

The court has carefully observed the times in and times out for 11th to 16th November both days inclusive for all these seven salesmen and finds that up to 15th their time out was 10.45, 10.15, 12.15, 10.30, 11.15 and 10.30 as recorded in milk issues forms yet on 16th the time out for all of them is 8, i.e. when all of them on that day came back with sound unsold milk.

On that day the branch manager issued two letters to all of them one suspending them with immediate effect and the other seeking an explanation which was worded as follows:

"I am hereby ordering you to give a written statement on receipt of this letter on the circumstances leading to your returning to our offices in a go-slow style with crates of unsold sound milk. You are aware that you are expected to sell all your milk between 3 and 8 a.m. you are also aware that the normal working period is 7 hours and you are further aware that there are adequate provisions for delays on route as you should explain in the route occurrence book events which might necessitate longer stay on the routes. Your statement should reach me by 8.30 a.m. on 17th November."

The court notes that in this letter the branch manager has not made any mention that they were ordered to go back and sell milk and their refusal to obey such an order from the branch manager. The explanation given to this letter by all the salesmen was in the following words:

"Arising from your letter of 16th November for explanation why we returned to the cold store at 8 a.m. I came back in conformity with the instructions that I should be back by 8 a.m. to the cold store."

Under these circumstances where there was an on-going confrontation on the question of overtime coupled with workers' fears that they were being denied legitimate overtime dues and the notes of the discussion of 11th November the court has to decide if the action of these seven salesmen in returning to the respondents depot at 8 a.m. on 16th November, 1980, gave the respondents justifiable grounds for dismissing them. The court has carefully considered the parties' submissions and

the evidence of the witnesses and finds that these workers were under instructions to come back at 8 and that in the absence of a satisfactory solution to the overtime problem they had justification for doing what they did on 16th November. Even the findings of the Ministry of Labour established that when the hours of work were changed they were reduced by $1\frac{1}{2}$ hours, i.e. 3 and 10 a.m. to 2.30 to 8 a.m. instead of 9.30 a.m. Either deliberately or through oversight which was ironical for if occasionally it was necessary for employees to work overtime even though they had seven hours in which to work they could not be expected to do the same work in $5\frac{1}{2}$ hours.

The court has decided that the findings of the Ministry of Labour in this dispute were correct and the court has come to the conclusion that it should uphold them and accordingly finds that the seven employees have suffered a wrongful dismissal. The court concurs with the following observations made by the ministry's investigator:

"It was further established that clause 21 (c) and (d) was not correctly applied due to misinterpretation because the salesmen were neither proved careless nor drunk and therefore the loss, if any, or serious risk to the company's property was caused by the erroneous change of time. Subpara (d) was not correctly applied either because the management had all the time to consider the case of the overtime but they ignored this even though their attention had been drawn to it earlier on. The orders they were given on 16th November were therefore not proper as the employees had complied with the time they were expected to come back. The investigator was further told that the management was aware that the incident had been stage-managed by the shopsteward. His case is however not among the seven in question. The management also dwelt at length on the influence of politics on the incident, however from the submissions by both parties it was more evident that this was a culmination of an outstanding simmering dispute about overtime which was more of an industrial relations matter than political as it relates to the welfare of the employees and about which the man-agement had not attended to."

The court awards that all the seven employees should be reinstated to their positions with the respondents with effect from the first of the month following the date of the court award and the court further awards that each one of them should be paid eight months' salary by way of compensation for the time they were out of employment. The court further rules that they should not suffer any loss of service or forfeit any increments that might have been due to them.

THE Tailors and Textile Workers' Union shall hereinafter be referred to as the claimants and National and Seasun Garment Factory Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on the 10th February, 1983, and relied on their written and verbal submissions.

Award

3. The Notification of Dispute Form "A" dated 27th February, 1982, duly signed by the parties was received by the court on 2nd November together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Kassim worked for the respondents from 15th June, 1975, as a machinist and ceased working for them on 26th August, 1980, with him claiming that he was dismissed for an alleged gross misconduct and the management stating that he refused to work on the Juki machine and demanded for the payment of his dues as he wanted to leave employment. They maintained that they had not terminated his services.

The dispute was investigated by the Ministry of Labour whose finding was that the respondents had caused Mr. Kassim's constructive dismissal and recommended that he be paid four months' salary as compensation for wrongful dismissal in addition to his terminal dues.

The claimants accepted the recommendation but the respondents refused to do so.

During the hearing Mr. Kassim gave evidence on oath but the respondents did not call any witness. From the written and oral submissions and the evidence given during the hearing the court finds that on 21st August while Mr. Kassim was working on the Juki machine the plate in the machine made of stainless steel broke and he was transferred to work on the Paff machine. On 26th August he was again asked to work on the Juki machine but he asked the respondents' managing director that the machine should be thoroughly checked to determine if it was in perfect working condition. The incident then developed from there with the result that Mr. Kassim was sent to the claimants' Mombasa branch by the respondents with a letter from the managing director in which it was stated that the respondents were sending Mr. Kassim who was the claimants' member as he had refused to do work given to him and that he had asked to leave employment and had claimed his dues. In the last paragraph the respondents suggested that the claimants may get any good mechanic at the respondents' expense to certify that the machine was in working order.

The court can see the logic behind the respondents' move but finds that it was not the proper thing for them to do at that stage. Nevertheless the branch secretary wrote to the managing director on the same day stating that Mr. Kassim had given them a different story altogether and he proposed to meet the managing director the next day at 10 a.m. to discuss about the whole issue. The managing director in the first place having himself involved the claimants then wrote back to the branch secretary saying that they had no time to discuss the matter as suggested by them the next day and asked the claimants that since they had a different story they should put that in writing. This is most inconsistent because if the respondents had allowed the claimants to come as suggested by themselves then in all probability the matter would have been sorted out to the satisfaction of all.

After careful consideration of all the submissions the court is inclined to believe the evidence of Mr. Kassim and finds that the Juki machine in question was rather old and that he had on 26th August, 1980, asked for it to be rechecked before he commenced work on it lest it broke again and for which he would be blamed. The Ministry of Labour investigator found that this machine had since been replaced.

The court finds that the respondents were at fault after having involved the claimants' Mombasa branch in the dispute on 26th August in not meeting the branch secretary the next day as requested by themselves with the, result that Mr. Kassim found himself sent to his union's office with a letter by his employer who subsequently refused to discuss the matter with them! In these circumstances Mr. Kassim was left in an embarrassing position. The court must find in these circumstances that he was indeed suffered a dismissal which was not justified. The court concurs with the findings of the Ministry of Labour and awards that the respondents should pay Mr. Kassim four months' salary as compensation for the wrongful dismissal that he has suffered in additional to his other lawful terminal dues amounting to one month's salary in lieu of notice at the rate of KSh. 705 p.m., wages in lieu of leave accrued for 13 months, leave travelling allowance of K.Sh. 120 plus salary for the days worked in August 1980 (26 days). The court directs that the respondents should pay the amount due to Mr. Kassim under the court award immediately.


