VACANCIES OFFERED BY UNESCO

1. Title.—PROGRAMME SPECIALIST in environmental sciences (ecological sciences) (AS/RP/INS/SC/007).

Category and level.—Professional category (P-4).

Duty station.—Regional office for science and technology for South-East Asia, Jakarta.

Duties and responsibilities.—The specialist, under the supervision and authority of the director of the regional office for science and technology for South-East Asia and in close cooperation with the Secretary of the International Co-ordinating Council for the M.A.B. programme, will carry out activities for the stimulation and co-ordination of activities contributing to the Man and Biosphere (M.A.B.) programme and related Unesco activities in the field of ecological and environmental sciences in South-East Asia and Pacific. The specialist will exercise the following functions:

- (1) Promote the active participation of the countries of South-East Asia and Pacific in the M.A.B. programme.
- (2) Assist in the development of problem-oriented integrated M.A.B. field projects of research, training and demonstration, aimed at developing the scientific bases for sustained resource management.
- (3) Establish and reinforce links between M.A.B. field projects and participating institutions within flexible networks of scientific co-operation in the region, including development of mechanisms for exchange of people and information, organization of technical seminars and field workshops, etc.
- (4) Encourage links between the developing countries of the region and specialized institutions in such countries as Japan, Australia, New Zealand, etc., including negotiating for extra-budgetary and bilateral support for particular field activities.
- (5) Assist member countries in establishing effective networks of biosphere reserves and other protected areas, and in developing the various activities of research, monitoring of change, demonstration, education and training in these areas.
- (6) Develop co-operative programmes with relevant regional and international institutions in the region, such as the S.E.A.M.E.O. Regional Centre for Tropical Biology (B.I.O.T.R.O.P.).
- (7) Strengthen regional or national institutions or programmes dealing with trading and/or research on ecology, resources utilization and management, integrated surveys, or other connected activities that lend themselves to planning and development of natural renewable resources.
- (8) Such other duties as the director of R.O.S.T.S.F.A. shall consider relevant to and in support of the above-scheduled activities.

Qualifications and experience required:

- (1) University or equivalent degree in one of the environmental sciences with good knowledge of modern ecology.
- (2) Several years' experience in teaching and/or research together with appropriate field experience.
- (3) Experience in administration of scientific programmes, preferably at the international level.
- (4) Interest and preferably experience in the socio-economic development of South-East Asia, Oceania and in scientific co-operation in developing countries.
- (5) Interest and preferably experience in the problem-oriented interdisciplinary approach of the M.A.B. programme.
 - (6) Adaptable, sensitive and innovative personality.
- (7) Very good knowledge of English, with a working knowledge of French an advantage.

Duration of contract.—Initial period of two years starting as soon as possible after the closing date for the receipt of applications.

Salary and allowances.—Initial appointment will be at P-4 grade with a net annual salary equivalent to US\$27,612 per annum (\$25,672 if without dependants), plus the prescribed allowances, e.g. post adjustment, at present \$17,245 for staff members with dependants, \$16,020 for staff members without dependants, assignment allowance, at present the local equivalent

2. Title.—PROGRAMME SPECIALIST (science and technology policies) (AF/RP/SEN/SC/005—Rev. 2).

Category and level.—Professional category (P-5).

Duty station.—Unesco Regional Office for Education in Africa (B.R.E.D.A.), Dakar, Senegal.

Duties and responsibilities.—Under the authority of the director of the Regional Office for Education in Africa (B.R.E.D.A.), Dakar, and the supervision of the director of the Regional Office for Science and Technology for Africa, Nairobi (R.O.S.T.A.), and in collaboration with the appropriate programme division at Unesco headquarters, the incumbent will:

- (1) Participate in the organization and follow-up of ministerial conferences and government expert meetings dealing with the application of science and technology to development, convened by Unesco in Africa such as C.A.S.T.A.F.R.1.C.A. conferences.
- (2) Collaborate in the preparation of the documents relating to government policies in the field of science and technology for submission to regional meetings organized by Unesco, other institutions of the United Nations system, or regional intergovernmental organizations.
- (3) Assist in the development of standards and methodology for the gathering of scientific and technological data in the African region and in the analysis of the data obtained.
- (4) Assist in collecting, processing and disseminating basic information and factual data concerning: (a) the scientific and technological potential of member states; (b) their national science and technology policy-making bodies; (c) on-going research projects and training courses—national or regional—concerning policy-making and management in the field of science and technology.
- (5) Collaborate in the development and management of the Unesco special fund for research and experimental development in Africa.
- (6) Assist member states and intercountry organizations in the organization and implementation of activities carried out with Unesco's support (e.g. under the participation programme) and relating to science and technology policies.
- (7) Assist member states in the identification of projects and in the drafting of the relevant project documents in the field of science and technology policies for submission to international financing agencies such as the United Nations Development Programme (U.N.D.P.) and the United Nations Interim Fund for Science and Technology for Development (I.F.S.H.D.), etc.
- (8) Collaborate with national science and technology policy-making bodies, with a view to developing policies and plans for regional scientific and technological co-operation.
- (9) Co-ordinate the activities of the Regional Office for Science and Technology for Africa (R.O.S.T.A.) unit outpost to B.R.E.D.A.
- (10) Perform such related duties as may be assigned to him by the Director, R.O.S.T.A., and/or the Director, B.R.E.D.A.

Qualifications and experience required:

- (1) University education up to at least the Master's level in the natural sciences, engineering or the social sciences.
- (2) Considerable practical working experience in a government or international agency dealing with scientific and technological activities, preferably with national science policy-making or research management.
- (3) Good knowledge of the problems facing developing countries in the application of science and technology to development.
- (4) Excellent knowledge of the French or of the English language with a high degree of drafting ability in it. A working knowledge of the other language is desirable.

3. Title.—MAINTENANCE ENGINEER (OPI-257).

Category and level.—Professional category (P-3).

Organizational location.—Technical Unit, Audio-Visual Production Section, Press and Audio-Visual Information Division.

Duties and responsibilities.—Under the supervision of the chief of the technical unit, the maintenance engineer is responsible for:

- (1) The maintenance, adjustment and repair of the technical unit's apparatus and equipment, including video equipment, so as to keep them in good working order in conformity with the makers' specifications and prevailing international standards for professional radio and television broadcasting.
- (2) Proposing new equipment for purchase, examining, proposing and, where appropriate, installing new apparatus and modifying existing apparatus with a view to the modernization or improvement of production methods.
- (3) Keeping abreast of technical developments in his own field and in that of production.
- (4) Performing any other tasks in his field of competence that may be required.

Qualifications and experience required:

- (1) University degree or the equivalent in electronics.
- (2) At least five years' experience of maintenance work in a studio or a professional radio, film or television production organization.
 - (3) A knowledge of video equipment maintenance.
- (4) Experience in radio production techniques and in the techniques of film production for television.
- (5) A very good knowledge of French or English and a good knowledge of the other language.
 - (6) Initiative and ability to work as part of technical team.

Salary and allowances.—Initial appointment will be at P-3 grade with a net salary equivalent to US\$23,104 (\$21,600 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances, e.g. post adjustments, at present \$11,420, for staff members with dependants, \$10,651 for staff members without dependants, family allowances of \$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). These emoluments are normally exempt from all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with staff regulations and rules.

4. Title.—CHIEF of publications unit (CLT-029).

Category and level.—Professional category (P-5).

Organizational location.—Office of the assistant directorgeneral for culture and the assistant director-general for communication,

Duties and responsibilities.—Under the authority of both the assistant director-general for culture and the assistant director-general for communication, the incumbent will co-ordinate and supervise the activities of the two sectors in the field of publications. He will be responsible, in particular, for:

(1) Co-ordinating and correlating the divisions' proposals for publications in the programme and budget and establishing the draft publications plan of the two sectors.

- (2) Establishing each year, in co-operation with the divisions of the sectors, P.U.B. and C.O.L., the publication annexes for the P.A.D.s, with due regard to the activities provided for in the programme, staff resources and available budgetary resources in the sectors, as well as quotas allocated by P.U.B. and C.O.I.
- (3) Advising programme specialists on the content and form of publications under their responsibility.
- (4) Monitoring the implementation of the publication plan of the sectors, following each manuscript through the successive stages of preparation and taking care that deadlines are met.
- (5) Assuring the quality of manuscripts in terms of the subject of the work and the public for which it is intended.
- (6) Undertaking or making contractural arrangements for the final editing of all the manuscripts of the non-periodic publications of the sectors.
- (7) Seeing that copyright arrangements are respected, as regards both publisher and author.
- (8) Transmitting manuscripts in final form, together with a reader's report prepared by the responsible division, to P.U.B; assuring that the administrative procedures relating to publications have been followed, and that the necessary funds are available.
- (9) Maintaining constant liaison with P.U.B. and C.O.L. Representing the sectors at meetings of the consultative committee on publications and providing the committee with such information as will enable it to appraise the implementation of the publications plan.

Qualifications and experience required:

- (1) University degree related to the fields of culture or communication, or equivalent.
- (2) Thorough experience of publishing problems, acquired either in an international organization or in publishing house.
- (3) Administrative experience acquired in a post entailing high-level responsibilities.
- (4) Perfect knowledge of English or French; qualities of style precision in that language; very good knowledge of the other language; good knowledge of Spanish or other languages desirable.

THE Domestic and Hotel Workers' Union shall hereinafter be referred to as the claimants and Kagumo High School shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 18th November, 1982, and 8th March, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants,-J. T. Hiuhu.

Respondents.-F. Mwangi

AWARD

3. The Notification of Dispute Form "A" dated 25th November, 1981, duly signed by the parties as received by the court on 22nd July, 1982, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The four persons involved in this dispute used to work for the respondents as watchmen—two from 1975 and two from 1977—and were dismissed on 3rd January, 1979, on grounds of insubordination.

The claimants took up the matter on their behalf and the matter was first discussed at the provincial education officer's level under the chairmanship of L. Kago at which meeting the decision was that the action taken by the headmaster was justifiable as these four watchmen had refused to use the watchman's clock.

The Ministry of Labour's finding was that the watchmen's attitude had been tantamount to disobeying a lawful order but in view of the fact that they had previous clean records it was recommended that the dismissal be reduced to normal termination and they be paid all their terminal dues.

The respondents accepted the ministry's recommendation and prepared the following cheques:

The claimants however decided to bring the dispute to the Industrial Court.

Affter having heard the parties' submissions and the evidence called by them, the court finds that the claimants have really no case as it is quite clear that these watchmen were determined not to use the clock that had been provided in order to monitor their movements when on duty. The court has got to take very seriously the fact that at one stage deliberate attempt seems to have been made to wreck the clock which the experts found was due to someone having urfinated in it which had rendered many of its parts unworkable. All these parts had to be replaced and it had cost the respondents KSh. 513.15. The court finds this to be a wilful act of damage to a very valuable and expensive instrument which was Isgus 49 watchman's clock.

After the clock was repaired the watchmen were asked to start using it towards the end of 1978 and were warned by the head-master not to repeat any such action as disciplinary action would be taken against them.

On 2nd January, 1979, the bursar reported to the headmaster stating that the watchmen did not like the use of the clock because of the following reasons:

- "1. When the clock was absent they did as much as they ought to have done.
- 2. They have been sleeping most of time during their hours of work and we did not have the means of checking them.
- 3. As the habit has grown to the extent that to use the clock it means to wake up. This alone can make them declare war against anyone who suggests that they use the clock."

The court finds that the warning letters were issued to these four watchmen and their final act of insubordination in refusing to use the watchmen's clock left the respondents with no alternative but to sack them.

The court was impressed by the evidence given during the hearing by the headmaster F. Mwangi and accepts his evidence to be true as against the evidence of one of the watchmen, J. T. Hiuhu.

The court accordingly rejects the claimant's demand of either reinstating them or paying them heavy compensation.

THE INDUSTRIAL COURT CAUSE No. 81 of 1982

Parties:

Kenya Union of Commercial Food and Allied Workers

and

Kenya Cashewnuts Limited

Issue in dispute:

Underpayment of minimum wages.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Kenya Cashewnuts Utd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 9th and 28th February, 1983, and relied on their written and verbal submissions.

AWARD

3. Notification of Dispute Form "A" dated 16th February, 1982, duly signed by the parties was received by the court on 17th August together with the statutory certificate signed by the Labour Commissioner.

In this dispute the claimants maintain that quite a number of their members have been underpaid by the respondents since 1978. In this year the parties entered into a two-year collective agreement effective from 1st August, 1978. Clause 21 headed wages schedule reads:

"21. Wages schedule: Increases agreed upon are as follows: KSh. 1,000 and below, 1st year 18 per cent and 2nd year 14 per cent. Above KSh. 1,000 p.m. 1st year 12 per cent and 2nd year 8 per cent. The percentage increase to be on individual salary."

The court finds that there is no doubt that the minimum scale for each grade was revised as stated above and the new entrants were entitled to be paid the aforesaid new minimums depending on when they joined the respondents.

The parties then entered into another two-year agreement which read as follows with effect from 1st August, 1980, for one year:

"23. Wages schedule: increase agreed upon as follows: Workers earning up to KSh. 1,000 p.m. be awarded 15 per cent increase and those earning above KSh. 1,000 be awarded 9 per cent increase.

This increase to remain in force for one year or until urban council status for Kilifi is gazetted and the minimum salary scale applicable determined whichever is the earlier."

Then with effect from 1st July, 1981, the parties entered into an agreement which read as follows:

"23. Wages schedule: The annual increase to become effective from 1st July, 1981, was agreed upon as follows: That workers earning up to KISh. 1,000 p.m. be awarded 20 per cent increase and those earning above KSh. 1,000 be awarded 15 per cent."

The claimants' contention is that the agreement effective from 1st August, 1980, also increased the basic minimum scales by the percentage increase agreed and that further with effect from 1st July, 1981, the basic minimum scales were again increased by the percentage increases that were agreed between the parties although the minimum scales are not specifically mentioned in these collective agreements. This would result in the minimum scale from 1st August, 1980, and 1981, to be as follows:

The respondents submitted that they had interpreted the 1978 collective agreement to mean that the new entrants who joined

after 31st July, 1978, would get the rates specified under the heading "current year" and they had granted the wage increases agreed to those employees who were already in employment as at 31st July, 1978.

As far as the 1980 agreement is concerned the respondents maintained that the new employees who joined them after 31st July, 1980, were to get and did get the basic minimum wages as indicated under the current year of the 1978 agreement. Other employees got the wage increases as agreed.

The respondents pleaded with the court that if the claimants' submission was accepted this would eliminate wage differential, between the employees who were in employment prior to 1st August, 1978, and those who were employed after 31st July, 1980. This would affect about 1,900 employees and would create a very serious financial problem for them which they will never be able to manage particularly at this time when they do not have enough cashewnuts to process. They asked the court to reject the claimants' demand and requested that the court should direct the parties that for future they should divide their wage clause into two sections—minimum wages for new employees and wage increases for existing employees and to fix minimum wages for the entire period of the agreement for each year of the agreement.

The court notes that if the claimants' demand was upheld in its entirety then the respondents would have to provide KSh. 2,003,460.

This dispute involves about 717 workers.

The court notes that the annual financial position of the respondents indicating profit/loss retained from 1978 to 1982 before taxation was:

The court has already made its finding on the 1978 collective agreement to the effect that the basic minimum wages were revised as clearly stated in that agreement. After carefully considering the matter further the court finds in view of the fact that in the collective agreement effective from 1st August, 1980, the parties had clearly provided as follows:

"This increase to remain in force for one year or until urban council status for Kilifi is gazetted and the minimum salary scale applicable determined whichever is earlier."

The minimum scales were amended by the percentage increases agreed by the parties with effect from 1st August, 1980, for one year.

The court, however, cannot accept the claimants' submission for the collective agreement effective from 1st August, 1981, that the percentage increase again revised the minimum salary scales because this time the words are very clear as follows:

"Workers earning up to KSh. 1,000 p.m. be awarded 20 per cent increase and those earning above KSh. 1,000 be awarded 15 per cent increase."

The court finds that this time the percentage increase did not revise the minimum scales and they continued as revised with effect from August, 1980.

In view of the court's ruling that the minimum scales were revised in 1978 for two years and then again for one year with effect from 1st August, 1980, but not thereafter the court directs the parties to get together and work out the underpayments due to those employees who had joined the respondents during the material time. The court appreciates that in view of the arrears dating back to 1978 and the large number of workers involved who have suffered underpayments the financial strain on the respondents will be quite heavy. The court accordingly directs that the respondents should pay these arrears to the workers affected in four six-monthly equal instalments. The court further directs that in case the parties are not able to agree on the underpayments of the workers concerned then they should meet under the chairmanship of the Provincial Labour Officer, Coast Province, to do so in accordance with the terms of the court award.
