Issue in dispute:

Dismissal of George Nyadida.

THE Domestic and Hotel Workers' Union shall hereinafter be referred to as the claimants and University of Nairobi shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 15th March, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 28th December, 1981, duly signed by the parties was received by the court on 19th November, 1982, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Nyadida was employed by the respondents as a trainee technician in the Department of Human Pathology on 2nd January, 1976, after he had applied for the post as a result of the respondents advertisement on 3rd October, 1975. He was then sponsored for residential training at the Medical Training Centre, Faculty of Medical Laboratory Technology, Haematology Department.

On 19th September, 1978, he was dismissed from the medical training centre by the principal due to a serious breach of discipline. Efforts were then made to get him back into the course at the medical training centre with no success. This compelled the chairman of the Department of Human Pathology and Microbiology, Prof. Kungu, to recommend that since Mr. Nyadida could not continue with his training as he was employed as a trainee technician and he was not qualified for any of the other existing vacancies, his services must be terminated. On 25th May, 1979, he was informed by the deputy registrar that he had ceased to be an employee of the respondents with immediate effect and was told that he would be paid one month's salary in lieu of notice.

The claimants reported a trade dispute to the Minister for Labour and investigation was carried out and the ministry's findings and recommendation as conveyed to the parties on 18th October, 1981, were that Mr. Nyadida not only misbehaved at work but was also guilty of concealing important information which was that he had been dismissed from the medical training centre due to serious breach of discipline. The ministry rejected the claimants' argument that his training had nothing to do with the work at the university and recommended that the dismissal be reduced to normal termination and he should be paid his terminal benefits. The claimants rejected the findings and recommendation and have brought the dispute to the Industrial Court.

Their main argument is that after Mr. Nyadida had been dismissed from the medical training centre the respondents had continued to employ him from September 1978 to May 1979. They argued that he had not been issued with any warning by the respondents who had also not followed the clause on termination in the collective agreement. They reiterated that his dismissal from the medical training centre had nothing to do with the respondents since he was their employee and not of the centre. The claimants produced a diploma in medical technology dated 31st December, 1980, which Mr. Nyadida had since obtained from the centre.

The claimants have demanded twelve (12) months' salary by way of compensation to be paid to him for the wrongful dismissal that he had suffered.

The court has carefully considered the arguments put forward by the claimants and it appears that this whole action is misconceived by them. The crucial point in Mr. Nyadida's appointment was that he was a trainee technician for which the respondents sponsored him at the medical training centre and had spent KSh. 40,000 on his training alone and another KSh. 30,000 to cover all other benefits extended to him. It is quite clear that due to his misbehaviour the respondents suffered this loss and as there was no appropriate post for him in the university the respondents were perfectly justified in formally terminating his employment. He had been sponsored there to improve his skills and his contract was very much alive while he was there. In those circumstances the court cannot find the respondents to be at fault in this dispute.

The court notes that Mr. Nyadida is now a tutor at the Kisumu Medical Training Centre since June 1980.

The respondents confirmed that they had paid him one month's salary in lieu of notice, ten (10) days' leave entitlement for the period 1st January, to 25th May, 1979, and non-accountable travelling allowance on termination of appointment as provided for in section 10 (b) (i) of his terms of service.

The court rejects the claimants' demand made on his behalf for twelve (12) months' compensation as he did not suffer a wrongful dismissal. The court must add that this dispute was a mere speculative claim without any merit in it at all.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Kenya Co-operative Creameries Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 29th March, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 18th October, 1982, duly signed by the parties was received by the court on 8th December, 1982, together with the statutory certificate signed by the Labour Commissioner.

The parties have had collective agreements covering the respondents' unionizable employees since 1963 or thereabout when the first recognition agreement between them was entered into. The collective agreement which is being revised and has given rise to this dispute was signed on 8th January, 1981, but was effective from 1st January, 1980, for a period of two years from that date.

The parties have not been able to resolve the issue in dispute despite their own attempts and that of the Ministry of Labour conciliator.

It is a well known fact that the respondents play a major role in Kenya's dairy industry. The government also takes very keen interest in its activities and the court was told that the government has guaranteed most of the loans that have kept them in operation in the interest of the dairy industry in Kenya.

The respondents' permanent labour force position in the last six years is as follows:

The court notes that the respondents have over the years expanded and created new jobs but the claimants were quick to point out that although the respondents enjoyed a monopoly in Kenya, this expansion rate was not big enough considering all the circumstances.

Since this dispute concerns items which have a direct bearing on the respondents' finances, their financial position, therefore, needs very close examination. The respondents pleaded that

their financial problems date back to 1977 when they had to borrow heavily to finance their operations and since then they had operated on a deficit basis with 1982 deficit being K£ 1,656,367. The court, however, notes that the deficit over the years has declined but it will still take a few years before the respondents start making any profit. As at 30th June, 1982, they are operating on an overdraft which during the year ending 30th June, 1982, amounted to KSh. 20,000,000.

The claimants argued that the provision of depreciation in the respondents' accounts was unduly high and unless they satisfied the court on the investments they had made in the replacement of the various assets, they were positive that funds would be available for meeting their demands. The court would now like to deal with the specific items in dispute.

Leave travelling allowance.—At present the following leave travelling allowance is paid:

Grades	KSh.
1 to 4	130
5 to 8	150
9 to 12	180

The respondents have offered an increase of KSh. 40 on all the above grades and the claimants have demanded an increase of KSh. 120 for grades 1 to 4, KSh. 250 for 5 to 8 and KSh. 420 for 9 to 12. In support of their demand, the claimants cited the leave travelling allowance being paid by firms like Gailey & Roberts Ltd., Mackenzie (K) Ltd., Kodak Ltd. and E. A. Underwriters Ltd.

From the D.M.P.D. report it appears that the claimants are demanding a leave travelling allowance of KSh. 425,600 or 14.2 per cent per month over and above the respondents' offer of an average of KSh. 193.

The court finds that the claimants' demand is rather on the high side but the fact remains that the travel costs have indeed increased over the last few years.

The court awards an increase of KSh. 60 to all the existing rates.

House allowance.—The parties have all along had a deconsolidated wage structure with the current provisions being:

Grades	KSh.
1 to 4	150
5 to 8	175
9 to 12	230

The claimants' demand is KSh. 300 for grades 1 to 4, KSh. 400 for 5 to 8 and KSh. 500 for 9 to 12. They have argued that in order to be equitable the respondents should spend the same money by way of housing which they spend on their employees who are housed for those employees who are not housed by them. They maintained that at present the respondents were spending KSh. 600 per month per employee whom they housed. Considering this they maintained that their demand was not unreasonable.

The respondents have offered an increase of 2.7 per cent over the existing rates which would amount to an overhead labour cost of KSh. 79,800.

The court has very carefully considered this item and awards the following new house allowance:

Grades	KSh.
1 to 4	210
5 to 8	245
9 to 12	325

Salary/wage increases.—Under the guidelines, the respondents' employees would be entitled to a wage increase of 29 per cent for the two-year period or 14.5 per cent for the first year and a similar increase for the second year. The respondents have offered a 12 per cent increase each year for grades 1 to 4, 9½ per cent each year for grades 5 to 8 and 8 per cent each year for grades 9 to 12. The claimants' demand for the aforesaid groupings is 22 per cent, 20 per cent and 18 per cent each year. The court can see no reason why the respondents should not be able to give their workers their due entitlement under the guidelines. The court accordingly awards the following salary/wage increases:

Grades	Per cent	Per cent
1 to 4	15 for first year	15 for second year
5 to 8	13 for first year	13 for second year
9 to 12	12 for first year	12 for second year

Overtime payment for tanker drivers:

Under this item the claimants have demanded that the present system whereby the drivers are paid KSh. 55 per day should be discontinued and they should be entitled to normal overtime like other employees for all the extra hours that they work.

The respondents pointed out that under the present system these drivers were earning more than their monthly salaries because they were paid KSh. 55 per day when they were travelling and in addition they received safari allowance of KSh. 100 per day.

The court has carefully considered this item and rules that the present system should continue and awards an increase of KSh. 5 per day taking the existing figure to KSh. 60 and another KSh. 5 increase for the second year taking it to KSh. 65 per day.

Overtime payment.—On this item the respondents are seeking a provision to be added to the current clause which would give them the option of granting another day off in lieu of a public holiday work instead of payment of overtime at double the rate. The claimants have very strongly opposed this demand and the court has not been persuaded by the respondents to make any change in the existing arrangement. It is up to the respondents through efficient management to reduce the amount of overtime work involved in their operations. The court accordingly rejects the respondents' demand.

Casual payment.—It appears there is a provision under the heading of temporary employees which reads:

"(a) When circumstances deem it necessary temporary labour may be employed on specific tasks, ranging up to a period of 3 months.

(b) If a job for which an employee has been engaged temporarily becomes permanent then the employee shall be engaged on permanent terms."

The claimants' demand is that the respondents are using casual workers at inferior wage rates on permanent posts. This defeated the purpose of negotiating wage rates for this industry.

The respondents have argued that it is clearly stated in the recognition agreement that the claimants represent only the permanent staff. So, for the claimants to make representations on behalf of the casual workers, they would first have to seek an amendment to recognition agreement.

In view of the existing clause covering temporary employees and the provision of the recognition agreement, the court has decided to reject the claimants' demand under this item.

Retirement benefits:

Under this item the claimants are demanding a gratuity of 30 days for each year of service for the respondents' employees as they submitted that National Social Security Fund was not enough for a retired employee to maintain the lifestyle he was used to during the time he was employed. They also referred to various other companies which had introduced additional retirement benefits for their workers.

The respondents stated that they operate a contributory K.C.C. staff pension life assurance scheme whose objective is the provision of pension for its members on retirement. Any employee who is earning above KSh. 800 will be eligible to become a member and they pointed out that as from 1st January this year all the employees will be eligible to join.

In view of the fact that the workers will now be able to join the pension scheme being operated by the respondents the court rejects this demand.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.
