CAUSE NO. 9 OF 1983

Parties:

Tailors and Textiles Workers' Union
and
Knitting Technics

Issues in dispute:

- Warning system,
- Annual leave,
- House allowance, and
- Effective date of agreement.

THE Tailors and Textiles Workers' Union shall hereinafter be referred to as the claimants and Knitting Technics shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 27th April, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 23rd June, 1982, duly signed by the parties was received by the court on 31st January, 1983, together with the statutory certificate signed by the Labour Commissioner.

The parties' previous collective agreement expired at the end of January 1982, and the claimants had submitted their proposals for revising it on 4th January, 1982. The claimants had sought changes on ten items. The parties did not commence negotiations until 3rd April, 1982, but when they did meet, they were able to resolve four items and the claimants reported a trade dispute to the Minister for Labour on the remaining items. During conciliation, the parties agreed on leave travelling allowance and wages. Leave travelling allowance was agreed at KSh. 150 to be paid when an employee proceeded on leave and the following wage increases were agreed:

- (a) 12½ per cent increase on present minimum and general increase for the first year.
- (b) 10 per cent wage increase on both the minimum and general wage increase for the second year.

At a conciliation meeting held on 22nd June, 1982, the parties recorded a deadlock on the four issues which are now before the court.

Annual leave

The claimants' demand is 30 working days' annual leave because in the previous three negotiated collective agreements, except the one of 1980, the respondents had not improved on the statutory rate. In 1980, they agreed to add one more day on the statutory minimum of 21 working days' annual leave.

The respondents maintained that 22 working days excluding any statutory public holidays was more than adequate and argued that if annual leave kept on increasing with every collective agreement, then it would lead to economically unfavour-

able situation and maintained that items like annual leave should remain standard, otherwise workers will end up having more days on leave than at work. They stated that at present the workers were off-duty because of leave, public holidays and rest days for 84 days a year!

The court awards that the workers should get 24 working days' annual leave per year which appears to be the prevalent rate in this industry.

Warning system.—The dispute here is on the revising of part (d) of the existing clause. The respondents want this part to read as follows:

"If an employee refuses to accept the warning the shopsteward or any union member or the branch secretary shall be called to witness and if he/she refuses to accept, then he/she shall be liable for immediate termination of his/her employment."

They argued that at times the shopsteward is not available and under such circumstances they must have some arrangement for issuing warning letters.

The claimants opposed this demand maintaining that there had not been any serious problems for over seven years arising from it.

The court awards that the existing warning clause should remain as it is except that after the word "shopsteward" words "or the branch secretary" should be added.

House allowance:

The claimants have demanded a house allowance of KSh. 250 per employee per month in addition to the agreement on wages that has already been reached.

The respondents have vigorously argued that they gave general wage increase as quoted hereinabove on consolidated wages, and argued that the claimants had never come up with a proposal to deconsolidate wages.

The Division of Manpower Planning and Development report states that the conciliator, Mr. Kimai of Nakuru Labour Office confirmed to them that during conciliation meetings, general wage increase and house allowance were discussed as separate items. The D.M.P.D. was also given to understand that during the conciliation meetings the respondents had agreed to a house allowance of KSh. 125 per month, but the claimants had insisted on KSh. 150.

The court is satisfied that the issue in dispute is the claimants' demand for a house allowance in addition to the existing consolidated wages. It was up to the respondents to have taken such steps if indeed that was the position to safeguard their interest in not having to pay what they now call a double benefit. They could easily have got agreed on any wage increase.

The court has carefully considered this item and notes that the workers have been undercompensated by 4 per cent for a two-year period on the agreed wage increases. Considering this fact and the existing level of wages being paid by the respondents, the court has decided to award a house allowance of KSh. 125 per month in addition to the wages already agreed with effect from 1st February, 1983.

Effective date

The claimants' demand is that the effective date should be 1st February, 1982, to tie up with the previous collective agreements. The respondents, however, maintain that it should be, with effect from 3rd June, 1982. The claimants stated that they had not delayed the negotiations and blamed the respondents for it.

The court can see no reason notwithstanding the wording of the clause in the previous collective agreement on this issue to deprive the workers of four months' wage increases in these days of high inflation. The court accordingly awards that the effective date except for house allowances, should be 1st February, 1982. The parties have already agreed on the duration period of two years.
