Issue in dispute:

Pay in lieu of notice to Nelson Muasya.

THE Kenya Union of Domestic, Hotel, Educational Institutions, Hospital and Allied Workers shall hereinafter be referred

to as the claimants and Safari Park Hotel shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 19th May, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 21st October, 1982, duly signed by the parties was received by the court on 31st January, 1983, together with the statutory certificate signed by the Labour Commissioner.

Mr. Muasya worked for the respondents for nearly eleven years from 29th November, 1969 to 3rd December, 1980, when his services were terminated summarily. At that time he was holding the post of head receptionist, earning a monthly salary of KSh. 1,893.

It appears that he also performed the duty of night duty manager for which the respondents paid him a lump sum by way of overtime instead of promoting him to that substantive post.

The claimants took up the matter on his behalf and after trying to settle it with the respondents without success, reported a trade dispute to the Minister for Labour. The ministry carried out an investigation and its finding was that there were no valid warnings against Mr. Muasya at the time of his dismissal as all the previous warnings had expired in terms of the collective agreement. The ministry also came to the conclusion that even assuming that he was guilty of alleged offence of drinking and dancing at the restaurant, considering his eleven years of service, a summary dismissal was not warranted, hence the summary dismissal was harsh and recommended that it should be reduced to normal termination and he be given salary in lieu of notice in accordance with the parties' collective agreement.

The dispute before the court is the claimants' demand that the respondents should pay Mr. Muasya a sum of KSh. 5,679 being three months' salary in lieu of notice.

From the parties' submissions, the court finds that the respondents' general manager repeatedly issued memos and notices warning their employees against consuming alcoholic drinks in the main bar, slot machine bar and swimming pool area. In fact in one memo particularly to all the staff it was clearly stated that under no circumstances any alcoholic drinks will be served to Mr. Muasya whether he was on duty or not.

The court is satisfied that Mr. Muasya's whole attitude to his work was deteriorating because of his drinking habits but unfortunately for the respondents they did not follow very rigidly the warning system in the collective agreement and instead kept on issuing several notices on the subject matter of staff drinking. The last such notice was on 8th September, 1980, in which it is clearly stated that "from now on, any staff found drinking whether on duty or off duty shall be issued with written warning and that anyone serving the other staff with any alcoholic drinks will also receive a written warning". In view of this, the court concurs with the Ministry of Labour's finding that although Mr. Muasya deserved a termination, summary dismissal was indeed too harsh keeping in view his peleven years' service, the responsible position he held and also the lack of valid warnings against him at the material time. The court accordingly awards that the respondents should pay Mr. Muasya three months' salary in lieu of notice.

In conclusion the court would like to stress upon the employers that when they obtained certificates of discharge of all their liability from their employees, it would be very much in their own interest whether a dispute is pending in the Ministry of Labour to clearly explain to the employee concerned and also state that fact in the certificate of discharge that the discharge is in respect of that dispute also before asking an employee to sign it in the presence of a witness, It is happening quite often that employees sign for certain cash payments in full and final settlement of their claims under the impression that the dispute which is pending before the Ministry of Labour is a separate matter and that the discharge is not in respect of that claim. To be fair to the employees and to the employers, this additional precaution must be taken.
