**1. Title.—DEPUTY ASSISTANT DIRECTOR-GENERAL**  
(operational activities).

**Post No.—ED-568.**

**Category and level.—Director level (D-2).**

**Organizational location.—Education sector.**

**Duties and responsibilities.—**Under the authority of the assistant director-general for education and in collaboration with the deputy assistant director-general responsible for the co-ordination of programme activities, the holder of the post will be jointly responsible for the planning and evaluation of Unesco's education programme and will, in particular—

(1) be responsible for the planning, execution and evaluation of the operational programme assigned to the sector;

(2) supervise and provide overall direction for the sector's operational activities, ensuring that education projects entrusted to Unesco but financed by extra-budgetary resources, especially as part of country programming, are satisfactorily planned and implemented and receive appropriate administrative and specialist support;

(3) ensure, in consultation with the deputy assistant director-general for programme activities, that regular programme activities and operational projects are consistent, complementary and provide support to each other;

(4) represent the sector on the intersectoral co-ordinating committee for operational activities (CCO), which is chaired by the assistant director-general for co-operation for development and external relations and is responsible for examining periodically the way the operational programmes are being carried out and the state of each project;

(5) personally attend, or arrange for the sector to be represented at, intersectoral and interagency meetings and meetings with national authorities to deal with the programming, execution and evaluation of the operational programme;

(6) contribute to the sector's general activities in connection with the organization's medium-term plans and draft programmes and budgets;

(7) perform such other duties as may be assigned to him by the assistant director-general for education.

**Qualifications and experience required:**

(1) A good postgraduate degree or advanced academic studies and thorough knowledge of education problems, especially in developing countries.

(2) Experience in a senior post in government department concerned with education in a developing country.

(3) Experience of the management of international co-operation programmes at a high level of administrative responsibility.

(4) Excellent knowledge of English and French; a knowledge of the organization's other working languages would be desirable.

**Salary and allowances.—**Initial appointment will be at D-2 grade with a salary equivalent to US\$42,172 per annum (US\$38,627 for staff members without dependants) payable mainly in French francs, plus the following annual allowances: Post adjustment (which varies according to the cost of living and is at present US\$19,446 for staff members with dependants and US\$17,830 for staff members without dependants, family allowances of US\$700 for each dependent child (payable only in respect of the second child and subsequent children for staff members without a dependent spouse). These emoluments are normally exempt from all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with the staff regulations and rules.

**2. Title.—PROGRAMME SPECIALIST.**

**Post No.—SC-242.**

**Category and level.—Professional category (P-5).**

**Organizational location.—**Division of water sciences, science sector.

**Duties and responsibilities.—**Under the general supervision of the director of the division of water sciences, the incumbent will be responsible for planning and co-ordinating the execution

of specific sections of the International Hydrological Programme (IHP) and will participate in the implementation of other aspects of Unesco's programme relating to water resources. More particularly, he will be responsible for the following tasks—

(1) to contribute to the preparation of the meetings of the intergovernmental council of the IHP and its bureau and follow up the execution of activities decided by these bodies;

(2) to assist and co-ordinate the activities of working groups and rapporteurs established by the intergovernmental council of the IHP;

(3) to assist in the planning of future phases of the IHP;

(4) to prepare and organize symposia, workshops, seminars and other international conferences in the field of water resources;

(5) to prepare, supervise and evaluate, from the scientific viewpoint, activities undertaken to assist member states in the field of water sciences;

(6) to direct, supervise and evaluate, from the scientific point of view, the activities of certain regional offices for science and technology in the field of water resources;

(7) to establish and maintain contacts with organizations of the United Nations system and other competent international organizations as well as other divisions of Unesco, the activities of which are related to water resources;

(8) to plan, develop, carry out and evaluate studies and pilot projects concerning Unesco's programme in the field of water resources;

(9) to ensure the preparation of Unesco publications coming within his competence;

(10) to perform any other duties that may be assigned to him.

**Qualifications and experience required:**

(a) University degree in a recognized branch of engineering sciences or earth sciences, with a specialization in water resources.

(b) Several years of practical scientific experience and/or teaching experience at university or postgraduate level in the field of water resources.

(c) Sound knowledge of modern methods in hydrology (stochastic hydrology, use of mathematical models, application of remote sensing, etc.).

(d) Good experience in the administration of scientific programmes and international scientific co-operation; in particular, knowledge of the problems of developing countries.

(e) Excellent knowledge of English or French and good working knowledge of the other language; knowledge of another official language is an asset.

**Salary and allowances.—**Initial appointment will be at P-5 grade with a net salary equivalent to US\$33,318 (US\$30,776 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances; e.g. post adjustments, at present US\$16,228, for staff members with dependants, US\$14,994 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). These emoluments are normally exempt from all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with staff regulations and rules.

**3. Title.—ADMINISTRATIVE OFFICER.**

**Post No.—SC-216.**

**Category and level.—Professional category (P-3).**

**Organizational location.—**Administrative unit science sector.

**Duties and responsibilities.—**Under the authority of the chief of unit and the supervision of the administrative officer responsible for UNDP projects, the incumbent will perform administrative duties concerned with the preparation and implementation of the sector's activities, including those financed by UNDP and other extra-budgetary sources. In particular, he will:

(1) Take all necessary administrative, financial and budgetary measures, in co-operation with the relevant departments and offices at headquarters and with UNDP and Unesco personnel in the field, to ensure that the projects are prepared and carried out in conformity with current administrative policies and procedures and with the rules and methods of financial management.

(2) Collaborate with staff members in charge of activities and advise them on all the administrative aspects of the

preparation and execution of their tasks, which include compiling project descriptions and revising and adjusting such documents.

(3) Participate in the monitoring of operations from an administrative and budgetary point of view, on the basis of project descriptions, in order to help ensure regularity and efficiency in project implementation.

(4) Assist in drawing up and negotiating subcontracts with United Nations agencies and other appropriate public or private bodies for the execution of projects, and supervise the fulfilment of such contracts from an accounting and budgetary point of view.

(5) Administer consultant contracts, fee contracts and others; check and certify obligations incurred and travel orders, and request the corresponding payments.

(6) Ensure that the dates and financial aspects of appointments of staff away from headquarters are consistent with project descriptions and UNDP instructions and procedures.

(7) Assist in preparing the programme and budget documents and any other documents required for the science sector at headquarters and for the regional offices.

(8) Replace the administrative officer responsible for UNDP projects and other extra-budgetary projects during his absence.

(9) Carry out any other related duties that may be entrusted to him.

*Qualifications and experience required:*

- (a) University degree or equivalent, with sound experience of administrative and accounting work.
- (b) Experience in a post with administrative responsibility in an international organization.
- (c) Excellent knowledge of either English or French, and reliable knowledge of the other language; ability to draft in both languages.

*Duties and responsibilities.*—Under the general guidance of the director of the co-ordination of funding sources division and the supervision of the chief of funds-in-trust section, the incumbent will be required to:

(1) Advise on the policies, procedures and methods which Unesco should adopt for its trust fund programme and participate in the co-ordination of relations with donors.

(3) Be responsible, in consultation with the substantive sectors of the organization and the recipient governments, for—

- (a) identifying and preparing proposals for new trust-fund projects for financing by donors;
- (b) preparing and negotiating plans of operation and agreements with donors and recipient countries;
- (c) co-ordinating and supervising the operation of trust-fund projects;
- (d) evaluating and ensuring appropriate follow-up of existing projects, in order to ensure their impact and success;
- (e) maintaining close contact with other sources or financing within the secretariat.

(4) Carry out any other duties of equivalent level which may be assigned by the director of the division or the chief of the section.

*Qualifications and experience required:*

- (a) University degree or equivalent qualifications.
- (b) Good knowledge of international organizations, particularly Unesco, and experience in bilateral or multilateral aid programmes.
- (c) Experience in the administration of operational projects.
- (d) Good knowledge of the political climate and conditions both in donor and in recipient countries.
- (e) Good knowledge in English and French and ability to draft in both these languages.
