THE INDUSTRIAL COURT

CAUSE No. 11 OF 1983

Parties:

Railways and Harbours Union (Kenya)
 and

Kenya Ports Authority

Issue in dispute:

Unjustifiable action by the management of Kenya Ports Authority to cause the supersession of F. Nanzaba by a junior member of staff contrary to the established principles under the staff administrative rules.

THE Railways and Harbours Union (Kenya) shall herein-after be referred to as the claimants and Kenya Ports Authority shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th and 27th May, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 28th October, 1982, duly signed by the parties was received by the court on 31st January, 1983, together with the statutory certificate signed by the Labour Commissioner.

Mr. Nanzaba who is still working for the respondents is asking through the claimants for an order from the court to promote and appoint him to a higher grade as he maintains that another employee junior to him in his department was allowed by the respondents to supersede him.

He is working in the industrial relations section and holds the substantive grade PA 7. It is not disputed that when the holder of the post of senior clerical assistant PA 6 was interdicted for disciplinary reasons, Mr. Nanzaba was asked to act in that grade. He acted in this position for several months and when the substantive holder of PA 6 was eventually demoted to clerical grade PA 7 his post in grade PA 6 became vacant with effect from 4th May, 1979.

The position at that time was that Mr. Nanzaba was acting as senior clerical assistant grade PA 6, with effect from 1st December, 1978, and that post became vacant, with effect from 4th May, 1979. It is not disputed that the personnel officer (IR) and the senior personnel officer (IR) strongly recommended that Mr. Nanzaba should be confirmed in the post in which he was acting as they stated that he had proved himself capable of carrying out the duties of the post. The overall head of the department, however, after making inquiries regarding Mr. Nanzaba's seniority and being told that he was sixth in seniority in personnel department, decided that the post should be advertised.

The court would now like to examine staff regulation No. 7 of 1976, which is directly relevant to this dispute in which an elaborate procedure for employment and promotions has been laid down. Paragraph 1 (a) clearly spells out that appointments shall be made on merit, ability, experience, length of service, seniority, professional qualifications and satisfactory personal conduct including suitability and where an officer in a particular branch fulfils these requirements he shall be eligible for consideration for direct appointment without recourse to advertisement. The claimants have stressed this particular paragraph and have pointed out that in terms of it, Mr. Nanzaba should have been appointed directly without recourse to advertisement because having acted satisfactorily in that post he had met all the other requirements. They pointed out that before a person is appointed to act in a senior post he has to satisfy all the laid down criteria like merit, ability, experience, professional qualifications, etc. The present holder of PA 6 who superseded Mr. Nanzaba was junior to him in that department and he was not appointed to act in grade PA 6.

The claimants' argument would indeed be very forceful but for the provisions of paragraphs 1 (b) and (d) of the aforesaid circular which clearly state that where it is felt that there are a number of suitable candidates in the same branch and in other branches with comparable background, the post in question shall be advertised internally for open competition. In paragraph 1 (d) it is stressed that notwithstanding the other subparagraphs of paragraph 1, endeavour shall be made to advertise as many posts as possible to encourage competition without, however, in any way derogating management from its freedom to make recommendations for direct appointments or promotions in cases where it is felt necessary in the interests of the service to do so. Such recommendations, however, shall not lead to undue supersession.

It boils down to that if the management decides not to advertise the post and make recommendation for direct appointment then it should not lead to undue supersession. So if the present holder in Mr. Nanzaba's department had been appointed without management having advertised, the position then Mr. Nanzaba would have a strong case of undue supersession.

The facts, however, are that the management decided to advertise the post and ten employees applied for it. A panel consisting of finance manager, operations manager, personnel manager, secretary and legal officer and manpower services officer with personnel officer (II) in attendance conducted an interview for the post of personnel assistant grade PA 6. Out of the nine who appeared for the interview, the present holder J. J. Juma, secured 80 marks, H. Chepkoske 60 and Mr. Nanzaba 59. On the strength of this, Mr. Juma who was junior to Mr. Nanzaba in the same department got the post.

The claimants contended that there was something fishy in all this interview and selection. They maintained that because Mr. Nanzaba was acting in that post he should have got at least 50 marks to start with and therefore it was inconceivable that he secured only nine marks in the rest of the interview. The court cannot accept this because the claimants did not produce any relevant staff regulation or circular in support.

In this dispute were the court to uphold the claimants' submission, it would mean that the court will assume the functions of the interviewing panel and then decide which of the nine candidates was best qualified for the post in question. This certainly is not the function of the Industrial Court. Neither should the court be required to assume the role of the management and determine who should hold which post in an organization and say, or to decide who should be promoted and who should not be.

The court would like to emphasize that the claimants have made allegations of bias on the part of some officers against Mr. Nanzaba and personnel officer (I) who had recommended Mr. Nanzaba for the post but unfortunately apart from their representative's allegations, there is no concrete evidence which would lead the court to believe conclusively that Mr. Nanzaba had been victimized because of some ulterior motives.

The court is also not prepared to quash the proceedings and result of interviews conducted by a properly constituted panel and declare Mr. Nanzaba successful and order his promotion to the post in question.

The court concurs with the Ministry of Labour's findings that the management has the prerogative to confirm an acting appointment without interview or call for interviews and that the claimants' case for supersession had not been established and that their contention should be rejected.

After carefully considering all aspects of this dispute the court rejects the claimants' demand.
